HARVEST HEATS UP

Harvest slightly behind average

While harvest totals for Illinois were slightly behind average as of Sept. 20, that could change quickly, as farmers were busy in the fields this week.

Through Sept. 20, the USDA reports that Illinois farmers had harvested 4 percent of the state's corn crop – ahead of last year's 2 percent total at this time but behind the five-year average of 11 percent.

Soybean harvest was at 1 percent compared to the five-year average of 4 percent.

That can change quickly given modern farm equipment and a forecast that calls for continued dry, temperate weather.

One factor that could slow the process are sizable yields, with 17 percent of corn rated excellent and 56 percent rated good, 19 percent fair and just 8 percent poor or very poor. Through Sept. 20, soybeans were 15 percent excellent, 56 percent good, 22 percent fair and just 7 percent poor or very poor.

New COVID testing sites to open

While Stark County has returned to a more stable level in terms of COVID-19 cases, the Henry and Stark County Health Departments will be holding three drive-through, COVID-19 community-based testing opportunities in October.

Drive-through testing in Kewanee will be Saturday, Oct. 3 and Tuesday, Oct. 6, from 9 a.m.-3 p.m. at 700 Elliott St., the former Kewanee Hospital Site.

Testing in Stark County will be at Stark County High School on Saturday, Oct. 10,

from 9 a.m. to 3 p.m. These sites will be drive-through only with no walk-ups.

Users must wear a mask, show an ID and insurance card (if applicable), have a working car window and remain in the car once in line.

Any person with symptoms should be tested. Symptoms include fever, cough, shortness of breath or difficulty breathing, chills, muscle or body aches, headache, sore throat, new loss of taste or smell, nausea or

Stark County board narrows construction manager field

TOULON – The Stark County School Board took another step closer to building a new high school in Toulon on Monday. Board member Bruce West reported to the school board that the building committee examined six companies for the choice of construction manager.

The six companies, Valley, Bush, O'Shea, Core, Russell, and MCP Midwest, were narrowed down to three companies to interview the first week of October for the position of construction manager. Those three are Core, Russell, and MCP Midwest.

The company selected as construction manager will oversee building and renovation of the school buildings in Toulon. The project is considered a "renovation" because according to Stark School District Superintendent Brett Elliott, "We are not building a completely new building.

"We will build a new addition that will become the academic portion of the high school and then demolish the current academic portion. New hallways will be

added for better flow from the junior high to high school and the junior high will get flooring, cosmetic upgrades and an elevator," Elliott added.

Four seats on the school board are going to be "open" and board members who are up for re-election in April, 2021, – if they choose to run again – are Emily Holman, Beth Rumbold, Ann Orwig and Brian Rewerts.

Persons interested in running for the school board who are from Stark County's school district should contact Heather Hollis for particulars at the Stark County clerk's office.

The board approved the hosting of a COVID-19 testing clinic at the high school parking lot on Saturday, Oct. 10, from 9 a.m. until 3 p.m. The school district is working with OSF and the Henry-Stark Health Department to host this free community testing clinic.

The board also approved a plan to move from in-person learning to remote only learning if the school year is inter

Galva superintendent pleased so far

GALVA – Galva Superintendent Doug O'Riley said Monday he was very pleased at how the Galva School District is getting along with the many COVID-19 regulations.

O'Riley told the school board at Monday's meeting that the elementary staff is "phenomenal" in helping kids get into the school each day. He said that with parents just dropping off their children and not leaving their cars, it is a "tremendous safety improvement."

Elementary principal Mary Kelly agreed and said the students are doing very well. She said wearing masks has not been an issue and neither is social distancing.

"I couldn't be more proud of our teachers working four hours with no breaks,"

O'Riley said, while also giving credit to the Galva community. "Galva has had a count of 19-20 [COVID-19] cases for weeks. This is attributed to the community wearing masks and trying to keep everyone safe. I still hope we are still here in January and February."

With that in mind, O'Riley said classroom windows will be left slightly open this winter to let fresh air in. "Our energy cost will go up," he said.

The board unanimously approved a budget for 2020-21 with \$8,076,687 of revenue and \$7,409,766 in expenses.

The meeting began with a budget hear

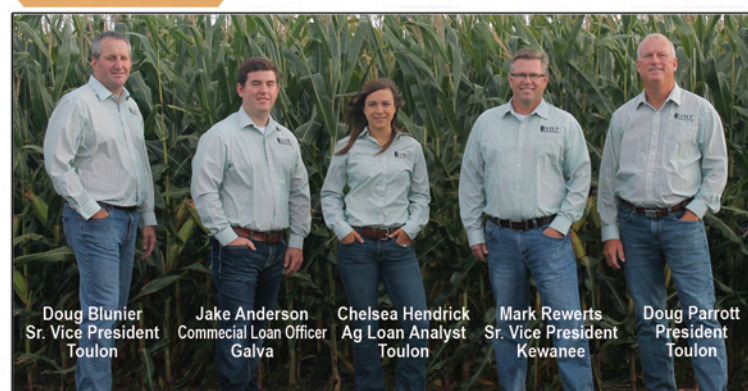

Two Toulon men drown in boating accident

WILLIAMSFIELD—Two Toulon men are dead after an apparent drowning at a strip-mine lake in Knox County last Saturday afternoon.

Two Knox County Sheriff's deputies responded to a lake in the area of 2100 Illinois Route 180 north of Williamsfield at 1:27 p.m.

William J. Self, 40, and Lawrence R. Self, 26, were pronounced dead at the scene, according to the Knox County Sheriff's office. The bodies were reportedly located by Illinois Department of Natural Resources

conservation police officers, who conducted a sonar search.

The Selves had been reported missing on T Lake, a satellite site of Snakeden Hollow State Fish

and Wildlife Area managed by the Illinois Department of Natural Resources.

A third man on the boat with the Selves, Jacob L. Johnson, 30, of Kewanee, was arrested following the incident and is reportedly being investigated for drunken boating.

Preliminary autopsies did not indicate evidence of foul play.

An investigation is ongoing.

The IDNR, Williamsfield Fire and Victoria Fire Department assisted the sheriff's office in the investigation and recovery.

vomiting and diarrhea.

Anyone may be tested; symptoms and referrals are not required and no appointment is needed for the tests.

"We want to encourage testing, especially if you think you have been

in contact with someone who has COVID-19 or if you got a call from the health department telling you that you may have been exposed," said Duane Stevens of the Henry-Stark County Public Health Departments. "Additional community-based testing will also help

us get a better idea of the prevalence of COVID-19 in our communities."

Through Sept. 21, Stark County had 50 confirmed COVID cases and Henry County had 624. Stark County's risk metric has moved from orange to blue, indicating a more stable level of cases.

ing. There was no public comment.

The board unanimously declared the intention to issue \$1.3 million in working cash bonds. These will replace bonds that expired on the tax rolls. The new amount will be levied in November.

O'Riley said total enrollment this year is 493 students, including 278 in the Elementary School and 215 in the Junior High and High School. That's down from 506 last year. O'Riley said 45 seniors graduated in May and only 33 signed up for Kindergarten.

There are 61 elementary students staying home and

34 junior and senior high schoolers staying home doing their work on the computer. Twelve Pre-K students are not attending and getting work in packets.

The board approved eight seniors for early graduation requests. They will finish at the end of this semester in December.

The Galva school board will have five seats up for election in the spring.

The four-year term seats are for anyone not living in Galva Township. They are the seats of Andrew Larson, Darcy Jeffries and Gary Edmunds.

The two two-year seats are for anyone in Galva

Township. They are the seats of Tyler Glaser and Aaron King. Both King and Glaser were appointed after resignations.

John VanDeVelde and Mike Clucas, both from Galva township, are not up for reelection.

Anyone interested in running can pick up their petition at the Circuit Clerk's office at the Henry County Courthouse or may download it.

Pritzker's political games hurt the unemployed

WYOMING – Wyoming United Methodist Church is collecting items to help those affected by recent wildfires in California and the hurricane in Louisiana.

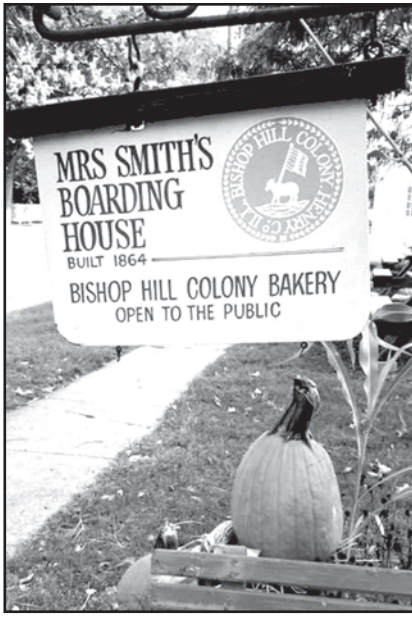
Items can be dropped off at the Wyoming Public Library, the church, or by contacting Pastor Rebecca Klemm at wyomingumc-pastor@gmail.com.

Coalition formed in opposition to Justice Kilbride

Deer hunters urged to be safe in tree stands

With the Illinois archery deer season opening Oct. 1, deer hunters will soon start heading to the woods.

Tree stand falls are one of the most common hunting injuries that can be prevented with some simple safety measures such as always wearing a harness and choosing a sturdy tree.

"Shortcuts lead to accidents, and there's not a deer out there that's worth falling 15 feet to the ground," says Curt Sinclair, University of Illinois Extension 4-H natural resources and shooting sports specialist.

From 2015 to 2019, 90 percent of all non-firearm or bow accidents happened when a hunter fell from an elevated tree stand, according to the Illinois Department of Natural Resources.

Sinclair has taught hunter safety for 30 years and leads the Illinois 4-H Shooting Sports program,

which includes a hunting and outdoor skills curriculum for youth that emphasizes safety and responsibility.

Deer hunters use stands, usually attached 10 to 18 feet up a tree, for a variety of reasons. The elevated position allows a clear line of sight over brush and the angle of projectiles is directed toward the ground.

"There's a lot of advantages to being above the ground, but the biggest disadvantage is you can fall," Sinclair says. "Being up in a tree is one of the most dangerous parts of deer hunting which is why you can't learn too much."

Hunters should pick a tree that is sturdy and straight with no obvious signs of disease or damage such as hanging limbs that could fall. Oak trees with a trunk 8 to 16 inches in diameter are a good option.

Tree stands are most dangerous during the installation and take

down.

"Whenever you are off the ground, even if it's 1 foot, you need to wear a safety harness that is attached to the tree," Sinclair says. "If you don't have a harness on and you're using both hands to work on something, you're in a dangerous situation."

Tree stand safety tips:

- Leave enough time, do not install a stand the day you plan to hunt.
- Select a sturdy, straight tree with a trunk 8-16 inches in diameter.
- Always wear a safety harness.
- Have a partner.
- Use a haul line to pull up gear instead of climbing with it.

To help hunters, Sinclair demonstrates how to safely install a ladder stand, a hang on stand or a climbing stand in a series of videos available on YouTube at go.illinois.edu/TreeStandVideos.

GOP legislator apologizes about recorded comments

SPRINGFIELD — Freshman state Rep. Amy Grant, R-Wheaton, apologized Monday after making disparaging comments in a recorded phone call about her opponent, Ken Mejia-Beal, which referenced his race and sexual orientation.

In a Monday virtual news conference, state Reps. Will Davis, D-Hazel Crest, Greg Harris, D-Chicago, and Emanuel "Chris" Welch, D-Hillside, presented three short recordings of Grant from a single phone call, and said they would not release the full call.

In the call, Grant said Mejia-Beal, who is a gay, Black Democrat from Lisle, is afraid to travel to the heart of her district, "not because he's Black but because of the way he talks, he's all LGBTQ." In another clip Grant says Mejia-Beal is "just another one of the Cook County people... Another Black Caucus."

The three lawmakers called on Grant to offer a "sincere apology" to Beal, and the freshman Republican lawmaker issued an apology in an email release shortly before the news conference began. She also apologized in a voicemail

to Mejia-Beal.

"I deeply regret the comments I made about Ken Mejia-Beal, and reached out to apologize to him this morning. These comments do not reflect my heart or my faith," Grant wrote in a short statement.

The conversation was between Grant and an unnamed party. Details about who initiated the call are in dispute.

The Democratic lawmakers said Grant had originally called the individual as part of her fundraising efforts, and that was the subject of their call. The individual returned Grant's

call and informed her the call was being recorded, according to the Democrats.

A spokesperson for state House Republican Leader Jim Durkin, R-Western Springs, disputed this story, however. In an email Monday, the spokesperson said Grant did not agree to be recorded, and the individual had actually initiated contact with Grant and identified themselves as a potential donor and supporter of Republican U.S. House candidate Jeanie Ives, who previously held Grant's seat.


The individual then turned the tape over to the Democratic caucus due to concerns about the comments.

Illinois is a two-party consent state, meaning it is illegal to record a phone conversation with a "reasonable expectation of privacy" unless all parties involved are aware and consent to the recording.

Davis said he was not sure when the call took place.

Later Monday, Mejia-Beal issued a statement criticizing Grant's apology and calling her comments "hurtful, degrading, and wholly unacceptable."

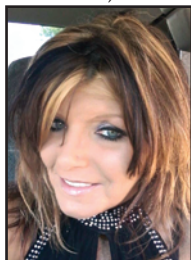

State police warn about phone scam

METAMORA – Illinois State Police District 8 is warning the public of a recent phone scam. On Sept. 18, a District 8 Trooper took a report of a phone scam. The victim informed the trooper he received a phone call from an unknown number with a local area code. The scammer told the victim that he had one of his family members and demanded a ransom.

"In the heat of the moment, these calls can be terrifying," said District 8 Commander Captain Chad Peterson. "Slowing down and taking a few additional steps could help you get out of a scam."

Here are tips from the Federal Trade Commission (FTC):

- **Spot imposters** – Scammers often pretend to be someone you trust, like a government official, family member, charity, or a company you do business with.
- **Do online searches** – Type a company or product name into the search engine with words like "review," "complaint" or "scam." You can even search for phone

numbers to see if other people have reported them as scams.

- **Don't believe Caller ID** – Technology makes it easy for scammers to fake caller ID information.
- **Don't pay up front** – Someone might ask you to pay in advance for debt relief, credit and loan offers, mortgage assistance, or a job.
- **Consider how you pay** – Credit cards have significant fraud protection built in, but some payment methods don't. Wiring money through services like Western Union or MoneyGram is risky because it is nearly impossible to get your money back. That is also true for reloadable gift cards.
- **Talk to someone** – Before you give up money or personal information, talk to someone you trust. Con artists want you to make decisions in a hurry.
- **Get free scam alerts** – The FTC offers free scam alerts at ftc.gov/scams. Get tips and advice about scams via email.
- **Don't hesitate to call 911.**

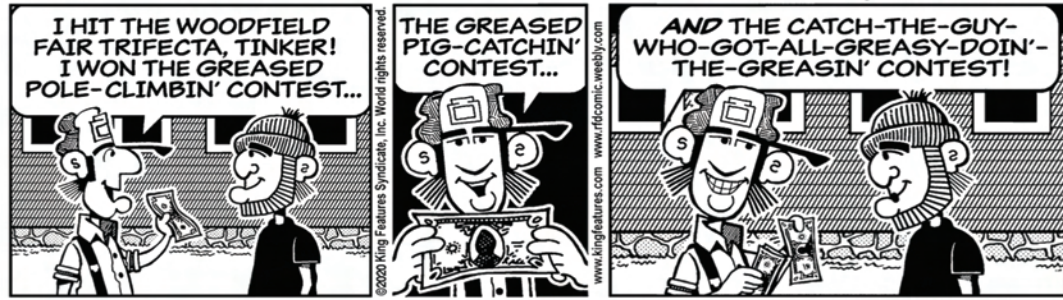

**CITY OF WYOMING TIF DISTRICT NO. 2
SUMMARY OF PROPOSED REDEVELOPMENT PLAN & PROJECTS**

Proposed Redevelopment Plan and Project Area: The City of Wyoming proposes to establish a Redevelopment Project Area and adopt a Redevelopment Plan and Projects pursuant to the Tax Increment Allocation Redevelopment Act [65 ILCS 5/11-74.4 et. seq.] (the "Act") for the proposed "Wyoming Tax Increment Financing (TIF) District No. 2" to stimulate commercial, light industrial and residential development within the City. The intent of the Redevelopment Plan is to promote and protect the health, safety, morals, and welfare of the public, address blighted conditions in the proposed Area and institute conservation measures so as to remove and alleviate adverse conditions, encourage new private investment and reinvestment, and restore and enhance the tax base of the local taxing districts by undertaking public and private redevelopment projects within the specified Redevelopment Project Area. The Redevelopment Project Area (the "Area") for the proposed Wyoming TIF District No. 2 includes areas shown on the proposed Boundary Map and is legally described in the proposed Legal Description of the TIF Area. These properties have been neglected and have not benefitted from coordinated planning efforts by either public or private sectors. All properties within the proposed Area would substantially benefit by a series of proposed public and private redevelopment projects. Pursuant to the Act, the Area is not less in the aggregate than 1½ acres and the proposed Area includes only those contiguous parcels of real property and improvements thereon which would be substantially benefitted by a redevelopment project. The overall Area consists of 136 improved and vacant parcels, 91.2% of which qualify as a combination of "Blighted" and "Conservation" Areas, as defined in the Act. Improved parcels display characteristics of age, dilapidation, obsolescence, deterioration, inadequate utilities, deleterious use and a lack of community planning. Vacant parcels in the Area display characteristics of obsolete platting, deterioration of adjacent properties, chronic flooding or contributing to flooding within the same watershed and being blighted before becoming vacant. In addition, evidence of a lag in Equalized Assessed Valuation (EAV) growth is apparent throughout the Area as a whole and has been documented pursuant to data made available by Stark County. The Redevelopment Project Area as-a-whole has not been subject to growth and development through investment by private enterprise and would not reasonably be anticipated to be developed without the adoption of the proposed TIF District No. 2 Redevelopment Plan. By improving public infrastructure and encouraging new private investment throughout a designated Redevelopment Project Area, the City expects to create new employment opportunities, improve public services necessary for stimulating future population increases, further stimulate the local economy and improve the overall quality of life for its residents.

Long Term Goals and Objectives: The City intends to use the Wyoming TIF District No. 2 to redevelop property that is currently underutilized for commercial, light industrial and residential development in an effort to increase population, improve employment opportunities, expand and diversify the local real estate tax base, manage growth and increase the overall quality of life for its residents. The Redevelopment Plan will allow the City to alleviate and/or remove blighting conditions such as the lack of adequate public infrastructure, increase Wyoming's overall competitiveness in the region and institute public policies that are more conducive to such business development. The properties located within the Redevelopment Project Area will substantially benefit by a series of public and private redevelopment projects made possible with tax increment financing. The Redevelopment Project Area is not otherwise reasonably expected to be substantially improved or be further developed without the use of tax increment financing. The Wyoming TIF District No. 2 Redevelopment Plan is expected to include, but is not limited to, the following general long-term goals and objectives: (1) Eliminate or reduce those conditions which qualify the Redevelopment Project Area as a combination of "Blighted" and "Conservation" Areas; (2) Facilitate the construction, improvement and maintenance of public infrastructure, environmental remediation and other capital projects which the City finds is in furtherance of the Redevelopment Plan or necessary to encourage commercial, light industrial and residential development; (3) Construct, improve, upgrade and maintain storm water drainage and sanitary sewer lines and related infrastructure throughout the Redevelopment Project Area and contiguous Redevelopment Project Areas; (4) Construct, improve, upgrade and maintain antiquated and/or inadequate water lines and mains, as well as water storage facilities and related distribution systems throughout the Area and contiguous Redevelopment Project Areas; (5) Construct, improve, upgrade and maintain streets, amenities relating to information technology, street lighting, landscaping, curbs, alleys, parks, public green space, recreational amenities, signage, sidewalks, bike paths and other pedestrian walkways throughout the Area and contiguous Redevelopment Project Areas; (6) Encourage residential rehabilitation/renovation projects within the Redevelopment Project Area through the use of financial incentives offered by tax increment financing; (7) Enhance the tax base for the City and other

taxing districts through coordinated comprehensive planning efforts by either the public or private sectors to improve essential infrastructure, develop vacant properties, and upgrade/redevelop existing buildings; (8) Attract new commercial and light industrial development which complies with City zoning and land use ordinances, if applicable, increases assessed valuations and enhances the real estate tax base for the City, thereby also creating additional employment opportunities within the Wyoming community; (9) Encourage the development of new residential choices for retired persons and elderly residents over the next 20 years; (10) Encourage new residential development which will thereby help to adequately increase the City's population, expand the overall tax base of the community, sufficiently increase and maintain local school enrollments, and raise local economic thresholds to levels necessary to support new commercial retail development; (11) Attract new retail/commercial businesses and tourism development while also vigorously reinvesting in existing properties within the Redevelopment Project Area so as to increase retail business activity that will generate new local retail sales tax revenue for the City, Stark County and the State of Illinois; and (12) Undertake redevelopment projects which will further improve the overall quality of life, health and well-being of the Wyoming community.

Description of Tax Increment Financing: A TIF District establishes a geographic boundary (a redevelopment project area) in which new private investment is encouraged. A municipality may also issue obligations to finance improvements that will enable the redevelopment of deteriorated, blighted, or other key conservation areas within its corporate limits. By making public improvements, the municipality may invite new private investment so that the expected increase in property tax revenues can be captured, temporarily, to amortize the public improvements. A municipality may also choose to use TIF funds on a pay-as-you-go basis whereby revenue is spent as it is collected. In either case, it is expected that new investment in a designated area will stimulate a resurgence of population, employment, and assessed valuation throughout the entire community. It should be noted that TIF **DOES NOT** raise property taxes and it **IS NOT** a new tax or a new taxing district. Only an increased assessment or an overall increase in tax rates can raise taxes. TIF is merely used to reallocate increased property tax revenues created by increased assessed valuation that is realized after a TIF District is established. A TIF District may last for up to 23 years. With Tax Increment Financing, a property tax base is preserved during the life of the TIF District that will continue to pay for the basic public services the proposed redevelopment area already receives. New incremental property tax revenue in the City of Wyoming may be used to help pay for the infrastructure necessary for stimulating additional private-sector investment.

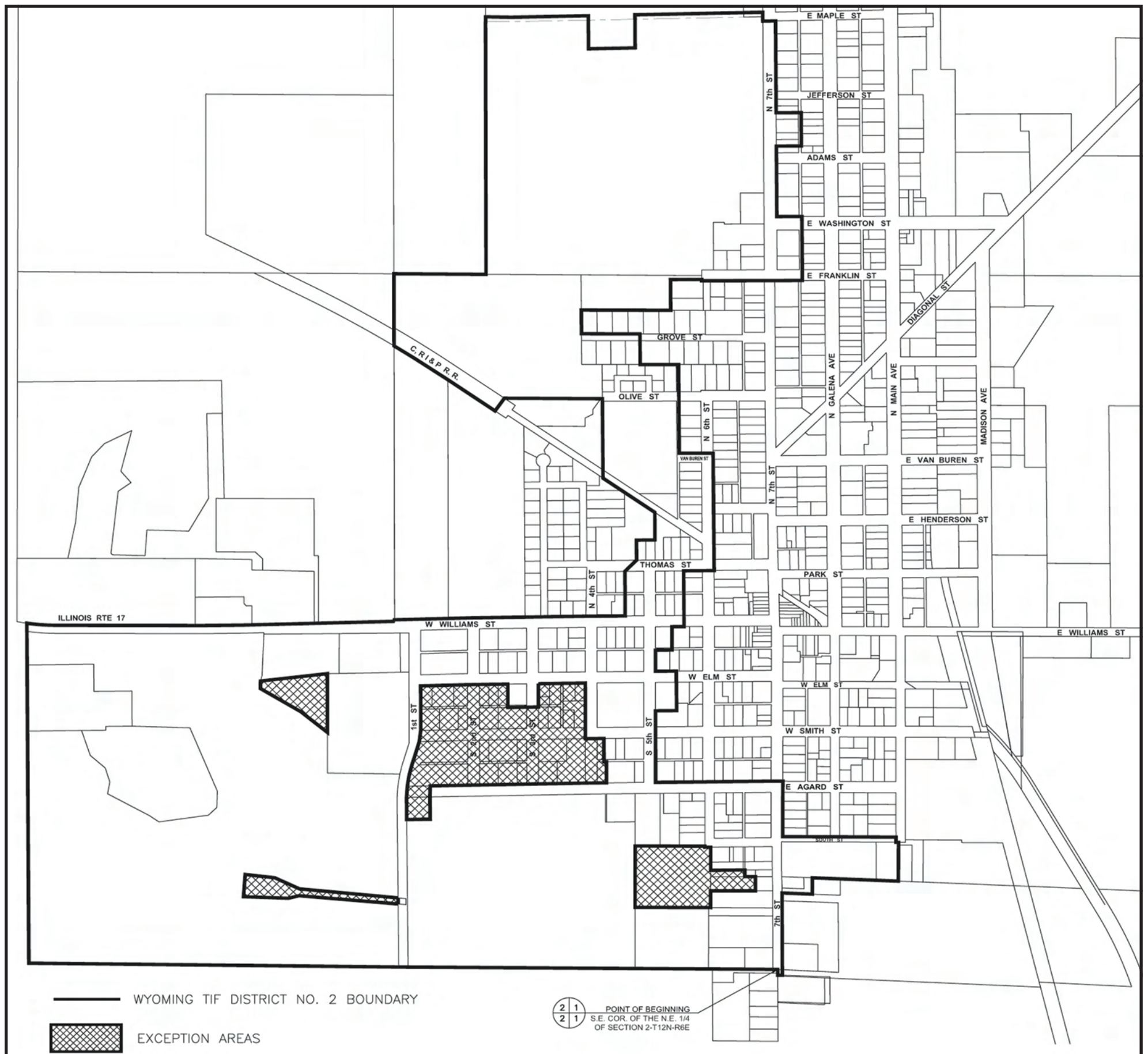
