Election provides intrigue

By Jeff Lampe

Maybe by the time this paper arrives in your mailbox, we will know the President of the United States. But that race was still to close to call on Election Night and even into Wednesday afternoon.

The race between President Donald Trump and Democratic challenger Joe Biden was to be decided by several key swing states with votes still to be tallied.

But there were clear results in some other races and issues in an election that saw record early turnout in Illinois and nationally, as well as the highest voting percentages on record since the early 1900s.

Among the noteworthy Illinois votes was rejection of a proposed constitutional amendment that would have changed Illinois from a flat income tax to a







graduated tax, effective Jan. 1,2021.

With 96.7 percent of precincts reporting, results showed 55 percent of Illinoisans had voted against the amendment and just 45 percent were in favor – well short of the support needed for the measure to pass, even with outstanding mail ballots still to be counted.

"It is clear that Illinoisans do not trust this legislature and this administration to spend more of their precious tax dollars without

restraint," said Illinois Chamber of Commerce President and CEO Todd Maisch.

By Monday, more than 3.5 million voters had already cast early ballots across Illinois and turnout Tuesday was strong locally and across the state. Stark County reported 72.8 percent turnout, Henry County was at 73.15 percent and Knox County saw 69.4 percent of voters cast a ballot.


My Cousin's Military Experience

Veteran Interview **By Emily Hurst**

Gary Hurst, Senior Master Sergeant E-8, worked for the Air National Guard which is a Reserve Component of the Air Force. He was in the military during the Vietnam War, the Gulf War, and Afghanistan War. Although he had several jobs in the military, his final

occupation was budget analyst.

He was born in Macomb on Sept. 15, 1949. His dad was a farmer and his mother was a housewife. He was an only child. He attended Plymouth CC#319, then went to Western University through his junior year of college.

In his youth he liked to build plastic models: cars and airplanes. When he was 20, he enlisted in the Army National Guard. The draft motivated him to enlist, as he was trying to finish college. He had never seriously thought of enlisting, but since the Vietnam War was going on then, he decided to enlist and felt excited and apprehensive about joining.

He received his basic training at Fort Bragg, NC. He made friends that he talked with while he was stationed at Fort Bragg; but once he left there, he lost track of them. In November of 1971, he transferred to the Air National Guard, in Peoria.

Military life was very controlled and very disciplined. "The training noncommissioned officers told you what to do and when to do it, and you were expected to follow them." His hours were 24/7. "You just didn't know what

the next thing to happen was."

The weather where he was stationed was hot and dry. "God made a beach and forgot the water 'cause it was sandy and it was dry." He never got anywhere near the enemy or the war zones because his job was laundry and paperwork. While some of his commanding officers were good, some were "aloof." There were also a few commanding officers that got to know each person personally. He did have contact with civilians during the Vietnam War, but if he was in his uniform, some people weren't very nice.

While Gary was in the service, he married his college sweetheart, Jeanne (Beecher) Hurst and together had two kids: Chris Hurst and Jeff Hurst. He now has four grandchildren: three granddaughters, one grandson. He retired from his last job as a Medicare specialist at OSF about four years ago. A couple of his hobbies include working old tractors and working around the house. He said that if he could go back and change anything, "It would have to be going back and finishing college while I had the chance."

ELECTION: Judge race a 'message' to Madigan

race saw Justice Thomas Kilbride become the first sitting Illinois Supreme Court justice fail to earn retention. With 97.7 percent of votes counted, Kilbride had 56.4 percent yes votes – short of the 60 percent he needed to retain his seat.

Stark County saw 66.7 percent "No" votes on Kilbride and Henry County was running at 43.66 percent "No" votes.

"This unprecedented outcome sends an unmistakable message that Illinoisans want an independent judiciary with no ties to Mike Madigan," said Jim Nowlan of Toulon, who was chairman of the group Citizens for Judicial Fairness. "We call on the Supreme Court to listen to the people as they consider a potential interim replacement to serve until 2022."

The Supreme Court will appoint a replacement until a 2022 special election.

The race to keep or remove an Illinois Supreme Court justice on the bench has become the most expensive retention election in the high court's history.

Kilbride's retention campaign and the anti-retention effort trying to remove him have spent millions, and the race could also top the record of \$9.3 million spent on a competitive, non-retention election in 2004.

The marquee race between Trump and Biden was decided early in Illinois. With 89 percent of the vote counted, the Associated Press called Biden the winner in Illinois with 55.1

percent of the vote to 43 percent for Trump.

Those statewide results were in stark contrast to the local vote for president. In Stark County, 69.42 percent of voters favored Trump and just 28.25 percent backed Biden.

Henry County saw 59.17 percent Trump voters compared to 37.84 for Biden.

Knox County went for Trump 62.9-35.02.

In other races, Democratic incumbent Cheri Bustos faced a battle for Congressional Representative from the 17th District. With 99.9 percent reporting, Bustos had 51.7 percent of the vote compared to 48.3 for Republican Esther Joy King. King carried Henry County with 57.85 percent.

For Congressional Representative from the 16th District, Republican Adam Kinzinger carried Stark County (77.55 percent) and the election, with 65.2 percent.

For Congressional Representative from the 18th District, Republican Darin LaHood won easily with 70.5 percent vs. 29.5 percent for Democratic challenger George Petrilli.

A race called just 15 minutes after polls closed was the reelection of Democratic Sen. Dick Durbin, who ran against Republican Mark Curran. With 73.3 percent of the votes counted, Durbin had 52.3 percent to 40.9 for Curran, 1.9 percent for Libertarian Danny Malouf and 3.9 percent for Willie Wilson.

Curran carried both Henry (56.29 percent) and Stark counties (66.93 percent).

Stark County had no other contested elections, though they did mirror the votes to retain three other judges: 10th Circuit Judges Stephen Kouri and James Mack and 3rd Judicial District Judge of the Appellate Court Mary McDade.

Henry County voters favored two winners in State House races. Republican Tony McCombie got 63.6 percent of votes in Henry County and 61.6 overall vs. Democrat challenger Joan Padilla to win in House District 71. And Republican Dan Swanson garnered 71.38 percent of the Henry County vote and 71.1 percent overall to win over Christopher Demink in House District 74.

Henry County voters also helped retain several judges: McDade and three in the 14th Judicial District. Linnea Thompson, Terence Patton and Walter Braud.





Life is good again down on the farm

Harvest is complete; half the cornstalks are baled; and dawn comes at the proper time once again. Life is good here on the farm. After the impossibly wet fall last year, it has been sheer joy to anticipate a string of full days of combining this year.

The increased efficiency of being able to use storage, dryers, equipment, and manpower to full capacity is in itself a huge benefit Add to that the improved

attitude that comes from feeling productive. We have much for which to be thankful.

AJ and I share work with neighbors Rick and Joyce Rumbold during harvest. On a typical day Joyce runs the combine; I haul grain in; and Rick drives the semi, manages logistics, keeps the grain dryer going, and does the million things that keep everything running smoothly. AJ goes for parts, runs errands, and serves as a shuttle service to get us all in the right place at the right time with the right equipment. We make a pretty good team. Rick and Joyce do most of the work, and AJ and I just sort of fill in the gaps.

Between the two families there are only a handful of fields that are rectangular. Both of us farm along Walnut Creek, so we have extremely scenic, but seldom geometric fields. Still, it is hard to get tired of watching deer graze unconcerned along the margins of the cornfields or seeing a wily coyote make a dash for the timber line when he gets flushed out of his corner of the cornfield by the combine. One day while I was unloading corn I watched a pair of eagles circling their way slowly, gracefully from one field to the next.

Because we live on AJ's family farm, we often think about how much agriculture has changed, even just within his 78 years of living here. His father Gerald picked corn by hand. He was apparently quite good at it. Still, it was slow, hard work. He would pull the ear from the stalk, use the husking peg to remove the husk, then toss it into the wagon being pulled by a team of horses. The wagon would hold about 75 bushels of ear corn. Once it was full, the team pulled it to the corn crib where it was shoveled into one side or the other.

The crib could hold 2,000 bushels of ear corn. At 75 bushels to the acre, that was adequate storage. Later, it was fed as ear corn to the hogs, or

shoveled back out into a small corn sheller. Once the ears were shelled, the corn was shoveled into a wagon and then into the granary in the barn. There was a small slide on each granary, so that a bucket could be placed below the slot, the slide raised, and a bucket filled to carry to the milk cows.

Gerald eventually purchased a tworow corn picker powered by his 1942 International H tractor. That tractor is at this moment hooked onto one of the augers at Rick's bins across the field. The biggest corn picker ever to be used here was a four-row New Idea. When Earl Curry worked for us, he and I picked corn for several years. Earl ran the picker and I hauled in and unloaded the corn into the elevator. We both unplugged the picker. It seems we did that a lot.

It is hard to comprehend just how much agriculture has changed. The barns and out buildings that make up our barnyard today had begun to be assembled in 1837. How could anyone then have foreseen combines or auger carts nearly as large as the cabin that served as the family home for 17 years?

It does make for some interesting configurations when we fill the Harvestores both here and at the Other Place. To add to the challenge



Continued from Page 4 of equipment placement in cramped quarters, both barnyards are criss-crossed

by electric wires.

We finished our last field at the Other Place last night. Rick had the last semi we were taking to town loaded and had about 40 minutes before the elevator closed for the day. He parked the truck beyond the barnyard because once he got the auger set it wouldn't fit through there. Nothing would. He put the auger up to the Harvestore first. I climbed up to center the spout. Then he had to park the catch wagon so that it emptied into the hopper of the auger, yet allowed for the Massey and auger cart to maneuver up to it. And then there was that overhead wire.

Rick knew I was less than comfortable deploying the auger of the cart anywhere near that electric wire, so he was working hard at getting the catch wagon as far as possible from it. After a couple placements, he wasn't quite satisfied.

"Hey," he said. "How much hay is in that barn?" I told him there wasn't much in there.

"Let's open the door." I could see what he was going to do, so I quickly loosened the turnbuckles on either side of the door and hauled it open. He pulled the truck well into the nearly empty barn and then was able to get the wagon just where he wanted it.

"I think you'll be all right there if you put the auger out before you pull up."

I had hoped for something more reassuring than "I think you'll be all right," when referring to the proximity of a power line that still bisected the wagon diagonally, but I did successfully unload without electrocuting myself.

Rick and Joyce still have a few acres to pick, but that should be done in a day. Then harvest will be complete in this little neck of the woods. It went fast this year, which is to say it went well. That is most welcome in a time when much else is not going well at all.

Beef Picadillo-Stuffed Acorn Squash

A nutrient-rich alternative to the brown-sugarand-butter treatment for squash. Top it instead with a spicy-sweet blend of Ground Beef, onion, cinnamon and raisins. Ingredients:

2. Sprinkle seasoning mix and cinnamon over beef; mix well. Stir in tomato sauce and raisins; bring to a boil. Reduce heat; cover and simmer 15 minutes, stirring occasionally. Serve over squash. Garnish with almonds, if desired.

Mexican Seasoning Mix: Combine 1/3 cup chili powder, 1 tablespoon salt, 1-1/2 teaspoons ground cumin and 3/4 teaspoon garlic powder. Store in airtight container. Shake before using to blend.





LaFayette holding caucus for village offices Dec. 7

LaFAYETTE - The Village of LaFayette has scheduled Monday, Dec. 7, as its date to conduct a caucus for nominations of candidates for village offices. Any resident who is of legal age and is willing to hold office must attend the caucus and be nominated at that time for office.

The offices up for the village election are village president currently held by Donald "Greg" Bartley, village clerk currently held by Robin Bartley, and three trustee positions currently held by Larry Townsend, Bethany Peterson, and Christopher Smith.

The water booster pump for the village's pump house needs to be replacing and contractor Dean Rosebecke is having a difficult time trying to find a replacement pump. According to President Bartley, the pumps for the village's water system were replaced many years ago and have been rebuilt at least once in the past. Rosebecke said that a company will hopefully be able to build one, "or something," to replace the current booster pump.

If a pump that matches the existing plumbing cannot be rebuilt or constructed, then the plumbing for that pump will have to be replaced, as well, which would be expensive.

Also, the motor on the aerator for the water system needs repairs. Rosebecke said "anything above the tank has to come down - the motor is inside of the aerator." Those repairs could prove costly, too. First, an electrician will check the pump house circuitry to the unit to determine if that is the problem with the motor running for a minute, then shutting off. Normally, it would run for a longer period of time to sufficiently aerate the water.

Approved was the sole bid for \$900 by LaFayette's Ryan Peterson's tree service to remove two ash trees on

village property at the intersection of Mulberry and Madison Streets.

Additionally, Clarence Wagher and Chris Smith were approved to drive the snow plow this year for the snow season. Wagher will be primary driver with Smith as his backup.

The trustees discussed this fiscal year's appropriations, which is the estimate of expenditures to conduct village business. The trustees approved leaving the current appropriations "as is" without any changes in the estimated cost amounts.

Finally, an update on the snow plow building was given. Trustee Chris Smith has contacted American Steel concerning the construction of the snow plow building for the snow plow storage. It was assumed that Smith will give a report to the board concerning this topic at the next village meeting. Smith was absent from Monday's



SENECA – Stark County senior Alyssa Dyken closed out her Lady Rebels cross country career in style last Saturday at the Class 1A Seneca Sectional.

Running on a difficult, hilly course in the wind, Dyken placed 12th in the first heat in a time of 21:30. Her overall finish would have advanced Dyken to the state meet as an individual, if COVID-19 had not caused the cancellation of that event.

"She's the first runner Stark County has had qualify for state as an individual," Rebels Coach Bob Rennick Jr. said, noting that his 2018 girls runners reached state as a team. "That's a heck of an accomplishment."

Rennick said Dyken's strong season started early, when she competed well with Annawan-Wethersfield runners.

"From there, it was like let's challenge ourselves and let's see what's in the tank. And she just got better and better from there," Rennick said, calling a win at

Princeville another "turning point" in the vear for Dyken.

Overall, the Stark County girls placed 9th out of 14 teams after running second in the regionals.

Heat 2 saw Ashley Orrick (40th, 22:14) finish 17th and Lena Becker (42nd, 22:22) finish 19th. In the third heat for the girls were Paige Rewerts (73rd, 23:33) and Trinity Shimmin (76th, 23:38) who finished 13th and 15th respectively.

The fourth and final girls heat featured McKenzie Stahl (108th, 26:27) and Riley Menssen (110th, 28:58).

Five of Saturday's runners were seniors: Becker, Shimmin, Dyken, Menssen and Stahl.

"We put in a great effort on a really tough course," Rennick said. "There was a point in the season where sectionals wasn't realistic for us with the injuries and setbacks we had. Getting out of regionals was even questionable. So for them to do what they did, I'm really proud of these girls."

Boards to decide basketball's fate

The future of Illinois high school and junior high school basketball remains up in the air.

Last week, the Illinois Department of Public Health changed its classification of basketball to a high-risk sport from its previous designation of medium-risk. And Gov. JB Pritzker has said that basketball can't be played until spring.

That jeopardizes the Illinois High School Association's scheduled start dates of Nov. 16 for practices and Nov. 30 for games. But the IHSA's board of directors said last week it will not heed the latest IDPH changes and, aside from a few additional restrictions, will leave the decision of whether or not to compete up to local schools.

That has sent local superintendents, principals and athletic directors scrambling. Concerns center on liability, since many insurance companies have informed

schools they would not be covered if they move forward and play.

"Our insurance company has informed us our policy does not cover liability associated with communicable disease. They implied other school districts are in the same boat," said Williamsfield Superintendent Tim Farquer, noting representatives from the Williamsfield and ROWVA school boards were meeting this week

At Stark County, Superintendent Brett Elliott informed staff in an email that a basketball decision would be made Nov. 16 by the Stark County School Board.

A Nov. 2 poll by the Illinois Athletic Directors Association of 372 athletic directors from across Illinois showed 9 percent were planning to play basketball, 29 percent were not and 62 percent were unsure.

In the mean time, most schools are requiring that any practices do not involve contact and that players must wear masks.


