Galva schools dealing with masked intruder

GALVA – News of a masked intruder breaking into the Galva school building was naturally a topic of discussion at Monday’s school board meeting.

After the board approved the installation of cellular motion detectors in the school, Superintendent Doug O’Riley noted the detectors would have helped catch the intruder had they been in place on

the night of Jan. 30. That’s when a white male subject gained entry to the school by breaking a classroom window. The intruder then searched every room and took property along the way.

Galva police estimate the intruder was between 5-foot-8 and 5-10. He was wearing a black winter coat. Anyone with information is asked to call the Galva police at (309) 932-3911.

The board also voted to accept a

bid from East Moline Glass of \$266,350 to replace all windows at the Elementary School.

The board approved a two-year contract with ROWVA and Williamsfield for football. Williamsfield has also joined the Mid-County coop for golf.

The board also approved a nine person committee to study and discuss co-oping all sports with Williamsfield and ROWVA.

O’Riley said this could take up to

a year and they could decide on all or just a few sports to coop.

O’Riley said district employees can get their second COVID vaccine next week.

The curriculum committee has met and Galva hopes to be back in school by March 16 for a five-hour day. O’Riley said times have not yet been set, though a 7:45 a.m. to 12:45 p.m. day is possible and would allow lunches to be sent home with students.

Bradford man faces attempted murder trial

TOULON – A Bradford man, 36-year-old Carter Leo Scott, was found by Circuit Judge James A. Mack to have had probable cause in charges of attempted murder of a peace officer, aggravated discharge of a firearm at a peace officer and aggravated assault with the use of a deadly weapon.

Mack set a jury trial date for Aug. 9 with a pretrial date of April 13.

Scott, along with his attorney Kevin Sullivan, of Peoria, was in Stark’s Circuit Court Friday for a preliminary hearing.

“The evidence is only speculative,” Sullivan said. “Speculation is the testimony [of Stark County Sheriff’s Deputy Dawson

Nuding] that the rifle was fired in the direction of the deputy.”

Sullivan also argued there is not enough evidence for the charge of aggravated discharge of a firearm at a peace officer, because Nuding could not be sure the rifle was fired at him.

Nuding said that with his military experience and deputy’s experience the rifle’s muzzle

Stark County board battles Frontier woes

TOULON – Frontier Communications continues to add billing charges to accounts the Stark County board of supervisors is attempting to disengage from that business. The county has switched, or is attempting to switch, to Mid-Century for telephone lines in courthouse offices, annex offices and the Sheriff’s office.

Stark County treasurer Paula Leezertold the board at its Tuesday meeting that she contacted the Frontier representative on Jan. 13 to cancel all existing phone lines, except for the Law Enforcement Agencies Data System for the Sheriff’s Office.

“I received an email of January 26, 13 days later, that they (Frontier) finally cancelled them. We’ve received a couple of more bills prior to Jan. 26,” Leezer said. “They are saying that we owe more than what we do. I’m wondering why it took 13 days to go through as opposed to cancelling on the 13th.”

One of the account numbers Leezer informed the board about is a new account Frontier presented for billing purposes, according to Leezer, and has an \$824 amount due. Leezer said the new account is a bill for the courthouse and annex phone service “that was not cancelled when re-

Wyoming plans to demolish old locker property

WYOMING – Wyoming’s city council plans to move forward with demolition of the old locker building at 103 N. Galena after an update on the issue at its Monday meeting.

Paralegal Julie Maher called the locker building “an immediate hazard” and presented steps necessary for the city to take possession of the property so that the demotion could commence. Maher told the council a sign at the property must have Wyoming Police Chief Mark

James’ signature on it and be posted at the property for 30 days, plus the city’s intent to take possession of the property must be published in the local newspaper. After 30 days, the city must start demolition within another 30 days.

 requested." Leezer said the account was billed Jan. 25 and was cancelled Jan. 26. "I don't agree with it. Again, what Caroline [Borden-Campion, State's Attorney] found in the terminology of the contract for that particular bill, our contract was dated in July, but Frontier is saying the contract is from October, which is not right." This prompted board chairman Al Curry to say, "The five years that we were promised [by Frontier] to halve our bill, has actually doubled. Plus we paid \$300 a month, I believe, for all that equipment that was supposed to halve our bill and it actually dou-

bled. "These guys have done – in my opinion – nothing but lie to us over this whole five year period. This is a very, very dishonest outfit." Leezer said Frontier has put up "a lot of roadblocks for Mid-Century in converting the phone lines." Curry said the county will pay less than half for Mid-Century's service vs. what Frontier charged. An employee handbook revision was approved allowing employees to carry one week of vacation to the next year. If vacation time is not used, the employee "loses" any additional time. Committee assignments were an-

nounced: Police – Bill Loane and Kari Bush; legislative/economic development – Tom Howes and Tim McMillen; Health Board – Bush; Judicial – McMillen and Howes; Building/Grounds – Curry; Road/Bridge – Robin Nowlan and Loane; Building Compliance – Howes; Policy and Procedure – Bush; and Finance – all board members. Curry said nobody has stepped forward to fill two vacant seats on the board. Tabled to next month was a request by Bo/Gar Enterprises to rezone from commercial to light industrial the former Wyoming Motors building on South Seventh Street.

flash indicated to him that the rifle was being pointed in his direction. When asked by Sullivan if the rifle could have possibly been pointed in a different direction, Nuding answered, "Yes."

"I don't believe the threats are speculative and

I will find probable cause on counts one, two and three," Mack said.

Sullivan then entered a plea of not guilty on behalf of Scott.

Scott was charged last Oct. 5 with the three counts after Nuding responded to a domestic/hostage situation.

Documentation shows that Shawna D. Cassidy called the Stark County Sheriff's Office stating that she, with her two children, had locked themselves in a bathroom at a North Modena Road residence because there was a man outside with a gun.

At some point during the situation, Cassidy and children went to a neighbor's residence. Nuding's report states that he went first to the neighbor's residence, then travelled to Scott's residence.

Nuding made verbal contact with an alleged intoxicated Scott, but Nuding remained at his deputy's vehicle "not knowing if Carter had his firearm."

It was at this juncture that Scott allegedly fired three shots from "an AR15 style rifle" in Nuding's direction after asking Nuding if "he was ready to meet his maker."

Scott was subsequently arrested after his father, Stark County Chief Deputy Chuck Demetreon, Wyoming Police Chief Mark James and other law enforcement officials arrived at the scene.

The first two charges are Class X felonies punishable of up to 45 years in prison each, with a mandatory minimum prison term of 10 years on each.

Scott is free from custody on a \$250,000 bond, with 10 percent applied.

...TOULON – After months of delays in getting a long-awaited girls basketball season underway, the Stark County girls didn't waste any time on Tuesday.

The Lady Rebels jumped to a 22-8 lead after one quarter against Wethersfield and then maintained a lead throughout the game at Stark County High School on the way to a 67-43 victory.

Lindley Johnston had 10 of her team-high 25 points in the opening quarter, as Stark County (1-0) unleashed some pent up hoops energy on Wethersfield.

Johnston rained in a trio of 3-pointers for the Lady Rebels, whose coach Scott Paxson had hoped for improved outside shooting this year to go with normally stingy defense.

Stark County also got treys from Kelsey Berchtold, who was second on the team with 20 points, and Olivia Hopp, who tallied 10. Lexi Davis added eight points for Stark County and Riley Menssen tallied four.

Elsewhere in girls basketball, Galva (0-3) lost Tuesday to ROWVA-Williamsfield, 55-38, and fell to Mercer County last Saturday, 57-32. The Lady Wildcats dropped their opener at Kewanee, 39-35, after leading heading through the third quarter.

The girls are at West Central Friday and then return home Saturday to face

Peoria Heights.

• **Boys basketball:** The Stark County boys started slowly in a 69-42 season-opening loss at Wethersfield. The Rebels (0-1) trailed 19-1 after the first quarter and 35-16 at half-time before holding their own in the final two quarters.

"We played better from the second quarter on, but it's hard to spot a good team 20 points and recover," Stark County Coach Dustin Browning said. "[Ryan] Murphy's inside presence helped right the ship, but the damage was already done."

Murphy led the Rebels with 18 points, while Raidon Porter added 9 and Caden Daum and Matthew McCauley had six apiece.

Coltin Quagliano had 13 of his game-high 25 points in the first half for Wethersfield (2-0).




