BOATING SAFETY WEEK


Checklist helps with boat safety

The nation’s biggest recreational boating safety event of the year, National Safe Boating Week, starts this weekend and runs from May 22-28. The annual event helps remind boaters to keep boating safety front and center all season long.

Regardless of the type or size of your watercraft, now is the time to go through a checklist to insure that your boat is safe, properly equipped and legal, so that you can enjoy a long summer season of fun on the water.

“No matter when you are on the water this season, make the safety of you, your passengers, and other boaters your most important consideration,” said Illinois Department of Natural Resources Law Enforcement Director Timothy Tyler. “Review a boating

safety checklist, and make sure your boat is tuned up and ready for the season before you back down the boat ramp or push off from the dock.”

Here’s a quick boat safety checklist to review, courtesy of the IDNR.

- Make sure you have Coast Guard-approved life jackets/personal flotation devices (PFDs) for everyone onboard. All persons under age 13 must wear a PFD

while a vessel is underway. But why not just wear your PFD no matter what, no matter your age, whether you are trolling or using “the big motor”, shallow or deep, paddling, skiing or fishing.

- If a boat is 16 feet or longer, it must have a throwable flotation device (ring, cushion with straps) available.
- Have a working fire extinguisher that is properly charged.

New rules on masks

Vaccinated can go mask free

SPRINGFIELD – Gov. JB Pritzker has issued a new executive order that allows fully vaccinated residents to not wear masks inside and outdoors.

The updated rules for mask wearing are nearly identical to the U.S. Centers for Disease Control and Prevention’s updated guidance, released last Thursday.

The CDC guidance permits fully vaccinated people to not wear masks or physically distance in any non-health care setting, “except where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.”

The CDC still recommends that fully vaccinated people wear masks in health care settings, as well as on planes, trains and other forms of public transportation.

The new executive order requires residents follow this recommendation regarding

planes and public transportation. It also permits any entity to continue stricter masking requirements than are required by the state.

“Businesses are encouraged to prioritize the health and safety of their workers and customers, and may continue to require face coverings and social distancing, even for those who are fully vaccinated,” the order states.

Pritzker said it will be up to private businesses to decide if they require patrons to provide proof of vaccinations.

“We are relying on people to do the right thing,” he said.

The mask mandate in Illinois took effect last May when Pritzker issued an executive order requiring anyone older than 2 years of age “to cover their nose and mouth with a face-covering when in a public place and unable to maintain a six-foot social distance.”

The state says 37.7 percent of the population, or more than 4.8 million people, are fully vaccinated.

Superintendents address Illinois teacher shortage

SPRINGFIELD – Following a February survey of school districts that illustrated a persistent teacher shortage in the state, the Illinois Association of Regional Superintendents of Schools has released policy recommendations calling for better benefits and more le-

nient certification in an effort to reverse the trend.

The IARSS, an intermediary between local school districts and the Illinois State Board of Education, had the survey conducted to see how school districts were faring with the supply of professional and substitute teachers amid the coronavirus pandemic.

Illinois was split into seven regions, and school districts reported the shortage was worst in west central and southeastern Illinois. White papers developed in response to the survey give seven policy recommendations as ways to combat it from the local to statewide level. The two primary methods discussed are

improving teacher benefits and reducing restrictions on certifications teachers need.

Compensation

When it comes to compensation, it’s not as simple as just increasing teachers’ salaries, according to IARSS President Mark Klaisner.

Two years ago, Illinois

SAFETY: Alcohol top factor in boat accidents

- Have a working horn and a whistle.
- Have navigation lights that must function properly.
- Have fresh flares (required or not); and
- Current proof of registration or copy of registration application (if required).

IDNR Conservation Police strictly enforce boating safety laws and regulations, patrolling Illinois lakes, rivers, and other waterways throughout the year to encourage safe boating and prevent boating accidents, injuries, and fatalities.

Last year, CPOs investigated 81 boating accidents involving 36 injuries and 21 fatalities, issued 863 citations and more than 3,200 warnings to boaters and arrested more than 100 boaters on charges of operating under the influence (OUI).

According to the U.S. Coast Guard, operator inattention, improper lookout, operator inexperience, excessive speed and alcohol rank as the top five primary contributing factors in accidents. This summer, recreational boaters can focus on these factors by putting down the cell-phone, avoiding distracted boating, taking a free on-line boating safety course (www.boat-ed.com/illinois/), slowing down and driving defensively, especially in congested areas.

Alcohol use is the leading known contributing factor in fatal boating accidents, so save the celebration for after the boat is safely tied up for the night. Boat operators also need to understand they are responsible for the safety of their guests, including inebriated ones.

“Wearing life jackets and staying sober while operating a boat are two of the most important things boaters in Illinois must do – for their safety and the safety of others,” Tyler said. “Our message to boat operators is simple: You booze, you lose.”

Don’t let your planned fun on the water for the upcoming holiday weekend and the rest of summer be marred by an accident. Boat safely, boat smartly and wear a PFD.

China’s buying binge continues, until it stops

China is even hungrier, richer, and – to the delight of almost every American farmer – more impatient in today’s global food market than anyone thought possible even a decade ago.

In fact, according to the data crunchers at Agricultural Economic Insights (aei), China now imports “about 100 million acres worth of crop production, or roughly 25 percent of total crop consumption.”

Think about that; one in four bushels of any grain like soybeans, rice, corn, wheat, and sorghum used in China today is not grown in China. Part of the reason is that the nation’s farming acreage, explains aei, “has remained mostly stable since 1990.”

Another key reason is that the country’s population has been anything but stable. In 1990, China was a nation of 1.13 billion; today it’s home to 1.41 billion people, or 18 percent of the world’s population.

Put another way, since 1990, China has added as many people as now live in Indonesia, 280 million, the world’s fourth most populous nation.

This wild, continuous growth, however, is over. According to the May 10 New York Times, only 12 million children were born in China last year, the lowest birth total since famine-ravaged 1961. The slowing birth rate indicates China “faces a demographic crisis that could stunt growth in the world’s second-largest economy.”

This change, however, can’t change

China’s demographic challenge in the coming decade: it still has too many people to feed from too little land.

In the past, notes aei, that mattered less. From the 1970s through the 1990s, “China’s production and consumption of soybeans was nearly lock-step.”

Of course, balancing the books back then often came with the wave of an autocrat’s hand, not the market’s free hand.

Soon thereafter, though, a growing, more trade-dependent economy took root and “(a)round 2000 ... China’s consumption of soybeans surged from 20 million metric tons to 114 million in 2020/21.”

That’s an “average annualized 7.6 percent” growth rate. As a result, China quickly grew to become the big dog in the global bean business and, now, it buys “more than 60 percent of globally imported soybeans.”

The growth picture for Chinese corn imports is similar. From the 1970s onward, “Production and consumption have been essentially in lock-step ... In the last three years, however, domestic consumption has outpaced production ... [and] for the 2020/21 marketing year, China purchased 13 percent of the globally traded corn ...”

In fact, China’s grocery list is so long, say the aei analysts, that it now purchases “85 percent of global trade” in sorghum, “more than 60 percent of the global trade in dry milk powder,” and “nearly 30 percent of global beef trade.” (A decade ago, it “essentially imported zero beef.”)

And that’s not all.

China now composes “10 percent of the global chicken trade,” and, with the onset of its devastating African Swine Fever outbreak in 2019, China moved from buying “roughly 20 percent of global [pork] trade... to nearly 50 percent for 2020/21.”

With a cash buyer like that roaming global grocery markets, little wonder any food production glitch – like a run of dry weather in South America or a crop-flattening wind in Iowa – sends many commodity markets to once-in-a-decade highs.

But can China’s big – and, perhaps, overly big – market influence last? Big, probably; overly big, probably not.

“China likely holds strong growth in consumption and more reliance on imports,” aei analysts forecast. “But trends will also be impacted by consumer preferences and habits, policies, trade disruption, and global events...”

“In short,” aei concludes, “it will become harder to point to China and make a blanket statement about strong demand for agricultural commodities.”

That’s a prudent reading of today’s ag export markets. There are reasons – like China’s binge buying and today’s weather-tightened supplies—why commodity prices soar. Once those reasons flatten or disappear so, too, do the once-in-a-decade markets.

Or, as a now near-90 year old farmer once told me: “I’ve been through four or five ‘new market plateaus’ in my life and not one ever became an ‘old’ market plateau.”

passed a law raising teacher pay, with a mandated minimum of \$40,000 by the 2023 school year. “Unfortunately, small school districts were reporting to me, that didn’t solve a problem it caused a problem, because if I have to pay a minimum of

(\$40,000), I’m going to let a couple teachers go so I have money to meet the 40 threshold,” Klaisner said. “Now my class sizes go up, so education’s not better.”

Problems with teacher retirement are also an issue. The Tier II retirement system available to those hired after 2010 requires teachers

work until they are 67 to receive full benefits. It also provides less compensation in retirement.

IARSS is recommending school districts lobby the state to approve state-funded loan forgiveness programs for teachers who take jobs in underserved areas, as well as experiment with signing bonuses to attract new applicants. The IARSS also recommends amending the pension plan to allow teachers to retire at 55 years of age for reduced rates.

Certification

During the pandemic, ISBE, in conjunction with the Illinois Community College Board and Illinois Board of Higher Education, granted endorsement waivers as part of Gov. JB Pritzker’s emergency order to allow schools to fill positions with teachers certified for grade levels or subjects other than the ones they were hired to teach.

IARSS recommends continuing this practice as well as auditing whether current licensing restrictions are unnecessary.

Finally, Klaisner suggested the state should use an evidence-based formula to distribute federal COVID-19 stimulus dollars, including around \$5 billion for education.


