Jury awards \$7 million in Wyoming woman's death

 WYOMING – A jury of 12 people has awarded \$7,020,883 to the family of a Wyoming woman whose wrongful death occurred on July 11, 2017, two miles west of Toulon on Route 17. Corina Miller, 41, was headed westbound on Route 17 when at 4:42 a.m. she drove into, underneath and beyond the tanker-trailer of a milk semi-truck driven by 51-year-old Timothy E. Schwenk, of Brimfield.
 Schwenk had stopped in the eastbound lane of Route 17 in

front of Doug Murray's dairy farm and had backed the trailer across the westbound lane to enter the farm for a pick-up of milk.
 Court documentation stated that Schwenk had installed "extra bright halogen headlights on his

truck two weeks previously that were for off-road use only." He used them on the road and blinded Miller as she approached from the east.
 The civil case found that Schwenk and his employer, Cluver Milk Transportation, had admitted in April Court pleadings that they were negligent and caused Miller's death. The jury deliberated two and a half hours before delivering their verdict.
 Last year in a Stark County criminal case, Schwenk won several Circuit Court decisions that resulted in that case being dismissed. Schwenk's attorney

argued successfully that Schwenk's constitutional rights were violated and Circuit Judge Bruce P. Fehrenbacher agreed. Both urine and blood tests taken shortly after the fatal crash were suppressed, as well as, Schwenk's oral and written statements.
 It was argued in Stark's Circuit Court that Schwenk was never read his Miranda Rights or given a Warning to Motorists, that is normally issued in suspected DUI situations, before he was tested for intoxication. Additionally, Schwenk was detained

Galva council honors deceased alderman

 GALVA – A moment of silence was observed at the beginning of Monday night's city council meeting for former third ward alderman Wayne Buck for all he did for the city. Buck died in a Peoria hospital on Nov. 1 after a fall from his roof.
 During the business portion of the meeting, the council voted to temporarily amend the liquor ordinance to serve alcohol until 1:30 a.m. and to require all patrons to leave bars by 2 a.m. on Saturday and Sunday mornings. This means all patrons are out of the bar and not taking drinks outside. The ordinance applies to all Galva bars.
 The only people allowed

in a bar after 2 a.m. are the owner and bartender. The council said this will be enforced.
 Nick Ballard and Harry Hergert of Crescent City Tap were present and explained to the council that before 2018, Galva's liquor license stated 2 a.m. on Saturday and Sunday morning. They said that they felt there had been an error in changing the closing time to 1 a.m.
 Police Chief Kraig Townsend reported that two officers are trying to work on Monday and Thursday afternoons on ordinance violations.
 Townsend also told the council that he has hired part-time officer Alex Wagner of rural Knox County to start as a full-

 for approximately four hours and during that time he made the statements, which violated his 4th and 5th amendment rights. Judge Fehrenbacher

stated in his ruling, "He had no option but to submit to tests because he was never read his rights." Fehrenbacher also ruled that Schwenck was never advised that he had a choice to refuse the testing.

Corina Miller is survived by her husband, Michael, who has remarried, and by her daughter, Kaylene, who is now 25-years-old. Judge Stephen Kouri presided over the four-day trial that was tried by

 time officer. He started in Galva in July and Chief Townsend said he has done a "wonderful job." Townsend also reported that officer Calib Ingle is in K-9 training with

Galva's crime dog. During the meeting, Galva residents were reminded of the need to keep their vehicles, tractors, trailers and lawn mowers off the streets during snowstorms to assist the city

with snow plowing this winter. Third ward alderman Dougie Anderson asked about the progress of the demolition of the Hemphill house on Southeast 4th Street and the West house on Southeast 1st Street. He was told that the Hemphill house will be down in December but there are still legal issues with the West house.

Anderson said he will bring up several other homes that residents are asking him about. He said one vacant house has sat in disrepair for at least 5 years following the owner's death. The council also passed a TIF resolution. TIF 1 will expire Dec. 31. City Administrator David Dyer said the city is working on replacing it with TIF 4. He said it will be later in 2022 before the agreement is completed.

Dyer said there are obligations that did not get completed with TIF 1 monies. The list includes storm-water management, tearing down three dilapidated buildings, rehabbing Market Street buildings, infrastructure water and sewer off U.S. Route 34, downtown façade improvements, EPA mandated nickel corrections, rehab off street parking and more for a total of \$1,622,000. Finally, the council moved its Dec. 27 meeting to Dec. 20.

Kewanee man set for domestic battery trial

TOULON – A 23-year-old Kewanee man has a Dec. 6 trial date scheduled for a case that initially charged him with Class X felony home invasion with injury, Class 4 felony domestic battery, Class 4 felony criminal trespass and battery with physical contact.

Cassel O.R. Taylor was initially arrested last Spring in Stark County after he allegedly entered the Wyoming residence of Courtney Frisby on March 16 without permission and committed battery against her and Steven Earthley.

On May 5, Taylor had his bail bond of \$2,500 posted by Alicia Toliver, of

East Moline. Taylor was released from custody from Stark County Jail, but was required to wear an ankle monitor as part of his bond conditions.

At a preliminary hearing concerning the counts charged against Taylor, probable cause was found for Count 2 domestic battery and Count 4 battery. Count 1 home invasion and Count 3 criminal trespass to a residence were both dismissed.

Taylor was rearrested on Nov. 16 for allegedly violating the terms of his release from custody in that he was not to have contact with Frisby, which he allegedly did on Aug. 6 in Yates City at the home of Frisby's grandmother. Purportedly Taylor was

out of his restricted area as well because the ankle monitor showed him as being present in Yates City.

In Stark's Circuit Court last Friday, Stark County State's Attorney Caroline Borden Campion requested an increase in Taylor's bail bond, which subsequently was denied by Circuit Judge James A. Mack. Mack also denied Taylor's private counsel attorney Matthew Paulson's motion to have Taylor's ankle monitor removed should he post bond.

At the time of his initial arrest, Taylor was on probation in Henry County for charges he was convicted for in 2020 that included aggravated battery, battery and possession of a controlled substance.



Stark Co. boys show promise

Lady Rebels field young team as basketball tips off

Despite graduating three starters and five key letterwinners, the Stark County boys basketball team shows promise this year according to Coach Dustin Browning.

“Really want to establish ourselves early in the season as a fast, athletic team that will compete and battle for the entire game,” Browning said. “We have a lot of players with athleticism and length.”

That showed up in the Rebels’ opener, as Stark County (2-0) beat Wethersfield, 51-34, in its first game at the Wally Keller Invitational in Kewanee.

The Rebels got balanced scoring in the game, with five players tallying 8 or more points: 6-foot-4 senior forward Blake Orwig (11), 6-2 senior guard Ethan Unhold (10), 6-0 junior forward Daniel Kieser (9), 6-0 sophomore guard Luke Rewerts (9) and 6-2 junior forward Joey Harmon (8). Browning expects more of the same from Stark County.

“We have lots of depth, especially with guards, and really have 11 guys that have enough skill to be successful in a varsity

game,” Browning said. “We are very athletic and fast overall as a team. And we have good enthusiasm and leadership from the senior class looking to turn things around at SC.”

The turnaround continued Tuesday at Wethersfield, as the Rebels downed Annawan, 49-36. Leading 18-15 at halftime, Stark County took control with a 17-10 run in the third quarter led by Rewerts scoring 12 of his team-high 16 points. The Rebels also got 13 points from Kieser and 8 points from Unhold.

Others who have seen plenty of time so far are senior guard James Groter, the top returning scorer after averaging 5.6 points per game last year, 6-5 junior Xander Swank and 6-3 German foreign exchange student Arvid Steudte. Swank and Steudte will be asked to help inside along Orwig, the Rebels’ only true post player.

“We do not have a lot of post players with experience, but the guys we have are more athletic and able to score from more spots on the floor than previous years,” Browning said.
