## Fund transfer helps reduce P'ville tax rate

PRINCEVILLE – A pair of resolutions passed by the Princeville School Board should save district taxpayers money in the coming year.

The school board voted on Nov. 9 to transfer \$111,000 from the school facility occupation tax fund to help pay for debt service on general obligation bonds. The board also approved abating taxes that would have been levied to make those bond payments.

The combined effect should cause the district tax rate to drop from 5.52 to 5.45, depending on the actual increase in equalized assessed value of properties in the district, according to Superintendent Shannon Duling.

Duling also reported that enrollment is 683 students, which is down 16 students from last year. Duling said that will be a subject for future board meetings and noted that declining enrollment is not limited to Princeville, but is

## Illinois courting e-vehicle makers

Pritzker signs tax incentive package

SPRINGFIELD – Gov. JB Pritzker signed into law a tax incentives package Tuesday that state lawmakers hope will help Illinois become a manufacturing hub for the budding electric vehicle industry.

The Reimagining Electric Vehicles in Illinois, or REV Act, passed the General Assembly with near-unanimous bipartisan support during the recently concluded fall session. It provides tax credits for income tax withheld for EV manufacturers and costs to train new or retained employees.

The bill also applies to the manufacturers of EV parts, such as batteries. It's an effort to lure new manufacturers to Illinois while incentivizing existing manufacturers to invest in their Illinois facilities and workers.

"With this bill, we intend to attract more EV manufacturers, charging station manufacturers and automotive parts manufacturers, more than ever

## Time is here to get the bird feeders out

And here we are in November, with snow on the horizon. Before we know it, winter will be settling in around us. That's what makes this the time to get out your birdfeeders for coming hard times that our beloved songbirds will soon be facing.

Backyard birdwatching and feeder stations were once just a passing hobby or done only by the most avid birders. That has changed significantly over the past few years.

Birding and birdwatching in the

United States has become one of the fastest-growing outdoor recreational activities. Our backyard bird friends do much to enrich our lives during the dark and dreary months of winter. They inspire us, bring us bright bits of color and entertain us with their social behaviors and feeder squabbles.

So how do we bring the magic of birds to our yards?

It's straightforward. Birds find food by sight. "Build it, and they will come" absolutely applies to backyard bird feeding. Put the food out, and in

almost all cases, the birds will show up.

Backyard bird feeding and the enjoyment it brings can be as elaborate or simple as you wish and can afford. Some folks choose to take things to a whole new level with specialized species and seed-specific feeders and landscaping. Yet simply hanging one or two simple, inexpensive feeders can bring your family lots of bird-watching fun.

If you have a particular type of bird you want to attract, it's a good idea to

# BIRDS: Use safflower seeds to stymie squirrels

do a little research into what attracts that specific species. Some birds like to feed at elevated levels, like the chickadees, nuthatches and goldfinch. Juncos, doves and native sparrows feed primarily on the ground. Then we have woodpeckers and brown creepers who are happier feeding on and around a tree trunk or log.

Some birds aren't at all picky – cardinals and blue jays are just plain opportunistic and will feed wherever seed is provided. The two easiest to inex-

pensive feeders for attracting a large variety of birds are hopper feeders and seed tube bird feeders.

Other popular styles include ground and platform, bird feeders. Many consider the platform feeder the best at attracting a variety of species.

For variety and to bring in even more birds, consider adding a tube or sock feeder for thistle seed and some suet cakes.

It's not just the type of feeder that attracts specific birds but also the kind of food you put out. Birds that prefer elevated hopper

and tube bird feeders love sunflower seed, safflower seed and a few nuts mixed in. Be aware if you use a general wild bird mix in these feeders. The birds may well pick through things looking for the favorites and kicking everything else onto the ground. That's not all bad – the little ground-feeding birds will generally clean up that mess.

General wild bird mixes usually consist of millet with cracked corn, sunflower seeds and occasional bits and pieces of nuts or berries. I've always found these to work great on platform and ground feeders. Birds seem to find the bits and pieces they prefer without kicking out as much of the other food.

My platform feeder has a small roof over it to shield things from the weather. I also supplement inexpensive mixes with a handful or two of more expensive treat-type seeds such as black-oil sunflowers or nuts and dried fruit.

Read the label when buying seed. Many inexpensive mixes contain fillers such as milo, wheat, red millet that birds don't find attractive. Sometimes almost 40 percent of a bag may be these fillers.

No discussion about

backyard feeders is complete without mentioning squirrels, those crafty little bottomless pits that can empty a feeder in the blink of an eye. If squirrels are driving you crazy and gobbling up all your seed, you can add a baffle or invest in a squirrel-proof feeder.

Another trick I have learned is to use safflower seed in feeders that squirrels like the most. While most backyard birds enjoy safflower seed, squirrels will not eat it.

To encourage birds to visit your backyard regularly, make sure you have a water source. Even in winter, water is essential for their survival. A well-placed source of open water will attract more birds than birdseed alone. Shop around and consider adding a heater to your birdbath for the winter.

Lastly, consider planting bird-friendly habitat in your yard. Hedges, shrubs, small brushpiles left to overwinter offer shelter and protection.

Whether you go all out with feeding stations, habitat and other bird attractants or just hang a few feeders, you won't be disappointed. Nothing perks up a dreary winter day like a backyard bustling with birds!

Too much money and too much drift &

The federal government can spend more money in 10 minutes than Congress, its watchdog, can track in 10 years. Still, Congressional oversight--as late and limited as it often is--remains a vital element of government.

The House Select Subcommittee on the Coronavirus Crisis proved just how vital in two reports released in October: Tens of millions in pandemic spending were wasted on programs run by the U.S. Department of Agriculture, or USDA.

The first report, titled "Farmers to Families?" followed the money of the ill-conceived, poorly-run Farmers to Families Food Box program pushed in 2020 by the White House

and Secretary of Agriculture Sonny Perdue. Sold as a way to get fresh food to pandemic-hit American families, it also threw millions of taxpayer dollars at wildly unqualified vendors.

The second report, titled a "Memorandum," describes an even bigger scandal. Documents given to the subcommittee by the five principle meatpackers in the U.S. (JBS USA, Tyson Foods, Smithfield Foods, Cargill, and National Beef) show "at least 59,000 meatpacking workers were infected with the coronavirus during the first year of the pandemic -- almost triple the 22,700 infections ... previously estimated."

Also, "At least 269 meatpacking workers lost their lives to the coronavirus between March 1, 2020 and February 1, 2021 -- over three times higher than what was previously es-

timated" noted the independent Food & Environment Reporting Network.

Worse, few of the workers had a choice in the-life-and-death matter. In late April 2020, the Trump Administration used the Defense Production Act to order slaughterhouse workers back into packing plants where thousands got ill and hundreds died.

On Sept. 14, 2020, however, "emails obtained by ProPublica," an independent, non-profit newsroom, "show(ed) that ... just a week before the order was issued, the meat industry's trade group," the North American Meat Institute, "drafted an executive order that (carried) striking similarities to the one the president signed."

So Big AgBiz used its political muscle to bulldoze aside public health -- and public decency -- to keep its kill lines and profits flowing at top speeds.

One of the few things more profitable than meatpacking during the pandemic, according to the select subcommittee investigators, was contracting to distribute USDA's slapped-together Farmers to Families Food Box Program.

For example, according to the subcommittee, "The Trump Administration awarded contracts worth \$16.5 million to Yegg, Inc., a self-described 'Export Management, Trading, and Trade Finance company that had listed its most recent annual sales as \$250,000..."

With that kind of institutional blindness, little wonder USDA later "reimbursed Yegg for more than \$2.85 million worth of milk and dairy boxes purportedly delivered to ... a nonprofit operated by the wife of the company's CEO..."

USDA also oversaw a food box

contract "worth \$39 million to CR8AD8, LLC, a company focused on wedding planning and event planning without significant food distribution experience..."

Experience? Come on, noted one of its owners, how hard could it be "compared to ... his usual work of 'stuffing tchotchkes into bags.'"

Actually, it paid far better than tchotchke-stuffing: "CRE8AD8 was ultimately paid \$31.5 million of this contract," explained the subcommittee report.

The slickest icing on the USDA cake, however, was the award of a \$40 million contract to something called Ben Holtz Consulting, Inc. When the USDA application asked the company to list references, the applicant -- presumably Mr. Ben Holtz himself -- replied "I don't have any," noted the investigators.

The company's honesty didn't pay; USDA canceled the contract "before any payments were made," maybe, investigators suggest, because its proposal "pitched an unusually broad range for delivery capacity: between 5,000 and 200,000 16-18 pound boxes of produce per week."

In releasing the "Farmers to Families" report Oct. 13, Subcommittee Chairman James Clyburn, D-SC, noted the program "was marred by a structure that prioritized industry over families ... cutting corners over competence, and ... politics over the public good."

That's another truism in Washington: Policy drift usually leads to political grift.

Water trees, shrubs now heading into winter

URBANA – After this year’s summer drought in Illinois, it is more important than ever to monitor soil moisture conditions and water trees and shrubs going into winter.

Drought conditions in the late fall, along with dry air and low soil moisture, can lead to plant damage if no supplemental water is provided.

Plants under water stress are more susceptible to insects and diseases. They can also experience injuries to roots or foliage.

Before watering, check the soil moisture. Monitor the moisture levels about once a week. Dig a small hole under the tree’s drip line, 4 to 6 inches is enough. Feel for moisture. If the soil is dry, the tree should be watered.

In particular, newly fall-planted trees, shrubs, and perennials should be monitored and watered late into

the season, since they do not have as much time to develop extensive root systems as anything planted in the spring.

Pay attention to evergreens and shallow-rooted trees such as birches and maples. Some shallow-rooted trees can be identified by roots breaking the surface of the soil. Evergreens do not go dormant in the winter and are still actively respiring and lose water through their needles.

Dormant trees respire at lower rates. Since soil insulates and cools down later in the year than the air temperature, roots stay warmer longer and respire at higher rates than the above-ground parts, the trunk, and branches, of deciduous trees after their leaves drop.

Only water when the temperature is above 40°F. In some places, that could be as late as the end of December. Stop supplemental watering after the ground freezes because at

this point the trees cannot absorb water through the frozen soil.

To water, use a soaker hose to provide a slow stream of water. Soil should be moist, but not waterlogged. This method results in less runoff and the water is more likely to be absorbed by the root zone.

Water at the tree’s drip line and not right against the base. To conserve water, start with newly planted trees and shrubs weekly and then large and established trees once a month.

Avoid fertilizer, which stimulates late-season growth, and instead, consider applying mulch. Mulch can help conserve moisture. Apply mulch 2 to 4 inches away from the base of the tree all the way to the drip line in a doughnut shape around the trunk.

As always, planting hardy species or cultivars with deep roots is best since they are more likely to be able to survive temperature fluctuations and prolonged periods of cold.

a statewide issue.

School board members are scheduled to meet with school staff on Nov. 23 to discuss how things are going. Meetings will be in smaller groups and board members will report their findings at the December meeting.

One topic likely to arise is the salary increase for staff approved at the last board meeting. Projected raises were 2.62 percent for Fiscal Year 2022, followed by percent raises of 2.61, 2.73, 2.67 and 2.62 in the following years of the five-year pact.

Technology coordinator Kelly Jenkins is recommending that the district

make “significant” upgrades to the camera system in the junior high school and elementary school. Cameras are also being considered for the junior-senior high school.

The board also reviewed three quotes for replacing the stage curtains in the high school. Teacher Chris Delbridge plans to contact one of the companies to see if they can reduce their quote. The board has opted to delay any decision until they find out if part of a maintenance grant can be used to help defray the cost of curtains.

The board also reviewed the audit conducted by Go-renz and Associates, Ltd.

In other business, the

board:

- Heard that 3rd-grade teacher Elizabeth Klein received \$689 in grant money from the Illinois Retired Teachers Foundation that she plans to use to purchase poetry materials for her classroom.

- Heard Anna Schupbach has resigned as 8th grade volleyball coach and that high school social science teacher Devin Nordstrom has requested an FMLA leave for April and May.

- Approved Michael El-sasser as freshman boys basketball coach.

- Approved Brittany Smith as an aide.

- Approved adjusting compensation for non-certified staff.

# Law makes election changes

SPRINGFIELD — A new law in Illinois will require all candidates in judicial races to disclose sources of their contributions.

Senate Bill 536 also raises the threshold for itemizing contributions to \$1,000.

A number of other changes in the bill relate to filing deadlines to coincide with the change in the 2022 election cycle when primary elections will be held in June instead of March.

The law also allows voters the option of identifying as male, female or non-binary on their voter registration applications, so their gender identity can match what appears on their passport or driver’s license.

It also allows people to apply for permanent vote-by-mail ballots year round. And it requires all polling places to have at least one polling booth that is wheelchair accessible.

# Shop and plant now for fall color

The trees and shrubs in landscapes and roadsides have finally dropped their veils of chlorophyll to reveal their true colors of yellow, orange and red. It’s intriguing to me how individual trees suddenly stand out from the crowd when the landscape changes from shades of green to the brilliant colors of autumn.

Fall colors are muted at my place where I have mostly oaks and hickories. Green goes to tans and browns with just hints of yellow and dark red. Instead of brilliant color I have to settle for huge crops of hickory nuts and acorns, both especially plentiful this year for some reason.

I do have one huge old maple that turns an unremarkable yellow when fall arrives. It looks better than it should because it’s such a contrast to the oaks and hickories. To my dismay however, it is a Norway maple, *Acer plantanoides*, which many of the arboreal cognoscenti consider to be a weed tree. The tree is a rugged species able to grow in just about any kind of soil. It’s a prolific seeder, so much so that many states have declared it invasive. Its seeds can sprout and grow even in deep shade.

I can attest to the Norway maple’s prolificacy. I spend a good amount of time each summer cutting down and pulling up seedlings. I would dispatch the mother tree if it weren’t so costly to remove it.

There are a number of more desirable maple species that behave themselves and produce fabulous fall color. If you’re looking to add fall color to your place, now is the time to shop, while rows of trees are showing their colors at local nurseries.

In the maple department, the cultivar ‘Autumn Blaze’ is a good choice for rich orange-red fall color. It’s actually a hybrid, a cross of red and silver maples, and one of the most popular lawn trees for fall color. It will be 40-50 feet tall in 20 years, the fast growth from the silver maple side, no doubt. Despite its fast growth, it’s a stalwart

tree able to tolerate wind and snow without littering the yard with sticks and branches. The maples don’t hold the exclusive patent on red fall color, however. Another tree, *Nyssa sylvatica*, flaunts fabulous fall foliage. Its common names include black gum, black tupelo, and sour gum. This tree typically is pyramidal with a strong central leader and graceful, pendulous side branches. The female version produces berries of deep blue which contrast nicely with the red fall foliage.

Of course it’s possible to add shades of red to your landscape’s fall color palette with plants other than trees. Up until a few years ago, burning bush, *Euonymus alata*, shrubs were popular for their brilliant fall red color. But the bushes produce seed which finds its way into woodlands and natural areas to compete with the natives. Many states, particularly in the northeast, have outlawed the sale of it. Our own extension folks here in Illinois advise us to look to alternatives.

An excellent choice for brilliant autumn color is the serviceberry variety named ‘Autumn Brilliance’. Grown either as a large woody shrub or a small ornamental tree, ‘Autumn Brilliance’ gives you three bangs for the buck.

In the spring it gives you a quick show of white flowers which come forth before the leaves have fully emerged. Later it yields a crop of tasty blueberry-like fruits which make a tasty jam if you can get them before the robins move in. Then in fall the leaves turn a bright red.


You’re no doubt familiar with the bright red foliage of the staghorn sumacs decorating the roadsides. Well, there’s a special selection called ‘Tiger Eye’ which is bright yellow in summertime, not the typical green of the species. In the fall its yellow foliage becomes overlaid with shades of red and orange.

They say the best time to plant a tree is yesterday. Right now is not only a good time to select a tree or shrub, but also the best time to plant them.

# REV ACT: Illinois the Silicon Valley of

before, and it will help Illinois become one of the leading EV hubs in the entire nation,” Pritzker said during a signing ceremony at the Rock Valley College Advanced Technology Center in Belvidere.

The tax credits created by the new law range from 75 percent to 100 percent of income tax withheld for creating new jobs or 25 percent to 50 percent for retained employees, depending on factors such as company location and number of employees hired. A 10 percent credit for training expenses would also be available.

Tax credits for construction wages and building materials are also included in the bill.

The added incentives complement Illinois’ other advantages when it comes to manufacturing, Pritzker said, but they are needed to make Illinois competitive with other states from a financial perspective.

Bill sponsor state Sen. Steve Stadelman, D-Rockford, said that’s particularly true in Belvidere near his district, where the Stellantis manufacturing company, which produces Jeeps at the location, is reportedly considering retooling its facility to manufacture electric vehicles.

The state has also been looking to lure a joint battery manufacturing venture announced by Stellantis and tech giant Samsung.

“I don’t think Stellantis would have conversations with the governor and the governor’s staff and lawmakers if they weren’t serious about considering the retooling of this plant here locally,” Stadelman said. “They would not be in conversations if they would not be considering Belvedere to invest in this area. So that’s why I think this package is so important.”

The other advantages to choosing Illinois, according to Pritzker, are a centralized location in the U.S., strong infrastructure,

the second-largest crop of computer science engineer graduates in the nation and a pair of major national laboratories.

Those assets helped lure the electric vehicle manufacturer Rivian Automotive to a closed Mitsubishi plant in the Bloomington-Normal area in 2017. Its vice president of public policy, Jim Chen, said the bill will be a major support for the company that already employs more than 3,000 Illinoisans in its 3.5 million square feet of manufacturing space.

“Today’s bill signing represents the next step in promoting Illinois as the Silicon Valley of EVs, as we work together to attract new investment from suppliers and other supporting players in this industry,” he said.

For Pritzker, the bill represents an opportunity to fulfill carbon reduction goals while bringing much needed economic opportunity to the state.

“The Reimagining Electric Vehicles Act is about acknowledging that there doesn’t need to be a trade-off between a cleaner environment and more jobs,” Pritzker said. “We can do

both. And today we take a giant leap forward in that quest.”

Republicans were broadly supportive of the tax incentives package. But during floor debate, they peppered the bill’s Democratic sponsors with questions as to why the governor froze a similar tax incentives package known as the Blue Collar Jobs Act as part of his budget proposal for the current year, grouping it with other policies he referred to as “corporate tax loopholes.”

Rep. Dan Brady, a Bloomington Republican who represents the area where Rivian is located, emphasized the importance of the bill’s focus on the manufacturing of EV parts, not just complete vehicles.

“This incentive plan targets companies who will supply our existing manufacturers,” he said. “This proposal will help make Illinois more competitive to attract companies who will not only be here to supply, but provide jobs – sorely needed jobs.”

The measure also has support from the state’s manufacturing industry. Mark Denzler, CEO and

president of the Illinois Manufacturers’ Association, a trade group representing the industry, said the bill will allow Illinois to “keep and grow good-paying manufacturing jobs in an exciting and flourishing industry.”

“This law builds on our state’s proud history of auto manufacturing and positions Illinois to become a national leader in electric vehicle and battery production,” he said in a statement.

Pritzker’s administration has been working to sell the idea of Illinois as an EV hub on the global stage.

He and top staff traveled to London then Glasgow, Scotland, earlier this month to meet with business leaders and attend the United Nations Climate Change Conference.

Dura said Lune should score her 1,000th career point early this season, likely by the second or third game.

Three other senior starters this year will be point guard Ellyn Peterson (8.5 ppg, team leader in assists), 5-foot-10 post player Sophie Bedell (6 ppg) and 5-8 Jaclyn Fabry, who will start for the first time as a guard/forward.

“[Bedell] plays really well with Lune in the post,” Dura said.

Joining those four seniors in the starting lineup will be 5-6 junior Elly Doe, a three-year varsity player who was first off the bench last season.

“We’ve got a solid 10,” Dura said.

Other contributors figure to be 5-8 senior forward Maddie Hessing, 5-6 junior Taylor Wiewel, sophomore guards Kylee Vaughn (who was on the varsity last year) and Olivia Kappes and 6-foot freshman post player Ava Heinz.

“I’ve got tall, I’ve got speed, I’ve got good shooters, I’ve got guards that can take care of the ball and senior leadership,” Dura said. “I’m really excited about this year.”

Brimfield looked strong in Monday’s season opener, topping visiting Princeville, 64-32, and holding the Lady Princes scoreless until 5:05 of the second quarter.

Nine Brimfield players scored, led by Peterson (16 points), Hessing (12) and Lune (8).

Paisley Schock (2 points). Also seeing time in the game were 5-10 sophomore Brianna Brodie and 5-9 junior Leah Wieland.

Princeville had won regionals in three of four years coming into last spring’s “season with no postseason.”

**Princeville**

Leading the way for the Princes and veteran coach John Gross will be senior guard/forward Caitlyn Thole, an IBCA first-team all-stater last year after averaging 16.5 points, 11.3 rebounds, 5.2 assists and 3.0 steals for the 10-2 Princes. The 5-7 Thole has committed to St. Ambrose. She put up 13 points in Monday’s loss at Brimfield.

Junior guard Destinee Harwood should see plenty of time as Princeville seeks to win a fourth straight Lincoln Trail Conference title. She was an LTC second-team selection last year and had 4 points vs. Brimfield.

Lost to graduation is LTC first-team post player Ashleigh Brawley.

Jesenia Horton-Meza is the only other senior on a young roster and she tallied 9 points Monday. Other contributors in the season opener were 5-7 sophomore Kinley McGinn (4 points) and freshman

**Farmington**

Three starters are back for a Farmington team that graduated its top scorer (Emma Vallas) and top rebounder (Sydney Barton) from an 8-5 finisher.

The trio of three-year starters back this year are point guard Emma Evans, forward Reece Putrich (10 ppg) and guard Delaney Foster (10 ppg), who was the Farmers’ leading scorer as a sophomore.

Vallas emerged to take the scoring lead last year after working extra hard in the offseason, Coach Brad Whitcomb said.

“A lot of our kids took note of that and they’ve put in a lot of work too, so I’m really excited,” Whitcomb said.

Heading that list of offseason workers is senior Riley Jansen, who was first off the bench last year and averaged 7.5 ppg.

“I’m trying to get her a bigger role. I think she is arguably the best player on our team,” Whitcomb said. “She’s 5-foot-10, she can shoot, she can handle the ball and she can run. She’s a complete player.”

Along with Jansen, Whitcomb is

also hoping for help inside from junior post player Anna Webel.

“We’ve been very guard-dominant the last few years, but [Jansen and Webel] are going to give us a presence inside and that’s going to give us some balance,” Whitcomb said.

Finally, he calls sophomore Emily Vallianatos a “sleeper” who could help at guard.

Farmington opened play in the Fulton County Tournament on Tuesday at Lewistown vs. North Fulton. The Lady Farmers then play South Fulton today (Thursday) and battle top-seed Lewistown on Saturday.

**Elmwood**

After a slow 1-5 start last year, the Trojans finished 5-1 to end the COVID-shortened season. Coach Gregg Meyers is hoping to build on that despite graduating three top scorers: Molly Malone, Olivia Caldwell and Hannah Burkiett.

“It’s a funny thing, we don’t have a lot of points coming back, but having the sophomores and freshmen a year older now after they’ve already done a good job is encouraging,” Meyers said.

The top returning scorers are junior post player Olivia Meyers and sophomore guard Mae Herman, who is one of two home-schooled students on the roster (junior Bre Turner is the other).

Turner and junior guard Ainsley Faulkner figure to see plenty of time this season, as does senior post player Brooke Dawson. Sophomores Lauren Rushing and Emma May will also contribute, Meyers said.

Added support comes from junior Melody Glenn, who is out after sitting last year, and senior Lexi Lehman, who transferred back to Elmwood and did not play last year.

“Adding Melody back in is a piece that will help and Lexi will really help us out, too,” Meyers said. “This is probably one of the more balanced teams we’ve had with people being able to score at every position.”

Even so, early on, Elmwood hopes to lean on defense, a strength in last year’s 5-1 finish.

“They were pretty good [on defense] last year and really started to get it,” Meyers said. “Hopefully that can carry over. It might take a week or two, but I feel like we’re much more prepared this year.”

Elmwood opened at Peoria Christian on Tuesday.

## Tri Valley outmuscles Farmers

Farmington falls again in quarterfinals, 34-12

**DOWNS** – As the quarterfinal game started slipping away Saturday afternoon, Farmington Coach Toby Vallas began shifting lineups and changing plays in an attempt to rally against Downs Tri Valley.

Standing nearby, unable to play for medical reasons, was senior Kevin Shultz, arguably the most physical of this year’s Farmers.

“Kevin put his hand on my shoulder and he said, ‘Coach, they are more physical. This was decided in the weight room,’” Vallas recalled. “He said, ‘I know you are trying, but that’s what it is.’”

Indeed, in a season when Farmington (11-1) ran at will against most opponents, the Farmers finally hit a brick wall in a 34-12 loss to Tri Valley (12-0).

Held to minus-5 rushing yards on 19 carries, Farmington never got its potent offense going against a big, physical Tri Valley defense. And de-

fensively, the Farmers yielded 273 rushing yards and 6.3 yards per carry to Tri Valley and its talented quarterback, Andrew Petrilli.

“In the box, they were much stronger,” Vallas said. “Their D line and linebackers, they dominated the line of scrimmage ... on both sides of the ball.”

Meanwhile, Tri Valley pressured Farmington quarterback Gage Renken all game, sacking him seven times and coming up with three interceptions – including one on the

Farmers’ second play from scrimmage.

Even so, Farmington was still in this game in the first half. After falling behind 13-0, Ethan Evans took the ensuing kickoff and sprinted 80 yards for a score.

“After a couple drives, I was pretty tired, because I was playing both ways,” Evans said. “I don’t how long [the kick return] was, but it felt super long because I was so tired.”

“I thought we got some life then,”
