Local police chiefs still find satisfaction in law enforcement

While the last two years have seen plenty of changes, job satisfaction of three area police chiefs hasn’t wavered even with the pandemic, increased training requirements and changes in public perception of law enforcement.

Police chiefs in Elmwood, Farmington and Yates City say they are glad to be on the job and helping people, and they stress that the support of the community is huge.

Yate City Chief Randy Benson

is pleased with Yates City’s “positive public image” and having “the support of the citizens and Yates City Village Board.”

Part of Farmington Chief Chris Darsham’s satisfaction comes from “a great relationship with the Mayor, City Administrator, City Council and the citizens of Farmington. Most of them know how difficult this job is in the current climate and they are supportive of us.”

Benson goes further, giving accolades to his fellow chiefs and other emergency response de-

partments, saying, “local police agencies, Yates City, Elmwood and Farmington work closely together in spite of all being in different counties. This cooperation assists tremendously in protecting and serving our communities. These local jurisdictions are also fortunate to have outstanding volunteer fire departments in each community providing quality fire and EMS service.”

Another constant has been crime, which has decreased slightly, but hasn’t changed sig-

nificantly for Farmington, Elmwood and Yates City.

Darsham said there has been a slight increase in thefts and domestic violence in Farmington in 2021 compared to previous years.

Theft from motor vehicles picked up slightly from 2020 to 2021 in Elmwood, but compared to a typical year, the total number of crimes is down, according to Elmwood Police Chief Aaron Bean. That typical number is around 400 cases compared to a total of 284 for 2021, even

though domestic situations and attempted fraud has picked up since the start of the pandemic.

The only increase of criminal activity in Yates City is for attempted scams through the mail and telephone, Benson said.

A considerable part of being in law enforcement is training. Bean said that, as a chief, he is required to spend at least 20 hours per year in training. In addition to learning about new laws, Bean trains in “community relations, arrest laws, the Illinois

STINK BUG INVASION

Smelly pests

Warmer weather bringing stink bugs out of hidey holes

Recent relatively warm, sunny days between winter storms woke a sleeping enemy at my house. There was more than a modicum of spitting, shouting and squalling in my kitchen just the other morning. I realized most unpleasantly that the warm sunshine had unleashed one of the yuckiest of our invasive species, the Brown Marmorated Stink Bug.

The first one I encountered had been lurking in the bottom of my coffee cup. Set under the spout of my timed brew pot, I pulled it out, took that first sip ... only to immediately be hit with not only the horrendous smell these heathen creatures emit, but a rather unholy taste, as well. Shrieking and cursing, I quickly threw that entire cup into the sink.

In my haste, all I managed to do was create enough commotion for the stink bug to stir it up, so it made even more stink in the sink as it went swirling down the drain.

As the morning progressed, I found a few more crawling along the window sill, hanging out in a houseplant and creeping around the dogfood and bird-seed containers.

I am not ready to start

battling these beasts just yet. Brown marmorated stink bugs (BMSBs) are a relatively new invasive invader in Illinois homes.

Then again, these devils are no prize even if they stay outside. They can be damaging garden pests.

A call for civility

House leaders seek mask compliance

SPRINGFIELD – In the first half-hour of the House session Tuesday at the Capitol, leaders of each party made calls for civility, two lawmakers recounted their recollections of a House floor altercation and three Republicans were removed from the floor for not wearing masks.

Both House Speaker Emanuel “Chris” Welch, D-Hillside, and Minority Leader Jim Durkin, R-Western Springs, had a message for members of the chamber: The public is watching and it’s time to get to work.

“Let’s lower the divisive rhetoric,” Welch said in a House speech. “That’s what we’re talking about. Don’t lose your passion. Come ready to debate the issues.

But let’s lower the divisive rhetoric.”

Tensions have been high on the House floor in recent days as Democrats have repeatedly called for the removal of GOP members who refuse to wear face coverings.

The chamber approved masking and temperature requirements when they first returned to session amid the COVID-19 pandemic. They say a member should be masked unless eating, drinking or talking into a microphone.

But from Tuesday to Thursday last week, several GOP members refused to wear face coverings, accusing Democrats of hypocrisy for enforcing mask requirements on the House floor, but not at fundraising events, and faulting the majority party for not taking

STINK BUGS: Asian import first found in 1998

The insects are problematic and unwelcome because, as the name suggests, what they do best is create a stink. Anything the BMSB perceives as a threat (such as hot coffee dripping on them or chasing them with a spray of water down the drain) causes them to pump out stench. The stench will linger, too.

The other issue is they are very happy to move into your home. They are quiet, sneaky bugs, drawn to light and warmth, so there exists the possibility you can find them anywhere inside. They could

be basking on a windowsill, hanging out on your dishes, lounging on your clothing, or even resting comfortably in your hair.

If you don't smell them first, the BMSB body has a shield-shaped characteristic to all stink bugs, and is as wide as it is long. The three most identifying characteristics are black and white banding on the antennae, smooth-looking shoulders and alternating dark/light banding on the edge of the wings.

The brown marmorated stink bug was first found in 1998 in Pennsylvania. It is thought to have arrived as a stowaway from Asia. BMSBs have a large and ever-growing range and happily feed on many plants.

The bugs have piercing mouth parts and damage many crops, including apples, pears, soybeans and even landscape ornamentals we tend to so lovingly. The bugs can also be destructive to tomatoes and green peppers.

The emerging pattern finds many of us battling them outside in late summer and early fall. Then we discover, to our horror, that as the weather cools off, they invade our homes and vehicles. Cold weather tends to send them into hiding, but given a few warm days, the foul creatures emerge.

They tend to gather in large bunches under siding, in window frames, in dark corners of your home and in other man-made structures. In the wild, USDA studies show they prefer large dead trees that are still standing. After they overwinter and spring is in full swing, they lay 20-30 eggs, usually in April. Multiple hatches can happen in a single year, depending on temperatures.

Here are ways to control these smelly invaders.

Use a vacuum to suck up adults and then empty into soapy water. Trust me, you will want to hold your nose when you do this, because all that bouncing around really gets the stink production going. If it's just a single bug here or there in the house or vehicle, I grab an empty jar, scoop them up, put the lid on and toss the whole works.

An ounce of prevention is worth a pound of stink bugs, so in early fall, look for places where they can gain entry to your home and caulk any cracks and crevices you find. Pay special attention to windows and doors, and

make sure windows frames are in good repair and tight-fitting. Door sweeps attached to the bottom of your entrance doors are also helpful.

If there appears to be an extensive invasion outside, consider a perimeter spray of pyrethroids.

One do-it-yourself trap has worked relatively well for me when the warming days bring these stinkers out of the woodwork. I fill a foil pan with water and dish soap, then place a light over the pan to attract the bugs in a dark room. One study showed this homemade trap eliminated 14 times more stink bugs than store-bought traps.

While I fervently hope you don't face these stinky invaders in your home, we can take some comfort in knowing that they are relatively harmless to people. (Other than the incredible yuck factor).

According to Orkin, "Stink bugs do not prefer to bite people. In fact, most species of stink bugs only feed on plants. They suck the juice from leaves, stems, and roots of plants."

Here's hoping this information will help in the warmer days to come.

Big Ethanol sees electric cars as market makers

One of modern agriculture’s most beloved offspring, ethanol, received a sharp reprimand Feb. 13 from Iowa’s largest newspaper, The Des Moines Register.

In an editorial titled “Ethanol has been a boon for Iowa’s economy. But it’s time to pivot and figure out what’s next,” The Register chided Iowa Republicans and Democrats alike for supporting ethanol-pushing programs when everyone in the Hawkeye State “would be better served to figure out what comes after ethanol.”

It wasn’t ethanol’s only recent slap. Two days before, Christopher S. Jones, a research engineer at the University of Iowa, lit up Twitter with a post “Iowa is Addicted to Cornography,” an essay that, in part, compared energy from an acre of Iowa corn grown for ethanol to that of an acre of solar panels making electricity. “There are about 75,000 BTU in a gallon of ethanol,” Jones explained, and “it takes about 35,000 BTU to grow the corn and produce the ethanol...” That means, on average, an acre of Iowa corn will “produce about 500 gallons of ethanol” with a “net energy gain [of] about 20 million BTU per acre.”

That sounds big, noted Jones, until you add in corn/ethanol’s unaccounted costs: “soil erosion, nutrient pollution, degraded streams, lakes

and drinking water, habitat loss” and farm program subsidies “that keep the herniated system from blowing out.”

By contrast, one acre of solar panels in Iowa “produce 34 times the amount of usable energy as an acre of [corn-made] ethanol... Not twice as much... not 10 times as much. Thirty-four times as much.”

Case closed, right? Not so fast, says the Union of Concerned Scientists (UCS), a non-profit science advocacy agency in Cambridge, Mass., known more for its strong endorsement of wind and solar rather than any love of ethanol.

However, in an interview for an episode of the podcast “Corn Save America,” Jeremy Martin, the director of fuels policy at UCS, suggests ethanol and other “biofuels” may claim a larger share of the fast-shrinking “liquid fuels pie” as electric cars rise to dominate the roads.

For example, farm and commodity groups are lobbying for an updated Renewable Fuels Standard that mandates a 15 percent ethanol-to-gasoline blend, one and a half times more than today’s 10 percent blend. If the lobbying succeeds, Martin figures the 15 percent requirement would hit just as gasoline sales start to plunge, say 2035, due to fast adoption of EVs, or electric vehicles.

“If those two things happen in parallel,” he tells podcast host Sarah Mock, “they perfectly cancel each other out.” In short, “We can go to electricity as fast as possible ... and still maintain the corn/ethanol program.”

And, he adds, “If we sell no more gasoline-powered cars by 2035, we could see total liquid fuel sales used for transportation fall by 85 percent.” If most of that remaining market is claimed by biofuels, “Then there’s a huge opportunity to expand corn and other feedstock biofuels.”

Thus Big Ag’s big rush to lock in higher, at-the-pump ethanol blends at state and federal levels: they see EVs as a market maker for biofuels, not a market taker. As such, the biggest fight over future biofuel policy won’t be between corn farmers and solar advocates; it’ll be between Big Ag and Big Oil, two of the oldest titans of Capitol Hill lobbying.

That also means the steep environmental costs of biofuel production will likely get buried in the higher-blend fight and the current CO2 pipeline craze.

That would be a mistake. Ever-emerging evidence – like the just-published “Environmental Outcomes of the US Renewable Fuel Standards,” (link at farmandfoodfile.com) – shows ethanol’s cost, when fully tabulated, is substantially more than previously calculated.

Which brings us back to The Register’s and Jones’ original worries: Ethanol’s environmental price is already steep. So steep, in fact, that everyone would be “better served to figure out what comes after ethanol.”

Careful Rational Thinking is not racism

To the Editor:

We live in interesting times, when a cartoon that reflects reality prompts an angry cry of “racism” from one of the readers of this paper. Allow me to point out a few facts.

Critical race theory is just that, a theory, an academic concept that has been explored for more than 40 years by academics and some policy makers. It suggests that race is a social construct, and that racism is embedded in legal systems and policies. It is not being “taught” at any level of education, even university level, although some students there may choose to take courses related to it. This theory is approached at a level of intellectual development well above the grade school and high school levels, and yet there is a vitriolic response to such a “curriculum” being “forced” on our children.

There have, in fact, been changes to the curriculum of our grade schools and high schools, but these changes are not a product of CRT. These changes in the curriculum have expanded the range of topics that our

students learn about to grow into educated, engaged citizens, reflecting a broader and deeper understanding of our society, culture, and history. These changes demonstrate that black, Asian, Latino, women’s, disabled and others’ history and contributions are legitimate parts of the story of the U.S. In addition to our white, European, male historical figures and events, students gain a more complete and rich picture of our past.

None of this constantly evolving curriculum is a detriment to our students. Students will naturally gravitate to the figures and events of history that appeal to them, and opening the fuller spectrum of those figures and events is a service to their educational platform. It is not going to turn them into socialists, or guilt-ridden adults, as those who equate this broader education with CRT have argued.

For example, teaching that the historical policy of bringing Africans to this country as slaves, forced labor who could be beaten and killed at the whim of their owners, does not make

me feel guilty for something I did not do. However, a good teacher, and we have many really good teachers, can help me understand that policies have consequences, and that to improve the consequences, I need to understand the facts of history that led to them.

Students of all ages, including us adults, benefit from learning more about our own history, society and culture. That includes the good, for which we should be proud; the bad, which we should not want to repeat; and the ugly, from which we should make every effort to understand and learn. Our society has recognized we are more valuable than the sum of our parts, and giving value to all of those parts by learning about them is what builds that value. This principle is not critical race theory; it is Careful Rational Thinking. Let’s leave the vitriol out of it.

ing votes on the governor’s authority to issue statewide mask mandates.

That led to a Thursday motion by Rep. Lakesia Collins, D-Chicago, to remove nine Republicans from the floor for failing to comply with House rules.

But it was Collins’ inclusion of state Rep. Steve Reick, R-Woodstock, in her initial motion that led to an altercation.

Reick, who was not disobeying the floor mask mandate, confronted Collins on the floor shortly after the motion. The Dem-

ocrat reported that she felt threatened when Reick pointed a finger in her face.

Other lawmakers came between the pair, and about 10 minutes later, Reick said he attempted to apologize, but was told that the time was not right.

The three members removed Tuesday for disobeying mask mandates were Reps. Dan Caulkins, R-Decatur, Blaine Wilhour, R-Beecher City, and Adam Niemerg, R- Dieterich. They were allowed to participate remotely.

Wilhour, who was also one of the nine removed

last week, is suing Welch for the mask mandates, asking a judge to prevent the speaker from removing him from the House floor.

He is represented by Thomas DeVore, a frequent litigant against

Gov. JB Pritzker’s mandate authority, who announced this week he is running for attorney general.

Welch pointed out the House rules were adopted by majority vote to prevent COVID-19 outbreaks.

human rights act, homeland security, counter-terrorism awareness, use-of-force laws, civil rights and civil liabilities, understanding the levels of supervisory engagement,” and more.

Officers also need training in new laws plus additional mandated training. It’s no surprise that COVID produced a greater focus on sanitizing squad cars and work areas. That was the case with the Yates City staff, according to Benson. And sanitation training is not the only new addition.

“The state of Illinois continues to increase each year the number of unfunded training mandates,” Benson said. “With the advent of COVID, in-person training has been significantly impacted.”

Online training, he says, has allowed him and his six part-time officers to be fully compliant.

Darsham expressed dissatisfaction with Gov. JB Pritzker and the state legislature in failing to make new training available to meet changes required in new laws.

“We are currently waiting for the required training to be available for the officers, but the state was in such a hurry to change law enforcement and the criminal justice system they forgot or didn’t care to setup the proper training for officers to follow the new laws,” he said. “The blame for this rests solely with the Governor and the lawmakers who voted for the bill.”

In addition to Darsham, Farmington employs six full-time and four part-time officers.

There have been improvements made over the last two years, giving rise to optimism.

Bean says protection for Elmwood’s residents has been increased with added hours and more coverage on the streets.

For Yates City, there have been upgrades in equipment, including portable radios and emergency equipment. Benson said there have been no changes in his staff of “educated, experienced and dedicated” officers. He said Yates City’s officers have more than 150 years of combined experience.

Though Darsham noted struggles with completing required training, he feels his officers are well trained for police work, something in which he places high value.

Still, there are challenges to be faced, one being attracting new officers.

“A lot of men and women are not interested in doing this job anymore,” lamented Bean.

Darsham agrees. “With all the law changes and the national climate towards police in general it is hard to get young adults to enter this profession when they see what is happening to officers all over the country,” he said. “It seems like every day an officer or more than one officer is getting shot or killed somewhere in this country, which has a huge impact on how many people want to enter this profession.”

Darsham said it is also difficult for smaller departments such as Farmington’s to keep pay competitive with larger departments.

Benson sees challenges ahead with the “number of additional unfunded mandates being instituted as well as the Bod Cam mandate required by Jan. 1, 2025.”



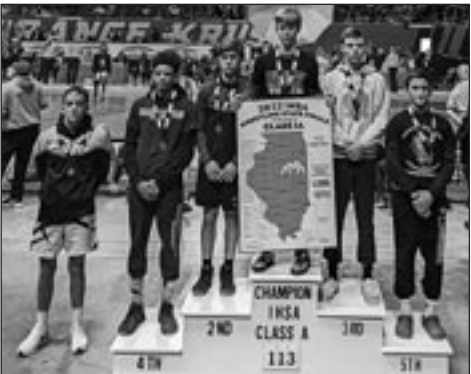
Farmington wrestler Jennings places 6th in 113

CHAMPAIGN – Farmington sophomore Keygan Jennings earned a sixth-place medal Friday in the Class 1A 113-pound weight class at the Illinois Individual State Tournament at the State Farm Center.

The margin was closer this time, but after its strong second quarter, Brimfield was in control.

Eastern Illinois recruit Lune scored 22 points and had 8 rebounds and 6 assists, but also had plenty of support from fellow seniors Peterson (15 points, 10 rebounds, 6 assists, 5 steals) and Sophie Bedell (18 points, 8 rebounds).

“Sophie was just all over the place, diving on the ground and getting after balls. It was good to see,” Dura said. “And our all-purpose player Jaclyn Fabry, she drew the toughest defensive assignment.”

Fabry limited center Annawan’s Cassidy Miller to 13 points and earned praise from Dura for keeping Miller from backing to the basket for layups.

Elmwood, Brimfield win boys regional openers

The Elmwood and Brimfield boys basketball teams won regional openers Saturday and were to compete Wednesday in semifinal games.

Elmwood beat Princeville, 53-32, on Saturday after getting off to a fast start courtesy of senior Andrew Marincic. Playing at home for the last time as a Trojan, Marincic scored 15 of 25 points in the opening quarter. “He got off to another quick start from the 3, and when we can get him going early in transition, it allows him to be aggressive,” Elmwood Coach Josh Fugitt said. “He’s done a good job lately of pushing the ball in transition and finding other guys.”

Ahead 20-5 after the first quarter, Elmwood (17-11) used stingy defense and balanced scoring to advance to Wednesday’s 6 p.m. semifinal vs. top-seed Peoria Christian (23-6) at Brimfield.

Host Brimfield (17-11) plays in the other semifinal at 7:30 p.m. against Abingdon-Avon (15-14).

Ranked No. 7 in the state, Peoria Christian downed the Trojans 66-45 on Jan. 25 without 6-foot-7 junior West Hunt, who is expected to play after sitting several games with injury while PC lost 4 of its last 10.

“When Hunt wasn’t out there, they still had a handful of other guys that hurt us just a bad,” Elmwood Coach Josh Fugitt said. “We need to block out better and play better defense.”

Elmwood did that against Princeville, limiting the Princes standout sophomore Tayshaun Kieser to 6 points. Zach Stalter led Princeville with 11 points in the loss, but Kieser had been hot for Princeville of late, scoring 15 in Friday’s loss to Wethersfield (47-45). Tucker Osborne tallied 10 in a 48-29 win over Anna-

wan on Feb. 15. Things didn’t go so smoothly against Elmwood, which Fugitt said has been playing better defense the past two weeks.

“They shot the ball really well and played outstanding defense and we just couldn’t get anything done,” Princeville Coach Tait Sennett said. “They pressured our guards and once we got by those top guys, they had their big 6-6 [Victor] Lenzi kid down low and we were hesitant to attack.”

Elmwood got 8 points apiece from Lenzi and Brendan Williams, both of whom also stepped up for the Trojans on Feb. 16 in a 51-32 home win over Brimfield. Lenzi had 21 points in the win and Williams had 8 in the first half. Marincic finished with 13.

Brimfield was without point guard Jakoby McKown in the loss to Elmwood and he was less than 100 percent in a Feb. 15 loss at Farmington (54-35), Coach Kevin Kreiter said.

“When you don’t have your point guard where all the offense starts and no days to practice without him, it’s tough,” Kreiter said. “It changed our defensive scheme too. He’s one of our best defenders by far.”

McKown played in Saturday’s 49-42 home win over West Central in the regional first round. After a 5-5 first quarter, Brimfield switched to its 1-3-1 defense to speed up the game. That helped jumpstart the offense, which was led by Oliver Heinz with 17 points and Max Walters with 16.

Kreiter said he is happy to be at home for the regional, but hopes the sickness that sidelined McKown and has limited other players is past.

“We seem to have something new to deal with every week,” he said.

Wethersfield Regional
After winning its third straight on Feb. 15 against West Central (68-47),

ROWVA-Williamsfield (16-16) dropped its final two. First came a lopsided loss to Monmouth United (25-6) last Friday, then a regional opening loss at home to Stark County (66-57), which faces United in the semis Wednesday. Peoria Quest battles Ridgewood in the other semi.

“We had a bad game at United and I think that spilled over into the game against Stark,” R-W Coach Bob Anderson said.

R-W led 25-23 at the half but could not stop SC’s balanced attack in the second half. Graham Wight led R-W with 23 points, Carson Malek added 18 and Lewis Sams had 12.

Wight had 25 and Malek scored 22 in the win over West Central.

Anderson said he’s unsure if he will return to coaching next season.

“I’m going to sit back and look at things for awhile,” said Anderson, 74, who is 707-534 in 43 seasons at R-W and before that Williamsfield.

Knoxville Regional
Farmington Coach Marty Lozier is hoping he doesn’t have a chance to review this season any time soon.

Seeded No. 1 in its Sub-Sectional, Farmington opens play at the Knoxville Regional Wednesday at 6 p.m. vs. No. 7 seed Mercer County, which beat Canton on Saturday, 66-50.

“They’re prepared,” Lozier said of his team. “All we can do now is go out and execute.”

Knoxville faces Monmouth-Roseville in Wednesday’s other semi.

Farmington beat Brimfield (54-35) on Feb. 15, as Ethan Evans scored 16 points, Corbin Rutledge tallied 15 and Riley Embry had 12.

“After being flat to start against Peoria Christian, I was glad to see us bounce back with the energy we had,” Lozier said.

Coach Gregg Meyers said. “There’s been nights we haven’t made shots and nights the ball didn’t bounce our way, but I felt they played hard the whole time.”

Playing on its home floor for the sec-tional, Brimfield again looked comfortable
