## ROAD CLOSED FOR SNAKES

# Snake road

### A mythical, magical destination

Many Illinoisans are familiar with the Shawnee National Forest. But did you know that the Shawnee National Forest is also home to a herpetological world-class destination? Snake Road – as it is known to locals and herpetology enthusiasts – is a 2.5-mile stretch of La Rue Road. Most consider Snake Road the most famous portion of the LaRue-Pine Hills/Otter Pond Research Natural Area (RNA). This short stretch of gravel road fame is due to the biannual "Snake Migration" across the LaRue Road at the base of the bluffs, adjacent to LaRue Swamp.

The road is closed to vehicular traffic every spring and fall to help protect thousands of reptiles and amphibians during their migration between their summer and winter habitats. About 66 percent of the amphibians and 59 percent of the reptiles known to occur in Illinois are found here (approximately 35 species of snakes).

Due to unseasonably warm weather and increased reptile/amphibian activity, Snake Road (FS Road #345) closed early on Friday, March 4. It will remain closed to vehicular traffic until May 15, 2022. Though closed to vehicles, it is open to people traveling on foot.

That's why herpers, photographers, researchers and

## Nine candidates

### Gov. Pritzker faces 8 challengers

SPRINGFIELD – Seven teams of Republicans and one team of Democrats have lined up to challenge Gov. JB Pritzker and Lt. Gov. Juliana Stratton in the 2022 elections.

Monday was the deadline for candidates to turn in their nominating petitions to the Illinois State Board of Elections to get their names on the June 28 primary ballot.

Candidates who were in line at 8 a.m. on the first day of filing, March 7, enter a lottery for a chance to have their names listed first on the ballot. Those who filed in the final hour before 5 p.m. Monday, March 14, have a chance to be listed last on the ballot.

Some studies have suggested being listed first or last in a crowded field of candidates improves a candidate's chances, especially when candidates have low name recognition.

The State Board of Elections has until Monday, March 21, to certify petitions. In the meantime, candidates and party officials may try to challenge signatures.

Among the last to file in the governor's race were Republicans Jesse Sullivan, of Petersburg, and his running mate Kathleen Murphy, of Warrenville.

"To be honest, it's not a beautiful day today and any day I don't have to be next to a bunch of other politicians and we get to be outsiders stepping into this race, it's a good, day," Sullivan said outside the State Board of Elections office

## Farmington hires Mathewson as principal

FARMINGTON – The Farmington School Board voted unanimously to hire Clint Mathewson as elementary principal for next school year.

Mathewson is currently the assistant principal and will replace Missy Ryba, whose is resigning at the end of this school year.

Mathewson is a former social studies teacher within the district who has coached scholastic bowl, track and basketball in the past. The past two years he has served as assistant principal and technology integration specialist.

"The district is excited to see his career continue to grow with us and look forward to him advancing an already exceptional elementary school," Superintendent Zac Chatterton said.

The board also approved Midwest Construction Professionals to help oversee an estimated \$631,310 remodel of the elementary research and media center, with another \$101,950 allotted for furniture and technology.

Chatterton noted that the remodel is slated to be completed for the 2023-24 school year and that estimated costs are based on current pricing.

"We're just getting the drawings done and a tentative budget so we can be all ready to go when the bidding is right," Chatterton said. "We could bid it as early as this fall or we may wait until winter."


The board also approved DLA Architectural Services to assist in the remodel.

# FARMINGTON: District selling surplus bus

Since the resignation of Adam Powell as technology director earlier this year, Farmington has been working with CDS Technology Service to handle IT work in the district.

The board formalized that agreement Monday, agreeing to a short-term contract with CDS that will be reviewed and possibly extended in May or June.

“There’s just more money in the private sector with that skill set than we an ever offer in public education,” Chatterton said.

Based on declining enrollment and the ability to combine a bus route, Director of Student Services Toby Vallas recommended selling a 71-passenger 2020 Bluebird Vision bus. The board agreed.

The board also heard a presentation from Jason Koenig of the Farmington JFL, which is asking the district to sell the league the football field at the old high school. Koenig said the JFL, which last year had 162 players out for football, would handle mowing and maintenance.

The school board is expected to discuss the request at a future meeting.

In other business, the board:

- Approved the 2022-23 Student Handbook.
- Approved the 2022-23 District Calendar, which shows a later start date of Aug. 17 to bring the district more in line with other nearby schools.
- Heard that Art Club students are planning to do a mural in Yates City.
- Approved hiring Ty Loveland as technology assistant and Dylan Hayden as a baseball assistant coach.
- Approved FMLA leave for Quincy Thompson and Amanda Collins.
- Acknowledged the resignation of teachers McKenzie Cooper and Dominique Pohl and cheerleading coach Kim Pillman.
- Acknowledged tenure for Lilybeth Mendez, Brian Littrel, Quincy Thompson and Donovan Benson.
- Approved eight volunteer bass fishing coaches.

# Toulon man faces federal porn charges

# Broken systems raise costs fast

One of the most beautiful – and inexplicable – aspects of economics is how its practitioners never seem to be wrong.

Indeed, almost every school of economic thought, from John Maynard Keynes’ demand-driven economics on the left to Arthur Laffer’s supply-side economics on the right, is crowded with disciples defending their leader’s theories and just often, if subtly, attacking their theological foes.

One such fistfight broke out in, of all places, the Feb. 28 editorial pages of the New York Times. In it, writer and editor David Dayen undressed one of the most famous economists of the last 40 years, Lawrence Summers, for his role in building one of the most efficiency-centered, imbalanced and fragile economies in history.

“For decades, economists like Mr. Summers advanced policies like globalization, deregulation, and markets that valued efficiency over competition,” says Dayen. “They promised that these trends would deliver lower prices. And they did, for a time. But they also left the system vulnerable.”

Vulnerable to what we see today – broken global supply chains impossibly slow to repair; a domestic economy that, somehow, is both quickly growing and mired in inflation; and a consumer culture so treasured that we gladly trade regulation and competition for lower prices and higher economic growth.

It’s the manifestation of Nobel

Prize-winning economist Milton Friedman’s “marketized economy,” explains Dayen. “(T)he sole social responsibility of business is to increase profits. Cut regulations, cut taxes and allow companies to structure markets, people like Friedman maintained, and watch the economy take off.”

In short, markets are most important and government – regulation, taxes, antitrust – are far less important.

That’s been a solidly bipartisan tenet for 50 years. While Republican administrations – Reagan, Bush II and Trump – cut taxes and nearly eliminated antitrust, Democratic administrations, especially Carter and Clinton, deregulated trucking, airlines, railroads, banking and agriculture.

And most of this was accomplished by the early 2000s to lay the foundation for globalization – ever bigger free trade deals; the rapid rise of unregulated financial derivative markets; easy access to cheap, plentiful labor; and sophisticated, just-in-time supply chain management.

A Summers’ acolyte, Dayen reports, once likened it to how Walmart initially impacted the U.S. economy. The giant retailer might not have been good for local communities or local job markets, but there “is little dispute” Walmart’s cutthroat business model helped the other 120 million Americans not employed in local retail.

As such, “The trade-off was clear: sacrifice resiliency, wage security, and community for the promise of a five-dollar pack of tube socks.”

We may not like the comparison but we know it’s spot-on because, by golly, a pack of tube socks for \$5 – even if the socks were made by chil-

dren working 70 hours a week in a pollution-riddled sweatshop – is still an easy, smart buy, right? Until this year, when those socks, like our long-ordered television, new dishwasher, or car, were trapped somewhere in a global supply chain with too few manufacturers, too few shipping companies, too few ports, too few railroads, too few truck drivers, too few retailers, and too few solutions on how to fix the whole bloody mess.

American farmers and ranchers know the feeling. Two years ago a global pandemic, predicted though it was, fouled the food system because no one thought it could happen so no one had any plans for when it did happen.

And when it did happen, what was our first instinctive reaction? Give market giants like exporters and meatpackers even more market power; power it will take decades, if ever, to get back.

Today, war is ripping through integrated markets from Odessa to Omaha. No tax cuts, fewer environmental rules, more deregulation or less antitrust enforcement will lower crude oil prices or cut U.S. potash costs.

But none of this should be news because, as Dayen reminds us, “Broken systems raise costs far faster than resilient ones.”

America’s too few farmers and ranchers, too many broken rural communities, and too much cheap food are testament to that inarguable economic fact.

cut off.” We also grew corn, soybeans, wheat, oats and clover hay.

The picture at left of me and my English Setter, Queenie, posing by the wood pile, brings back more memories. My father cut the wood, split it and piled it, but one of my jobs was to stack it on the porch.

The kitchen stove had a flat top where a tea kettle sat most of the winter. The entire stove top swiveled so a large piece or two of wood could be deposited before bedtime with hopes of coals being there to rekindle the flame in the morning while breakfast was being prepared.

Often we kids would stand beside the stove and quickly change from pajamas into school clothes just in time to catch the school bus at the end of our quarter-mile lane. Thus, began another winter day in southern Illinois during the 1950s and 60s. Summer days? That’s another story.

## Column stirs memories of life on the farm

To the Editor:

While reading Alan Guebert’s article in the Jan. 20 issue of The Weekly Post, I realized he and I have several things in common. Like Guebert, I grew up on a farm in southern Illinois, my family burned firewood for heat in the kitchen, some of my chores included carrying wood to the porch and we had two unheated upstairs rooms in our home.

Alan grew up on a dairy farm on the southwestern side of the state and I grew up on the southeastern side on a general family farm. We had two dairy cows, a Guernsey and a brown swiss. We milked them by hand twice daily. The milk was used for drinking and cooking, plus we sold the excess.

Cream was skimmed off the milk and used to churn our own butter. Sometimes my mother sold extra butter. Extra cream, milk and eggs were sold on Saturdays in town. Money was used to buy flour, sugar, salt and other spices that we did not produce ourselves.

Occasionally, we went to a movie at The Strand Theater, which was very



similar to The Palace in Elmwood.

Our milk was strained into a separator. We drank raw milk and never knew what pasteurized milk was, except that which we drank in the half-pint cartons at school. Extras of those cost 2 cents. Chocolate-flavored ones cost 3 cents, which was too expensive, so I drank a lot of white milk.

We raised beef, hogs, sheep, chickens and the dairy cows. I collected eggs daily from our Rhode Island Red hens. Several baby chicks were purchased each year for butchering when they weighed about 2.5 to 3 pounds each. As a young boy, I learned the meaning of “running around like a chicken with its head



in Springfield.  
“Yeah, we’re not looking for a photo op with Gov. Pritzker. We were looking to turn in the best petitions possible to represent the people who worked so hard to help us get them,” Murphy said.

Sullivan, a political newcomer and owner of the venture capital firm Alter Global LLC, and Murphy, a former spokeswoman for former state Rep. and 2018 GOP gubernatorial hopeful Jeanne Ives, will face formidable competitors for the 2022 nomination.  
Those include Aurora Mayor Richard Irvin and his running mate, state Rep. Avery Bourne, of Morrisonville.  
Another late filer Mon-

day was GOP gubernatorial candidate Max Solomon, of Hazel Crest, and his running mate, Latasha Fields, of Chicago. According to his website, Solomon is a native of Nigeria who now practices law in the Chicago area, while Fields is the founder of Christian Home Educators Support System.  
They join other teams of candidates who filed earlier: state Sen. Darren Bailey, of Xenia, and his running mate Stephanie Trussel of Lisle; Bull Valley businessman Gary Rabine and his running mate Aaron Del Mar of Palatine; former state Sen. Paul Schimpf, of Waterloo, and his running mate Carolyn Schofield of Crystal Lake; and the team of Emily

Johnson, of Wheaton, and Bret Mahlen, of Orland Park, members of the group We Are the People Illinois, which has called for investigations into unfounded claims of voter fraud in the 2020 elections.  
One other GOP candidate, Keisha Smith, of Country Club Hills, filed for governor without a run-

ning mate, which could be grounds for disqualification since state law requires candidates for governor and lieutenant governor to run as a team.  
Pritzker and Stratton also face one challenge from within their own party, Beverly Miles, a nurse and U.S. Army veteran from Chicago, and her running mate Karla Shaw.

# SNAKES: Migration in Shawnee underway

wildlife enthusiasts from across the country descend on Snake Road each year.

If snakes, salamanders, frogs, toads, turtles and all other varieties of reptiles interest you, you must visit Snake Road. The yearly migration involves the hibernation of the animals during the winter months in the bluffs. These animals then move to their feeding grounds in the swamp during the summer

months. Herpetologists have reported that ground temperature is the main factor in triggering seasonal migration. The road was open to traffic year-round before 1972, but traffic resulted in the death of too many animals crossing the road.

Small parking areas are located at the north and south ends of the closed road. The leisurely 2.5-mile walk down the gravel road is relatively easy to

traverse, with only a few slight rises scattered throughout. During spring migration, some of the best days for viewing, finding, and photographing are during mid-April. Longer, warmer, sunny days trigger the herps to leave the bluffs and head to the swamp.

Follow weather patterns and look for days when the temps top in the high 70s to low 80s. Also, look for areas that get the most sun during the warming parts of the day, usually southern exposures.

The best way to enjoy the road is to observe your surroundings. Was that rustling sound a snake in the leaves, or was it the wind?

Is that a weird musky sort of smell you can sense all of a sudden? There might be a water snake near you.

Did you notice the gravel move right where you planned to take your next step? That might be a ring-necked snake or

brown snake. Most people don't realize that many snakes on the road are commonly less than a foot long and can hide in plain sight in the rocks on the road.

Each species has different habits. Once you learn where and when it becomes a question of how long you want to spend hiking that day.

One of the most common finds is the Western Cottonmouth (Agkistrodon piscivorous leucostoma). They are commonly seen basking on the road near the waterways and bluffs. Keep a safe distance, and do not worry. They do not want to "attack" you. They just want sunshine.

Other common finds will be green frogs, southern leopard frogs, midland brown snakes, ring-necked snakes and plain-bellied watersnakes.

If you develop a keen eye, you will notice hundreds of tiny cricket frogs jumping out of your path wherever you see water. These species are only the tip of the iceberg, though. Pine Hills has approximately 54 species of reptiles and amphibians that can be observed throughout the year. A good field guide can be a great help to the casual hiker. I suggest the "Petersons Field Guide to the Reptiles and Amphibians of the Eastern U.S."

When visiting Snake Road, dress appropriately in long pants, long sleeves, heavy and sturdy boots. Use plenty of sunscreen and insect repellent. Not only are there venomous snakes to worry about, but there are also biting insects, ticks, and irritating plants like poison ivy and stinging nettle.

Have an emergency plan, including the phone number for the Jonesboro Ranger Station. Cell phone service can be spotty.

Most importantly – maintain your distance from venomous snakes. We suggest maintaining a distance of two times the snake's body length between you and the snake at all times. Do not pick up, handle, touch or harass any snakes and remember, collection or removal of any snake species is strictly prohibited.

So why not plan a trip to this beautiful area of the Shawnee National Forest this spring? There are also these outdoor fun possibilities to consider, from blooming trees to migrating songbirds and warblers there's a lot going on.

# Infrastructure work part of Billtown budget

**WILLIAMSFIELD** – The Williamsfield Village Board revised a draft budget at its March 7 meeting in anticipation of approving a final budget that should include “substantial” infrastructure work, according to Village President Matt Tonkin.

The board is expected to vote at its April meeting on a Fiscal Year 2022-23 budget that should fund continued repairs to existing sidewalks, ongoing repairs at KP Hall, repairs or reconstruction of road margins that are slipping into adjacent ditches and implementation of stormwater management improvements. The latter is in response to a village survey that’s still in-process.

Trustees also voted to join both the Illinois iBID

system and the GSA system, which will allow them to review and possibly buy equipment from other government bodies.

Tonkin gave an update on strategic planning MAPPING meetings, which were being held in collaboration with Western Illinois University. The meetings, which were slated to conclude March 10, have yielded four focus areas for Williamsfield: infrastructure updates, youth-focused activities, expanding park facilities and programming and village-wide beautification.

Tonkin said a formal plan will be developed to “guide implementation of these focus areas.”

In keeping with that theme, trustees tentatively approved a mini-golf extension for Doubet-Benjamin Park, pending cost

estimates.

And probable dates were set for a Farmers’ Market to be held once or twice a month at Veterans Park and on surrounding streets, if needed. This was the No. 1 item identified in a survey of residents for activities at Veterans Park.

In other business, the board:

- Denied an application for a liquor license.
- Set April 2 as Paint and Electronic Recycle day.
- Discussed, at length, the issue of unsightly properties, yard cleanups and enforcing existing ordinances to improve the village’s appearance.
- Accepted a final design of the new sign commemorating Veterans Park. Tonkin said it is hoped the sign will be installed early this spring.

Princeville school board OKs storage building

PRINCEVILLE – The Princeville School Board on March 8 approved a bid for a new storage building.

Bruna. “He was very demanding and very disciplined, but he got the most out of everyone and everyone loved playing for him.”

A state championship game played in an ice storm was the only blemish on an otherwise perfect season for the Princes. Princeville lost that game to Concord Triopia, 36-6, after trailing just 14-6 at halftime.

“They probably averaged 30-40 pounds heavier than us across both lines,” said Elsasser, a middle line-backer. “Our guys were quicker, but it was so icy. I wish we could have played them on a nice day.”

That’s one of the few regrets from this hall of fame season, as Princeville won its third straight Black Hawk Conference and had one other close game, a 26-24 win over previously unbeaten Stronghurst in the second round of the playoffs.

Elsasser recalled Bruna saying of the game, “I talked to football coaches and people from all over. They came from Iowa and all over Illinois and they said it’s the best high school game they had ever seen.”

In those playoffs, Princeville also beat Forest Strawn-Wing (40-8) and Deer Creek-Mackinaw (26-3).

“We were just very well-balanced and really worked together as a team very well,” Elsasser said. “And we had amazing support from our fans, even when we went away.”

The unbeaten 1973 Princeville football team is also in the Greater Peoria Sports Hall of Fame. Elsasser said he doesn’t think the 1975 squad

would have beaten 1973.

“We probably couldn’t have beaten them, just because of Al Martin,” Elsasser said of the 1973 team’s bruising running back who ran for 2,014 yards in nine games.
