## MEMORIAL DAY 2022

### Busy slate of events for Memorial Day

Area towns will hold a variety of Memorial Day remembrances on Monday, May 30, to honor fallen soldiers.

Memorial Day has its roots in Illinois, tracing back to General John Alexander Logan, who led a movement to make May 30, 1868, an official day of remembrance for soldiers who had died in battle. Logan called it “Decoration Day” because he wanted graves of soldiers to be decorated with flowers and other decorations.

In 1968, Congress decreed that Memorial Day would be observed on the last Monday of May.

Here are local events that follow in the footsteps of that 154-year-old tradition.

• **Farmington** – The American Legion will gather at Reed Park at 10 a.m. on Monday. All are invited. The legion will also hold a short service at *Continued on Page 10*

### Peoria Co. ballot has few contested races

Political division may be stronger than ever. Political participation is not. Such is the conclusion based on a review of Peoria County’s sample ballot for the upcoming June 28 general primary election.

While most races for spots in Springfield and Washington, D.C., feature several candidates, contested elections for local spots are rare.

One actual race is for Peoria County Sheriff, in which Republicans Chris Watkins and Jason Buckley will face off to replace retiring incumbent Brian Asbell. Buckley is the senior patrol lieutenant in the sheriff’s office with nearly 21 years of experience. Watkins has 18 years with the sheriff’s office and is currently Captain.

No Democrat is running for sheriff.

Beyond the local scene, most intrigue surrounds state or federal elections.

The highest-profile election in Illinois is the gubernatorial race, which pits incumbent J.B. Pritzker and Lt. Gov. Juliana Stratton vs. Beverly Miles and Karla Shaw in the Democratic primary.

Republican challengers are Darren Bailey, Paul Schimpf, Richard C. Irvin, Gary Rabine, Max Solomon and Jesse Sullivan.

Another interesting state race is for state representative in the newly drawn 93rd district – which encom-

### Princeville seeks ATV reciprocity agreement

**PRINCEVILLE** – Golf-cart owners of northwestern Peoria County, unite. That goes for owners of all-terrain and utility-task vehicles, too.

Princeville residents who have municipal approval to drive such transportation on village streets might soon be OK to also operate them in Brimfield. And perhaps in some other communities, eventually.

During its meeting last week, the

Princeville Village Board authorized preparation of an intergovernmental agreement with Brimfield to allow golf-cart, ATV and UTV reciprocity.

The agreement might be ready in time for the Princeville board to vote on it June 21. It wasn’t clear when the Brimfield board might consider the proposal. As of Monday, it was not on the agenda for the board’s June meeting, according to Brimfield Village Clerk Holly Johnson.

Trustee Ron Delbridge led the Princeville promotion of the pro-

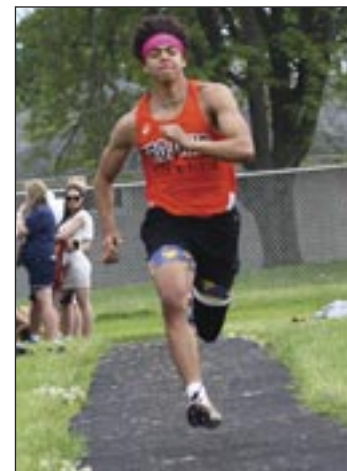
posal, according to Village President Jeff Troutman. Delbridge had discussed it with Dan Fishel, the Brimfield village president.

Troutman said he isn’t sure how many people ride golf carts, ATVs and UTVs regularly between the communities, which are about 13 miles apart.

“That’s up to the owner,” Troutman said. “If they want to try it, they can do it. ... They’re taking that risk on their own.”

# PRIMARY: Six vying to be Secretary of State

passes much of The Weekly Post area. Republican incumbent Mark Luft of Pekin will face off against Travis Weaver of Peoria.

The state senator race in the 37th legislative district pits incumbent Sen. Win Stoller of Germantown Hills, who was elected in 2020, against Brett S. Nicklaus of Dixon in the Republican primary.

Six candidates are running to replace Jesse White as Secretary of State. On the Democratic side, former state treasurer Alexi Gianoulis has the most name recognition out of a group that also includes David H. Moore, Sidney Moore and Anna Valencia, who was endorsed by White. Republican candidates are Rep. Dan Brady of Bloomington, a funeral director, and former U.S. Attorney John Milhiser of Springfield.

Three Republicans are also vying for the right to face Attorney General Kwame Raoul in the Nov. 8 general election. Those three are Steve Kim, David Shestokas and Thomas G. Devore, who brought several legal challenges against Pritzker's COVID-19 mandates.

Aside from some contested state central committeeman races, the focus beyond that is for contested spots in the Washington, D.C., delegation.

U.S. Sen. Tammy Duckworth is waiting to see who she will face in November out of a crowded Republican primary that includes Casey Chlebek, Peggy Hubbard, Robert Piton, Jimmy Lee Tillmann II, Anthony W. Williams, Kathy Salvi and Matthew Dubiel.

The race to replace Cheri Bustos in the 17th Congressional District – which includes Elmwood, Yates

City, Farmington, Trivoli, Williamsfield and Dahinda among other towns – has races in both party primaries.

On the Republican side, Esther Joy King is running against Charles William Helmick Jr. Both are from East Moline.

Democrats will have six candidates to choose from in the 17th: Angie Normoyle, Eric Sorensen, Litesa Wallace, Marsha Williams, Jacqueline McGowan and Jonathan K. Logemann.

In the 16th district, incumbent Rep. Darin LaHood faces three challengers on the Republican card: Michael Rebresh of Minooka and Rockford residents JoAnne Guillette and Walt Peters.

### Of an inevitable pipeline, otters & catfish eggs

Rambling through central Illinois pondering how many critters thought they could eat a snapping turtle – only to learn they were wrong.

Spent a morning last week with surveyors from the Navigator CO2 Ventures pipeline that is proposed to run under parts of Knox and Fulton counties, including our little French Creek farm. While I have mixed feelings about the pipeline, it was good to meet the surveyors, since the proposed route has changed dramatically since meetings in January. They showed where the pipeline is proposed to cross our farm and seemed willing to entertain changes to that plan. "Better to tell us now than later," said **Shane Chronister**, the affable, professional talker leading the crew. The proof will come when a 6-inch pipe goes into the ground, of course, but I now believe that's inevitable. As a wise man told me, "The Farm Bureau is behind this. The train has left the station." In other words, if the money is there, the pipeline will happen. Look at the political climate: How are you going to defeat a "green pipeline" now?

Those memories came back to me recently while watching critter videos and seeing a river otter whip a snapping turtle. Turns out otters eat snappers occasionally. That's a bet I would have lost. ... Speaking of lost wagers, Once Upon a Time in Buffalo, the fightmakers in our neighborhood pitted my little brother, **Junior**, against **Ernie Freiburg**, who was four years older but kind of weaselly. Junior was bigger, and my brother, so my money was on him. These things happened back then, where kids were squared off against each other by older kids. Some will say that wasn't good, but it is a fact. So is this: After Ernie kicked a sensitive area below Junior's waist (while wearing church

shoes!) and sent him sprawling, nobody wanted to fight Ernie.

Question of the day: We can't live on bread and water alone. OK. What about rhubarb pie and milk? ... For years, I mistakenly thought what made life worth living were the big moments: weddings, births, AFC championship wins and the like. While those are great, my realization is that life is too hard for those to sustain me without also finding joy in the tiny moments, like catalpa trees sprouting unexpectedly, the middle son's corydoras catfish laying eggs all over the aquarium or eating pickled asparagus given by a kind reader with excellent penmanship. ... Parting shot: Arguments over global warming are beyond my comprehension and outside my scope of interest. But there's one aspect of the debate that is comically understandable. You can be sure on a hot day, someone, somewhere will spout off about how we are headed for ruin due to carbon emissions, coming heat waves and rising ocean levels. And when the temperature turns unexpectedly cooler, as it has during this wonderful week of open windows and deep sleep, someone, somewhere will spout off about how global warming is a sham and we are all being duped.

# Meatpackers, pols colluded to keep work going

It's no surprise that the nation's five largest meatpackers, according to a May 12 government report, "engaged in a concerted effort with Trump Administration political officials to insulate themselves from coronavirus-related oversight."

After all, the House Select Committee on the Coronavirus Crisis (the Committee), the body charged with oversight of government's response to the pandemic, released a 23-page "Memorandum" last October that mapped how meatpackers and the Trump Administration joined forces to keep employees working in coronavirus-rife meat plants.

Those efforts paid off big time for Big Meat but proved deadly for their employees. According to the Committee, tens of thousands became infected with coronavirus and nearly 300 died of it.

Still, Trump's Big Ag supporters were uncharacteristically silent after the May 12 report was released. None rose to declare it fake news or partisan hackery.

They didn't because they couldn't. The 12-member Committee is decidedly bipartisan; its seven Democrats and five Republicans feature James Clyburn, the Dems' third-highest-ranking House member, and Steve Scalise, the Republicans' second-most-powerful member.

As for facts, the Committee has bushels gleaned from 29 public hearings and 151,000 pages of evidence. Twenty-six of the May 12 report's 61 pages are footnotes documenting every detail of the meatpackers' actions to influence government, often the U.S. Depart-

ment of Agriculture (USDA).

The evidence is remarkable for how brazen the meatpackers and their Big Ag allies – especially the North American Meat Institute (NAMI) – were in pushing their private agenda on public officials and how reflexively responsive government – again, especially USDA – was to the backdoor lobbying and backroom deals.

For example, meatpackers knew their plants were coronavirus hotbeds even as they lobbied to keep them open. An "April 2020 email from a doctor in a hospital near JBS' ... facility," tells JBS that "100 percent of all COVID-19 patients we have in the hospital are either direct employees or family member[s] of your employees," and warn[s] that "your employees will get sick and may die if this factory continues to be open."

The meatpackers prevailed because, the Committee reports, of a "pattern of interference" by Trump-appointed USDA officials "with state and local health departments ... with career [USDA] staff being 'walled off,' and leaving 'no paper trail' of such meetings."

The report names names. One was USDA's "Under Secretary for Food Safety Mindy Brashears" whose efforts "delighted" the packer lobbyists who later crowed how "fortunate" it was "to have USDA as their 'primary regulator' because it was 'representing [the] industry's interests in every important inter-agency conversation.'"

Brashears was more than helpful: "A few months later, a meatpacking lobbyist told [another meatpacking] executive that Brashears 'hasn't lost a battle for us' in connection with efforts to block a local health department order to regulate coronavirus measures in a (named) facility."

There's more.

The report details how the meatpackers drafted the federal order to keep their plants open and how the Trump White House "requested" that they then "issue positive statements and social media about the President's action..."

For example, meatpackers were so sure they could push Trump Administration officials to issue an Executive Order to keep meatpacking plants open that Julie Anna Potts, the CEO of packer lobbyist NAMI, emailed Tyson Foods boss Noel White April 18, 2020, to note, "As of my conversations with USDA, they still think that they are ... in better shape with POTUS than other agencies."

But, Potts related, "I have said we have to see some results!"

On April 28, her meatpacker members got their results: the White House ordered plants to remain open. Big Meat's capture of government was complete.

But "The results," reports the Committee, "... were tragic: during the first year of the pandemic, workforces" for the Big Five packers "alone saw at least 59,000 worker infections, at least 269 deaths, and countless more cases and deaths among meatpacking-adjacent communities..."

And, most likely, the only punishment any of the Big Five packers – Tyson Foods, JBS USA, Smithfield, Cargill, and National Beef – will ever face for all the predicted illness and death is this detailed, shame-filled, soon-to-be-forgotten report.

# Momentum builds for Elmwood I.A. building

ELMWOOD – Not long after giving final approval for \$2,345,889 in General Obligation School Bonds for an HVAC project, the Elmwood School Board on Monday heard encouraging news about another possible project.

The board voted unanimously to approve bond issuance for installation of a new HVAC system in the grade school. Several other outstanding bonds were also rolled into the total and Morton Community Bank was authorized to handle the sale.

While the HVAC system has been a decades-long topic of conversation, proposed construction of a new Industrial Arts building between the east side of the school and the football field is a relatively new topic.

Yet several board members expressed optimism about the project,

which was first introduced in March by board member Claude Keefer. Keefer's idea is to build a 30-foot by 100-foot structure that would provide more space for industrial arts and trades education.

Speaking for the building committee on Monday, board member Mark Davis said, "The intent is to start breaking ground in the spring of 2023, if we can."

The finance committee also met to discuss the project and member Tom Conklin said, "We feel it's financially doable in the spring. Let's get bids and see where we're at."

Keefer's original plan called for fund-raising to pay for the entire project. But it now appears the district will contribute to the project, reducing but not eliminating the need for donations from the public.

Less rosy was news for a proposed pavilion north of the school that could serve as an outdoor classroom. Parents Club members received bids that were twice as much as they had hoped for. The plan is to continue fundraising and hope construction costs drop in the next 6-12 months.

In other business, the board approved a \$2 increase in hourly pay for paraprofessionals (to \$15 per hour) and a \$2 increase for non-certified staff (to \$14 per hour).

Superintendent Chad Wagner said he hoped the increase would help recruit and keep staff, saying "we are just having a bear of a time keeping people employed."

The board also approved Gorenz and Associates, Ltd. of Peoria to handle the school audit.

A detailed list of items in the consent agenda was not available.

# PRINCEVILLE: Lighter vehicles easier on roads

But Troutman suggested some Princeville residents might transport golf carts, ATVs and UTVs in other ways to use during village-wide garage sales in Brimfield, for example.

Princeville golf-cart, ATV and UTV owners pay \$25 annually for licensing. Vehicles must undergo an initial inspection at the village hall and have turn signals and brake lights. Golf carts and UTVs also must have seat belts. Owners must have proof of insurance.

Golf carts and UTVs first were allowed on Princeville thoroughfares about six years ago, Troutman said. About four years ago, ATVs were permitted. This year, the village has issued 53 permits.

"It's growing every year," Troutman said.

The lighter-weight vehicles help reduce wear and tear on pavement, according to the village president.

"Especially in the hot summer weather, when oil is bubbling through, damage from UTVs on streets is less than a car or a pickup truck is," Troutman said.

Princeville officials plan to check with colleagues in Chillicothe, Dunlap and Wyoming to see if they're interested in agreements like the impending one with Brimfield. Only golf carts are allowed in Chillicothe, according to Troutman.

During the meeting May 17, the Princeville board also voted to allow two properties along the village's eastern boundary to tap into

the municipal water system.

Private wells currently service the properties Alan Knobloch and David Stoner own along Oertley Road, Troutman said. Knobloch and Stoner are to pay for hookups to the village system.

Knobloch's property is in Princeville. His water bill is to be less than Stoner's, whose property is outside village limits.

For Knobloch, fees are to be the standard village rates – a flat charge of \$10.41 monthly, plus \$5.69 per thousand gallons used each month, according to Village Treasurer Julie Delbridge.

Stoner's fees are to be \$14.56 and \$6.10, respectively. A technology fee of \$3 is charged each village-water account monthly.

**Fairview man accused of hitting relative's car**

McFarland was charged with aggravated domestic battery and failure to remain at the scene of a personal-injury or fatal motor-vehicle accident, among other crimes. He was transported to the Fulton County Sheriff's Office in Lewistown.

**Farmington woman cited in two-car crash**

HANNA CITY – A Farmington woman was cited for failure to reduce speed regarding a two-vehicle collision May 11 in Hanna City, according to authorities.

According to Harwood, there is no way to know for now what caused Koehler's death. Toxicology results from an autopsy are pending, a process that usually takes five or six weeks.

Foul play is not suspected, Harwood stated. A detective has been assigned to the case, according to sheriff's-office Capt. Chris Watkins.

# City of Elmwood electricity bill increasing

ELMWOOD – The city’s electricity bill is about to increase. A lot. But Elmwood city government also has enough money in reserve to pay it. For now, at least.

A new one-year contract with Homefield Energy sets the electricity rate for its municipal customer at 15.042 cents per kilowatt hour, according to Elmwood Mayor JD Hulslander. The current rate is 4.8 cents. The new contract takes effect in June.

During a meeting May 17, Hulslander informed the City Council about the increase.

The Homefield Energy contract covers all city facilities. That includes City Hall, the water-department plant – even the flashing lights on crossing-guard signs around town.

Supply-chain issues and a rise in the price of natural gas are among the reasons for increasing energy prices nationwide. According to The New York Times, rates in Illinois have risen about 15 percent from 2021.

The increase in the Elmwood municipal rate is substantially higher than 15 percent. But according to Hulslander, the situation is not yet dire.

“We’re not going to have to go slash everything,” Hulslander said after the meeting adjourned. “We have some savings. We don’t spend everything we have every year.

“We do have some money to put back to be able to keep going with stuff, but we’ll just have to watch closer.”

In an email following the meeting, City Clerk Bethany Lovingood sounded a similar theme.

“The city will need to keep a very close eye when discussing and planning any expenditure budget items for this upcoming fiscal year,” Lovingood wrote.

From December through May, the city paid about \$37,675 for gas and electricity, according to Lovingood. The bill for May was \$5,828.65, a decrease of about \$1,000 from April.

During a meeting that lasted about

15 minutes, the council approved the final extension of the Fairground Acres subdivision at the northeast edge of town.

The extension consists of five lots that are to connect two ends of Hickory Run, an unfinished thoroughfare on the east side of the development. According to subdivision co-developer Tom Meyers, one lot has been sold so far. Lots are listed at \$30,000.

With those five lots, the subdivision established about 18 years ago will be complete, according to Meyers. The farmland upon which the subdivision was built was owned by wife Cathy’s family.

“The whole goal of this was to keep the school vibrant and away from consolidation,” Meyers said.

Fairground Acres is part of a tax-increment-financing district. In TIF districts, property taxes that are to go to various bodies are frozen. Subsequent tax increases are diverted into a fund that can be used for infrastructure improvements, as has been the case at Fairground Acres.

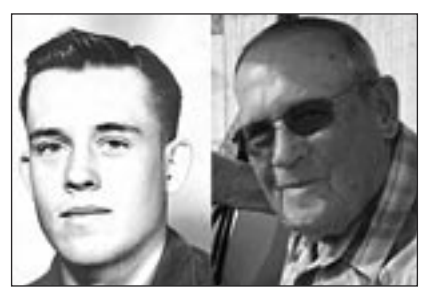

"She makes it look easy. It's not easy, but she makes it look that way," E-B Coach Kyle Anderson said. "It started with her saying she wanted to try it. Then she got a good coach and she just has a knack for it. She understands how to use her body and her hands."

Rain in the forecast Saturday also helped, since it moved the pole vault indoors, which is where Strahm practices.

"She's been doing this 5-6 months and the majority of her

vaulting experience has been indoors," Anderson said. "Being indoors, where she is a little more comfortable, just set her up to do what she did."

Strahm tied with three other senior vaulters for second after clearing 11 feet, 5.75 inches. State champion Livia Binder of Maroa-Forsyth cleared 11-7.75. Farmington senior Miranda Hursy tied for ninth at 10-8.

Like most athletes who competed Saturday, though, Strahm also wound up getting wet in the day's rainstorms. Running in the rainy finals, she finished sixth in

the 300 hurdles in 47.18, just a hair behind senior teammate Elynn Peterson who was fifth in 47.12 seconds. Cambria Geyer of Tremont won in 44.43.

Peterson and Strahm had flip-flopped wins in the hurdles races all year, including Thursday in prelims when both broke school records. Peterson was first to set a new mark in 47.11, but just two heats later, Strahm rattled off a 47.1 to reset the record.

"Obviously there was a little playful competitiveness when I told them what happened," Anderson said. "Those two have

been fantastic. They are competitive, but they get along and they roomed together."

The other Lady Trojan to medal was sophomore Etta Wagner, who placed seventh in shot put with a throw of 37-1, a personal best from the prelims which had her sixth heading into the finals. Wagner was one of two non-seniors in the top nine.

"To be one of the two underclassmen, there's a lot to be excited about there, as well," Anderson said.

And while E-B's 4x100 relay did not reach the finals, the quartet of Peterson, junior Ainsley Faulkner, freshman Chloe Howerton and sophomore Emma May broke the school record with a time of 51.5 in prelims.

That proved true, as the 4x800 quartet of junior Brendan Williams, sophomore Mika Nelson, senior Nick Feller and Hill won in 8:46.06. That 4x800 time earns them the No. 17 seed heading into the Class 1A state prelims today at Eastern Illinois University. Finals are Saturday.

Hill was also second in the 800 (2:00.99) and first in the 1,600 (4:41.26) and ran on the second-place 4x400 (3:33.83) along with freshman Daniel Yeagle, Williams and Harmon. The 4x400 is seeded No. 19.

Aside from winning plenty, it was an unusual meet for Harmon, who held back mightily in his 3,200 win before surging in the final 200 meters. And he and Hill were directed not to race hard in the 800 and 1,600 to conserve energy, though they did battle some in the 800.

"I still had that race mentality, but obviously I was going to be on the track a lot more than usual, so in my mind it was just like another workout day," Harmon said. "The goal was to get points today. And I think Isaiah and I have done

that."

As a result, Harmon's seeds are not as lofty as they would have been had he ran hard in just one or two events. And that's OK, since unlike last year, there will once again be prelims at state.

Harmon ranks 10th in the 800 and 28th in the 1,600. But his season-best 800 time of 1:56.2 would push him up to No. 1.

"Bringing home a state championship would be nice, but as long as I can

be up front and compete, that's my goal," said Harmon, who placed 7th in the 800 at state last year. "And I think the 800 is my best chance to be up front and compete ... the 800 is definitely my forte now and I've really grown to love the event."

E-B also got points from senior Johnny York, who earned a trip to state by placing second in long jump with a leap of 19 feet, 6.75 inches despite an ailing hamstring.

"Hopefully with six days rest and a little work on it he can maybe jump a little farther," Meyers said.

York's p.r. of 21-5.75 came May 9 and would place him 8th out of the jumpers who qualified for state. His sectional effort is good for 29th.

Princeville was led by

senior Grant Hunt, who won the 400 in a personal record 51.32, ran second in the 100 (11.34) to Peru St. Bede speedster Tyreke Fortney (10.89) and ran on state-qualifying 4x100 and 4x400 relays.

Hunt's top seed heading to state is 8th in the 400.

"Frank really crushed that home run," Porter said.

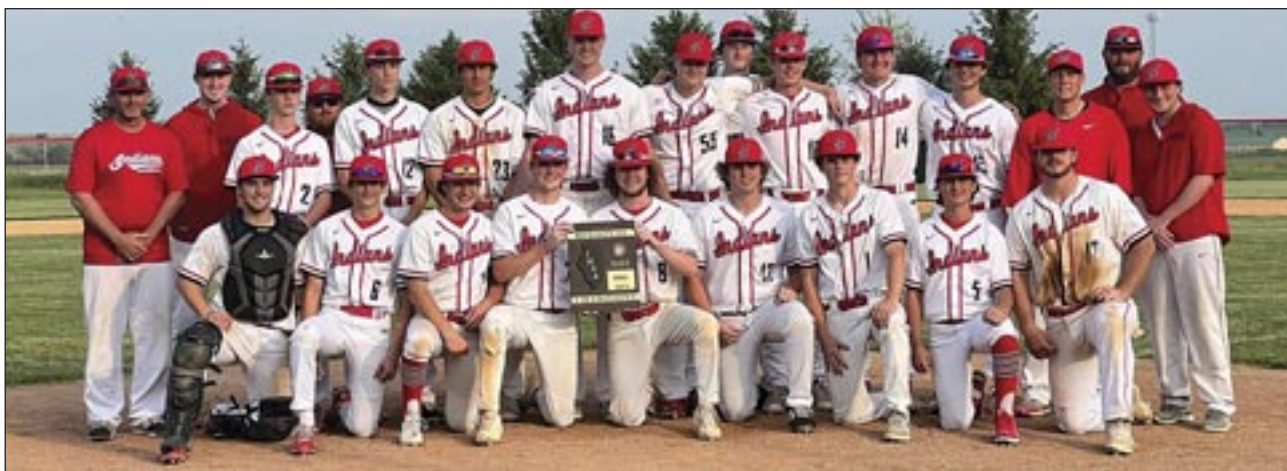

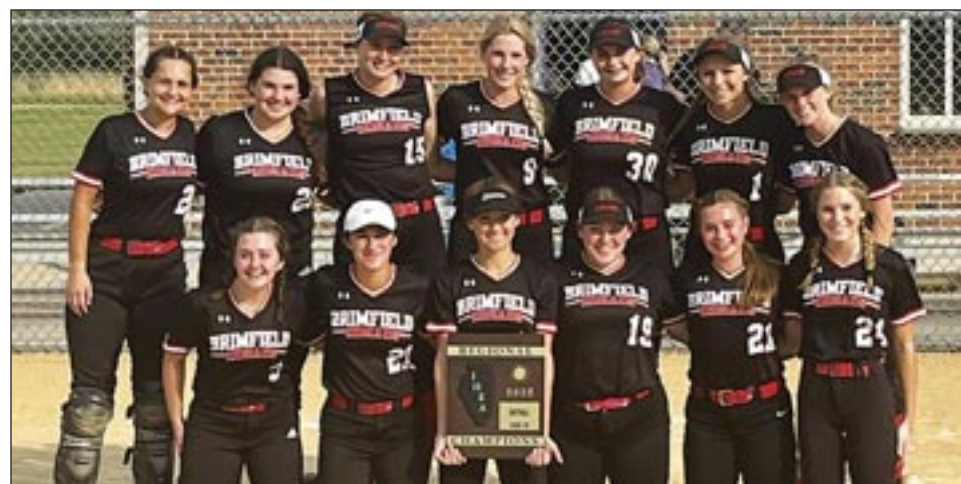
