Capitol News Illinois SPRINGFIELD - Gov. JB Pritzker has signed 401 bills sent to him this calendar year, leaving just 10 of those passed by lawmakers this year awaiting his action as of Monday.

His most recent crop of signed bills included a measure taking aim at wage theft in the construction industry and a pair of bills aimed at increasing access to treatment for HIV.

The wage theft measure, House

Bill 5412, was a major initiative of a regional carpenters' union that allows a worker with a wage theft or fringe benefit grievance against a subcontractor to sue the primary contractor to rectify the situation.

The Mid-America Carpenters Regional Council was the main backer of HB 5412. Minority contractors lobbied against the proposal, which they said would drive up costs and limit work opportunities. Minority groups argued that the measure was a union attempt to drive up the cost of non-union labor.

HB 5412 specifically exempts union projects, homes built on private property where the property owner is the general contractor and projects contracted

through the government.

A follow-up measure, House Bill 4600, was also signed Friday. It exempts any renovations or repairs to existing residential structures, any project that costs less than \$20,000 to complete and construction on any single unit within a multi-family dwelling. It also created the Bond Reform in the Construction Industry Task Force to report to the General Assembly by March 1, 2023. The laws took effect upon the governor's signature.

Vegan lunches: House Bill 4089 requires school districts to provide a plant-based lunch option that complies with federal nutritional requirements to any student who submits a prior request to the district asking for such an option. The law takes effect in August 2023.

Health care visits: Senate Bill 1405 requires that a health care facility must ensure "an opportunity for at least one visitor to visit a resident or patient," even amid Continued on Page 13

Redevelopment plan may expand in P-ville Board to consider scope, payments

For The Weekly Post PRINCEVILLE - The Residential Redevelopment Program in Princeville might become more than just paint. And more than a \$350 reimbursement for homeowners.

Owners of residential properties in certain sections of Princeville might receive from the village up to \$2,500 to help pay for completed exterior physical improvements. During its meeting June 21, the Princeville Village Board is expected to con-

The revision represents a redistribution of current village-improvement funds and an expansion of a proposal the board first considered in early May and discussed again June 6.

Initially, the plan was to reimburse residentialproperty owners for at least part of the cost of exterior paint. Typical maximum reimbursement would have been \$250, with an upper limit of \$350 if the paint was purchased in Princeville.

The addition of other exterior repairs and renovations would harmonize the proposed residential program with a current municipal program for business beautification, Troutman Continued on Page 10

"So. We tried some new products as well and we contacted a few publishers to sell their products. That's the part of the business that took off," Schneider said. "We dropped the used books in 1997 and it's been new products only, since then."

RRC's focal point is providing good materials for private education.





event finally hit the wall. So what. Raising \$111,383 in one day for any cause is still worth applause, particulary in the face of record gas prices, record inflation and now a crashing stock market. Kudos to all who put on the event. ... Brimfield native Travis Kreiter was busy Sunday helping his fiancee, Mina Harigae, take home the largest second-place prize in women's golf history. Harigae finished second at the U.S. Women's Open to earn \$1,080,000 - after having earned \$84,721 so far this season. Kreiter has been caddying for Harigae for more than four years and she credits him with helping her game. "He has a great killer-athlete mentality," Harigae told golfchannel.com. A 2008 Class 1A state golf champ who played at Bradley for two years, Kreiter spent two years on the pro tour and works as an assistant pro at

Superstition Mountain Country Club in Arizona, which is where he met Harigae.

I've heard glowing praise for biodiesel, but what I'd never heard until this spring was the downside to this hybrid fuel. Those lessons were learned the hard way when my previously reliable tractor started conking out whenever I mowed. Turns out, mold, bacteria and fungus can grow inside a tank if fuel sits too long without use. While this can happen with normal diesel, it's more common with bio-diesel products, which are produced from vegetable oils, grease, cooking oils and animal fats. Legends of bio-diesel include vehicles driving around emitting exhaust that smells like french fries due to the cooking oils that made up part of the fuel. That's nice. What's not nice is clogged filters, reduced power and costly repairs. So be warned. There are additives you can put in bio-diesel to help avoid problems of water separation and gunk in the tank. Or you can pay more for real diesel. ... There was one benefit to the tractor being sidelined for several weeks. One of our food plots planted ostensibly for deer-went crazy, flowered and has been attracting all sorts of insects. When I finally went out to mow the overgrown

patch to plant something "better for wildlife," I was excited to see 13 tiny pheasant chicks running ahead of me, as well as a gorgeous rooster pheasant. In a flash, I turned off the PTO and raised the mower deck. Those weeds can stay put until August, when we're all done with nesting seasons and the cute chicks will have grown into gangly adolescents.

The Republican gubernatorial primary is getting uglier. Monday's mail brought an eight-page newspaper printed, apparently, by Darren Bailey's campaign. The paid ad is designed to strike back at comments made by Aurora Mayor Richard Irvin in various flyers and in his own fourpage newspaper, which came a week ago. What's ironic to me is that most candidates act like newspapers are dead. Why then would they use the very same format they belittle in an attempt to boost their campaigns? I'm also curious about the Prairie State Wire website

(prairiestatewire.com) mentioned in Bailey's paper, which has links to several "publications" around the state. Who is paying for all this? ... Parting shot: After this hot weather, I'll be expecting big tomatoes to show up soon. The scale is ready.

Continued from Page 1 suggested. That program has been in effect about five years.

Each fiscal year, the village board has budgeted \$50,000 in tax-incrementfinancing money for the commercial program. That amount would be reduced to \$20,000, with the other \$30,000 transferred into the residential program.

"We're not changing the amount of money, we're changing how we allocate it," Troutman said.

In TIF districts, property taxes that are to go to various bodies are frozen. Subsequent tax increases

and ramps; and demolition of garages and sheds. In some cases, tree removal and repair and replacement of private concrete or asphalt driveways and sidewalks might also be eligible.

Maximum reimbursement would be 75 percent of eligible project costs, not to exceed \$2,500. There would be an application process. Projectcompletion deadline would be 180 days after the Village Board approves an application.

The grant is to be paid upon project completion and verification of how much money residentialproperty owners spent. Only one grant per property would be approved each fiscal year (May 1 through April 30).

During its meeting on June 6, the board discussed expanding the scope of the proposed residential-paint program. It also approved a special-event liquor license, with fees waived, for the Akron-Princeville Fire Department entertainment garden held from June 24-25, during the village's annual Heritage Days festival.

No action was taken regarding the village budget for fiscal year 2023. According to Troutman, deadline for approval is July 31.





Continued from Page 1 a gubernatorial disaster declaration. A clergyperson would not count against the limit. It became effective when signed on May 27.

Health safety guidelines set by a facility, U.S. Centers for Medicare and Medicaid Services and the Centers for Disease Control and Prevention would still apply. A person seeking entry may be required to pass a health screening test and denied entry if they fail.

Rep. Chris Bos, R-Lake Zurich, the bill's chief House sponsor, said in April it was in response to constituent anger over Pritzker's COVID-19 executive orders.

HIV: House Bill 4430 allows pharmacists to order and conduct testing and dispense pre- and post-exposure HIV medications to individuals at high risk for infection. The law takes effect Jan. 1, 2023.

The governor signed that bill the same day he signed House Bill 5549, which requires that for every \$3 million in the state's African American HIV/AIDS Response Fund, the fund must maintain at least one Black-led Center of Excellence HIV Biomedical Resource Hub.

Family bereavement: Senate Bill 3120

expands the state's child bereavement leave act to allow for unpaid leave related to pregnancy loss, failed adoptions, unsuccessful reproductive procedures and other pregnancy-related events. It expands existing law that allows 10 days of unpaid leave for workers suffering losses. The measure will go into effect on Jan. 1, 2023.


Higher education: House Bill 5464 requires state public universities and community colleges to develop and implement equity plans to increase the access, retention, completion and student loan repayment rates for minority students, rural students, adult students, women and people with disabilities. HB 5464 took effect when signed on June 7.

House Bill 4201, which goes into effect Jan. 1, 2023, requires state universities and community colleges to employ "benefits navigators" to connect students to any federal, state or local assistance programs.

Fentanyl testing: House Bill 4556 expands access for pharmacists and other health care professionals to distribute fentanyl testing strips to help reduce opioid overdoses. The measure became effective when signed June 2.





Source of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

Source of Water: Williamsfield To determine Williamsfield's susceptibility to groundwater contamination, information obtained during a Well Site Survey published in 1990 by the Illinois EPA, and Source Water Protection Plan were reviewed. Based on information contained in these documents, fourteen potential sources of groundwater contamination are present that could pose a hazard to groundwater pumped by the Williamsfield community water supply wells. these include Ferrol Gas, Spoon River FS, Farmhouse Gas Station, Sunoco Station, Hart Feed & Milling, Williamsfield Farmers Co-op, Na-Churs Plant Food Com-pany, Country Craft Ceramics, theVillage of Williamsfield, Ingle Construction Co., Wheelhouse Lawn & Garden, Gas & Service Station, unknown machine shop, and Weavers Hardware. Based upon this information, the Illinois EPA has determined that Wil-bereafield Wellie & and #2 and #3 are act suspectible to I/CC. liamsfield Wells #2 and #3 are not susceptible to IOC, VOC, or SOC contamination. This determination is based on a number of criteria including: monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and the available hydrogeologic data for the wells. In anticipation of the U.S. EPA's proposed Ground Water Rule, the Illinois EPA has determined that Williamsfield's community water supply wells are not vulnerable to viral contamination. This determination is based upon the evaluation of the following criteria during the Vulneralability Waiver Process: the community's wells are properly constructed with sound integrity and proper site conditions; there is a hydrogeologic barrier that restricts pathogen movement; all potential routes and sanitary defects have been mitigated such that the source water is adequately protected; monitoring data did not indicate a history of disease outbreak; and the sanitary survey of the water supply did not indicate a viral contamination threat. However, having states this, the U.S. EPA is proposing to require States to identify systems in karst, gravel and fractured rock aquifer systems as sensitive. Water systems utilizing these aquifer types would be required to perform routine source water monitoring. Because the community's wells are constructed in a confined aquifer, which should provide an adequate degree of protection to prevent the movement of pathogens into the wells. well hydraulics were not considered to be a significant factor in the vulnerability determination.





Harmon sets third E-B track record

Thomas Harmon's assault on the Elmwood-Brimfield track record books hit a snag earlier this spring when the annual Journal Star Honor Roll Meet was cancelled due to weather. But last Saturday, Harmon made the most of one last opportunity.

Harmon had hoped to use the honor roll

meet to take a shot at the E-B 1,600-meter record of 4:23.63 set in 1976 by Brad Fryer. Harmon had already set school records earlier in the season in the 400 (50.94) and 800 (1:54.77).



Undeterred, Harmon Harmon traveled to Iowa's

Pleasant Valley High School last Saturday to run in The Belmont Mile, a new event held strictly for mile races. The Brimfield grad won the high school boys race in 4:23.2. While that betters Fryer's mark, Harmon looks even better after converting his mile to the 1,600 (which is actually 9.3 meters shorter than the mile, even though the two are nowadays used interchangeably). After doing the conversion, Harmon's time is an even faster 4:21.67.

E-B Coach Gregg Meyers said Fryer's record was also converted from a full mile, since he posted that time at the state meet in 1976.

"Thomas basically blew it out of the water," Meyers said.

And Harmon's is not the first E-B record

set after the state meet, according to Meyers, who said Paul Hammond's 110 hurdles record of 14.73 came at the Journal Star meet. Meyers also has other unspecific recollections of a record set at a meet in Iowa City.

In the ICAC, Kelch and Bryant were joined on the first team by ROWVA-Williamsfield senior Logan Kuberski. Houlihan and Baysingar were second-team selections, along with ROWVA-Williamsfield senior Wyatt Self. Named honorable mention were Strahm of B-E and R-W junior Graham Wight.

In the Lincoln Trail Conference, East Division honorees were Kuberski and Parker Dickinson of Princeville as pitchers, while position players singled out were Wight and Brian Bertlshofer of R-W along with Gage DeVries and Conner Freres of Princeville.
