Galesburg totals lift Knox sheriff candidate

In James Robertson's primary-election race for Knox County sheriff, Galesburg made all the difference.

Robertson's winning margin in the county's largest city propelled him to victory June 28 in the Democratic primary. The Williamsfield police chief defeated former sheriff's-office deputy Douglas Sampson by 91 votes (1,218-1,127).

Meanwhile, Travis Weaver defeated de facto incumbent

Mark Luft on his home turf in winning the Republican nomination for the 93rd District seat in the Illinois House of Representatives. The district includes most of The Weekly Post circulation area.

One area primary-election winner already has assumed office. Chris Watkins, who won the Republican nomination for Peoria County

sheriff, replaced incumbent Brian Asbell. He resigned July 8.

Watkins, who was a captain in the department, was sworn in as interim sheriff. He is unopposed in the general election, which is Nov. 8.

In the Knox County sheriff's primary, Sampson carried non-Galesburg precincts, 457-427. But Robertson won 791-670 in Galesburg, which counts its votes separately from the rest of the county. This led to a mistaken result The Weekly Post

reported in its June 30 edition.

Robertson, 48, said he focused on Galesburg late in the campaign.

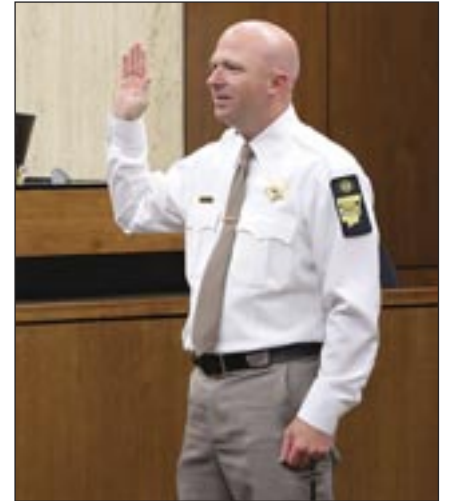
"It's more heavy population," said Robertson, who also is a police sergeant in Galva. "I just went door to door and made contact with individuals who voted in the last couple of primaries and introduced myself. I think that made the difference."

Sampson is from Abingdon, which is more populated than Robertson's native area in

'I bled for this pool'

Fired Princeville boss tells her side of story

PRINCEVILLE – Hillary Hartley's departure as Princeville Aquatic Center manager might have been a matter of time.

A dispute about how long Hartley was expected to be present at the village-owned swimming facility led to her firing, according to her. Hartley was terminated June 13 and replaced by Landon Rice, a student at Knox College in Galesburg.

Hartley was pool manager in 2021 and began this season, in late May, in that role. She said she was on duty at the pool for at least two or three hours daily and had been handling business remotely when she wasn't there.

The 28-year-old Edelstein resident suggested her constant physical presence was unnecessary at the

Peoria to Brimfield

District hires high school principal

BRIMFIELD – The Peoria-Brimfield school-administrator pipeline is flowing again.

Marcy Steele is the new principal at Brimfield

High School. During a school-board special meeting July 6,

Steele was hired to replace Billy Robison. He resigned last month to become principal at Richwoods High School in Peoria.

About 3½ miles west of Richwoods is Mark Bills Middle School, where Steele was principal in the 2021-22 academic year. She had spent her entire

20-year education career in Peoria Public Schools, where she was a teacher and administrator.

But Steele isn't a stranger to small-town education.

The Illinois State University graduate attended high school at Warrensburg-Latham, near Decatur. Her husband, Bryan Steele, graduated from Williamsfield. Their adult daughter is an Elmwood graduate.

"That's like the second half of my career plan, to have a school like a Brimfield so we can devote the second half of my life to that," Steele said. "We love the 1A and 2A schools, the small communities that get behind their schools. That's what we want our life to be. It's

northern Knox County. Robertson said that helped lead to his Galesburg-centric election calculus.

Robertson also cited an endorsement from Knox County State's Attorney Jeremy Karlin as a possible factor among late-deciding voters.

"I truly think it's just a matter of getting out there and knocking on doors and talking to people and putting a face with a name," said Robertson, who resides in the Lake Bracken area south of Galesburg.

Robertson is a former sheriff's patrol deputy and supervisor, among other duties. In the general election, he is to face Republican nominee Jack Harlan and independent candidate Zachary Cox.

The winner is to replace David Clague, a 15-year Democratic incumbent who announced last year he wasn't running for re-election.

As of now, the 30-year-old Weaver has no Democratic opponent. Weaver is former Caterpillar Inc. manager and current small-business owner. The Edwards-area resident also is a son of Chuck Weaver, a former state senator and Peoria City Council member.

The new 93rd District, created following the 2020 U.S. Census, extends from the Pekin area to the outskirts of the Quad Cities.

Among communities in the 93rd are Brimfield, Edwards, Elmwood, Kickapoo, Laura, Williamsfield and Yates City.

In the GOP primary, Weaver defeated Luft 7,440-4,253, or 64 percent to 36 percent. Luft, who also is mayor of Pekin, won election in

Asbell steps down in Peoria Co.

PEORIA — There's a new sheriff in Peoria County.

Chris Watkins was inaugurated July 8 to replace Brian Asbell, who resigned the same day. Watkins was a captain in the sheriff's department. His ascension is considered interim but probably will become permanent following the general election Nov. 8, in which he is running unopposed.

During an upcoming meeting, the Peoria County Board is expected to appoint Watkins officially as interim sheriff.

In the primary election last month, Watkins defeated Jason Buckley for the Republican nomi-

nation. No Democrats have filed to run in the general election.

Asbell, also a Republican, became sheriff in 2017 but declined to run for a second four-year term.

"I will forever cherish the accomplishments made and relationships built during this time," Asbell wrote in his resignation letter. "However, the last couple of years have taken a toll on both me and my family, and I just don't have much gas left in the tank."

"Major operational and budgetary decisions need to be made over the next couple of months, and these decisions will have multi-year implications. The new leadership team of Chris Watkins (needs) to make these decisions, not me."

2020 in the old 91st District. It was relatively compact and included Pekin, East Peoria and most of Fulton County.

The 93rd District covers all or parts of six counties, most of which were new territory for Luft. He carried only Fulton County, but only 141 votes were cast in it. Luft won 79.

Meanwhile, Weaver won 57 percent of Tazewell County ballots (1,929-1,481). Like Robertson did in Galesburg, Weaver employed a door-to-door strategy in Pekin. According to him, that city accounts for about 90 percent of the district's Tazewell County population.

"Door knocking is a great way to get the word out and take the temperature of the local voters," Weaver

stated in an email to The Weekly Post. "Given this, I had a good sense we were going to do well in Tazewell County."

Should no general-election opponents emerge, Weaver is expected to take office in January. His top two priorities are to be improving the state's financial situation and its education system.

"In this strong Republican district, our message of standing up for conservative values resonated with voters," Weaver wrote, "and as a Christian, gun-owning farm kid who owns a small business and was an FFA president, folks had confidence that the conservative message wasn't just talking points, it was backed by somebody who lives it."

*All student health & immunization records must be on file before the start of school.
Examinations: Students entering Kindergarten, 6th and 9th Grades must have a new physical exam on file in the school office before they will be allowed to start school. Students entering Kindergarten, 2nd, 6th, and 9th grades are required to have a dental examination. Students enrolling in Kindergarten or upon first entry into an Illinois school beyond Kindergarten (i.e., grades 1-12) are required to have an eye exam. Please Note: It is also recommended that children entering Kindergarten or Preschool for the first time be lead tested.
Immunizations: One chickenpox/varicella vaccination is required for Pre-School and proof of having had two chickenpox/varicella vaccinations is required for students entering Kindergarten, 6th and 9th grades or a letter from their physician stating they've had the chicken pox. All students entering 6th grade are required to have proof of completion of the Hepatitis B series shots. All students entering, transferring, or advancing into 6th through 12th grades will be required to show proof of receipt of one dose of DTap vaccine (tetanus, diphtheria, acellular pertussis) and proof of receipt of two doses of MMR (measles, mumps, Rubella). All students entering 6th & 7th grades will be required to show proof of one dose of Meningococcal Meningitis vaccine given on or after their 11th birthday. All students entering 12th grade will be required to show proof of two Meningococcal Meningitis vaccines with the second dose being given on or after their 16th birthday. (Only one dose is needed IF the student's first dose was given at age sixteen years or later).

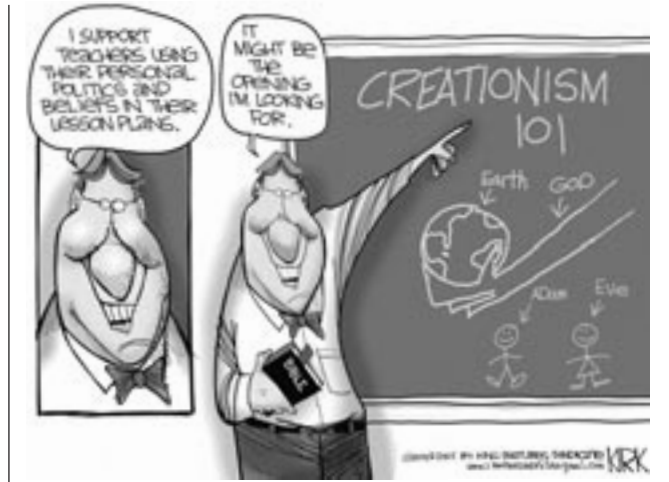

There's nowhere to hide at markets' low tide

Mega-billionaire Warren Buffett has a well-deserved reputation as a genius "value investor" and pithy commentator. His annual reports to Berkshire Hathaway shareholders are highly anticipated for their market insight and expressive language, and often make news because of both.

For example, one of Buffett's most quoted sayings colorfully explains that "You only find out who's swimming naked when the tide goes out."

While followers of the Oracle of Omaha dispute its precise meaning, most agree that Buffett is warning investors not to base their success on just a bull market. Any real test of an investment should include how it performs in a down – or low tide – period.

That advice came to mind recently when examining a list of how the shares of some of the world's biggest ag companies have performed in 2022's decidedly low-tide markets. Many, like the grain processor and merchandiser Archer-Daniels-Midland (ADM), posted a solid price rise through late spring while the overall market, as tracked by the Dow Jones Industrial Average (Dow), slid lower and lower.

In fact, ADM share prices began 2022 at \$70 and rose to nearly \$100 by April 22. Then, as if the winter swim against the market tide had finally taken its toll, ADM shares dropped to \$75 in two months.

Other ag companies not only followed the same pattern – higher from January through late April, then hard declines – most prices peaked on or about the same day, April 20.

For example, Deere & Co., a huge market winner for several years, saw share prices climb from \$373 on Jan. 3 to \$441 on April 20, then sink to \$320 by late June. Similarly, shares of Bunge Ltd., an ADM competitor, began the year at \$94, rose to \$125 on – yet again – April 20, then crack back to \$94 by late June.

Likewise, share prices of Mosaic, a world leader in potash and phosphate fertilizers, rose from \$40 on Jan. 3 to \$78 (on, eerily, April 20) and now trades at \$50.

So what was going on with these strong, against-the-tide swimmers this past winter and what happened on April 20 to convince many of these companies' investors to get out of the water?

The simple answer is the most obvious answer: Higher ag commodity prices led to higher ag company share prices because better commodity prices often lead to increased farmer purchases of inputs like machinery and fertilizer.

That was especially so for wheat. On Jan. 3, July wheat futures were snoring along at \$7.55 a bushel. By May, however, new crop futures had leapt to \$12.80 on war news from Ukraine and reports that famine might soon follow.

By June, though, commodity traders had updated their demand and supply estimates – and re-checked their math – and began to discount famine forecasts. After-

wards, wheat prices sank back to \$9.

Wheat wasn't alone; other key commodities began to show more, ah, bare skin.

Lumber futures prices, once the highest of flyers, splintered from their January mark of \$1,330 per 1,000 board feet to just \$584 on June 27. Likewise, copper futures fell from \$4.47 per pound in January to their year-to-date low \$3.37 on June 28.

And why April 20? On that date, reported Pro Farmer, Federal Reserve Chairman Jerome Powell "blessed a half-point interest rate hike" to "signal support for further aggressive monetary tightening..."

The key word in the announcement turned out to be "further;" markets don't like that word – especially when it arrives unexplained and open-ended.

But the Fed announcement marked high tide. On April 20, the Dow stood at 35,160; two months later it was 29,160, 15 percent lower. Those two months left a lot of investors burnt beet red on the beach.

So what's it mean for markets in the second half of 2022?

our country was still dealing with COVID and we were still unvaccinated, hoping for our lives to return to normal. Last year there was little demand for oil, and prices were very low. Oil companies reduced production and even before Russia invaded Ukraine, supply was starting to lag behind demand.

This year's first-quarter profits for the top five oil companies alone (Shell, ExxonMobil, BP, Chevron, and ConocoPhillips) brought in more

than 200 percent more in profits than in the first quarter of 2021 – more than \$35 billion in profits in just three months.

U.S. gas prices remain low when compared to the rest of the developed countries who are also facing inflation and shortages. The average cost of a gallon of gas in Canada for April-June was over \$6.50. Yes, we Americans are facing financial challenges but we should look at the big picture and be proud to live in the U.S.

Princeville won't co-sponsor 'shred day'

PRINCEVILLE – A community document-destruction event this autumn probably will proceed without village financing.

During its meeting July 5, the Princeville Village Board voted 4-2 not to give the Lillie M. Evans Library District up to \$240 to co-sponsor its first “shred day” in recent memory. It’s to be held Oct. 15 at Cutter’s Grove Park.

The event is to allow Princeville-area residents to have confidential materials, including old tax returns and credit-card receipts, destroyed securely. Fraud and identity-theft prevention are among the goals.

According to Village President Jeff Troutman, the board’s rejection had to do with redundancy.

“We already sponsor a recycle day with village money,” Troutman

said. “I think everybody felt like we already were spending money for recycling, so we don’t need to duplicate it.”

Trustees Ron Delbridge, Lisa Hughes, Donald Peterson and Rick Pope formed the majority. Teresa Gilroy and Nathan Wineinger voted to approve.

The total cost of the shred event is \$240, according to Beth Duttlinger, the library director. Princeville State Bank also is a shred-day sponsor. The sponsors are to split the cost, which meant the village would have spent \$80.

Confidential Security Corp. of Peoria is handling material destruction. Acceptable items are paper, computer disks and towers, tapes and laptops. No cathode-ray-tube monitors will be processed. Materials are limited to 10 boxes per vehicle.

The Village Board first considered the shred-day sponsorship June 21, but Delbridge questioned it before it was tabled.

“I don’t want to be a Debbie Downer or anything, but we give the library quite a bit of money every year,” Delbridge said. “240 dollars is not a lot of money, but...”

Another shred day has been scheduled for April 29, 2023, according to Duttlinger.

Village officials also received three applications for the new Residential Redevelopment Program, the board learned. The program allows owners of residential properties in certain sections of Princeville to receive up to \$2,500 reimbursement for completed exterior physical improvements.

The board approved the program June 21.

how all of us were raised.

“I feel like now is the right time where I could do that for our family.”

Steele’s starting pay at Brimfield is to be about \$88,000 annually, according to district bookkeeper Kyle Petty.

There were six applicants for the job, said Brimfield Superintendent Tony Shinall, who is a former Peoria educator. Robison, too, worked in the Peoria district before he arrived at the Brimfield high school two years ago.

“Brimfield had this appeal even before Tony was there, because it’s not far from my house,” said Steele,

a Dunlap-area resident who has twin teenage sons. “I heard Tony and Billy talking about how much they loved it out there. I was in regular communication with them even before the position came open.”

The district also hired Matt Cox as its transportation coordinator, a new position. He is to oversee the district’s nascent student-transportation program. Brimfield had contracted with outside firms for that service, but financial considerations helped prompt an in-house move.

Cox had been manager at Crossroad Truck Service in Brimfield. His starting salary is about \$70,000 a year, according to Petty.

“He knows the area and he knows

what our route needs will be,” Shinall said. “We’re really excited to have him. He has experience working on school buses.”

The board also approved a three-year contract with the Brimfield Education Association, which represents certified teaching personnel.

In the first two years of the deal, teachers are to receive an aggregate raise of 4.31 percent plus 1 percent of their salary from the previous year, according to Shinall. Teachers are to receive a 4.5 percent across-the-board raise in the third year.

The contract covers about 50 Brimfield employees, said Shinall, who described negotiations as having gone well.

Elmwood woman, daughter hurt in crash

KNOXVILLE – An Elmwood woman and her teen-age daughter sustained injuries in a two-vehicle accident July 4 in Knox County, where a woman was accused of drunken driving. The accident happened about 10:45 p.m. July 4 on Illinois Route 97 near U.S. Route 150 east of Knoxville.

pool, given the manager has two assistants. Hartley, who attends Illinois Central College in East Peoria, also cares for her father and her 3-year-old daughter.
“All I was told was, ‘Hey, we’re having second thoughts. You’re not available to us like we want you to be,’” said Hartley, who appeared to be surprised about her firing. “We want somebody physically at the pool 36 hours (a week) at a minimum.’ I’m like, ‘You want someone to sit there for 36 hours?’
“I see how it can work if it’s somebody who’s

younger, but honestly, you’re sitting. There’s nothing to do.”
The aquatic center is open from noon until 6 p.m. daily until mid-to-late August, weather permitting, for general use. It also is open for private parties and swimming lessons. According to Hartley, about 20 lifeguards work at the center, most teenagers employed part time.
During a Village Board meeting June 21, Trustee Teresa Gilroy announced the aquatic-center managerial change. She leads the committee that oversees the facility located at 620 Princeville Ave. Rice is being paid \$18 an hour, which according to Hartley is \$3 more than what she was earning. Hartley had been hired to

replace Rice’s father, Nate Rice. He left in part because of additional duties he assumed with the Peoria Fire Department. Hartley suggested the elder Rice recruited her to be his replacement.
“Nate did it for 10 years. I thought this was a great, long-term thing,” Hartley said. “When Nate got a hold of me, he told me,

‘You can do this for a long time.’ He said, ‘You’d be good at this.’”
Regarding Hartley’s firing, Gilroy cited issues last year and this year. She would not elaborate, neither during the board meeting nor afterward.
Hartley suggested the issues last year might stem from an incident in which Gilroy visited the center and verbally disciplined employees. Hartley was not there at the time. She said Gilroy was responding to complaints from customers regarding bullies at the pool and the cleanliness of the center’s bathrooms. According to Hartley, she and other employees informed Gilroy the complaints had been handled a week earlier.
“She does not like me, and that’s OK,” Hartley said of Gilroy. “There were hiccups every now and then. I’m not telling you it was a perfect season, but I’ve never, ever had to yell at my kids, not because I’m afraid to be stern.”
Hartley said she isn’t mad at Gilroy or anybody else. Hartley’s biggest regret is leaving behind its employees. Hartley aspires to be an English teacher and believes dealing with teens at the pool has been good preparation.
“I bled for this pool,” she said.

SNAP/TANF HOUSEHOLDS: If the school provided you a letter that stated your child(ren) is eligible for free meals via the direct certification process, you do not have to complete this application to receive free meal benefits. Households that currently receive Supplemental Nutrition Assistance Program (SNAP) or Temporary Assistance for Needy Families (TANF) for their child(ren), only have to list the child(ren)'s name and at least one SNAP or TANF case number and sign the application. If at least one SNAP/TANF case number is provided for any household member, then all children listed on the application are categorically eligible for free meals. Applications listing LINK card numbers cannot be used for free or reduced-price meals.

ALL OTHER HOUSEHOLDS: If a household's income is at or below the level shown on the income scale, children are eligible for either free or reduced-price meal services. Households must provide the following information: (1) the names of all household members; (2) the last four digits of the social security number of the adult household member signing the application, or indicate if the adult does not have a social security number; (3) the amount of income each household member received last month, how frequently it is paid, and where it came from (wages, child support, etc.); and (4) the signature of an adult household member.

The information on the application may be checked by school or other officials at any time during the school year.

Households may apply for benefits at any time during the school year. Households that are not eligible now but have a decrease in household income, an increase in household size, or a household member becomes unemployed, should fill out an application at that time.

Homeless, migrant, runaway youth, Head Start and foster care children, are categorically eligible for free meals. Please follow instructions and return form to school.

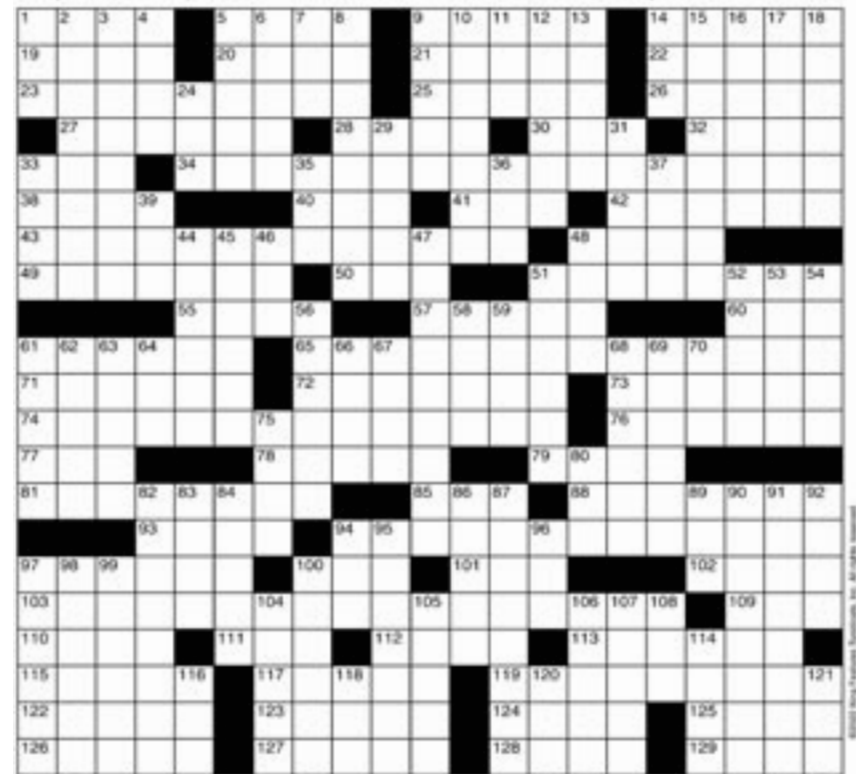

Elmwood street, water employees receive raise

ELMWOOD – Full-time employees of the Elmwood street and water departments are making more money this month than they were last month.

During its meeting July 7, the Elmwood City Council approved pay raises that range from 8.5 percent to 9.4 percent, or from \$1.60 to \$2.50 per hour. The raises were granted to four employees.

Pay for Superintendent Dan Bybee rose by the lowest percentage but by the highest dollar amount. Bethany Lovingood received the \$1.60-an-hour increase (9.4 percent), John Traver received a \$1.65 raise (9 percent) and Jordan Wagner's pay rose by \$1.75 (8.75 percent).

The raises were retroac-

tive to July 1. The four employees work for both departments.

Lovingood handles street-water clerical work, including billing. She also serves in an elected position in which she takes meeting minutes and maintains city records. That job receives an annual salary separate from the street-water pay.

According to Lovingood, raises this year were the same or slightly higher than those each worker received in 2021.

Mayor JD Hulslander noted the current general business climate affected the size of the raises.

"We want to make sure our employees stay our employees," he said. "We have good employees. We want to have good retention. We wanted to make

sure that we take care of them."

During its meeting Aug. 3, the council is expected to consider raises for police-department employees and for Amy Davis, the city's economic-development director.

Last week, the council tabled a decision on whether to renew an agreement with Xstream Communications regarding land it leases on Poplar Street in Sweetwater Park. The company bases some equipment there.

The city wants to assure it's receiving fair market value for the lease, Hulslander said. He wasn't sure

how long the renewed lease might run but believes it's five or six years.

The board also took no action regarding the municipal budget for the 2022-23 fiscal year. A report is expected to be discussed in August, Hulslander suggested.
