## Stark County Board settles lawsuit with Williams family

TOULON – Members of the
Stark County board voted to go
into closed session Tuesday
evening after vice-chairperson
Kari Bush jumped down the
agenda to a "New Business"
agenda item described as: "S.
Williams vs. Stark County et al
Lawsuit Settlement."

The closed session lasted 10 minutes and included attorney Michael Bersani, who represents the county's insurance company, and is believed to have discussed terms of a law-

suit settlement with board members. After returning to open session, Bush returned to the order of the agenda. When the "S. Williams vs. Stark County" item was acted upon, the board merely "approved the terms of the settlement" without discussion.

In 2021, Sterling Williams Sr. and his family filed a wrongful death lawsuit over the death of his son, Sterling Williams Jr. The suit was against Stark County, Sheriff Steven Sloan and jailers Julie Chamberlain and Valerie Wagher. Williams

Jr. was incarcerated at the Stark County Jail in 2019 and placed under a suicide watch.

On May 3, 2019, Williams Jr. committed suicide in his cell at the Stark County Jail and was pronounced dead at St. Luke Hospital, in Kewanee.

Earlier this summer on July 7, a settlement was reached and on Aug. 2 The Prairie News filed a Freedom of Information Act (FOIA) request with Stark County to receive settlement terms. The County's response was, "You can expect the same timeline as your previous FOIA request regarding the Zerla lawsuit, which was approximately 8 weeks. When this information becomes available, it will be provided to you."

In other business, Denny Rewerts appeared on behalf of the City of Wyoming to request ap-

proval of a rezoning of a residential property to commercial. Last month, Rewerts presented a similar proposal but said he failed to do a good enough job.

Wyoming wants to rezone the property located at South Seventh Street and South Street so that a Dollar Tree/Family Dollar store can be constructed there. Previously, the zoning board voted "yes" but the planning committee voted "No." The final vote rests with the county board.

## Dec. 10 deadline set for Toulon sewer lift station


TOULON – After nearly a year of delays, Toulon's lift station project is scheduled to begin construction this week.

The project was originally scheduled to have been completed early last spring, but now with a time extension, contractor Stark Excavating faces a Dec. 10 completion date. Stark Excavating was invited to attend Monday evening's city council meeting, but declined to attend.

In other business Monday, the council voted to increase water and sewer rates with the next billing cycle. The ordinance was passed to increase the fees for water to \$4 per 1,000 gallons with the base rate going from \$20 to \$25. Sewer rates will be raised 3 percent. Last month, Mayor Larry Hollis stated that the rates have not been raised in 14 years.

Only one bid was received for sidewalk replacement in three areas of Toulon and that contractor was Bob's Concrete. Sidewalks targeted for replacement are in front of Lucy Dot's on Washington Street and by the

### Pritzker using abortion laws to lure businesses

SPRINGFIELD - Democratic Gov. JB Pritzker said this week he is actively reaching out to businesses in Indiana and other states that have recently passed restrictive abortion laws in hopes of luring those companies to Illinois.

"Well, already I've reached out to companies that are affected in Indiana. I want to make sure that they know that they're welcome in Illinois, any expansion that they may be looking to do, that we welcome their employees," Pritzker said at a Monday news conference.

His comments came just days after Indiana Gov. Eric Holcomb, a Republican, signed into law a near-total ban on abortions in that state, making Indiana the first state to enact a new law restricting abortion since the

U.S. Supreme Court in June overturned the landmark 1973 decision in Roe v. Wade which had previously legalized abortion nationwide.

Indiana's new law bans the procedure except in cases of rape, incest, fatal fetal anomalies or when the pregnant person's life is at risk.

The day after Holcomb signed that bill, pharmaceutical giant Eli Lilly and Company, one of the state's largest employers, issued a statement saying it would look to expand its workforce outside of its home state.

"We are concerned that this law will hinder Lilly's - and Indiana's ability to attract diverse scientific, engineering and business talent from around the world," the company said. "While we have expanded our employee health plan coverage to include travel for reproductive services unavailable locally, that may not be

enough for some current and potential employees."

That statement helped highlight the growing fallout from the Supreme Court's decision in Dobbs v. Jackson Women's Health Organization, the decision that overturned Roe, exposing both the political and economic consequences of the ruling.

According to the Guttmacher Institute, a research and policy organization that supports abortion rights, Illinois is one of only a handful of states – and the only state in the Midwest – with laws specifically protecting access to abortion services.

Although Indiana was the first state since the Dobbs decision to enact a new law restricting abortion, several other states had so-called "trigger laws" on the books that only went into effect once Roe v. Wade was overturned.

Mower's residence a block to the north. Also, Vine Street is set for replacement across from City Hall. The third location is the sidewalk at Miller and Thomas Streets by the Gerber residence. Total cost of this project is \$25,070.

The city council approved a landscape collection ordinance that provides residential pick-up of landscape waste for residents of Toulon with the following stipulations: landscape material should be placed in paper yard waste bags; branches, limbs, and logs may not exceed 8 feet in length and 2 inches in diameter; landscape waste must

be placed on the curb and will be collected on a weekly basis between April 1-Oct. 31 each year, with pick-up on Mondays. Waste must be placed on the curb prior to 7 a.m. on the collection day; landscape waste is limited to what is generated at the residence being serviced.

The council also approved the final plat for Toulon's new Dollar General store to be located at the intersection of Routes 17 and 91.

A bid of \$1,700 from Saw-N-Logs to remove two trees, one by the Toulon Methodist Church and the other at South Miller Street and East Turner Avenue, was passed.

Approved was a credit card with a

\$1,000 limit for use by Toulon Police Chief Gary Bent and city employee Jake Streitmatter to be issued by a local bank.

Water meter quotes for the purchase of two meters for the Stark County Jail and Toulon's Water Plant was approved for a total of \$2,323.

The public hearing on the new water tower grant has been delayed until further notice by the state.

Two bids were received and tabled for the city's Ford truck with a snowplow that is for sale. The city is going to list the truck on Facebook for sale to see what response is generated for a selling price.

Continued from Page 1 tion by Rewerts, a motion was made but failed due to lack of a second. This month the board approved the rezoning request of Wyoming.

Budget presentations from the county's assessment/zoning officer, circuit clerk, treasurer, and State's Attorney were given. There were no changes in any of the office's budgets with the exception of salary increases.

Sheriff Steven Sloan presented his report stating that the tornado siren will be moved west toward the jail. A new radio tower will be installed where the tornado siren currently is located and two trees "will have to be taken down out there. One is in the way of the new building and the other will be in the way of the (radio) tower."

Board member Robin

Nowlan gave the Highway Department report and said the rock base has been placed, graded and packed for Duncan Road and County Highway 24. Discussion with IDOT continues about the North Valley Road bridge replacement. Investigations continue for possible locations for the new maintenance building.

### California kid enjoys cats, bugs & treehouse

It is always interesting and illustrative to view your own little chunk of the world through the eyes of a seven-year-old. It is especially so when you live on a small Midwest family farm and the seven-year-old lives in Alameda, Calif.

AJ's nephew Ben lives in San Francisco now, but he grew up in Toulon until he was in the seventh grade and spent about as much time here on the farm with us as he did at his own home in town. Ben recently brought his godson Gabe to visit for a week.

Ben had backgrounded Gabe on what to expect on the farm. I worried that he might over-romanticize the glory of playing in the haylofts or trekking through the cow pastures to

play in Walnut Creek. I needn't have been concerned. Within a few hours of his arrival, Gabe had set his own priorities as to what constituted fun. What Ben, AJ and I thought he

would be interested in (haymows, the creek, and calves, respectively) gave way to cats, lightning bugs and a treehouse.

Gabe's family has a lovely home in California, but no yard to speak of. Here he could dash out the door and romp around an acre or so of yard whenever he wanted. His only reference for a farm is the one his grandparents now rent out to farmers who grow strawberries and sweet potatoes. Our acres of tall field corn invited frequent exploration of their long, dense rows.

Gabe is a gentle child and soon won over a couple of our barn cats. The sleek little black female became his fast friend and followed him around the house. Lightning bugs were also a big fascination and something he had not seen before.

"Can we capture one?" he asked excitedly.

I just said sure and went after a pint jar.

On his first day here, prompted by Ben, Gabe began climbing in the big pine tree. Typical of its species, it offered abundant, if somewhat sappy, branches arrayed in multiple levels and angles. Creative and imaginative, Gabe proposed building a treehouse in its welcoming boughs. Earlier in the day Gabe had seen an old pallet in a pile of used lumber, which he insisted would perfect for his treehouse.

The first step was to build a ladder up into the tree. I showed the guys where the scrap lumber was, selected a cut-away milk jug half full of sixteen-penny nails, and pointed out the hammers of various sizes lined up on the bottom shelf of the workbench in the machine shed. I then retreated to the kitchen to prepare lunch. I could hear the tap, tap, tap, bam, bam, BAM of nails being pounded into the trunk of the tree. The taps were tentative at first, but soon a rhythm developed. From the kitchen I could see them working.

Over lunch AJ and I got a detailed update on the construction plans. I then accompanied Ben and Gabe to the worksite. Affixed to the tree were five boards of varying lengths and thicknesses. This was the ladder up to the first level of branches where the treehouse would be constructed. Gabe demonstrated the use of these steps and perched on one of the big horizontal limbs. "Come on up!" he shouted excitedly.

Why my brain chose this moment to disengage from processing information, I do not know. It should have registered that Gabe was a slightly built 7-year-old. Another key fact was that as far as any of us knew, this was the first time he had ever nailed any two things together. Add to that the uneven surface of any bark-covered tree. A simple count of the nails in each board should have alerted me to what was about to happen, but no. My brain could not be bothered with that, either.

The first step was fine. It wasn't too high off the ground, and the board I was grasping seemed firm. The second step wiggled slightly as I transferred my weight to it, but by then I could almost reach a branch. The next step looked to be easy, as it was made of a longer board that extended beyond the trunk of the tree. This was my brain's last chance to redeem itself. Instead, it allowed me to take that big step up onto the long board. As I reached for the branch, gravity kicked in, as it is wont to do at times like this. That nice long board pivoted on the one nail left in it. Instead of thunking to the ground in one compact heap, I sort of slid down the very rough trunk of the tree, being sure to hit each of the steps on my way by.

On the plus side, the ground beneath old pine trees tends to be covered with many years' worth of shed needles. It was on that cushion I landed at last. Oof! After a quick inventory of body parts, I clambered to my feet. Gabe was looking down at me with a somewhat surprised expression. Ben was properly horrified, as I had landed at his feet. The only visible damage was some abrasions to my arms. Later I would find a

series of three deep bruises and more scrapes down my right side. It had been a long time since I had fallen out of a tree.

By this time AJ had finished his farm chores and provided some much-needed expertise and power to the nailing process. After reconfiguring the steps and adding an actual stepladder, originally shunned, as a back-up, we hoisted one of the pallets into place and secured it with a log chain. It fit neatly across two thick branches and needed just a few nails carefully placed and soundly pounded by AJ to make it stable. Gabe spent the next couple days adding scores of nails to the structure.

We did take Gabe along to check cows and tour pastures. As we were preparing to move the herd into a new paddock AJ opened the gate and we all walked through into the fresh

Appropriately cautious of the cows, Gabe asked, "Can those cows access this pasture?" Yes. They can now access this pasture.

The week went by too swiftly, but we had lots of adventures. In the end I hope that what Gabe remembers about his stay on the farm isn't so much about cows or haymows or the creek, or even cats and treehouses, but that it was a fun place to be.

### **INGREDIENTS:**


- 1 pound ground beef

Combine ground beef, beer, and Worcestershire in medium bowl, mixing lightly but thoroughly. Shape into four 1/2-inch thick patties. Place patties in center of grid over medium, ash-covered coals. Grill, uncovered, 8-10 minutes (over medium heat on preheated gas grill, 7-9 minutes) until instant-read thermometer inserted horizontally into center registers 160°F, turning occasionally.

About two minutes before burgers are done, place buns, cut-side down, on grid. Grill until lightly toasted. During last minute of grilling, top each burger with cheese.

Place burgers on bottom of buns; top with bacon slices. Close sandwiches. Enjoy!



KEWANEE - Certified copies of death certificates since 1971 and birth certificates for children born in Henry County since 1971 can be obtained through the Henry and Stark County Health Department office.

"The complimentary record of a child's birth certificate that is provided by the hospital is not a legal document," said Naomi Stahl, deputy registrar.

Parents are required to show proof of the child's birthdate upon applying for security benefits or for a social security number.

"Proof of birthdate is also required for school entrance," adds Stahl, "and a certified copy of the original birth certificate is necessary"

## Squirrel hunting develops outdoor skills

For The Prairie News Let's face it squirrel hunting – that long held traditional way to build hunters and woodsmen has fallen from grace.

R3 and hunter recruitment programs bypass the lowly squirrel in favor of focusing on large game, turkey, waterfowl. By focusing so much on large game many miss out on the critical foundation building that squirrel hunting provides not just young hunters but any new

Squirrels are not glamorous. There aren't Squirrel Pro Staff positions. No Squirrels Unlimited conservation groups. Squirrels and squirrel hunting seem to have lost its "cool" factor. Folks don't seem to see three or four squirrels on your belt or in your vest as the same quality "trophy" as a big buck, a tom with a full fan, strap full of greenheads.

The squirrel has been relegated to lowly little rodent "tree rat" status, and that's extremely sad.

Generations of us began our lifelong love of hunting and being afield as wee little ones tagging along with grown-ups or the "big kids" squirrel hunting. We spent those gays roaming and learning about the forest, it's inhabitants, how to read sign, how to be safe, how to feel successful in bringing home supper all from squirrel hunting.

How many of us remember just how proud we were that Mom fixed a great supper of squirrel, biscuits, gravy, and sliced fresh from the garden tomatoes because we could bring home that meat?

Squirrel hunting sets the stage not just for children, but for any new hunter to develop strong hunting and woodmanship skills. Hunting requires a basic skill set: patience, persistence, self-discipline, camouflage and stealth. The ability to read and understand the signs of your quarry.

The ability to read and understand the rest of the landscape around you. Whether it's a 200-inch buck or 2-pound red squirrel, the basic skill set needed is the same.

In my experience, most of the really good hunters and woodsmen I have come to know all started their time afield trundling along as a little one hunting squirrels. That basic foundation of gun safety, stealth, reading the surroundings, was all built in a hot, buggy, late summer

Here's five good reasons why squirrel hunting is the ideal way to introduce youngsters to hunting.

1. Chance for success is high. We know that if youngsters are not successful harvesting game, seeing game, interacting with game the odds of them wanting to stick with it are just about zip. Squirrels are plentiful. While there is the learning curve of proper shot placement, the opportunity for available shots that lead to success is high. Because the chance for success is high it helps to build confidence and gives young ones the chance to proudly bring home supper for the family.

2. There are more opportunities for squirrel hunting. There are no Quality Squirrel Management Areas. No special fees, tags, permits, lotteries or drawings to hunt squirrels. They are found here there and yon. There's not a packed parking lot at the local SFWA with squirrel hunters all vying for just the right spot.

Any reasonably managed piece of public can and will produce squirrels. Landowners who would never allow someone to hunt deer, turkey, or waterfowl on their property, often will allow a squirrel

hunter to make the occasional foray through the woodlot or along the fence

Especially if the little bushytails have been sneaking into mama's garden from the fence row wrecking the tomatoes and stealing all her pears.

3. More tolerable weather. Yes, it can be darned hot, humid and buggy. However, hunting early in the day or evening goes a long way to solve those issues. It's hard to keep a young one interested in the outdoors or hunting if they are cold and miserable or bundled up to the Michelin Man degree of roundness and can't move. Done squirrel hunting for the morning? What the heck throw in a quick, barefoot, rolled up pant leg, wade in a creek for cooling off and just a little more fun in the woods before heading home.

4. Low entry investment. It doesn't cost half the family coffers to get a young one set up to squirrel hunt. Study boots/shoes, lightweight pants and shirt (worn thin hand me down camo works even better as it's cooler) a hat, a can of bug spray and you are set. The ability to use a lower cost entry level firearms like a .22 or a youth model shotgun also helps to decrease the entry cost.

5. The environment is vibrant and full of interesting things. Because of the timing of squirrel season, the woods are vibrant, rich, full of all sorts of things kids find downright cool. Snakes, spiders, birds, other small game, baby animals out learning their place in the world. Frogs, crawdads, mushrooms.

Lots of things that can be incorporated into fun learning. If interest in squirrels alone begins to wane, there's something new and cool to check out just around the corner in the trail.

It's much easier to keep a child interested when plenty is going on around them than just sitting endlessly waiting for one deer to walk by or a flock of ducks to make an entrance. This same vibrant living landscape makes for great opportunities to learn tree, plant, and mushroom identification easier than in a empty desolate winter hunting environment.

Let's all do our part to introduce one new person to the fun of squirrel hunting this year shall we?



Several new programs will be offered, including a bluebird trail building workshop, a prairie walk and a humorous talk on the relationships between T-Rex, Wild Turkey and our ruby-throated hummingbirds.

The focus of the children's program is a scavenger hunt that begins with the making of a hummingbird at The Commons. Children, and the young at heart, will then have a challenge to find flowers from all three seasons, all around town, and then make their own flowers at VASA and the Methodist Church to succeed in their annual migration north to south and back again. There will be prizes for those who complete the migration successfully.
