## BUSHYTAILS BUILD SKILLS

### Squirrel hunt to teach kids outdoor skills

Let's face it, squirrel hunting – that long-held traditional way to build hunters and woodsmen has fallen from grace. Squirrels are not glamorous. There aren't Squirrel Pro Staff positions. No Squirrels Unlimited groups. The squirrel has been relegated to lowly "tree rat" status, and that's extremely sad.

Because squirrel hunting sets the stage not just for children, but for any new hunter to develop strong hunting and woodsmanship skills. Hunting requires patience, persistence, self-discipline, camouflage and stealth. You need to read and understand the signs of your quarry and the landscape around you. Whether it's a 200-inch buck or 2-pound red squirrel, the basic skill set needed is the same.

Generations of us began a lifelong love of hunting and being afield as wee little ones tagging along with grown-ups or the "big kids" while squirrel hunting. We roamed and learned about the forest and its inhabitants, how to read the signs of animals, how to be safe and how to bring home supper – all from squirrel hunting. How many remember being proud that Mom fixed a great supper

of squirrel, biscuits, gravy and fresh-sliced garden tomatoes because we could bring home that meat?

Most really good woodsmen I have known started their time afield hunting squirrels. That basic foundation of gun safety, stealth and reading the surroundings was all built in the hot, buggy, late-summer woods.

Here are five good reasons why

### Pipeline foes

Opposition to CO2 pipeline rising as Sept. 1 hearing approaches

WILLIAMSFIELD – John Feltham does not want a CO2 pipeline built across his Knox County farmland. He doesn't even want the Navigator CO2 Ventures pipeline near his farm overlooking the Spoon River north of Williamsfield.

"No amount of money Navigator offers will return my land to its pre-pipeline state.

Navigator wants to construct the Heartland Greenway Pipeline across slightly more than half a mile of our farm, through ground that is classified as highly erodible," Feltham said.

"Because of the damage the pipeline will cause to my farm, I am doing everything I can to prevent Navigator from constructing this pipeline."

And the retired U.S. Marine Corps colonel is not alone in his opposition. According to Hannah Lee Flath of the Illinois Sierra Club, five Illinois townships have filed resolutions opposing the pipeline heading into a Sept. 1 pre-hearing conference with the Illinois Commerce Commission (ICC).

## Who owns Princeville museum land?

PRINCEVILLE – Village officials might dive into history to determine who owns the land where the Princeville Heritage Museum sits. Whether the village will reimburse the museum \$8,000 for a maintenance project might hinge on the answer.

Museum officials requested the village cover the entire cost of recent blacktop work outside the facility at 325 N. Ostrom Ave. The Historical Association of Princeville

is the not-for-profit group that oversees the museum and the adjacent restored and relocated Akron Townhouse School building.

The blacktop project is eligible for municipal tax-increment-financing funds. But during a Village Board meeting Aug. 16, it became clear the ownership status of the museum property is murky.

According to Village Treasurer Julie Delbridge, tax bills state the museum owns the land. But Chad Gardner, the village superintendent of public works, said the municipal-

ity owns the property and leases it to the museum for a nominal fee.

Village Trustee Ron Delbridge said the terms of the lease as Gardner presented them jive with what he's been told previously.

Just as cloudy as the ownership question might be how it affects a potential TIF payment to the museum. Neither Ron Delbridge nor Gardner were sure about the ramifications if it's determined the village owns the property.

"It's an eligible project, but if we own it, there could be issues there,"

# SQUIRRELS: Chance for success is better

squirrel hunting is the ideal way to introduce youngsters to hunting.

1. Chance for success is high. We know that if youngsters are not successful harvesting game or seeing game, the odds of them wanting to stick with it are just about zip. Squirrels are plentiful. While there is a learning curve of proper shot placement, the opportunity for available shots that lead to success is high. That helps build confidence and gives kids a chance to proudly bring home supper for the family.

2. There are more opportunities for squirrel hunting. There are no Quality Squirrel Management Areas. No special fees, tags, permits, lotteries or drawings to hunt squirrels. They are found here, there and yon. There's not a packed parking lot at the local SFWA with squirrel hunters all vying for just the right spot. Any reasonably managed piece of public can

and will produce squirrels.

Landowners who would never allow someone to hunt deer, turkey, or waterfowl, often allow a squirrel hunter to make an occasional foray through the woodlot or fencerow — especially if bushytails have been raiding mama's garden.

3. Weather is more tolerable. Yes, it can be darned hot, humid and buggy during the early days of Illinois squirrel season, which runs from Aug. 1 to Feb. 15. However, hunting early in the day or evening goes a long way to solve those issues. Besides, it's hard to keep a young one interested if they are cold and miserable or bundled up to the Michelin Man degree of roundness. Done squirrel hunting? Go for a quick, rolled-up-pant-leg wade in a creek for cooling off before heading home.

4. It's affordable. It doesn't cost half the family coffers to get a young one set up to squirrel hunt. Outfit

with sturdy boots or shoes, light-weight pants and a shirt (worn thin, hand-me-down camo works even better, as it's cooler) a hat, a can of bug spray and you are set. The ability to use entry-level firearms like a .22 or a youth model shotgun also helps to decrease the entry cost.

5. Because of the timing of squirrel season, the woods are vibrant and full of all sorts of things kids find downright cool. Snakes, spiders, birds, other small game and baby animals are out learning their place in the world. So if interest in squirrels begins to wane, there's usually something new and cool nearby. It's much easier to keep a child interested when plenty is going on vs. sitting endlessly waiting for a deer or a flock of ducks to make an entrance. This same vibrant landscape offers opportunities for tree, plant and mushroom identification not present in a desolate winter environment.

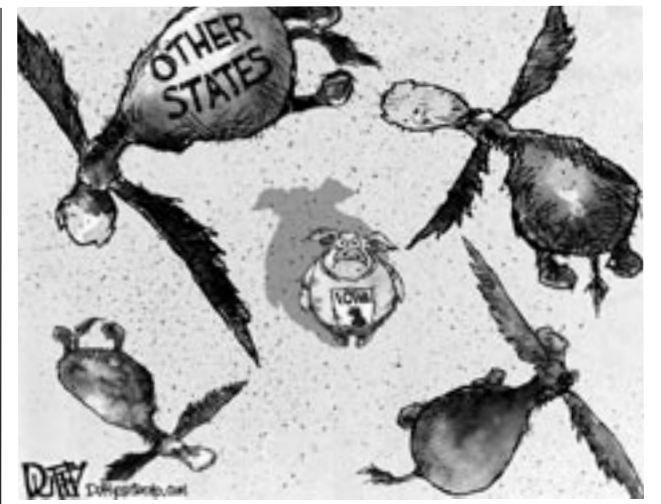

# Stop the world, I want to get off

Even though we are overall much better off than our grandparents in wealth, health and lifespan, many of us are unsettled, deeply concerned, even jittery about how the movie of life is playing out. Stop the world, I say, I want to get off.

First, some context. From reptiles to humans, we animals are continually scanning the horizon for threats and opportunities. We absolutely crave information. That is why, according to research firm Statista, Americans on average spend four or more hours a day on our smartphones.

Underneath, it's a survival thing. When television came into our homes post-World War II, the world shrank. Prior to that, we lived our lives largely confined, somewhat comfortably, in our own communities. By printed, rather impersonal newspapers, we heard about earth-shaking events such as Krakatoa (1883) and recurrent wars in Europe.

Today, thousands of satellites beam happenings worldwide to our pockets and wrists almost simultaneously, overloading our brains with mayhem and scary possibilities. Unsettling.

Second, the rate of change in society has been accelerating lickety-split (a technical term). For most of human history, nothing, or very little, changed in the life span of most humans. Then, with the Renaissance in the 14-15th centuries, the

Enlightenment, Industrial Revolution, flight, and radio-TV, change took off.

Personal computers are only a few decades old (remember the Apple computer of the 1980s?), and Facebook has been with us less than 20 years.

Third, the nano-world of science is incomprehensible to me, and thus unsettling. One thousand cells can sit side by side on a gossamer hair on the back of your hand, and within each cell is six miles of spooled DNA! And scientists can now, with some precision, snip into that coil of DNA, take out and replace defective genes.

Magic.

Fourth, information sells. After all, social media and advertisers are in the eyeball business. So, the social media platforms suck us into scrolling through our devices even more of the time.

And when it comes to information, fear trumps nice every time. Again, a survival thing.

For social media, this means, for reassurance, that on social media we tend to retreat into echo chambers of like-minded people. And we come to fear and loathe those who don't agree with us. We call it polarization.

Stop the world, I want to get off. But we can't. So, what to do? What might calm the waters (and relieve my jitters)?

Many of us retreat to Florida, and try to forget about all this. We love our grandchildren, we declare, yet leave what we have wrought for them to wrestle with.

We could use, and might follow, a charismatic leader who would take

us out of this scary morass. Yet, such captivating leaders can be either good or evil, as we have seen through history.

Or, we could use a secular Great Awakening, such as the two, broad, religious revivals of spirit in early American history.

Until recent years, I had hoped that Colin Powell might be that leader who would awaken the better angels of our nature. But it wasn't to be, and I can't think of anyone else of that reassuring, dignified and calm stature.

So, the opposite of giving up is "pitching in" to address our problems. We could start a new political party, which would be radical in the sense that its mantra would be, simply, "Settle down, we can handle this, together."

My cynical, practical friends who think they know much about politics would say that musings such as these are pure fantasy, yet they have nothing to offer in rejoinder, other than more cynicism.

I keep wrestling with this. We can't step off the world, and we can't give up.

# PRINCEVILLE: Board approves two TIF requests

Ron Delbridge said.

In TIF districts, property taxes set to go to various taxing bodies are frozen. Subsequent tax increases are diverted into a fund used for infrastructure improvements.

Trustee Delbridge suggested the board table the museum request, which it did. The board is expected to consider it again Sept. 6.

"We'll find out for sure who owns it. We can't pay ourselves," Delbridge said.

What appears more definitive is who owns the land upon which the Akron schoolhouse sits. The village

and historical association are 18 years into a 99-year lease, according to Julie Delbridge. The association pays the village \$10 a year.

Ron Delbridge chaired the board meeting as village president pro tem. Village President Jeff Troutman was on vacation.

The board had no problems with or questions regarding two other requests for TIF money. It voted to approve \$1,367.25 to help pay for garage-roof replacement at a residence at 516 W. Evans St. and \$2,500 for house-and-garage siding replacement at a residence at 117 N. Stanton Ave.

Both projects were eligible for village reimbursement under the recently enacted Residential Rehabilitation Program.

The board also approved a \$5,000 payment to Jacob Wilson and Spencer Wilson for constructing a house in the newest section of the Aten Acres subdivision. The village incentive was part of an effort to spur lot sales in the subdivision, Delbridge said.

For incentive eligibility, lot owners had to commence construction within one year after purchase and complete it within a year after it began.

# PIPELINE: Illinois path passes through 13 counties

The ICC is a quasi-judicial body that is responsible for regulating several industries, as directed by the Illinois General Assembly. According to the 2011 Carbon Dioxide Transportation and Sequestration Act, the ICC must take local landowners' concerns and objections into account before approving a permit and allowing the use of eminent domain.

As a result of the filing, Navigator can contact landowners for easements. Certified letters have been sent to landowners along the proposed pipeline, which would transport liquified CO2 across 240 miles and 13 counties in western Illinois to be stored underground in Christian County.

The route includes Knox County, primarily along the Spoon River corridor. Feltham is president of a group called Citizens Against Heartland Greenway Pipeline, which filed a petition for leave to intervene last week. That's because the ICC will only hear objections from land-

owners or other legal "intervenors."

And Feltham feels strongly about intervening. He believes the pipeline will do long-term damage, despite Navigator's assurances they will make every effort to return farmland to its previous condition.

"Essentially, it's the same principal as repairing a car after a wreck," Feltham said. "A wrecked, repaired car is never the same after the wreck."

Feltham also questions the effectiveness and motives of CO2 sequestration, has concerns about the storage site and worries about the dangers of a pipeline rupture. What's more, he doesn't think the pipeline is as "green" as Navigator claims.

"It's an eco-friendly masquerade," he said. "This is a mercenary, for-profit venture designed to make money off tax credits, selling CO2 for industrial use and probably trying to sell what are called carbon offsets."

But Feltham does not believe the pipeline's future is a certainty, which is why he is speaking out prior to the ICC's review of the situation, which

starts Sept. 1 at 11 a.m. in Springfield and can be viewed online at [illinois.webex.com/meet/nicole.roth2](http://illinois.webex.com/meet/nicole.roth2).

The Illinois Farm Bureau (IFB) has not taken a stance on the pipeline.

"Now that Navigator has filed for approval of the Heartland Greenway carbon dioxide pipeline, IFB staff will review the filing and monitor the regulatory approval process before the ICC," said Richard Guebert Jr., IFB President. "IFB previously conducted landowner education meetings for our members along the pipeline's proposed route. The meetings helped our members understand how to work through the approval and easement negotiation process. We will continue to provide information to our members as the process continues."

Negative reaction to the pipeline is widespread in Iowa, where 36 of 56 Iowa counties the pipeline would pass through have filed objections with state regulators, according to the Iowa chapter of the Sierra Club.

A call to a Navigator spokesperson was not returned.

**Woman arrested on drug charges in Farmington**

FARMINGTON – A Pekin woman was arrested in Farmington on drug-dealing and drug-possession charges, according to police.

Brooke E. Turpin, 27, was a passenger in a 2018 Toyota sedan that Farmington police stopped about 12:15 a.m. Aug. 21 on S. Main St. because of a suspended vehicle registration. The driver – Aaron J. President, 31, of Peoria – was found to have an active Fulton County warrant for driving on a suspended license.

When Farmington police searched the vehicle, they found bags that contained 58.25 grams of methamphetamine, 24 grams of marijuana and 3.2 grams of cocaine, a report stated. Also found was \$579 in cash and a syringe loaded with meth.

The narcotics were found in the front-passenger area, where Turpin was sitting. She slurred her speech and was unable to remember her telephone number, according to the report.

Turpin was accused of intent to deliver between 15 and 100 grams of meth, possession of meth, possession of a controlled substance, possession of drug paraphernalia and possession of adult-use cannabis in a motor vehicle outside of an approved container.

President was accused of operating a motor vehicle with no insurance; driving with a canceled, suspended

or revoked license; and failure to appear in court. He and Turpin were transported to the Fulton County Jail in Lewistown.

## COVID did not kill football!

After lamenting turnout in 2021, coaches see better numbers this fall

Last year, coaches in this same space were fretting about the future of high school football. Numbers were down. Injuries dominated the conversation. And eight-man football was all the rage.

Twelve months later, some teams are still turning to the eight-man game and measures are still being taken to make the game safer. But at least locally, turnout for most programs playing 11-man football is the best in years.

Farmington doesn't have enough varsity jerseys for its 87 players. Princeville has the best turnout in Coach Jon Carruthers' career. Elmwood has a big group of freshmen, as does Stark County. And ROWVA-Williamsfield has 48 players – including nearly one-fourth of the 80-student high school population in Billtown.

What gives? For one thing, practices are not what they once were. There's no Hell Week anymore. Not even Heck Week, really. My youngest is a freshman at Elmwood and spent about 15 hours in football practice during "Hell Week." In those same five days, he spent 25 hours in marching-band practice (can one suffer lip injuries from too much trumpeting?).

Then too, measures to make the game safer are real. Newer helmets. Funny-looking foam pads on top of the helmets. All are designed to decrease concussions. All are needed.

"The truth is, football is safer than it ever was," Farmington Coach Toby Vallas said. "Before, we might have thought football was dangerous. After COVID, we know what's really dangerous – staying home and being isolated."

At Farmington and elsewhere, kids are coming out to play football just to be active, outside and around their



friends. Sure kids today still play too many video games, but many are sick of sitting at home alone, as they did through so much of COVID.

Not just boys, either. More girls have started coming out for football, including one at Farmington and two at Princeville. Both are firsts for those programs.

For those of us who enjoy the spectacle of Friday Night Lights, renewed interest in the gridiron is an encouraging trend.

**Too few officials** – Less encouraging is the steady decline in the number of officials available to work high school football games. While there are more high schoolers coming out to play and enjoy the company of friends, there are fewer grownups willing to get yelled at every week for a few bucks.

That shortage has created major scheduling problems, forcing some schools to move games to Thursdays, Saturdays and even Sundays, in a few cases. As many businesses have learned in this post-pandemic era, hiring and retaining employees is tough unless you increase pay. In the case of officials, it would also help if loudmouths would shut up.

**Crystal ball** – The area's top team once again looks to be Farmington,

which has gone 53-7 since 2016 and twice reached the quarterfinals. This year shows no dropoff, as the Farmers lead the area in turnout and have veteran leadership at many key positions. Plus, quarterback Gage Renken is more of a threat to run, which makes the always dynamic Farmers offense even tougher to defend. Nobody racks up more chunk plays than Farmington.

That said, the Prairieland favorite Farmers face a test this Friday at Mercer County, which is picked to win the Lincoln Trail Conference. With a win, Farmington could be headed to another unbeaten season.

But there is also reason for optimism in Elmwood-Brimfield, Princeville and ROWVA-Williamsfield, all of whom have a realistic chance at making the playoffs if things go right during the season.

**Et cetera** – Grandparents are sure generous. During the annual Elmwood-Brimfield player auction last week, one pairing of Trojans fetched a record \$2,100 while another pairing brought \$2,000. ... Abingdon-Avon has installed a new grass field, but grass has been slow to grow and the Torandoes will have to play their first home game vs. Stark County in Galesburg on Sept. 3 at 6 p.m.

# Experienced Elmwood has 6 back on OL

ELMWOOD – If experience matters, the Elmwood-Brimfield football team should matter quite a bit this season.

The experience on the sidelines has long been evident. Todd Hollis is beginning his 24th season as the Trojans' head coach. His staff is filled with assistants who have coached with him for years or who have played for him.

But on the field in 2022, E-B is likely to have plenty of youthful grey-beards.

On each side of the ball, E-B returns eight starters from a 6-4 team that qualified for the Class 3A state playoffs last season. E-B lost a first-round game 28-16 to Chicago Clark.

Although 2021 ended relatively well despite that defeat, it didn't necessarily begin that way. E-B had only five seniors among its 40-some players.

"Last year when we started, we probably had three starters returning, and a couple of those guys were playing different positions than they played the year before," Hollis said. "You're just trying to get guys lined up in the right spot. Now we start this summer and we're off and running."

Or off and blocking, perhaps.

E-B has six returning starters among its seven offensive linemen, according to Hollis. The only newbie is junior Edwinn Strong (6-foot-1, 310 pounds).

The returnees are sophomore Aaron Brown (6-2, 280), junior Elijah Davis (6-0, 260), senior Mason Geeseman (6-1, 225), senior Caleb Hollis (6-2, 240) and senior tight ends Jerry Harkness (6-0, 145) and Tyler Scheps (6-1, 165). All are projected to start the season opener Friday in Carthage against Illini West.

"Really, at the end of the day, it's the linemen," Coach Hollis said. "If your linemen are locked in ...

"I told the whole team that the most difficult and most important position on the field is the offensive line. Those guys are the group that absolutely has to function as a unit. And the fact that we have six of the seven returning, that makes it pretty easy."

The E-B offensive line is expected to open holes for senior running backs Gavin Buhl (5-11, 180), Aiden Frail (5-8, 140) and Slone Windish (6-0, 185). The latter two are returning starters. Senior Oliver Heinz (6-3,

185) is in his first season as starting quarterback.

Buhl, Frail, Heinz and Windish are among 12 seniors on a 61-player E-B roster. Each school in the co-op accounts for about half the roster, according to Hollis.

"With all these guys back, I don't know if we're going to be trying to do a little bit more, because we have the guys that we can do a little bit more with, or will it be like, 'Let's just settle into what we are and get even better at it than we ever have been,'" he said.

The E-B experience is not limited to offense. All the Trojans' projected starting linebackers this season are returnees: senior Rohman Mitchell (5-5, 155), sophomore Bo Windish (5-11, 165) and Slone Windish, one of six two-way projected starters overall.

Returning starters at defensive back are Frail, Heinz and fellow senior Jacob Avery (6-1, 145). Buhl is to join them as starters this season. Caleb Hollis, Strong, senior Travis Howard (5-11, 210) and sophomore Erik Vazquez (5-11, 175) are to form the first-string defensive line.

Juniors Layne Durst (5-10, 155) and Bailey Elwell (5-11, 155) are expected to help provide depth at running back and on defense.

Having so many veteran players helps facilitate verbal interaction during practice and games, according to Todd Hollis. He considers that aspect almost as important as physical ability.

"Once you get all that experience and you've been coached for a year – or for some of our guys, two years – that communication is so key," Hollis said.

"It's not just talent on the field, it's talent communicating with each other so that everybody truly is moving, 11 guys doing what they're supposed to do. It expresses knowledge of the game."

That knowledge will be tested almost immediately.

Home games Sept. 2 against Rushville-Industry and Sept. 30 against Macomb followed by a trip Oct. 7 to Farmington probably will help decide Prairieland Conference supremacy. That doesn't mean Hollis is bypassing Illini West, historically among the top small-school programs in Illinois.

"Week 1 is still Week 1," Hollis said. "As talented as I think we are and all the experience and all that, until you go out there the first night, you still don't totally know what you have."

# Farmington features strong, deep group

FARMINGTON – Chunk plays have been a constant for Farmington in recent years, when seeing the Farmers gash foes for multiple 50- and 60-yard scores in a game has not been unusual.

This year the Farmers might grind a little more. Because if there is a dropoff in team speed, these Farmers figure to make up for it with strength.

“We were awfully fast last year. I don’t know that we can match that kind of explosive play from last year, but I think we can be good in other ways,” Coach Toby Vallas said. “This is one of our strongest teams.”

Prior to the construction of a new weightroom, the Farmington program had a problem: how to fit its deep roster of players in one space at the same time. With the weightroom finished, last summer there was room for everybody. And more lifting means more strength.

“I don’t think we had less than 80 kids in the weightroom all summer,” Vallas said.

Among those pumping iron regularly was senior quarterback Gage Renken, who added 15 pounds of muscle to his 6-foot frame, according to Vallas. Being stronger makes Renken more of a threat to run – a headache for foes since the quarterback was so good passing as a junior. He completed 81 of 142 passes for 28 touchdowns and 1,601 yards along with just four interceptions.

“I think he was excellent as a first-year decision maker, but now he’s got so much thicker, so much stronger and so much faster,” Vallas said. “We held him back on the ground last year, but he’ll be a true dual threat now.”

Renken ran for 477 yards and seven TDs last year, making him the top statistical returnee in a backfield that will include senior Rese Shymansky (6-0, 215) and junior Jack Wheelwright (6-0, 190), with occasional carries going to Logan Utt and senior wideout Logan Morse. Shymansky is a pounding back while Wheelwright is a speedster who is dangerous in open space.

The same can be said for Morse, who last year had 18 catches for 428 yards and six touchdowns but was also dangerous on returns and as an occasional ball carrier.

“He’s just lightning quick and has such a nose for the ball,” Vallas said.

Another primary pass catcher figures to be 6-4 junior Keauntrey Barnes, who has combined confidence to go with his great leaping ability and “has really



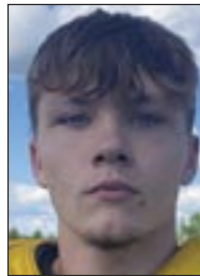

come on,” Vallas said.

Up front on the offensive line, Farmington returns two starters in senior center Virgil Haggard (5-9, 225) and senior right tackle Sam Gronewold (6-0, 200). That leaves three jobs to be filled by newcomers, including two sophomores stepping in at guard: on the right side is Aiden Shepherd (5-10, 190), while 6-5, 310-pound Caden Mowen will play left guard. Top candidates at left tackle are senior Kaden Larmore (6-0, 200), who has returned to the district, and senior Sam McMillin (6-3, 220).

“We’re not huge (on the offensive line), but we’re definitely bigger than last year,” Vallas said.

The Farmers actually return more experience on defense, with five starters and six top tacklers returning.

One of the most improved is senior cornerback Collin Terrell (5-7, 175). Though he had 20 solo tackles and 28 assists in a starting role last year, most of that came in the regular season. In the playoffs, Terrell saw less time and Vallas explained to him that he wasn’t fast enough.

Instead of sulking, Terrell hit the weightroom hard and changed his physique. “He might be the best player on our defense now,” Vallas said. “It’s ex-

actly how you want a kid to respond.”

Logan Morse also started in the defensive backfield last fall and will be joined by the likes of Kaden Runyon, Connor Huber, Zac Taylor (an athletic, 5-8 dunk master in basketball) and Kyle Litchfield.

The next-most-changed athlete for the Farmers is Tanner Kenney, a 6-1, 215-pound linebacker.

“He has added a ton of muscle ... and he was damaging already before that,” Vallas said.

Shymansky, Wheeling, Dane Hitchcock and Hunter Darsham are other likely linebacker starters.

The defensive-line rotation will include returning started Gronewold, Haggard, McMillin, Gabe Thompson, Larmore and Darsham.

With a good amount of experience back in key positions, Vallas said success will hinge on how well this group handles adversity and plays on the road. The first test comes in the opener against a Mercer County team picked to win the Lincoln Trail Conference.

“They’ve got almost everybody back and they’re a very scary team to play right away,” Vallas said. “Last year it seemed like a lot of the tough games were at home. It’s just the opposite this year.”

## New positions, new players for Princeville

PRINCEVILLE – Jon Carruthers said it was a good idea to stay away from him during the first week of practice. In addition to losing nine key seniors to graduation, the Princeville coaching staff is this year moving several players to new positions.

As a result, coaches have spent a lot of time working on basics and technique instead of team offense and team defense concepts. During week one, things were not going so well.

But by the end of week two, Carruthers was a much happier coach.

For one thing, the turnout of 52 players is the biggest in Carruthers' tenure and includes a sizable frosh-soph contingent. More importantly for this year, Carruthers said his team is figuring things out.

"We took it pretty slow this summer and did a lot of technique work, and I think it has paid off," Carruthers said. "You've got to have technique. You've got to see little things before you can start to see the big picture."

The big picture for Princeville is that it figures to be part of a six-team pack competing to be in the top half of the Lincoln Trail Conference behind pre-season favorite Mercer County and Knoxville – the two biggest schools in the league.

"I really think that every week we're going to be in a ballgame where it's going to come down to the little things," Carruthers said. "It could be a penalty or a turnover or something and we have to minimize those."

On offense, the Princes return five starters, though Jordan Johnson is moving from quarterback to wideout. The bulk of the experience is on the offensive line, where senior Leo Johnson (6-foot, 230 pounds) is back at center, senior Kellen Francis (6-4, 300) is back at right tackle and senior Zach Menold (6-1, 200) is back at left guard.

Newcomers on the line will be junior right guard Denzell Garza (5-11, 210) and sophomore Logan Olshawsky (6-0, 185) and junior Brayden Harmon (6-0, 210), who are splitting time at left tackle.

They will be blocking for a pair of speedy running backs who held down two legs of Princeville's state-qualifying 4x100 relay last spring: senior Marcel Primera and junior Tayshaun Kieser. Kieser has the most experience, carrying 65 times last fall for 370 yards and one score. The other top back is

senior JT Snyder, a first-year player.

"We've got some speed, but it's hard to tell what we've got since they haven't had much varsity experience," Carruthers said.

Taking over at quarterback is junior Logan Carruthers (6-0, 160), who has shown flashes of passing ability despite being the son of a run-first head coach. Jordan Johnson will also take snaps at quarterback.

"I think this team has the ability to be balanced running and passing the football, and that's really what we want to be," Coach Carruthers said.

The pass-catching crew is a crowded one, with seniors Jordan Johnson, Marcus Daily, Griffin Crear, Ayden Herrmann and Liam McGrath all candidates to see action. McGrath, however, is the only member of the group to catch a pass in a varsity game last fall.

If offense seems unsettled, defense is even more so according to Carruthers.

"We have a lot of change on defense," he said. "And a lot of ironman football over here."

That's in reference to all the two-way starters at Princeville, where 35 of the 52 players on the roster will compete

primarily at the frosh-soph level.

The strength of the defense will be up front, where Leo Johnson and Garza will play defensive end and Francis returns to plug the middle at nose guard.

Behind them are five relative newcomers to linebacker, with only Liam McGrath a returnee after racking up 13 solo tackles and 3 sacks in 2021. Flanking him in a fairly speedy group will be Menold, Snyder, Kieser and Daily.

"Zach Menold has really stepped up and taken leadership of that linebacking crew," Carruthers said. "Once we put pads on, we've seen really good improvement from them."

Behind them are cornerbacks Primera, Herrmann and Crear. Jordan Johnson is moving from corner to safety.

"We were similar to this last year with a lot of new faces playing different positions and it just took a little longer to gel," said Carruthers, who called last year's Game 3 win in overtime against Anawan-Wethersfield, "a program saver."

Opening at Knoxville is no easy way to start the process again, though.

# Playoffs a goal for experienced R-W team

ONEIDA – Grant Gullstrand believes he’s been building toward this, his fourth season as head coach of a ROWVA-based football team. For one thing, 13 seniors have been in his program their entire high school careers.

But if significant things are to happen for the ROWVA-Williamsfield Cougars in 2022, the second half of that co-op combination is likely to be a significant factor.

About one-third of the 48 players on the R-W roster are from Williamsfield, according to Gullstrand. That isn’t shabby, considering Williamsfield’s entire enrollment is about 80.

The R-W contingent from Billtown includes three players who last season were second-team Lincoln Trail Conference selections on defense – Nolan Bronaugh, Adam Kohl and Graham Wight. Not bad for a school long known for its basketball proficiency under legendary coach Bob Anderson.

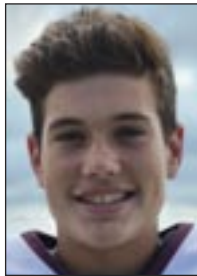
Gullstrand, athletics director at ROWVA, suspected some Billtown kids could handle an oblong ball, too.

“When I first took this job, I had people tell me you’ll never get kids from Williamsfield to play football,” Gullstrand said. “I have great support from that community over there.”

R-W also expanded its Williamsfield connection on its coaching staff. New defensive coordinator Garrett Rau teaches chemistry at Williamsfield. The Wisconsin native has been defensive-backs coach at Knox College, where he played and from which he graduated two years ago.

Another R-W assistant, James Sams, is from Williamsfield, although he teaches at ROWVA.

None of this is to say there’s a distinc-

tion between ROWVA and Billtown students on the field in the second season of a football co-op between the schools.

“Even though I work at ROWVA, they’re ROWVA-Williamsfield Cougars to me,” said Gullstrand, a 2011 ROWVA grad. “We’re an experienced group. That doesn’t necessarily mean you’re always going to be good, but they know how hard it is to win on Fridays.”

All the R-W starting offensive linemen return from last season, when the Cougars went 2-7.

Brian Dennis (6-foot, 220 pounds), a senior who started two games in 2021, joins longstanding linemen Gage Aldred (6-0, 190), Brody Bledsoe (6-4, 250), Matthew Dennison (5-10, 240), Grant Erlacher (5-8, 190) and Wight (6-4, 230). Juniors Aldred and Dennison are the only non-seniors.

“I tell our guys all the time, offensive line is the most important position,” said Gullstrand, who was a lineman at Monmouth College. “If you don’t have a good offensive line, there’s not a lot you can draw up that’s going to work. You need to have an offensive line that can block and protect and open lanes.”

If the R-W line does its job, lanes should open for the backfield, led by junior and returning starter Riley Danner (6-4, 173) at quarterback.

Among 14 running backs listed on the

R-W roster are seniors Nolan Coverdill (5-9, 150), Jaxon Sharp (5-6, 125) and Mason Stone (6-0, 145).

Defensively, the aforementioned Billtown trio leads the way. Rau has done a good job of getting the defense into shape, according to Gullstrand.

That defense will need to be stout in the Cougars’ season opener, a Lincoln Trail game Friday night at Oneida against Abingdon-Avon. A-Town advanced to the Class 1A state quarterfinals last season.

“That is our only focus right now,” Gullstrand said.

Still, Gullstrand has told players one goal is to still be in practice Oct. 27, before the first round of this year’s postseason: “I do think that’s achievable, but it’s not going to be an easy thing.”

Gullstrand appears to have hope despite two 2-7 seasons and an 0-4 record in 2021, when the COVID-19 pandemic prompted an abbreviated spring schedule. Knowledge of his players the past three years might lead to power, according to the coach.

“We know what they’re good at. We know what things they need to work on,” Gullstrand said. “It’s not like we went 8-1 or 9-0 these years. We’ve been building it from the ground up, really. The seniors have bought in, and our juniors are right along with them.

“It’s a pretty special group to me.”

# Political theater part of Illinois State Fair

SPRINGFIELD – Along with fried foods, carnival rides and an 800-pound cow made of butter, the Illinois State Fair is known for its political theater.

For the Statehouse press corps, it means we clear our schedules for at least two days in mid-August each year to take in the candidate stump speeches, hand shaking and one-liners.

On that last front, the quips ranged from knee-slappers to brow-raisers.

One comment that falls into the latter category came from Republican attorney general candidate Thomas DeVore, who gained statewide notoriety by suing Gov. JB Pritzker to challenge his executive order authority during the COVID-19 pandemic.

During his stump speech at Republican Day Thursday, DeVore took aim at Cook County State's Attorney Kim Foxx, a favorite target of many on the Republican ticket for her prosecutorial leniency in certain circumstances.

"You make me attorney general, and if Kim Foxx won't prosecute 'em, I will," DeVore told the crowd. "And she better get to prosecuting or we'll figure out a way to prosecute her."

It's the type of comment Democratic Attorney General Kwame Raoul alluded to when he contended the AG's race "matters more than any time in American history."

Crime was also on gubernatorial candidate Darren

Bailey's mind when the downstate farmer said for at least the third time in recent months that he believes Chicago is a "hellhole."

He doubled down when asked by reporters if he thinks most Chicagoans believe the same.

"Actually, I believe they do," he said. "Because it's unsafe. But it's going to change."

Pritzker, meanwhile, characterized the Bailey-led GOP as having been taken over by the "lunatic fringe."

While Bailey also criticized Pritzker's "soft hands" as compared to his work-worn "hands of a farmer" in a compelling contrast, the hellhole comment is the type of messaging that has made many in the GOP hesitant to even mention Bailey's name.

House Minority Leader Jim Durkin, of Western Springs, told members of the media he'd support the

Republican ticket but wouldn't go as far as name-dropping Bailey for an endorsement.

Durkin said he's optimistic the record-high 106 Republican candidates for the state House can make a dent in Democratic supermajorities, especially if candidates focus on economic conditions.

"The cost of living, inflation," he told me in an interview. "Those are the

things on people's minds, and they've had enough."

Durkin also had one of the more memorable one-liners in characterizing the Democratic festivities at the Bank of Springfield Center, sometimes referred to by its initials, BOS.

"The only thing they should have done is removed the 'O' from the BOS because it was more of a BS center," he said.

**Princeville** – With six of the top seven boys back, Coach Jeremy Melick's team is seeking to be even stronger than last year's sectional qualifier.

No. 1 runner junior Joey Bosch is focusing on cross country after attempting to play football last year and has strong support in sophomore Tucker Sennett and junior Parker Melick, who ran 2-3 last year.

Sophomores Jack Lied, Luke Graham and Austin Carruthers were all part of the sectional team and spent time in the top seven.

Newcomers sophomore Matthew Bowers and sen-

Leading the returnees is Symonds, who placed third in the regional last year with a time of 18:58.7 and was ninth at

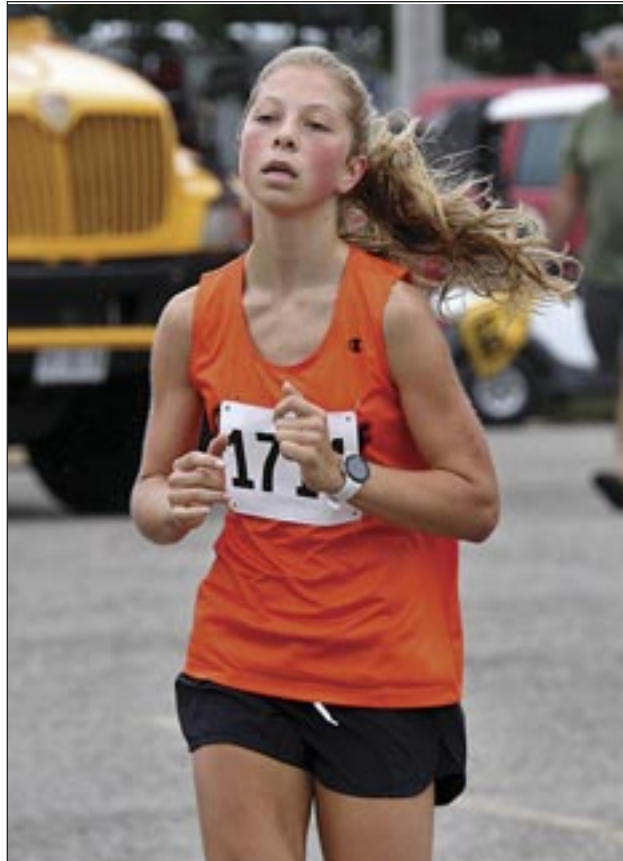
the sectional, where E-B placed fifth. Symonds placed 55th at state with a time of 19:04.
