Solar delay

Brimfield OKs solar farm but state delays funding decisions

BRIMFIELD – Local officials have approved a proposal to construct a community solar-energy farm at the east edge of Brimfield.

But state officials aren't quite ready to begin the application process regarding the Jubilee Solar project and other, similar ones.

The Illinois Power Agency has delayed the public-schools segment of the Adjustable Block Program, according to Kiersten Sheets. She is a manager for Highland Park-based Trajectory Energy Partners, the developer of the proposed 12-acre Brimfield solar facility. Submissions for state funding were to be accepted beginning Thursday. But on Aug. 19, the state announced the delay, Sheets stated in an email to The Weekly Post.

"I think the Illinois Power Agency needs more time to publish the guidebook ... for all of the solar programs, and that's why the date has been moved," Sheets wrote.

The block program helps support development of community solar projects in Illinois. Sheets isn't sure when the public-schools block-program segment would open. She

Keefe honored

Elmwood board votes to name building for board member

ELMWOOD – Plans are moving forward rapidly for a new Ag, Trades and Industrial Arts Building at Elmwood High School. And that includes a new name for the proposed addition.

After reading a resolution praising board member Claude Keefe, the board on Monday voted unanimously to name the planned building after Keefe, who abstained from voting but seemed moved by the gesture. When asked for comment, Keefe said haltingly, "I won't be able to say much."

Keefe has been a tireless advocate for teaching Elmwood students about industrial arts, agriculture and the trades. His motivation, the 1971 Elmwood grad has said, is because of the good those subjects did for him as a student.

"Everything I've done is because of teachers," Keefe said Monday. "That's why I'm so committed to the school and the students."

The board also approved a \$47,350 fee to the Farnsworth Group for architectural and engineering studies for the 3,000 square-foot Claude W. Keefe

Crashed plane had almost no fuel left

HANNA CITY – Almost no fuel was found inside a single-engine airplane involved in a fatal crash last month in downtown Hanna City, according to authorities.

The National Transportation Safety Board released a preliminary report last weekend regarding the accident, which happened about 12:30 p.m. Aug. 13. A New Mexico pilot and his wife were killed after he attempted an emergency landing on Illinois Route 116.

During a post-accident examination

of the four-seat 1982 Mooney M20K, only a small amount of aviation fuel was found in the right-wing tank, the report stated. The report was not specific regarding fuel quantity.

The plane's fuel selector was on a right-tank setting, according to the report. No fuel was found in the left-wing tank, which the crash breached.

About 3 ounces of fuel were found in the fuel strainer. No blockages were found in the plane's fuel lines, at least one of which was empty. Magnets, which produce voltage that helps provide engine ignition, worked properly when tested.

The examination took place at an undisclosed location, according to NTSB spokesman Keith Holloway. When contacted Sunday, he had no additional information.

A receipt from Santa Fe (N.M.) Regional Airport indicated 54.2 gallons of fuel were purchased Aug. 10 for the plane, the NTSB report stated. After that, the plane flew once for about four minutes above the airport. There was no evidence of subsequent fuel purchases.

James W. Evanson, 75, and Lisa K. Evanson, 67, were killed in the

Hanna City crash. They were traveling from Santa Fe to the Peoria international airport, according to the NTSB. No flight plan was filed.

Normal fuel capacity and range for the Mooney M20K is about 70 gallons and about 875 nautical miles, according to globalair.com. Nautical mileage between Santa Fe and Peoria is about 955.

According to the Santa Fe New Mexican newspaper, the Evansons were en route to New York, where they once operated a high-end furniture showroom. Married in 1984, the Evansons were registered architects. James Evanson also was an artist.

Evanson's plane left Santa Fe at 6:39 a.m. MDT Aug. 13 and climbed to 15,000 feet for the five-hour flight

to Peoria, the NTSB report stated. The plane made no stops on the way. Skies at the Peoria airport were clear. Visibility was about 10 miles.

About 28 miles west of the airport, James Evanson contacted Peoria air-traffic control, which gave him landing instructions. But about 18 miles later, Evanson informed controllers the plane's engine lost power, according to the report. He also said the plane wouldn't reach the airport.

The flight's last recorded data point plotted the plane at Route 116 and Pekin Lane, at the west edge of Hanna City. Video footage revealed landing gear was extended and the engine propeller was windmilling.

As the eastbound plane descended, it struck power lines that became embedded in its vertical stabilizer, the re-

port stated. After the aircraft touched pavement, the left wing struck a railing, a speed-limit sign and a power pole, all along the north side of Route 116.

Impact with the pole sheared the wing about 7 feet from the fuselage. The rest of the plane spun and struck a building, according to witnesses. The aircraft came to rest outside Gil's Supper Club. Pilot and passenger were pronounced dead at the scene.

There was no fire or explosion. Peoria County Coroner Jamie Harwood suggested James Evanson's actions were heroic. The plane avoided vehicles, and nobody on the ground was injured.

A final report that includes probable cause of the accident might take up to two years, according to the NTSB.

SOLAR: No timetable on awarding energy credits

speculated it might be sometime this autumn. Sheets doesn't know how long it will take for the state agency to award her firm solar renewable energy credits, a financial incentive.

The state delay might be considered ironic. When presenting the solar plan to Brimfield-area officials last month, Sheets and others suggested time was of the essence regarding their decisions, given the impending opening of the application window.

Sheets said the state program is first come, first served.

"Just because they're submitting doesn't mean they're going to get funding," she told the Brimfield School Board last month.

On Aug. 16, the Brimfield Village

Board met in special session and voted 6-0 to authorize development of the 2-megawatt solar project. According to Village Clerk Holly Johnson, conditions include a 100-foot setback from Jackson Street and a three-year period for construction completion.

Earlier in August, the Brimfield Zoning Board of Appeals recommended approval. On the same day, the school board approved a non-binding letter of intent to purchase at least 10 percent of the solar farm's electricity output.

In April, the school district and Trajectory agreed to a 25-year lease for the solar-project land. It's to be located east of Jackson Street and south of the school baseball and softball fields.

According to figures Trajectory provided, the school district would be the project's biggest financial beneficiary. Trajectory is expected to pay about \$8,200 in school property taxes the first year of operations. First-year rent would be \$12,000, and utility savings would be about \$20,800.

Overall, the solar project is expected to generate almost \$14,000 in property taxes its first year, according to Trajectory. It's also expected to generate 4 million kilowatt hours of electricity annually.

Subscribers are to receive a credit on their utility bills. Trajectory plans to allow as many as 350 Brimfield residential utility customers to subscribe, Sheets said. The company also intends to solicit Brimfield businesses.

Yates City lights up park in impressive fashion

It wasn't just the rhubarb pie and ribeye sandwiches talking.

Sitting at Harvest Home Park in Yates City on a recent Saturday during the town's annual festival, my family came to the same conclusion: What a nice park.

Nice dry pavilion (which was particularly welcome when the monsoons came). Well-kept ball diamond. New playground equipment. Nifty stage. Plenty of grass for kids to run on. A groomed tractor-pull pit.

And now the park will be even more usable thanks to the addition of lights to illuminate the ball diamond.

In just a few months of fundraising, the Light Up Yates City committee was able to generate more than \$104,000 to install the new lights.

That's an impressive sum anywhere, but is doubly impressive in a town of fewer than 700 residents. The generosity says a lot about folks in Yates City. It also perfectly reflects the passion of Jim Ralston, who as president of the Elba-Salem Park District has for years worked to improve the town's parks and community center.

If you spend time around Ralston,

you know he always has some project or another that he's pursuing. You also know that he will keep on talking about them until they get done.

Even Ralston needed help this time, though. After hitting up several politicians to help pay for the lights and getting nowhere, Ralston was frustrated. Then he skipped the politicians and hooked up with park district board member Debbie Newell and the Galesburg Community Foundation and things took off.

"She knows how to communicate with people a lot better than I do," Ralston said. "I'm from the old school. She's from the new school."

After a March 29 meeting with the Galesburg foundation, Newell helped come up with a marketing campaign and Ralston went to board meetings seeking money. The original deadline to raise funds was May of 2023, but response was more immediate and more generous than expected.

"We started pounding doors right away in April and I couldn't believe the response," Ralston said. "It's unbelievable we raised that much, and right in the middle of Jody (McKinty) having her St. Jude benefit and raising \$111,000. You talk about a small community coming through."

Money raised includes sizable donations from the City of Farmington, Salem Township, the Bank of Yates City and the Bank of Farmington.

The village of Yates City also contributed and overall, Newell said 71 people, businesses and organizations made donations.

"This adventure has been a whirlwind and heartwarming, to say the least," Newell said.

The money came so quickly that lights should be in this month, as the first meeting with contractors is Sept. 6. Extra money was used for a new scoreboard and will pay to run electrical lines to the tractor pull area and other "wish list" items.

Newell said anyone who still wants to donate can do so through the Galesburg Community Foundation and the Bank of Yates City. Oct. 31 is the deadline to be on a donor's plaque that will be installed at the park listing all who gave \$500 or more.

At present, primary users of the Harvest Home field are t-ball players from Farmington's summer baseball league. But Ralston has also extended an open invite to other local travel teams as well.

"When you spend that kind of money, you hope it will take off," he said. "We're going with the old Iowa saying, 'If you build it, they will come.'"

If they do come, they'll find a nice, clean park that any town would be proud to call its own.

All hats, no cattle and little chance

Two groups – one of South Dakota investors, the other tied to Texas cattle ranchers and feeders – are preparing to spend a collective \$1.8 billion on two meatpacking plants that they say will be so innovative each will pay cattle suppliers more for their cattle and bison than any of today’s Big Four packers.

Most meatpacker pros, however, think both projects are all hat and no cattle. Why?

Because one of the oldest stories in cow country is how big, bad packers ride roughshod over regional and local cattle markets to acquire an unfair share of the beef dollar while powerless ranchers and feedlot operators take it in the saddle every time they deal with a packer.

Then, just when it seems no rancher or feeder can go on, a white-hatted newcomer rides into town to extol the virtues of a “producer-owned” slaughtering plant that will plow profits back to local ranchers and shareholders.

Rarely, however, is the plant built and, worse, if a plant is built, most quickly sink in a pool of debt.

Still, hope returns to cattle country with every new calf and every new “local” meatpacker plan. The latest, a \$670 million “beef processing facility,” is planned near Amarillo, Texas.

That plant, already named “Producer Owned Beef LLC,” is a “significant move ... in an industry controlled by four multi-billion dollar companies” – Tyson, Cargill,

JBS, and National Beef – “that aren’t run by cattle producers,” noted the non-profit Franklin News Foundation project, The Center Square.

Its business plan is to “shore up the supply chain, enhance food security, increase competition, and benefit Texas cattle producers” in an effort to “keep hundreds of millions of dollars in Texas.”

The South Dakota plant, planned for Rapid City, is even more ambitious; it will cost an estimated \$1.1 billion, employ 2,500 workers, pay \$28-per-hour wages, and slaughter and process 8,000 head of cattle and bison per day. That scale would make it the largest “single beef plant currently in operation,” according to Tri-State Livestock News.

And, notes the News, the billion-dollar bet, to be known as the “Western Legacy Development Corporation,” will be “the first of its kind in North America to use the methane gas from the facility as energy from the plant.”

While both plans are noteworthy, neither outlines how either facility will implement the First Rule of Meatpacking: Put more blood on the floor faster and cheaper than any competitor.

That is, after all, the most important – and some say, only – rule in the butchering business. And while it sounds quite simple, there’s nothing simple about meatpacking. It is one of the most complex juggling acts in or out of a circus tent.

Think of it this way: The South Dakota investors say they’ll put \$1.1 billion on the table to get in the meat game against the world’s four largest meatpackers who already are the lowest-cost, most ruthlessly ef-

ficient beef slaughterers, processors, and sellers on three continents. Is that a bet you’d make?

No way, says longtime packer critic and Kansas rancher Mike Callicrate, the founder of Ranch Foods Direct, an online, direct-to-consumer beef marketplace. In fact, he adds, “The bet I would make is that the plant will never be built because there just aren’t enough cattle to support a new plant that size. Not in South Dakota, not anywhere. This is all talk.”

And the Texas cattlemen group that says it will put \$670 million into a new beef packing plant in north Texas? “Same deal, maybe worse,” says Callicrate. “Producers aren’t mean enough and tough enough to last in meatpacking. It’s a brutal business.”

Still, it’s understandable that ranchers and feeders are tired of being gutted by the Big Four. “But spending \$1 billion or \$700 million to compete with them on their field is crazy.”

Crazy, too, is that few in government even mention challenging meatpackers where they might be most vulnerable – in a federal courtroom facing antitrust charges.

Instead, ranchers and feeders get more pie-in-the-sky talk while the Big Four continue to carve up markets both here and abroad.

Princeville adding third kindergarten class

PRINCEVILLE – This academic year in the Princeville School District, three kindergarten classes are expected to be better than two.

An enrollment of 44 kindergartners at Princeville Grade School prompted creation of an additional homeroom, according to district officials.

Initial plans divided the group into two classes. But Grade School Principal Julie Bayless suggested 20-plus students in each class at that grade level probably is too many. She said it might hamper how much individual attention teachers can offer, among other things.

The numbers as of early August included three kindergarten students from families that migrate to Princeville to work in area agricultural and food-processing facilities. A long-standing element of the Princeville community, the seasonal migrants usually come from Texas or Mexico.

“We have a couple of kids coming straight from Mexico who don’t know any English,” Bayless said last month during a school-board meeting. “Smaller classes help with that, too.”

The board approved hiring Kacey Bohanan to teach the extra kindergarten section. Before the three-class split, Bohanan was expected to be hired as a permanent substitute.

“With three sections of kindergarten, I think we’ll be really set well,” Bayless said.

Bayless’ school has three classes in each of three other grades – second, third and fourth. According to enrollment as of Aug. 25, there are 49 second-graders, 42 third-graders and 59 fourth-graders.

First grade (40 students) and fifth grade (44 students) have two classes each.

In addition to Bohanan, the board approved hiring Randi Brown as a pre-K substitute teacher, Jada Crose as migrant/English Language Learner director, Kahlia Metz as a second-grade teacher, Sara Miller as a substitute/pre-kindergarten teacher and Samantha Spears as a first-grade teacher.

Emily Simmons was approved as a speech and language teacher, but she is not expected to begin work until mid-November, according to the board.

Non-certified personnel approved for employment were Michelle Dal-

linger (cafeteria worker/aftercare supervisor), Alexis Garcia (day-care monitor/aide), Christine Hartz (aide), Jesenia Horton-Meza (day-care aide), Geneva Keyster (library aide), Kim Kirwan (cafeteria worker), Andrea Murillo (day-care monitor/aide), Elizabeth Snyder (aide), Mishona Waldis (aide/van driver) and Stephanie Younglove (physical-education aide).

Hired as volleyball coaches were Jessica Bliss (seventh grade) and Katie Eddlemon (sophomore). Mark Pilon and Greg Urbanc were hired as assistant football coaches.

The board also approved a change in a district insurance provider. Iowa-based EMC Insurance Cos. offered a low bid of \$128,425 for one year. That’s about \$22,000 less than what previous-carrier Selective Insurance Group Inc. proposed, according to District Superintendent Shannon Duling.

EMC coverage includes district automobiles, workers’ compensation and cyber liability, among other things. The district has a separate health-insurance provider.

Elmwood man drives through field, fences

TRIVOLI – An Elmwood man allegedly drove an automobile through a field, through tall bushes and under two barbed-wire fences. He is also accused of rear-ending a parked vehicle, according to authorities.

Rashann Grier-Bain was implicated in the incident, which happened about 2:30 a.m. Aug. 18 in the 18200 block of W. Farmington Rd. in Trivoli.

A license plate from the Malibu was found at the scene. A deputy used the plate to locate the registered owner, who is Grier-Bain's mother. She said she reported the wreck to her insurance company after her son told her he drove into a ditch.

When the deputy asked Grier-Bain about the incident, he invoked his right to remain silent, according to the report. Grier-Bain was cited for leaving the scene of an accident.

The Malibu was found parked at a Trivoli restaurant and bar. The car sustained dents and cracks in its front bumper, fender, hood, passenger-side door and grille, the report stated. The front passenger-side wheel was broken. The car also had deep scratches on the hood and roof, and its air bags were deployed.

Man burned in Edelstein explosion

EDELSTEIN – A man was burned over 90 percent of his body in a house fire in Edelstein, according to authorities.

Shortly before 5:30 p.m. Aug. 26, Peoria County Sheriff's Office deputies were dispatched to 3005 W. Main St. There the man's wife told them her husband had been preparing the house for sale when he shut off the circuit breaker. An explosion and fire ensued.

The victim was hospitalized, although the sheriff's office did not specify where. As of early this week, authorities were awaiting word about the man's condition. The man's name and hometown were not released. In an email Monday, Sheriff Chris Watkins stated a release will be posted on Facebook if the victim is pronounced dead.

The house was a total loss, according to Randy Haley, chief of the Akron-Princeville Fire Protection District.

"When we got to the house, there was nothing left," he said. "The whole back end was blown off and there was just the front wall standing."

Haley estimated the damage at \$60,000.

A recreational vehicle on the property also ignited and sustained significant damage, Haley said.

Firefighters from Brimfield, Chillicothe, Dunlap, Elmwood, Peoria Heights

and Wyoming assisted their Akron-Princeville colleagues.

The sheriff's office and the Office of the Illinois State Fire Marshal are investigating.

Industrial Arts Building, which is estimated to cost \$700,000. Fundraising has so far generated \$11,000, with hopes of reaching \$350,000.

Board member Mark Davis of the building committee discussed a timeline that would have bid documents ready for the Dec.

19 board meeting. That is necessary, he said, in order to break ground in April of 2023, as is hoped.

Board President Val Ramirez noted that it would be best to have material orders in by January of 2023, "so we can hit the ground running by August."

The board also voted to continue teaching repro-

ductive health classes as in the past without incorporating new sexual-education curriculum introduced by the state as part of the Keeping Youth Safe and Healthy Act. Parents can also opt their children out of any sex-ed classes.

Superintendent Chad Wagner discussed the Fiscal Year 2023 budget. The budget is on display and will be voted on at the Sept. 26 board meeting. (Check back next week for a follow-up story.)

Wagner and the board also voted to approve a 10-year extension of Elmwood's downtown Tax Increment Finance District. Under a current proposal, four taxing bodies – including the school district – would get 50 percent of TIF funds for five years of the extension and 100 percent of TIF funds for the last five years.

In personnel, the board approved: Dianne Burwell as a part-time learning loss specialist for 120 days for \$37,398; SheAnna Snider and Diana Ladd as cafeteria aides at \$14 per hour; Roberta Foster, Paula Jehle and Robin Thrasher as elementary paraprofessionals at \$15 per hour; and Debbi Hutchinson as student facilitator at \$14 per hour.

Approved as volunteer coaches were Steve Herridge (junior high girls basketball), Jared Harkness and Brett Morse (JH cross country), Erin Magee and Erin Funk (JH softball), Nicole Briney and Kathleen Conklin (JH cheerleading) and Clay Goreth (football).

After a 59-minute closed session, the board approved 6 percent raises for two years to district bookkeeper Sherry Swindler, whose salary is \$57,379 after 17 years on the job. Swindler plans to retire after the 2023-24 school year.

Mystery black-eyed Susan variety offers bliss

Where my driveway meets the road, a patch of black-eyed Susans has been in full bloom for several weeks, like a burst of summer sunshine. The few plants we set out 10 years ago have grown into a sizable plot of summer blossoms emitting no fragrance, just happiness to passers-by.

There's a long list of black-eyed Susan varieties in the Rudbeckia genus, many good ones and a few oddballs. Our driveway variety happens to be a mystery to me. If I ever did know the specific variety, its name has escaped through the ever-widening hole in my memory.

I have spent most of an afternoon searching reference books and the internet. I know it is a variety of the genus Rudbeckia fulgida, of which there are several outstanding performers. I've narrowed it down to two. The differences are subtle, maybe even non-existent, which sometimes happens from time to time in the world of identifying and naming species.

The first possibility is Rudbeckia fulgida var. fulgida. This plant grows up to 30 inches tall and two feet wide. Its 2-inch flowers have a chocolate brown center and narrow golden petals. It starts blooming in late July and continues into fall, a much longer bloom time than the more popular Rudbeckia fulgida 'Goldstrum'. In full bloom, a mass planting is a blanket of flowers, a sight to behold.

Like all rudbeckias, R.f. var. fulgida flowers best in full sun. It's not



fussy about soil type but will not tolerate wet feet. It spreads by rhizomes and by self seeding.

The second, and most likely possibility, is Rudbeckia fulgida var. deamii. Deam's coneflower is the common name for this variety according to the Royal Horticulture Society.

Deam's coneflower is a tough little critter, which is probably why it would survive and prosper in the poor soil of the roadside. Its stems and leaves are covered with tiny hairs, which account for its remarkable resistance to disease and insects. Deam's coneflower is especially resistant to mildew and to septoria leaf spot, a plague of many other Rudbeckia varieties, such as R. 'Goldstrum'.

Deam's coneflower produces two-inch daisy-type flowers with dark-brown center cones and straight, narrow golden-yellow petals. It grows 2 to 3 feet tall and two feet wide. It seeds out easily, forming a colony of sunny yellow flowers from mid-summer into fall. Pollinators

find nectar in the flowers and finches feast on the seedheads into the winter.

Because of its long prolific bloom, its resistance to drought and disease and its ability to grow in soils from sand to clay, Deam's coneflower earned the Royal Horticulture Society Award of Garden Merit in 1993. And that started the ball rolling in the Awards department.

In a crop of Deam's coneflowers at his wholesale nursery in Hebron, Brent Horvath discovered an individual plant that was naturally compact with a mounding habit. Its abundant golden-yellow flowers with slender downward-arched petals covered the plant from August through September. He named it Rudbeckia x 'American Gold Rush'.

Brent's selection received an All-America Selection award in 2020 and was just named the Perennial Plant of the Year for 2023 by the Perennial Plant Association. Those awards will generate a considerable amount of valuable publicity in magazines and catalogs so the name he chose was prophetic, I guess.

At the risk of appearing somewhat picayunish, I think the flowers of R. x 'American Gold Rush, although charming, lose some of that cheerful appearance with their petals being arched downward instead of straight and flat. The horticultural cognoscents don't agree with me, apparently.

Anyway, I'll probably never know for sure which Rudbeckia smiles at me every time I drive by. I'll just enjoy the cheerful blooms in ignorant bliss.

Extreme rain events could be the new norm

The expression “when it rains, it pours” certainly sums up the weather pattern much of this growing season in Illinois. Those who received steady rounds of rain absorbed massive downpours that caused extensive flooding, particularly in parts of northern, southwest and southeast Illinois in recent weeks.

Meanwhile, there are farmers in portions of Illinois, and more so in states west of the Mississippi River, who probably still feel like they can’t buy a rain this season.

So what’s with the extreme disparity in rainfall events? Convective thunderstorms typically generate a wide range of rainfall within a small geographical area, and that’s just what the jet stream is funneling right through the state as the subtropical flow from the south and northern polar jet merge.

“We’re in a region where we’re seeing the two jet streams come together,” meteorologist Jim Rasor said at the Illinois Wheat Association’s summer forum in Okawville. “The jet streams are like the train tracks and the storms are the trains.”

Some of the storms that barreled into Illinois on this track dropped close to a foot of rain or more in some areas in recent weeks.

“We’re already wetter than normal down here (in southern Illinois) for the month because of one rain event,” Rasor said on Aug. 9.

The stretch of extreme rainfall events improved topsoil moisture ratings in the state to 18 percent surplus, 58 percent adequate and 24 percent short or very short as of Aug. 8. Nearly one-third of topsoil moisture ranked short or very short on July 11.

But there are still areas of the state quite short on moisture. Portions of Champaign County and the southern tips of Alexander and Pulaski counties were in severe drought as of Aug. 11, according to the U.S. Drought Monitor. Moderate drought also remains an issue in all or parts of DeWitt, Douglas, Edgar, Piatt and Vermilion counties in east central Illinois and in Hancock, Henderson, McDonough and Warren counties to the west.

The weather outlook favors hotter and drier conditions to the north and warm, muggy and wet conditions to the south the next 45 days, with a fairly mild and dry forecast for harvest, according to Rasor.

Long term, the rise in rainfall disparity and extreme precipitation events could persist. “Climate change is real,” Rasor said.

Since 1981, the frequency of daily 2-plus-

inch rain events has doubled, Eric Snodgrass, principal atmospheric scientist at Nutrien Ag Solutions, previously told FarmWeek.

And changing precipitation patterns are causing a shift in the Corn Belt, according to Elwynn Taylor, Iowa State University climatologist.

“We’ve been getting increasing moisture in the Corn Belt, including almost all of Illinois. It’s pushing the Corn Belt to the north and west,” Taylor previously told FarmWeek. The geographical center

of the Corn Belt was located over Springfield in 1950, but has since moved to Peoria by 1964, the Quad Cities in the next decade and currently sits close to Des Moines, Iowa, Taylor noted.

“Minnesota was barely part of the Corn Belt (in the mid-1900s) and now is a major part of it (along with the Dakotas),” he said. “The reason is precipitation.”

B scored five straight times to roll to a Prairieland Conference win. "We had very few miscues," E-B Coach Todd Hollis said. "That's important. And when (the Chargers) made mistakes, we capitalized on them. When you have that kind of experience, you take advantage of opportunities a lot more quickly."

Aiden Frail and Rohman Mitchell ran for two touchdowns each for E-B, which returns eight starters on each side of the football.

Frail and Mitchell each scored in the first eight minutes of the game. Frail's touchdown came after only about a minute, when E-B recovered an Illini West fumble on the opening kickoff.

But after Mitchell's 6-yard TD at 4:10, Jerick LeMaire of Illini West returned the kickoff 70 yards to shave the E-B lead to 14-6. Hollis said his contingent knew what mistake might have led to that and rectified it. The Trojans' offense did the rest, with help from the defense.

Bailey Elwell's 18-yard scoring run came 1:42 before quarter's end. Then E-B scored three times in the second quarter to lead 42-6 at intermission. The big blow was Gavin Buhl's 78-yard interception return for a touchdown at 2:10.

"We were getting some pressure on the quarterback ... Gavin catches it and all the defensive backs became this train leading him all the way down," Hollis said. "We were very good defensively."

E-B outrushed Illini West 338-67. Slone Windish had eight carries for 66 yards and one touchdown. He also had four solo tackles, including two for a total loss of 14 yards.

After a round trip of about three hours for the opener, E-B plays host Friday night to Rushville-Industry in a key league matchup. R-I lost its opener to Macomb.

"One thing Rushville absolutely does do is they come straight ahead

offensively, like they're fired out of a cannon," Hollis said. "As quickly as they get off the ball, we better be ready to play right away."

Knoxville 54 Princeville 20

KNOXVILLE – A slow start and a quick, aggressive opponent was the wrong combination for Princeville in a lopsided season-opening loss to one of the Lincoln Trail Conference's preseason favorites.

"A lot of kids were starting varsity games for the first time and were in the first time playing those positions and it was a tough first-week matchup for that," Princeville Coach Jon Carruthers said. "Knoxville doesn't have the size they normally have on the line, but what they don't have in size they made up for in speed and aggressiveness."

Princeville lost a fumble early at its own 25-yard line and, one play later, Jaxin Johnson scored the first of eight TDs for Knoxville.

And while the Princes had some bright spots on offense, including a nifty 13-yard touchdown on a fade route from Logan Carruthers to Jordan Johnson just before halftime, Princeville could not slow the Knoxville attack.

"Everything that happened to us we can fix. The hardest part with an inexperienced team is replicating game speed," Coach Carruthers said. "To have Knoxville week one, where they fire off the ball and are double tight ... that's the level you have to get to. So getting smashed in the mouth the first game is probably the best thing for us."

Princeville is home Friday against a Monmouth United team that also struggled in its opener, falling 35-16 to Annawan-Wethersfield.

"United looked like us. A-W looked like us. Comparable in size," Carruthers said. "Every week you're going to be able to get running-clocked or beat somebody."

ONEIDA – Host ROWVA-Williamsfield recovered from an early deficit against an LTC foe that reached the Class 1A state quarterfinals last season.

Jack Godsil scored four consecutive times for R-W after A-Town led 6-0 at Bill Adams Field. Godsil and quarterback Riley Danner connected for three touchdown passes in succession, the last and longest for 52 yards and a 20-6 lead.

"We don't have one or two guys we say are going to score a lot of our touchdowns. It just kind of happened," R-W Coach Grant Gullstrand said. "Schematically, (Godsil) was in kind of the right spot for some things we set up and thought we could take advantage of. It kind of worked out in his favor."

Danner completed 8 of 11 passes, for 141 total yards. Godsil accounted for 67 receiving yards. The Cougars rushed for 217 yards, including Godsil's 56.

On defense, R-W had four interceptions and a fumble recovery. Defensive back Mason Stone had four solo tackles and one assist.

All told, it gave R-W a good finish after an iffy start. Before the game, Gullstrand warned his players about that last part.

"Our big thing was adversity," he said. "We told them bad stuff's going to happen. There's a chance we get down one or two scores and you have to keep battling and believing in yourselves. That situation happened. We kept fighting and fighting."

R-W will play nonconference foes in its next two games, both at home. First up is Saturday against Dupo. A member of the Cahokia Conference, Dupo won its opener 38-30 vs. Ob-long-Hutsonville-Palestine.

Farmers fall

E-B, R-W post convincing wins

ALEDO – Farmington lost a football game? How? Simple, according to Coach Toby Vallas. Mercer County is a strong, physical veteran team that returns eight starters on both sides of the ball.

And Vallas said the Farmers are not as good as the players believed heading into last week's 24-8 season-opening loss at Mercer County.

"I think the main thing was, we've got a lot of guys walking around and living off last year. And last year is over," Vallas said. "This was a hard lesson. You don't go to a place like Aledo and go there overconfident and thinking its last year."

One year after thumping Mercer County in the opener, 41-0, Farmington found itself plagued by penalties, dropped passes and an inability to generate the big plays that are typically part of its offense.

Instead, Mercer County

jumped to a 22-0 lead before Farmington got on the board just before half-time with a 30-yard run by senior quarterback Gage Renken.

A bright spot for the Farmers offense, Renken finished with 124 yards rushing on 24 carries. But he passed for just 58 yards and was 10-for-24 with an interception. Vallas said eight dropped passes and numerous untimely penalties hurt.

"That's not an insinuation of the referees, it's an insinuation of us," he said. "We had some holding calls and we were holding. And those penalties killed drives."

Thoughts of the Farmers making a second-half comeback were undone by fatigue and Mercer County's defense, Vallas said.

"We've had a pretty good track record of being behind at the half and coming back and doing well, but I think fatigue had set in on some of our guys by that point," Vallas

said. "Mercer County is good. They were definitely bigger and more physical than us."

Said Mercer County Coach Andrew Hofer, "The second half was a slog as there was a lot of cramping on both sides."
