# Legal issues may be ahead in Brimfield bus situation

BRIMFIELD – From a student-transportation standpoint, the Great Brimfield Bus Saga of 2022-23 appears to be at an end.

From legal and financial standpoints, there still appears to be more to the story.

Almost all the 10 buses the Brimfield School District agreed to lease last year from a Kankakee-based firm have been delivered. As of late last month, only one bus from Midwest Transit Equipment Co. still was missing, according to District Superintendent Tony Shinall.

The undelivered bus is to be equipped to transport students who use wheelchairs, but the district has another such bus available, Shinall said.

# Princeville hires Shinall as new superintendent

PRINCEVILLE – The current Brimfield School District superintendent is to become the next Princeville one.

The Princeville board voted Tuesday night to hire Tony Shinall, effective July 1. He is to receive a three-year contract.

Shinall, 43, is to replace Shannon Duling, who is in his 12th year as Princeville superintendent. He and the board couldn't agree on a new deal.

The new Princeville hire was approved after deliberation in executive session, which is closed to the public. It also came six months after Shinall



received a pay raise, from about \$117,000 to \$130,000, and a contract extension from Brimfield. He became superintendent there in 2020.

Shinall's original three-year Brimfield deal was to expire after the current academic term

## Williamsfield superintendent seeks new deal

WILLIAMSFIELD – Superintendent Tim Farquer is seeking to restructure his current three-year contract early, and not everyone in Williamsfield CUSD 210 thinks that should happen.

Those uncomfortable with an early contract change include three school board candidates, who have also expressed reservations about Farquer's paid, part-time job with another company.

Farquer's contract runs through June 30, 2024, and will pay him \$130,230 starting July 1. But in a note he handed to school

board members recently, Farquer has requested the contract be restructured

through June 30, 2027. Farquer wrote that, if the board is willing, he would like "to work this to resolution in February."

Also in the letter are five requests, seeking payment in lieu of health insurance, a one-time allotment for 150 sick days that be ex-

150 sick days that be exchanged for years of service, permission to consult on behalf of other school districts on renewable energy and electrification

and pay increases. Farquer suggested a "larger" increase in the first year of the restructured deal and 3.75 percent increases in the next three years.

As a fifth request, Farquer also wrote, "I would like the opportunity to rectify a situation prior to being fired for just cause." He is seeking an additional phrase in his contract that would say, "must be given a chance to correct any defect prior to call for discharge, when appropriate."

"I'm committed to the district. I'm entering the final year of my contract. I would like the district to commit to me. We have



## BRIMFIELD: 10 buses have been delivered

Continued from Page 1 tation service. Previously, a third party transported about 400 Brimfield students each school day. But Midwest Transit failed to provide the requisite buses in time for the start of the 2022-23 academic year.

Midwest Transit cited supply-chain issues, according to Shinall. Brimfield filled the breach by leasing buses from school districts in Dunlap and Farmington, among other places. The per-bus cost was \$750 each month. Brimfield also spent \$115,000 to purchase two buses.

It appears Brimfield expects Midwest Transit to reimburse at least some of the additional expenses the delays incurred, according to Shinall.

"I'm still waiting to get our full complement before I go after them," Shinall said regarding buses. "We've had conversations. They understand that there's an issue."

When asked if litigation

was possible, Shinall said it depended on what the district and Midwest Transit can work out.

Board President Steve Updyke has previously suggested that district attorneys are aware of the situation.

This is the first year of a three-year contract the district has with Midwest Transit. The annual cost is about \$166,000, according to Shinall.

Heinz Bus Co. of Brimfield was the district's previous student-transportation provider. A renewed contract with Heinz would have cost the district almost \$1 million more annually than did the previous deal. That helped prompt the district to forego external transportation sources.

Shinall said the district has hired about 15 bus


drivers, so it's in good shape in that regard. Despite the hassles related to the bus shortage, Shinall saw positives in establishing a student-transporta-


tion system.

"We were able to bring a really important part of education in house," the superintendent said. "We get our kids to school on time every day. I've learned a ton. The district office has learned a ton. And we've found some really good people to drive for our kids."

In other developments, the district has been awarded a \$50,000 school-maintenance state grant for which it applied last September. The grant is to help fund new windows at Brimfield Grade School, a project that is likely to begin this summer.



## Of short string, a tidy traitor & tree killers

Rambling through central Illinois, pondering wishy-washy decisions.

My wife often brings me books to read. Sometimes she surprises me with titles she thinks I might enjoy. Generally, she is correct.

That's a long-winded explanation for why I read **Marie Kondo's** book "The Life-Changing Magic of Tidying Up" shortly after it was published in 2014.

More than read it, I embraced much of Kondo's logic. Folding clothes and underwear into neat patterns? No, that part of the book didn't work for me.

But to this day, she has helped me throw away potentially sentimentals items since "they no longer bring me a spark of joy." Old pieces of wood. Gifts given years ago and never used. Ugly ties. Shirts with more than 10 holes in them. These are items that once plagued me. No longer. Marie's logic from nine years ago has brought a measure of calm to my life since.

So it was stunning to hear last week that decluttering queen Kondo admitted - after having three kids -"My home is messy." In essence, she backed off her thesis of tidiness.

What? You wrote a best-selling book that made every normal person feel guilty and now you make an about-face just because three kids bring home funky-looking pottery and piles of school projects? Judas Kondo. Benedict Kondo.

Seconds after processing Kondo's admission, I quenched my anger by calling G&O Disposal to order a dumpster. In the days since, my life

has entered uncharted realms of tidiness. With every non-working pen, scrap piece of metal and broken chair that leaves my life, a weight is lifted. Kondo's concept to me remains valid, even if she can no longer live up to it.

Added fuel to the tidy fire came while watching "The Queen of Versailles." There's no excuse for how that got in front of my eyes, but it's a Netflix documentary that shows the excesses of the Siegels, super-rich Florida billionaires who set out to build the biggest house in the U.S., then nearly went bankrupt in 2008 and got a dose of reality.

Seeing somebody other than me humbled is kind of fun. Better yet, as rich as these folks were, their house was dirty - packed with junk, cluttered and littered with dog poop. Inside dog poop.

I suspect a visit to the Siegels would send Kondo back into declutter mode. It certainly gave me added motivation to clear out more drawers and part with a collection of wax - once used to paste up newspaper copy – that I have moved at least six times in the past decade. No longer. To the dump with the joyless items. Hold onto what really matters and get rid of all the string too short to be saved.

Spent Saturday pruning trees and perusing damage done by raccoons. In my neck of the woods, raccoons are the No. 1 nemesis to tree-planting efforts, though deer and rabbits are not far behind.

To protect trees from deer and rabbits, we plant many in 6-foot plastic tubes. These work like mini-greenhouses and trees generally grow very well in them. Problem is, wasps like to build nests in the tubes. And raccoons like to eat wasp pupa, though

to do so they first tear up the expensive tree tubes, rip them off their fiberglass stakes and bend them over.

As a result, what was once a gorgeous 5-foot oak tree can quickly become a 2-foot stub if not rescued quickly. As a result, much of June and July is spent straightening tubes, rescuing trees and smashing wasp nests to eliminate the attraction. This year, we will integrate epsom salts into our plantings, since it is supposed to help keep coons at bay.

That will be important, because raccoons also dig up about 50 percent of the trees I plant, particularly those carefully grown from acorn. Even after removing the nut from the sapling and covering the hole with dirt from the area, coons still dig what I plant, then leave the little tree to die with roots exposed.

Somebody told me raccoons figure anything somebody buries must be worth digging up. Maybe so. But it's not an endearing quality. Nor is the damage raccoons do to outbuildings, attics, sheds, barns and other structures into which they can gain entry.

Raccoons create problems when their populations are at a low level, but they really make things miserable when their numbers balloon - as they seem to be right now.

Eventually, disease and road kill will bring raccoon numbers down, which amazingly seems to be a preferable alternative to some readers who are upset about a raccoon contest in Elmwood. Sigh.

As for the anonymous, gutless emailer who emailed to tell me "The term 'hunter' is a euphemism for PSYCHOPATH," please look in the mirror. My guess is you will see more than a euphemism. You will see the real thing.

## Memories of Grandma's ironic cow collection

After nearly causing an avalanche of cookbooks to tumble down onto my own head, I resolved to create order out of the chaos that was perched precariously above my kitchen sinks.

Anyone who knows me will acknowledge that I own an excessive number of cookbooks. I once tried counting them, in a futile effort to refute that claim, but stopped when I reached 400. In fairness to me, most of the books were inherited from AJ's mother, my mother and both my grandmothers.

In addition to the cookbooks

wedged tightly into the three shelves were stacks of notebooks containing menus, shopping lists, recipe locations and guest lists for family meals and special occasions. And

then there were the knick-knacks: My Kitchen Angel, a gift for helping with a wedding reception; the milk glass chicken I bought on a dear family friend's estate sale because as a child I loved it in her kitchen; and The First Cow.

The First Cow belonged to my Grandma Jane, a gift from my mom when she was just a little girl. It must have been purchased around 1930. The little Holstein is showing her age. She has suffered a broken front leg, well mended, and her left ear and horn are currently lying by her side, awaiting my attempt to reattached them for the umpteenth time. Then she will return to her place of honor in my kitchen.

The First Cow is significant. It was the first of what eventually became a sizable herd. Because it was a cherished gift from her young daughter, my grandmother displayed the figurine prominently and likely commented on how much she liked it.

Before long, someone else took that prompt and gave my grandma another cow, which also had to be displayed. The die was cast. One cow figurine was just that. Two became a collection. In her later years, grandmother confided with a giggle that she never wanted to collect anything, especially not cows, but people just kept giving them to her.

To appreciate the irony of my

grandmother inadvertently collecting cows, you need to understand she was actually terrified of the creatures. I loved to listen to my Grandma Jane tell stories about her life, and even as a small child I would beg her to "tell me about the olden days." Born in 1901, she had much to tell, and she told it well. If I have any of the storyteller in me, that is a gift from her.

Grandma Jane grew up near Barry, Illinois, in Pike County, and, of course, she walked to school. The shortest route, still over a mile, was through the timber and along a neighbor's pasture. Her older brothers, eager to get to school, would forge on ahead, leaving little sis to fend for herself. The neighbor's cows, spotting this little girl, would invariably walk or perhaps run over to the fence to see what she was. Cows are naturally curious creatures, but my grandmother felt threatened by them, understandably so, given their size and proximity.

Still, she could appreciate the beauty of cows grazing in a pasture with well-maintained fences, and often commented on how nice our fences looked back when they were all woven wire. She fretted over my going out among our cows and I don't think she ever got accustomed to my casual attitude about working with the big animals.

My grandma lived to be 98, and during what would be her last visit to my house, for Easter dinner, she lamented being unable to walk with the rest of the family to see newborn calves in the barns. I had a bottle calf at the time, so I quickly fashioned a twine halter and led the calf to the house to say hello. When we walked into the living room, Grandma Jane laughed gleefully and extended her hand to pet the little black calf. She didn't seem afraid at all and the calf relished the affection.

Upon her passing, I inherited the collection of cows that she kept in built-in cupboards on either side of the fireplace in their house in Toulon. As a child, especially, but even as an adult I enjoyed looking at the variety of figurines, everything from china and porcelain to bronze and wood.

The cupboards were white with small diamond-shaped leaded glass panes in the doors that always stuck. I was allowed to open the doors and browse through the cows whenever I wished. I have a couple dozen of them displayed around my house now. The rest are carefully boxed up in the basement. Like my grandma, I am an unwitting collector of cows. I wonder what she would have kept in those cupboards if it hadn't been for the cows? Cookbooks, perhaps?

## BEEF SAUSAGE AND CHEDDAR MONKEY BREAD

Mexican-style beef sausage is baked into a cheesy pull-apart bread. Perfect for breakfast or brunch.

Ingredients:

- 1 recipe Mexican-Style beef sausage
- 2 cans (7-1/2 ounces each) refrigerated buttermilk-flavored biscuits
- 1-1/2 cups reduced-fat shredded Cheddar cheese
- 1/2 cup chopped green onion
- 1/4 cup olive oil
- 1/2 cup Mexican crema or dairy sour cream

Cooking:

1. Prepare Mexican-Style beef sausage. Set aside.

2. Preheat oven to 350°F.

3. Generously coat bundt pan with cooking spray. Place sausage and biscuit mixture in prepared pan. Bake in 350°F oven 30-35 minutes until top is golden brown and biscuits are set. Remove from oven; immediately invert onto serving plate. Let sit for 10 minutes. Drizzle with crema.

but was renewed through 2024-25.

Shinall arrived in Brimfield in 2018 as high school principal. Previously, he was an assistant principal at Richwoods High School in Peoria, where he also taught.

Also Tuesday, Duling announced the resignations of varsity volleyball coach Anna Schupbach and freshman-sophomore coach Katharine Eddlemon.

## Yates City driver injured in rollover accident

• **ELMWOOD** – A driver from Yates City sustained multiple injuries when his automobile veered off a road east of Elmwood, became airborne and caught fire.

The rollover accident happened about 10:15 a.m. Jan. 31 in the 20100 block of Illinois Route 8. Brayden C. Davis was driving an eastbound 2006 Subaru Impreza and fell asleep behind the wheel, he told a Peoria County Sheriff's Office deputy. Davis was headed to a friend's house following his third-shift job.

The Impreza crossed the center line, rolled down an embankment and landed in a snow-covered field 80 feet from the road, per a sheriff's-of-fice report. The car became engulfed in flames, which the Elmwood Fire Department extinguished.

"When I pulled up, there were still flames on it," Jason Buckley, a sheriff's-office patrol lieutenant, said at the scene. "They got the fire put out pretty quick. Fortunately, it's no worse than it was."

The Brimfield-Yates City-Elmwood Ambulance Service transported Davis to OSF Saint Francis Medical Center in Peoria. He sustained a broken left kneecap, a bruised pelvis and other minor injuries, the report stated. Davis said he didn't remember the accident; he awakened in the snow.

"The guy was a little confused," Buckley said.

#### Police reports

• PRINCEVILLE – A man attempted a knife attack on a driver at a Princeville intersection, according to authorities. Collin M. Hause, 25, of Princeville was arrested following the incident, which took place about 4:30 p.m. Jan. 29 at Spring Street and Santa Fe Avenue.

A driver saw Hause punching signs and yelling, according to a Peoria County Sheriff's Office report. When the driver asked Hause if he needed help, he started yelling, pulled out a black pocket knife, waved it in the air and charged toward the vehicle's open driver's-side window.

The driver raised his window in time for it to withstand multiple knife thrusts, the report stated. A deputy noted a 4-inch scratch across the window midsection.

About 90 minutes earlier, deputies evicted Hause from a laundromat at 210 S. Walnut St. and told him not to return, at the owner's request. Hause disobeyed that order. Hause was accused of criminal trespass, aggravated assault and criminal damage to property.

James W. Wilson, 61, received a notice to appear March 15 in Peoria County Circuit Court in connection with the incident. It took place about 2 p.m. Jan. 31 at American Liquor & Food, 615 E. Main St. in Princeville.

An employee said a security camera revealed someone driving a 2007 Buick Lucerne entered the external restroom, emerged with the heater and left. A cable lock attached the

heater to the sink, according to a Peoria County Sheriff's Office report.

When a deputy arrived after 8 p.m. Feb. 1 at the residence where the vehicle was registered, Wilson came outside and said he knew why the deputy was visiting: "The heater." When the deputy asked who took the heater, Wilson replied, "I did."

The heater in Wilson's garage malfunctioned. Wilson said he knew there was a heater in the American Liquor & Food restroom and didn't think anybody would miss it, according to the report. Wilson surrendered the heater, which was valued at \$50.

• WILLIAMSFIELD – No injuries and minimal smoke damage were reported after a chimney fire at a residence southwest of Williamsfield.

Crews were called about 6:30 a.m. Jan. 31 to 1032 Knox Road 1900 East. By the time they arrived, the flames were out, according to Jamie Klein, chief of the Williamsfield Fire Protection District. He said a buildup in the chimney caught fire when someone burned hedgewood.

"It's a very hard wood and it burns really, really hot," Klein said. "They put a damper on it and it burned itself out. I'm glad somebody was home and found this early, not when it was out of control."

Firefighters checked for hot spots, according to Klein. He estimated damage at about \$800.

• ELMWOOD – There was smoke but no fire last week at Elmwood Laundromat.

Firefighters arrived about 1 p.m. Jan. 31 at the laundromat, 109 W. Main St., on a report of smoke filling the room. A belt on one of the dryers had burned, according to Elmwood Fire Department Chief Bob Tannock.

Elmwood firefighters used a thermal-imaging camera to make sure there were no hidden flames and the dryer was disconnected from electricity. No damage was reported.

The deputy determined McCosh drove in ditches beginning up to one-half mile from where the vehicle came to rest. She first drove into the east-side ditch, then into the west-side ditch for about 225 feet.

An ambulance took McCosh to OSF Saint Francis Medical Center for evaluation. Her vehicle sustained over \$1,500 in damage and was towed.

Perry was charged with aggravated fleeing and eluding and two counts of aggravated driving under the influence. He also is accused of unlawful possession of less than 5 grams of methamphetamine and aggravated assault.

Schmid died in the accident shortly after 10:30 a.m. Jan. 15 at U.S. Route 150 and Trigger Road at the northwest edge of Peoria.

The accident culminated a police pursuit that began about 20 minutes earlier at the Shell gas station at 7200 N. Kickapoo-Edwards Rd.

Peoria sheriff's-office deputies were summoned there after a report about two people unresponsive inside a vehicle parked at the gas

Subsequently, Perry drove away and in the process struck a squad car and almost struck rescue personnel, authorities alleged. An ensuing chase north on

Kickapoo-Edwards Road and east on Route 150 ended with the collision. Schmid died instantly, according to Peoria County Coroner Jamie Harwood.

The Weekly Post has requested police reports regarding the incident, but as of late last week the sheriff's office had not approved them for release.

Continued from Page 1 three candidates running for the school board who have consistently voiced displeasure with how the district is being run. Things became very turbulent the last time that happened here," said Farquer, who has been superintendent for 10 years. "My hope for the district and my family is to get all of this out of the way now. Commit to each other or don't."

The next school board meeting is Feb. 13 at 7 p.m. School Board President Teresa Stewart said of contract talks, "There is probably going to be discussion. Is there going to be action on that discussion? That I do not know."

At issue is the fact the school will undergo major change in May. Stewart, Jolene Tucker and Lora Kutkat will leave the board, as their terms have expired and they are not seeking reelection. Three candidates who will be on the ballot in April are Brittany Byrd, Chad Goff and Jennifer Hettinger. Rachel Tucker and Brittany Gibbs are write-in candidates.

Byrd, Hettinger and Goff all say they would like a say in any restructure if they join the board, since the contract is currently in place through 2024. They also have issues with some of Farquer's requests.

Goff said by his calcula-

tions paying out 150 sick days would cost the district an additional \$130,000.

Goff also raised issues with Farquer's employment by the non-profit World Resources Institute as an electric school bus senior advisor. Goff had a lengthy Facebook post on the subject and called into question whether the job was a violation of Farquer's contract and a conflict of interests, given Williamsfield's recent purchases of electric school buses.

"Unfortunately, with everything he's trying to get done with this board, I don't see how I could go forward with a yes vote on a contract without some serious questions being answered," Goff said. "I don't think there's been any accountability for awhile."

Katherine Roboff of WRI said Farquer is a part-time, paid fellow. "He was brought on to help provide advice," Roboff said. "He brings that on-the-ground information."

Roboff said WRI does not sell school buses and there was no commission paid to Farquer, as Goff questioned in his Facebook post.

"Everything we do is grant funded," Roboff said. "We offer free technical assistance and tools to school districts and other operators to make the transition to electric."

Farquer said he works the equivalent of 10 hours per week for WRI. He also said he told the school board about his job in closed session, though there has been no vote in open session approving the second paid

position.

"It's a consultancy gig. I love the mission. I love the work. The BOE was aware and granted permission prior to me accepting the gig," Farquer said. "I am requesting a language change in my contract that would allow me to make this decision on my own. I believe so long as the superintendent is committed to the district and does the work, they should be able to do other things with their life without having to get permission from the BOE.

"My consultancy work supports my work here and helps our district. That said, if I wanted to work as a Spoon River catfishing guide, I shouldn't have to ask for permission from the

Stewart would not com-

ment on Farquer's job with WRI, other than to say "these were things that were discussed in closed session."

Farquer said he is eligible for retirement on July 1, 2030, and said he would like to retire from his current position.

"I'm a Dahinda kid. I grew up working for local farmers. Laura State Bank loaned me money to help get me through school. My grandpa taught me how to make a little money painting houses and barns around the area," Farquer said. "I love this community. Most days they love me back. I've always felt indebted to them for everything they've done for me. For the first time in my life, I consider us even.

## Farmington council hears good audit news

FARMINGTON – The Farmington City Council heard good news from its auditor Monday in a short meeting that had a relatively light agenda.

Aaron Phillips of Phillips, Salmi and Associates told the council,

"You guys are in great shape."
Phillips said Farmington ended 2022 with \$4.3 million in cash reserves and investments compared, up \$380,000 from the year before.

Those reserves represent about 20 months of operating costs, Phillips said, noting that the 15 municipalities his firm audits average 15-16 months of operating cost in reserve.

"Every municipality in the local area is stronger than they were five years ago," Phillips said, attributing much of the stability to increased state revenues and federal funds paid out via the CARES Act and ARPA.

In the case of Farmington, he said added stability has come from the sale of the water system to Illinois American Water.

To illustrate that point, he noted that in 2017, Farmington's combined

capital assets, reserves and infrastructure vs. debt was \$4.9 million. By the end of 2022, that total was \$9,456,000.

He said the city's only debt is \$328,000 in general obligation bonds that will be paid off in 2029.

And Phillips noted that the city's pension is overfunded by \$700,000, which he said helps keep property taxes lower.

Phillips' lone caution to the council was to continue to review billing and payments, since the same people handle those jobs for the city. He said that is common in smaller municipalities due to limited staffing.

In other business, the council approved spending \$2,000 on fireproof file cabinets for storage of various historical city records and cemetery records.

The council also approved making TIF payments of \$1,500 to Duane Courtright for tree removal at his property and \$2,500 to Cody Rice to have windows replaced at his residence.

Police Chief Chris Darsham reported that his department has hired


Jacob Waller and Tim Herink as part-time officers and introduced incoming full-time officer Austin De-Wester to the council. Darsham said DeWester is a Farmington native who is married and has one child and one on the way.

Darsham reported the following activity for January: 262 business checks, 2,841 building checks, 2 crashes handled, 3 property crimes, 40 ordinance violations or traffic tickets issued, 1 crime against a person, 35 traffic stops, 6 arrests, 12 reports completed, 305 total calls, 18 assists to other police departments and 6 miscellaneous items.

Darsham said Sgt. Andy Steck took Farmington's K-9 Koala to assist the Lewistown Police Department in a drug search at the high school. Darsham said, "They found quite an amount in the vehicles out there."

The council also received a Blue-Gold Award from the Spoon River Valley chapter of the Fraternal Order of Police in appreciation of Farmington's support of law enforcement.

## Williamsfield buys building for storage

WILLIAMSFIELD – The Williamsfield village maintenance department has a new place to put its stuff.

During its meeting Monday night, the Village Board approved the \$25,000 purchase of a building at Oak and Lions streets.

Ag-Land FS Inc. had been using the almost-10,000-square-foot structure to store grain, Williamsfield Village President Matt Tonkin said. But that purpose was seasonal. The likely maintenance-department move probably will be gradual, according to Trustee Andrew Scott.

"There are so many different things we can do with it," he said.

Certainly, it appears the building is more versatile than the current one the maintenance department occupies on Gale Street. The roof has been leaking for decades and the steel beams are in bad shape, according to Tonkin.

"It could literally collapse," he said. "We did look at redoing the building on that spot. But then we need to store all our equipment. Where do you put it?"

Besides equipment, the village intends to store salt and sand supplies in the new building once it takes possession. Those materials are housed in a leased location, at an annual cost of \$3,000. Construction of an insulated storage area also is possible, Scott and Tonkin said.

Regarding the old building, Tonkin suggested it might be leveled. Parking is a possible use for the land. Tonkin said there's a shortage of parking in downtown Billtown, particularly if the Graham Medical Group office on Gale Street is busy.

Another recent transaction in town resulted in a new owner for Ladd's Food Mart. That proprietor wants to add video gambling, which by state regulations requires a license for onsite alcohol consumption.

Ladd's representative Harsh Puri and gaming-company representative William Raines have requested such permission, although neither man attended the board meeting, as Tonkin anticipated. Trustees did not discuss the topic.

The local American Legion post owns the Ladd's building and land. Post member Stan King said a special meeting is scheduled for Feb. 16 to determine the Legion's legal options and whether to support Puri's and Raines' efforts. Legion posts are eligible for video-gambling licenses. Tonkin expects a Village Board decision in March or April regarding the Ladd's liquor-by-the-drink request.

"I've got to admit, I'm not altogether comfortable with it," Tonkin said after the meeting. "I understand as a businessman why they want to do it. I think it's unfortunate that that's the way things have gone, that businesses feel it necessary to rely on gambling and alcohol to make a dime."

The meeting took a turn during the public-comment period. Tom Rice said local resident Susan Ott accused him and his wife, Village Treasurer Mary Rice, of stealing municipal money. Tom Rice oversees the village's reverse-osmosis water system.

"If she can prove that, we will resign and you can have us arrested," Tom Rice told the board.

Ott, who was in attendance at the board meeting, said later that she was misquoted and has no idea what the Rices are talking about.

"Our conversation was taken out of context. There was a dramatization of events in his statement," Ott said. "I did not make any criminal accusations about anything to do with stealing."

## Maquon woman charged with poisoning

GALESBURG – A Maquon woman used eye drops to help poison to death a man, then hid his body in a storage unit.

The Knox County State's Attorney's Office alleged that in court Monday as additional charges were filed against Marcy L. Oglesby. The 50-year-old has been in jail since last October, when she was arrested after authorities found the man's decomposed remains in Maquon.

During the hearing in front of Judge Andrew Doyle, prosecutors accused Oglesby of first-degree murder, attempted first-degree murder, aggravated battery by administering a dangerous substance and concealment of a homicidal death.

A preliminary hearing was scheduled for 2 p.m.

Wednesday, after The Weekly Post deadline. If convicted of first-degree murder, Oglesby faces a prison term of 20-60 years without parole.

Earlier, Oglesby was charged with other felonies, including firearms violations and forgery. She pleaded not guilty to the original accusations.

Court documents filed Monday revealed the name of the victim: Richard Young. Prosecutors allege Oglesby put eye drops in Young's food and drink between June and October 2021. Oglesby also was accused of giving Young citalopram, an antidepressant, without his consent.

Sometime between Oct. 15, 2021, and Dec. 25, 2021, Oglesby placed Young's dead body in a box and locked it in a storage unit, according to court documents. The body was




County Sheriff's Office deputies were summoned to Roberts Self-Storage, 105 E. Third St. in Maquon, regarding a complaint about a foul odor. Oglesby, identified as the unit owner, said the smell was from a dead opossum.


When deputies asked Oglesby to open a box inside the unit, she told them it contained a body. Decomposed human remains were found inside.

It isn't clear where Young was from or what relationship he had with Oglesby. A telephone message was left for Knox County State's Attorney Jeremy Karlin.

The sheriff's office has been awaiting results of DNA testing on the remains. Sgt. Brad Davis, a sheriff's-office investigator, stated Tuesday he

## Navigator seeking deal with McDonough County

MACOMB – The company seeking to build a 1,300-mile CO2 pipeline through Knox County and parts of central Illinois and southeast Iowa is seeking a development agreement with McDonough County.

The McDonough County Board Law and Legal Committee met Monday and discussed an offer of up to \$630,000 per year for 30 years from Navigator for cooperation with that company's proposed Heartland Greenway CO2 pipeline. The agreement would pay McDonough County \$20,000 per mile of constructed pipeline for 30 years in exchange for cooperation with the developer on a good-faith basis and positive assistance during construction as needed.

Last fall the McDonough County Board passed a two-year moratorium on such pipelines.

No action was taken at the meeting, according to Quincy television station WGEM, which quoted Committee Chairman Joe Erlandson as saying, "Our states attorney [Matt Kwacala] had advised us that due to the current legal case with the Illinois Commerce Commission that's not been closed yet, he was not recommending us to take action tonight."

In January, Navigator withdrew its application with the Illinois Commerce Commission, but the company said it plans to file again this month.

The Illinois Times reported last October that Navigator had offered officials in Montgomery County up to \$1.5 million a year for 30 years under a similar agreement. No agreement has been signed there.

## Man's hand burned when truck catches fire

BRIMFIELD – A man's left hand was burned after the truck he was driving caught fire near Brimfield.

The incident happened about 3 p.m. Feb. 4 in the 17500 block of U.S Route 150. According to a heavily redacted Peoria County Sheriff's Office report, the two men inside the 2005 GMC Sierra spoke little English, so how the vehicle caught fire wasn't clear. Brimfield firefighters doused the flames.

One man said he drove the vehicle into a field after they saw the fire, the report stated. He injured his hand when he turned off the ignition, then he and the passenger walked to a nearby business, where a deputy found them. One man had dried blood on his mouth and jacket.

The deputy summoned emergency medical personnel, who transported the burned man to OSF Saint Francis Medical Center in Peoria. Neither man provided identification. The truck was registered to a Peoria Heights construction firm.

## Fertilizer demand expected to grow this year

The supply of fertilizer is improving around the world following shocks to the system last year.

And the timing of the buildup is critical as fertilizer demand is expected to grow this season, according to BK Morris, senior markets editor, fertilizers, for CRU Group.

"The driver for prices will be from demand, not so much from supply," Morris told attendees of the Illinois Fertilizer and Chemical Association's annual convention in Peoria.

Fertilizer prices, of course, skyrocketed to historical highs last year as the war in Ukraine and a reduction of Chinese phosphate exports crippled the supply chain, along with numerous other factors.

Morris looks for Russia to export around 2 million tons of nitrogen fertilizer this year, up from just 800,000 tons in 2022. He also looks for increased fertilizer exports from China, Morocco and Saudi Arabia, among other locations into the global market, which should ease the overall supply strain experienced last year.

Elsewhere, new urea production is coming online in Nigeria.

"A lot of countries are getting production back out in the global supply chain," Morris said.

"Fertilizer affordability is improving," he noted. "But reluctance to pay high prices remains."

Morris believes fertilizer prices



will generally soften this year compared to last year, although highpriced inventory at some locations is slowing the process. But price spikes are still expected to occur during the peak seasons this spring and fall, but likely nowhere near the same levels experienced in 2022.

"Given where prices have been, there's a lot of room to go down," he said. "There's nothing to stop people from going back to normal production rates."

Morris believes tight crop supplies and strong prices will incentivize farmers in the U.S., South America and elsewhere to plant more acres and try to maximize yields.

CRU projects U.S. farmers could plant around 92.5 million acres of corn this spring, up from just 88.5 million in 2022. Soybean plantings this season could be similar to last vear – 87.4 million acres.

If realized, the boost in corn acres

along with an 11 percent increase in winter wheat seedings could drive fertilizer demand.

"There's going to be a lot of crop production," Morris said. "We will see lower (fertilizer) prices, although there will be peak periods. Of all products, nitrogen has the most downside potential this year."

Fertilizer prices in Illinois as of mid-January were steady for anhydrous ammonia (at a range of \$1,190 to \$1,490 per ton) and urea (at an average of \$710), according to the Illinois Production Cost Report.

Average prices in the state declined from the previous two weeks for liquid nitrogen (to \$614 per ton), diammonium phosphate (\$831), monoammonium phosphate (\$852) and potash (\$714).


