ACT OF CONGRESS

Post office renamed for Ben Desilets

ELMWOOD – Brenda Bland has a simple wish for visitors to the post office here that has been officially dedicated in honor of her late son.

"I really hope that when you are in the post office and see Ben's plaque, you smile," she said. "Please say his name with pride, because he was all about smiling and fun."

Bland spoke last Thursday after the Elmwood Post Office was formally dedicated in honor of her son, the late Cpl. Ben Desilets. A crowd of nearly 100 people attended the ceremony held in Central Park and heard speeches from various officials, as well as Bland and

Desilets' sister, Laura Lester.

"If you would have told my brother his name would have been on a building, much less the post office, he would have looked at you like you were crazy," Lester said. "Having his name on the post office means he'll never be forgotten, which means so much."

U.S. Rep. Darin LaHood (R-

Dunlap) introduced legislation to Congress last year to rename the post office and was on hand for the ceremony.

"Freedom is not free. And Corporal Desilets is an example of that," LaHood said. "We tend to get wrapped up in our daily lives and forget the opportunities we have, the pleas-

School cop

Elmwood schools hope to add officer

ELMWOOD – Faced with frequent headlines about school shootings, Elmwood Superintendent Chad Wagner is hoping to add a uniformed school resource officer at the building for the 2023-24 school year.

Wagner discussed his plan with the Elmwood School Board on Monday night during its monthly meeting.

"With the uptick of school violence we've seen, and I don't think it's going away, we need a uniformed officer," Wagner said.

Currently, Stu Ingersoll of Elmwood splits duties as a custodian and school resource officer. Ingersoll is a retired Peoria police officer.

But Wagner said he would prefer to have a uniformed officer in the building every day

on a full-time basis.

Wagner said he has discussed his plan with Elmwood Mayor J.D. Hulslander, Alderman Andrew Almasi and Police Chief Aaron Bean.

"All seem to support the idea," Wagner said. "I hope it will be a technicality of sorts to get [an officer] by the start of the 2023-24 school year."

Wagner said his thought is that the school would pay nine months of salary and benefits for an officer and the City of Elmwood would pick up the tab when school is not in session during the summer.

"It will be a little bit of an additional cost for us," Wagner said. "But the with the climate of school safety right now and the uptick in school shootings, I think it's really important."

In other business, the board approved retirement plans for *Continued on Page 10*

Accused murderer Oglesby now being held in Fulton County jail

After about seven months of incarceration regarding a suspicious death in Maquon, Marcy Oglesby no longer is in the Knox County Jail.

But regarding another case, Oglesby was in the Fulton County Jail, as of late last week.

During a hearing May 1 in Galesburg, Knox County Circuit Judge Andrew Doyle allowed Oglesby to be released from jail on her own recognizance. The 51-year-old Maquon resident was accused of killing the vil-

lage's former police chief after his decomposed body was found last October in a storage unit there.

Murder charges against Oglesby were dismissed earlier, although she still faces other allegations in Knox County. But Fulton County prosecutors have accused Oglesby of passing bad checks.

A court hearing for Oglesby was held May 2 in Lewistown. Her bond was set at \$7,000, of which she must pay 10 percent to be released from jail. Another hearing was scheduled for Wed-

nesday, after The Weekly Post deadline.

The Fulton County felony charge was filed in March 2022, according to court records.

In Knox County, Oglesby was arrested in connection with the death of 71-year-old Richard Young. Initial charges included concealment of a death.

But in February, prosecutors filed additional charges against Oglesby, including first-degree murder. They allege Oglesby used eye drops and other medication to poison Young, then hid his body in the storage unit. It re-

mained there for almost a year and was discovered after neighbors complained about an odor.

In March, Doyle dismissed the additional Knox County charges. *Continued on Page 10*

antries we enjoy and the values we have in our communities are because of the military and our veterans and people like Corporal Desilets."

Desilets was killed in 2007 during his second deployment to Iraq while driving the lead vehicle in a night mission.

Ron and Kim Crouch of Brimfield started the process of having the post office named in Desilets' honor after first contacting Bland.

"I had a friend reach out to me and asked if we would like to do that. I said 'Sure,'" Bland said. "I would give anything to have him back instead of doing this, but this is really an honor for him. It will keep his name alive. And that's all any mom wants is to keep their child's name alive."

LaHood said this is just the third post office renaming he has been part of in eight years in Congress.

"I wish I didn't have to do any of them," LaHood said. "But in some ways, it's a great way for the community to be reminded of the sacrifice and service of Cpl. Ben

Desilets and others. And it's a reminder to young people and everybody that we live in the greatest country in the world because of

people like Cpl. Desilets."

A plaque recognizing Desilets was placed inside the post office lobby.

A 2004 graduate of Elmwood High School, Desilets was awarded a Purple Heart, Navy and Marine Corps Achievement medals with Combat Distinguishing Device, Combat Action Ribbon, Good Conduct Medal, National Defense Medal, Iraq Campaign Medal, Global War on Terrorism Expeditionary Medal and Sea Service Deployment Medal.

He was posthumously promoted to corporal.

USDA forecast: Big crops, measly prices

The United States Department of Agriculture's most recent World Agricultural Supply and Demand Estimates report confirmed that a freight train of grain is barreling toward 2023-24 markets, and farmers everywhere need to prepare for the rockier prices sure to follow in its wake.

The report was succinctly summarized by DTN market analysts shortly after its release May 12: "USDA projects farmers are in the midst of planting the country's largest corn crop on record at 15.265 billion bu. (bb) and a record soybean crop at 4.51 bb..."

As every grain market participant knows, the double corn/soybean production record is a double-edged sword because the records will lead to larger, price-flattening carryovers. Again, per DTN: The huge crops mean "2023/24 'new crop' ending stocks for corn (are) projected at 2.22 bb and soybeans pegged at 335 million bushels (mb)."

The corn carryover is 805 mb higher, or 68 percent, than the 2022 carryover and the soybean carryover is 119 mb higher, or 55 percent larger.

The projected corn crop, which USDA forecasts will top 2016's record 15.1 bb, will slap the coming year's average price down to \$4.80 per bushel, a profit-clipping \$1.80 below this year's average price.

Likewise, this year's likely record soybean crop means its projected average price will slide from \$14.20 per bushel to \$12.10, or \$2.10 per bushel.

While \$1.80 per bu. lower for corn and \$2.10 per bu. lower for beans sound modest, the declines – taken across the record production for both crops – mean a chunky, multi-billion drop in gross U.S. corn income and a smaller but still substantial drop in gross U.S. soybean revenue.

And that's if either or both projected record crops hit their forecasted targets. If good weather boosts either crop's final production – a hard number not known until November – carryover will climb even higher, average prices will fall, and farm income will slip even lower.

In the middle of all this good-news-is-really-bad-news data for U.S. corn and soybeans farmers, American wheat farmers couldn't tell if their section of the WASDE was a pat on the back or a kick in the pants – a distance, the all-but-sainted former USDA chief Earl Butz liked to remind audiences, "is only 18 inches apart."

The headline to the wheat forecast, Bloomberg blared, was that "America's wheat fields have become so plagued by drought that farmers are now poised to abandon crops at the highest rate in more than a century."

In fact, the news service went on, "Producers are expected to harvest about 67 percent of their planted acres ... (that) if realized would be the lowest ratio since 1917..."

So the shorter U.S. crop means taller U.S. prices, right?

Bloomberg said that's a rock solid, ah, well ... maybe: The acreage abandonment "to lower levels than analysts were expecting ... could keep domestic prices elevated, even with rival producers such as Canada and Argentina

likely to boost output."

USDA's wheat price projection, however, did not agree.

Indeed, government forecasts didn't say "could" at all. Instead, drought or no drought, the WASDE pegged 2023-24 wheat prices at \$8 per bu., or 85 cents lower than last year's average price.

Which just goes to show the world why America's farmers continue their more than a generation-long love/hate relationship with wheat: They just can't catch a break with it.

For example, strong 2022 prices – buoyed by both lower U.S. acres and the Ukrainian-Russian war – encouraged hesitant growers to sow 10 percent more wheat this marketing year.

Last summer's drought, however, continued into winter, then spring, to deliver – holy cow – record acreage abandonment, normally a booster rocket for prices.

But, no, Chicago July wheat futures continue their sleepy, slow slide. On Dec. 30 July futures closed at \$8.03.

By mid-May, though, the July contract had slipped below \$6.50 per bu. and now has the grease to slide more.

Given 2023's soaring production-sinking price forecast, maybe Old Earl the Pearl had it right with his back-patting/backside-kicking wisecrack.

Man found with drugs in Farmington yard

• **FARMINGTON** – Authorities discovered various illicit drugs in a Farmington man's possession recently, according to a police report. Sean R. Holton, 37, was arrested about 4:30 p.m. May 10 outside a residence in the 100 block of N. Gold St. after someone reported a suspicious man in the area.

Princeville may expand border

PRINCEVILLE – A Princeville manufacturing company plans to expand. That might mean village limits will expand, too.

Greenfield Contractors is planning to purchase about 15½ acres of unincorporated land just north of the Dollar General store at 1107 N. Santa Fe Ave. There the agricultural-construction company intends to build an office and a 20,000-square-foot area for fabrication and inventory storage, among other uses.

During a Princeville Village Board meeting May 16, Greenfield owner Lucas Young and project manager Dean Bailey asked trustees to consider annexing the property. Village annexation would facilitate future Greenfield connections to the municipal water and sewer systems.

Bailey and Young also said annexation and resulting village services might lure other businesses to that plot, because Greenfield isn't likely to use all of it.

"I don't know what 10 years would bring, but we would hope to sell off some of that for some other use," Young said. "...You can get a lot of square footage on 15 acres."

The board took no action on the proposal but appeared receptive. Village President Jeff Troutman suggested Greenfield first must buy the land.

"Then it's a pretty simple process to annex them in," Troutman said.

Property purchase is probable within the next couple of months, according to Young. Bailey said Greenfield and the landowner have agreed on a sale price. Young said construction is about two years away ideally but might commence sooner, depending on business.

Currently, Greenfield occupies a 1,600-square-foot building at 1012 N. Santa Fe Ave., across the road and south of the proposed site at the north edge of Princeville. Until last September, Young and his family lived in the building. Greenfield is building a shed nearby as a stopgap space.

"We've grown very quickly over the last 11 years and feel we're going to outgrow where we're at now," Bailey said.

Greenfield specializes in constructing fabric-covered and steel-framed agricultural buildings. It also has offices in Iowa and Kansas.

An unoccupied house, an outbuilding and timber and overgrowth occupy the 15½-acre unincorporated plot. The house is beyond saving, Bailey said. He indicated purchasing a bigger-than-required property makes sense for Greenfield.

"We didn't want to tie our hands and build and in five years have to do this again," he said. "We looked at 'Can we save some of the trees?', but it would be a good spot for some future expansion for Princeville."

Regarding more immediate construction, the village issued building permits for new solar panels at 214 N. Ellen Ave. and a 21-foot above-ground pool at 322 S. Edwards Ave., Troutman reported.

Among action items, the board waived a liquor-license fee for the Akron-Princeville Fire Protection District beer garden during the village Heritage Days celebration June 22-24. The board authorized the location of the beer garden, at Spring Street and Santa Fe Avenue.

The board also gave final approval to Mark and Shelly Davis' \$10,000 purchase of a lot in the Aten Acres subdivision. A proposal to approve the village budget for the 2023-24 fiscal year was tabled.

three long-time teachers.

High school teacher and assistant football coach Brad Crisco will retire after the 2026-27 school year, as will longtime grade-school teacher Vicki Warner.

In closed session, the board approved granting 20 extra sick days to math teacher and coach Gregg Meyers, who will then be able to retire at the end of the 2025-26 school year.

The board also approved raises for paraprofessional and non-certified staff members. The minimum pay rate will be \$15 per hour. Those at \$15 per hour last year will receive a 5.82 percent raise.

Those were the big items in a quick meeting that also saw the approval of

several procedural items and some discussion of school improvement projects.

In regards to the latter, the school now has new boilers and a chiller for the elementary school air conditioning system in place and functioning. Since last fall, the school had been operating on a single boiler that was intended to be a backup only.

Work is also progressing on the Claude Keefer Industrial Arts Building, with concrete flooring work done and block work to start soon on the connection to the school. Board President Mark Davis said there was a week delay in some aspects of the construction project.

Also, crews will start Wednesday with demoli-

tion and remodeling of elementary school bathrooms, which will include stalls between urinals.

Welcomed back as a staff member at the school was Lane Hampton of Elmwood, who has been hired as the junior high special education teacher.

In other action, the board approved its annual insurance policy with Unland Companies for 2023-24 for \$101,137. While that reflects a 3 percent increase from this year, Wagner said it's very palatable given the 10-12 percent increase that is standard for most insurance policies nationwide right now.

The board also voted to approve Gorenz and Associates Ltd. of Peoria as the district auditor for a cost not to exceed \$19,985.

Wagner had intended to put that job out for bid, but heard from only one other possible taker.

In personnel, the board approved the following hirings for the 2023-24 school year (unless otherwise indicated): Tyler Baysingar as junior high baseball coach and JH assistant basketball coach; Alexandria Tomevi as art teacher; Derek McCoy as custodial help for summer of 2023; Stephanie Bolgan and Baysingar as freshman sponsors; Caleb Waddell and Luke Pratt as sophomore sponsors; Josh Fugitt and Lori Caulkins as junior sponsors; Alex Coulter and Destiny Wiebler as senior sponsors; and Hayley Davis and Wiebler as prom sponsors.

The board read in reports from principals that 39 high schoolers graduated last Sunday and 52 8th-graders were promoted on May 18.

Oglesby's defense attorney argued they were filed more than 120 days after Oglesby was taken into custody. That would violate her right to a speedy trial, per state law.

Knox County State's Attorney Jeremy Karlin appealed Doyle's decision to the Fourth District Appellate Court in Springfield. When contacted last week, Karlin told The Weekly Post he has received no word about the appeal, nor does he expect one for a while.

"The schedule is such that we don't know if we'll hear anything before the end of this year or early next year," Karlin said.

With the appeal pending, releasing Oglesby from jail was the only option, Assistant State's Attorney Ashley Worby told Tri States Public Radio of Macomb.

A pretrial conference for Oglesby in Knox County is scheduled for July 10. She faces forgery and firearms charges there, in addition to the death-concealment charge. Oglesby has pleaded not guilty.

Young's death has not been forgotten in Maquon. Yard signs emblazoned with "Justice for Rick," alongside Young's photograph, were found there and in Elmwood last week. A similar banner was in downtown Maquon. A candlelight vigil in Young's memory was held in February at a Maquon church.

Some Elmwood city staff receive pay raises

ELMWOOD – During a brief meeting on May 16, the Elmwood City Council voted in favor of 5 percent pay raises for some city staff.

Increases were approved for all staff in the police department and for Economic Development Director Amy Davis.

Still to be determined are pay increases for staff of the city water department and City Clerk Bethany Lovingood. Alderman Nathan Brunnelson said he wanted to first discuss any raises with Mayor J.D. Hulslander, who was unable to attend the meeting for work-related reasons.

Alderman Andrew Al-

masi was sworn into office at the start of the meeting.

Also at the meeting was Kenny Blum, who is expected to be appointed to the council at its June 6 meeting to replace Dara Wagner as representative for Ward 3.

Wagner and Ward 1 Alderman Walt Avery were not in attendance at the meeting.

In other business, Greg Devries, assistant fire chief for the Elmwood Fire Department, spoke to the council about a potential intra-governmental agreement with the new Illinois Professional Emergency Management Association.

Devries said such an agreement would provide mutual aid for Elmwood in

case of disasters. According to the IPEMA website, the group seeks to “embrace an ‘All Hazards, Whole Community’ approach taking emergency management response, training, and planning in Illinois to the next level.”

“It’s free insurance is what it is,” said Devries, who is interim president and a regional coordinator for the group.

Devries said IPEMA hopes to eventually have its own dedicated dispatch center.

Action on an agreement was tabled until the June 6

meeting.

Davis reported that the Ruck 22 Walk will be held May 27 at 7:30 a.m. Last year more than 130 people participated in the walk, designed to raise awareness of veterans suffering with PTSD and veteran suicide. The event raised more than \$13,000, which was divided among Freedom Paws Service Dogs, the John Pettit Memorial Scholarship and Elmwood’s Archie Miles VFW Post 4724.

B-E runs into hot pitcher in softball semis

Brimfield-Elmwood was a hot softball team most of this season. But in the Indians' first game of the Class 2A state tournament, they encountered a hot softball pitcher.

Katie Petran struck out 17 batters and allowed only one hit as she lifted Chillicothe IVC to a 7-0 victory May 17 in the Brimfield Regional semifinals. Petran's performance ended the B-E season and a 17-game winning streak.

The Indians, seeded third in the sub-sectional, finished 19-3. In the regional final May 19, fifth-seeded IVC lost 3-1 to No. 2 Mercer County, which advanced to a Taylor Ridge Sectional semifinal earlier this week.

Sawyer Drury's one-out single in the fifth inning was the only B-E hit against IVC (18-8). It followed a strikeout, and two more strikeouts followed it.

"Katie was just on," B-E Coach Kurt Juerjens said of the Butler University recruit. "I thought she pitched as well as she can, and we just didn't have an answer for it."

Juerjens said it was the best pitch-

ing effort his team saw this season, without question. Still, Drury matched Petran in runs allowed until the fourth.

A two-out batted ball dropped in the infield and allowed Petran to score the only run IVC needed. She doubled to lead off the inning. Brooklyn Smith followed with a three-run homer.

"I thought Sawyer pitched well," Juerjens said. "She got soft contact, but we weren't able to make those plays. It would have turned into no runs scored that inning, but it turned into four. But again, we would have had to find a way to score."

Drury pitched 5 1/3 innings and allowed six hits and six earned runs. She struck out six. Fellow freshman Schyer Meinders relieved her and struck out one in 1 2/3 innings.

The freshman duo and sophomore Brooke Sumner, who spent this season recovering from injury, should give B-E a solid pitching foundation for 2024. On offense, the Indians will lose seniors Ella Florey and Katie Yemm but return slugging junior Kierra Johnson and classmate CJ Troxell, among others.

As for this season, Juerjens said the finish was disappointing. But given the regional opponent in the pitcher's circle, perhaps it was understandable.

"If you have a good year, you're still going to look at how it ended. Could you do better in the postseason?" Juerjens said. "But facing (Petran) as good as she was, it kind of tempers the disappointment a little bit.

"I felt like we just kind of ran into a buzzsaw. I don't think we laid an egg. I just felt like she was really dominant."

Class 1A

ROWVA-Williamsfield couldn't sustain an early lead and lost 8-5 to North Fulton in a Billtown Regional semifinal May 16.

The Cougars (19-15) were ahead 3-0 after two innings, but the visitors scored three times in the fourth to take a lasting advantage. Avery Rigg had two RBI and a triple for R-W, and teammates Ava Landon and Maddy Nelson each had two hits.

North Fulton was seeded fifth in the sub-sectional, R-W fourth. Top-seeded West Central beat North Fulton 6-2 in the regional final May 20.

Continued from Page 20 sectional, where he placed third with a PR of 6-2.75, is senior high jumper Logan Morse of Farmington.

Reading too much into seedings can be a mistake, though. Some athletes save their best for state. Some sectional relays are missing a top runner or two. And some athletes may not even compete in an event for which they qualify.

Consider Hill, who is among the state leaders in the 800 and 1,600 and recently broke Thomas Harmon's 1-year-old E-B school record with a 1:54.26 clocking at a May 11 home meet. While he's a certain participant in the 4x800, Hill may not run the 1,600.

"A lot of it is going to come down to him deciding what he wants to do and the temperature and what the weather is," Meyers said. "If it's 74 degrees, he might race all three. A lot depends on the weather."

Hill said he is most excited about the 4x800, which has improved steadily this season and looked strong at sectional.

"We ran a really good time and I didn't expect us to run that fast," Hill said. "But after this time, I think we have a chance of medaling."

The same is true for Morse, who had the best day of any Farmington athlete at sectional.

"Logan as a high jumper has been great his whole career. The past few weeks have been a little rough for him, so that's what I was most worried about," Farmers Coach Brad Whitcomb said. "Then he came out and just crushed it right off the bat and got a 6-1 state-qualifying height on his first attempt."

Things did not go as smoothly for Farmington's usually reliable relays, though. The Farmers were disqualified in the 4x100 after a false start and had a bad exchange in the 4x200.

That relay of junior Hunter Darsham, sophomore Jake Martin, freshman Kyle Miller and Morse ran fourth but qualified with a time of 1:33.33 that has them seeded 28th.

The Farmers also narrowly reached state in the 4x400 behind Darsham, Jake Martin, freshman Ethan Martin and Morse. Second at sectional in the 4x400 in 3:36.80, Farmington is seeded 36th.

"We're in and we still have a week to clean things up," Whitcomb said.

Also advancing for Farmington was junior pole vaulter Brayden Morse, who cleared 12 feet, 4 inches to win the sectional and is seeded 16th.

Princeville's top placer at sectional was the 4x400 of junior Tayshaun Kieser, Johnson, Melick and Bosch, which won in 3:33.45 and is seeded 28th.

Bosch was second in the 800 in a PR time of 2:02.8 that has him seeded 26th.

Kieser placed third in the 400, but qualified with a time of 51.8 seconds that is good for a 26th seed.

"We got Parker Melick back. He hadn't run since the conference meet with a groin injury," Princeville Coach Jon Carruthers said. "We gave him a couple weeks off and he came out and had a good leg in the 4x8 and 4x4. It was a good meet and a lot of kids PRd."

Also advancing to state was ROWVA-Williamsfield senior thrower Brody Bledsoe, who won shot put (47-5.25) and discus (PR, 143-1.75) at the sectional and is seeded 13th and 19th in those events, respectively.

Smiles for Strahm

E-B sophomore wins pole vault; Brodie 2nd in discus

CHARLESTON – Mya Strahm was smiling long before she came back to earth and landed on a cushioned mat.

As soon as she cleared the bar last Saturday morning, Strahm's expression changed from serious to smiling. After a season that almost wasn't, after pain and stretching and laser therapy, the Elmwood-Brimfield sophomore could celebrate an unexpected pole-vault championship.

Vaulting in a competition for only the third time this outdoor season, Strahm won a jump-off Saturday, clearing a personal-best height of 12 feet, 4 inches to claim the IHSA Class 1A state pole-vault title.

The sophomore led a group of seven area placers at the state meet, being held at O'Brien Stadium on the Eastern Illinois University campus for the 50th time.

Hampered by a torn hamstring and later a torn bicep, Strahm said she was in pain Saturday.

"My hamstring is giving me some issues right now. It hurts the most since I tore it (in January)," Strahm said, while smiling broadly. "I just wanted to push through it. I just feel satisfied. I feel really good. I'm happy with myself."

A second-place finisher last year in pole vault, Strahm vaulted for the first time this out-

door season in sectionals and then Thursday was the leader after prelims by clearing 10 feet, 6.5 inches.

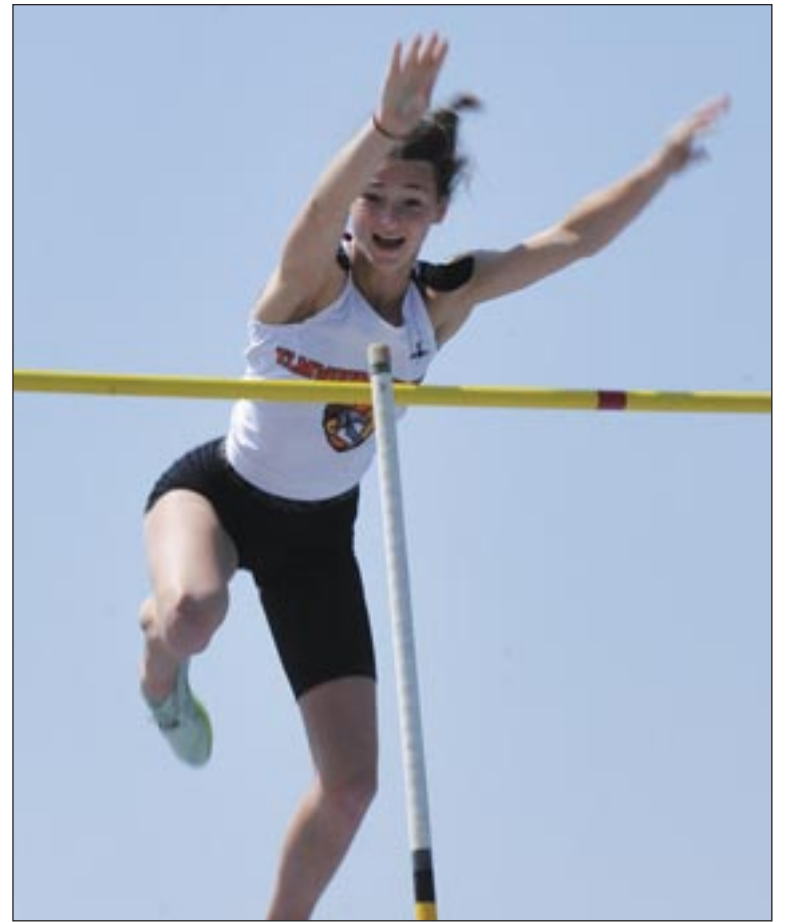
"I honestly didn't think I would be here. I thought my season was done," she said. "Then my injuries helped motivate me."

Strahm missed once Saturday out of the first four heights she attempted, including 12 feet. She was then one of four jumpers who cleared 12 feet but missed their three attempts after the bar was moved to 12-4.

Because Strahm and senior Livia Binder of Maroa-Forsyth had the fewest misses overall, they were pitted in a jump-off for the championship.

Strahm cleared the jump-off height easily in her first attempt and Binder narrowly missed to place second. The two are teammates on the Normal-base Flying Dragons Pole Vault Club, as is Class 2A state champion Chelsea Wetzel of Dunlap (12-2.5).

Even so, Strahm was proud to represent E-B. "We've never had

a girl pole vaulter (state champion) before, so I'm happy to be the first," Strahm said.

The next-best finish among local qualifiers was posted by

Princeville junior Brianna Brodie, who took second in Class 1A discus with a throw of 126-4.25.

E-B 4x800 relay seeded No. 2

KEWANEE – Isaiah Hill did what he had to last Friday at the Kewanee Wethersfield Class 1A boys track and field sectional.

"A lot of it is just winning. Not running (personal-record) times, just make sure you've got the points and the place and move on," Hill said.

Even though he was holding back, the Elmwood-Brimfield junior was impressive in helping the two-time defending champion Trojans (60 points) finish second behind Mercer County (98 points).

First Hill ran the anchor leg for E-B's winning 4x800-meter relay, waiting until 300 meters remained to open a six-second lead over runnerup Princeville.

"In the 4x800 he ran a 1:57," E-B Coach Gregg Meyers said. "When you can run a 1:57 and not go all out, that's pretty good."

Then Hill won the 800 in 2:00.05, waiting until the final 200 meters to pass

Lucas Arnold of Mercer County, who was third behind Princeville's Joey Bosch.

Finally, Hill moved a bit earlier in the 1,600 for a win in 4:38.88.

While none of his individual times approached personal records or have him seeded highly heading into the state meet, Hill was satisfied.

"It's like practice for state," Hill said. "It kind of gets you in that mind-set of winning."

In the wake of a sectional that saw 16 local athletes qualify for the Class 1A state meet today and Saturday at Eastern Illinois University, E-B's 4x800 ranks as the top-seeded area event. The Trojans' relay of senior Brendan Williams, freshman Aiden Faulkner, sophomore Reed Florey and Hill posted a season-best time of 8:19.72 that ranks second among state qualifiers behind Williamsville's 8:07.13.

Not far back is Princeville's 4x800 relay of senior Jordan Johnson, sophomore Tucker Sennett and juniors Parker
