# Stark Co. board discusses CO2 pipeline; to hold special meeting

**By JOHN A. BALLENTINE** For The Prairie News TOULON – A a packed with people heard the Stark County board discuss a proposed CO2 pipeline Tuesday, but take no action due to the lack of a quorom.

As a result, the county board will hold a special meeting to allow for possible action.

Only four of seven board members were present: Tom Howes, Tim McMillen, Joe Orwig and Bill Loane. Chair Kari Bush joined by Zoom, but that does not count toards a quorum because she was not physically present. Jamie Schaffer,

Adam Wilson and Robin Nowlan were absent.

The proposed pipeline by Wolf Carbon Solutions, of Denver, Colo., would run from Clinton, Iowa, to Decatur and would pass through southwest Stark County.

Opponents spoke about unknown standards and safety protocols, agricultural losses, pipeline deterioration due to corrosive effects of CO2, damage to field tiles and heavy equipment compacting the farm ground. They also said easements are permanent and that eminent domain could be used against landowners to take their land.

Opponents said crop yield loss

would occur and want the board to invoke a moratorium on the proposed CO2 pipeline, following the example of McDonough County.

Bill Winans, Goshen Township representative, said his township recently passed a moratorium because "there is concern and a need to check things out."

A representative from Citizens Against Predatory Pipelines, Joyce Harant, said a resolution should be passed and theboard should intervene to stop Wolf Carbon Solutions' pipeline.

CO2 is pressurized in the pipeline and opponents claim a ruptured or broken pipe presents

health hazards for people and communities near the pipeline.

Emergency management director Mat Schnepple was in attendance and said he came to the meeting to get Wolf Carbon Solutions to respond to him, since the company had not replied to previous inquiries.

Schnepple said it appears that in Henry and Stark counties there is only one Emergency Management Agency that would respond in case there was an emergency situation concerning the pipeline.

Wolf Carbon Solutions was represented by an ADM Engineer. He said CO2 pipelines have been regulated for 40 years and

drain tiles in fields would be avoided or repaired if damaged. Wolf Representative Todd Peterson said construction of the pipeline would begin in 2025, if approved, and pipe would be five feet underground.

Proponents said a ruptured CO2 pipeline incident in Satartia, Miss., was a rare occurrence. Wolf Carbon was not involved with that pipeline and company reps said protocols were not followed, which led to that rupture.

Wolf Carbon said that the pipeline would be monitored and inspected every five years.

# **Gun registry slow** Less than 1% reported so far

With Illinois' gun and magazine ban still facing legal hurdles in federal court, a registry created in relation to the ban has been open for a week. A fraction of a percent of gun owners have complied so far.

As part of the Protect Illinois Communities Act enacted earlier this year, a registration portal for firearms owners in Illinois that own certain semi-automatic firearms, accessories and ammunition opened Oct. 1. The law bans more than 170 guns.

Illinois State Police published the first round of statistics Tuesday, and of more than 2.4 million Firearm Owner ID card holders, 1,050 individuals have registered 3,202 firearms, .50 caliber ammunition and accessories.

LAURA - Debbie Arends pointed out the apples on the ground and the high grass surrounding some of the apple trees.

Finding employees this year has been tough at R.E. Arends Orchard just outside Laura. It's a small operation - 30 acres of trees - and Debbie Arends and her husband, Art, whose family has owned the farm since 1956, handle most of the day-to-day tasks.

"It breaks Art's heart" seeing the condition of the orchard, Debbie said, tearing up. Compounding the hiring challenges, Debbie, 65, was recently diagnosed with uterine cancer. While she'll still be able to handle tasks such as checking email and keeping the Facebook

page updated, her recovery will require weeks of rest. She also can't drive for four to six weeks, which worries her because she sells their produce at the farmers market and makes their wholesale deliveries.

"It's during the height of our season," she said of her surgery timing. "We make our money in two and a half months and we live on that the whole year."

Even though the orchard is small, four cars pulled up within an hour on a recent Tuesday afternoon.

"Do you have a quart of apple cider?" shouted one man who pulled up.

The couple chatted up customers as they browsed the apple selection in the former dairy barn. And when some of the older customers were ready to leave, Art helped them to their cars.

It's that kindness and top-level service that customers appreciate, Debbie said.

"He also took care of his aging parents. That's what attracted me to him," she said.

She notes her husband is proud of what he's built at his family's farm, and it's heartbreaking that she won't be able to help in the same capacity after her surgery. She asked customers to "be patient" going forward.





Continued from Page 1 in front of Southern District of Illinois federal Judge Stephen McGlynn Wednesday afternoon.

And the Seventh Circuit U.S. Court of Appeals has yet to release an opinion in the consolidated case challenging the state's law on Second Amendment grounds. Appellate judges heard that case June 29.

Vandermyde advised against registering right away as the law continues to be challenged in federal court.

"They've got a long way to go if they think they're going to get any real sort of compliance," Vandermyde sai


The emergency gun registration rules are before

the Joint Committee on Administrative Rules, which meets Oct. 17. The deadline to register firearms the legislation bans is Jan. 1, 2024.

Being found out of compliance could bring criminal charges ranging from a Class A Misdemeanor for the first offense to a Class 3 felony

for subsequent offenses. Only firearms owned before Jan. 10, 2023, can be registered, according to Illinois State Police.

State Rep. Amy Elik, R-Alton, has a measure filed last month that would require Illinois State Police to destroy firearm registration records if the law is found unconstitutional.

# **Unbeaten Rebels top Princes, 48-28**

WYOMING - Despite running just three offensive plays in both the first and fourth quarters, the state-ranked Stark County football team stayed unbeaten with a 48-28 win over rival Princeville.

While Stark County (7-0, 6-0 LincolnLand small division), Princeville did everything it could to stay in the game. The Princes (4-3, 4-2) attempted several onside kicks, made a determined effort to stop the Rebels' run game and controlled the clock.

But Stark County, ranked No. 8 in Class 1A in last week's AP poll, packed plenty of offense into its opportunities, passing for three scores in the second quarter and scoring twice in the final quarter despite running just three plays – two of them kneel downs.

"I thought we threw the ball well and we just ran our offense well, when we got some offense," Rebels Coach Jade Noard said.

The Princes opened the scoring on a 4-yard run by Tayshaun Kieser, but did most of their damage through the air. Quarterback Logan Carruthers passed for 325 yards and completed 24 of 40 passes, including a 74-yard TD toss to Jake Williams that made the score 14-12 late in the second quarter.

But Stark County came back to score on a 25-yard pass from Luke

Rewerts to Connor Wagenbach just before halftime. That was one of three Rewerts TD tosses in the second quarter, with the others going to Nolan Orwig (16 yards) and Wagenbach (25 yards). Rewerts also ran for a 4-yard score and passed for 160 yards overall.

"He made throws he had to make," Carruthers said. "They got that one right before half and our coverage was good. Just a nice throw and catch. That hurt our momentum."

Chris Barnwell also popped a 54yard scoring run at the end of the third quarter against a Princeville defense determined to stop the run.

"In the past two weeks we've shown we can do both, run and pass," Noard said. "That's something good you can put on film."

Down 34-20 heading into the fourth, Princeville gave up a 62-yard interception return to Charley Holmstrom. Then, after a scoring run by Logan Carruthers, a miscue on an onside kick gave Stark County the ball at the Princeville 7-yard line. The Rebels needed just one carry from Orwig to close out the scoring.

"Their defense is very good, very fast," Coach Carruthers said.

"They've got a lot of nice athletes." Stark County travels to Table

Grove todayto face South Fulton (3-4, 3-3), a traditionally scrappy program that is in most games.

"I think they are just a tough, hardnosed team that won't go away," Noard said.

Princeville is home against Rushville-Industry Friday and Coach Carruthers said controlling the ball will again be important against a runoriented foe.

PEORIA HEIGHTS - This might have been the best chance for Galva to win this season. Peoria Heights (2-5) was the only team the Wildcats beat on the field in 2022.

Things weren't looking too bad for Galva in the second quarter, when Alec Gustafson returned an interception 93 yards for a touchdown that cut his team's deficit to 8-6. But that's as close as Galva came.

"Let's have a great week of practices and do everything we can, because we've got a shot," Galva Coach Mark Jeffrey said about his team's approach last week. "The big story for us is kind of the same ending.

"You get into that third or fourth quarter and a couple of guys need to come out of the game and you've got to replace your guys with freshmen."

Princeville was third and led by Bethany Sennett (6th, 19:13).




