## Late-arriving seniors boost unbeaten Rebels defense

A broken bone was the clincher for Owen Gibler. In the final game of his JV season as a freshman, Gibler broke his hand and ended his football career.

Or so he thought.

But as senior year approached, Toulon resident Gibler decided to give the gridiron another chance.

"I realized how good of a class I had and how many athletes we have in our class, and decided I wanted to be part of what they made last year, that playoff run and everything,"

Gibler said. "The Stark County Rebels finally got in again and I decided to join them again."

Charley Holmstrom of Wyoming never played high school football. "I just didn't want to do it," he said.

But like Gibler, as senior year approached, he was enticed to

play by seeing the team's success and hearing friends tell him how much fun they were having.

Unexpectedly, both late-arriving seniors have been starters all season on a defense that has helped restore memories of Stark County teams of old.

Multi-threat quarterback Luke Rewerts deservedly gets plenty of credit for Stark County's 9-0 record, No. 5 state ranking in Class 1A and LincolnLand Conference small-division championship. Same with running back Nolan Orwig, three-year starting lineman Tanner Price

and defensive backs Matthew Bowser and Chris Barnwell. They are names you know.

But football is a team game, and this year's Rebels squad has fielded a better 11 because of unexpected contributions by 6-foot-2, 195-pound Gibler and 6-

1, 175-pound Holmstrom.

"People have talked about what's the difference this year. One of the differences is we have everybody out that should be out," Coach Jade Noard said. "At a small school, you can't afford to have guys like (Gibler and Holmstrom) walking the halls and not on your squad. They are both big, strong kids who are athletic."

Even so, not many seniors can come in and contribute, let alone start. Both Gibler and Holmstrom admitted they were very nervous heading into Stark

## No to pipeline

Stark Co. Board passes resolution

TOULON – The Stark County board passed a resolution to intervene against the Wolf Carbon CO2 pipeline at a special meeting held Oct. 16.

At the same meeting, the board heard that Stark County has been dropped by its longtime insurance carrier and that a new carrier no longer wants to insure the Stark County Jail for liability.

In regards to the proposed pipeline, the board voted to oppose the construction of any CO2 pipeline in Stark County because CO2 pipelines pose a threat to the health and safety of residents. The resolution also urges the Illinois Commerce Commis-

sion to oppose CO2 pipelines.

The board held its special meeting because a quorum was not present at the Oct. 10 meeting and no action could be taken.

Several Stark County residents spoke during public comment and Leslea Carroll reiterated why she believes Wolf Carbon should not be allowed to put a CO2 pipeline through Stark County and Illinois. She referenced safety as an issue, said Wolf Carbon has not provided transparency,





## STARK: Past claims diminish insurability

and noted reduction of property values among her concerns.

Carroll asked the board to pass the resolution to stop the CO2 pipeline and submit it to the Illinois Commerce Commission.

Other Stark County residents called for the board to pass a moratorium to stop Wolf Carbon's CO2 pipeline before the Oct. 24 deadline. They spoke about emergency management issues should there be a pipeline rupture.

Henry-Stark Emergency Management Director

Mat Schnepple submitted a letter to the board stating that the Office of Emergency Management has agreed to changes asked for in an Emergency Response Plan from Wolf Carbon, the CO2 pipeline company.

The county board discussed the pipeline and one board member said Wolf Carbon has not provided any compensation to the county for placing a pipeline in Stark County. Another board member proposed meeting with other county boards to see where they stand on this

issue. Board member Bill Loane said the Illinois CO2 pipeline is the dumping ground for CO2.

"I'm fearful for the water supply," Loane said. "This resolution is the first step to try and block some of this."

Chair Kari Bush said the board should submit a request to the Stark County State's Attorney's Office to file a petition intervening with the pipeline. The board made a motion to have the Stark County State's Attorney Caroline Borden Campion file that petition. Bush also discussed possibly hiring an outside law firm to aid the county in this regard.

In other business at the meeting, John Leezer of the Leezer Insurance Agency presented the yearly insurance quote for the county's insurance carrier. Tokio Marine has been the county's insurance carrier for approximately 25 years and has elected not to insure the county moving forward because of multiple costly claims against the county that were paid out in the past two years.

Illinois Counties Risk Management Trust Insurance agreed to insure the county, but will not insure the Stark County Jail for liability coverage. That decision may stem from another alleged suicide at the jail in September. The Prairie News has submitted a Freedom of Information Act request to the Stark County Sheriff's Office for details concerning the matter.

Leezer said the premium will be considerably be higher for insurance covering the county.

Board members discussed having to send Stark County Jail prisoners to other counties to be housed if there is no insurance covering the jail. If this happens, it would be an added expense for Stark County to pay other counties to house its prisoners.

The county board plans to pass a motion for county insurance coverage at its regularly scheduled Nov. 14 meeting.

One board member said that it could possibly be \$40,000 higher than last year.

## Getting to 'yes' and other Farm Bill worries

Representatives, the Speaker of the House will have less than a month to push through a workable federal budget, compromise with Senate Republicans to craft an Israeli-Ukrainian multi-billion-dollar aid package, and – at the very least – extend the now-expired 2018 Farm Bill through the end of the year, if not through all of 2024.

As often is the case with House Republicans, however, the new leader's hardest job won't be any of these very tough, all-but-intractable problems. The harder, more perilous task will be finding a safe path through GOP minefields to get to the other side of the political divide to even negotiate.

Just ask the experienced Republicans whose careers fizzled when they attempted that treacherous feat in the last 30 years: Newt Gingrich, John Boehner, Paul Ryan, Kevin McCarthy and Steve Scalise.

Deposed. Deposed. Deposed. Deposed. Kneecapped.

And it's not just the Pecan Wing of the Filbert Caucus that excels in member fratricide. Democrats are somewhat deft at it, too. For example, more than 40 years ago, then-House Majority Whip Tom Foley, D-Wash., explained to a rookie reporter, me, the most important skill he used in pushing farm bills through Congress.

"You have to know how to get people to 'Yes,'" said Foley, who chaired the House Ag Committee

when it wrote and passed the 1977 Farm Bill.

For example, Foley explained, he wanted the 1981 Farm Bill to include a phrase or two to help his district's sugar-beet growers. When his Dem friends on the committee balked, Foley – who had left the committee to move into House leadership – quietly let it be known that he, the Speaker's key vote-getting man, wouldn't vote for their bill unless his necessary additions were in it.

The unspoken threat was clear: If the party whip wasn't going to vote for the bill, don't expect him to whip the votes you need to pass said bill.

"That refocused everyone's mind," he explained, and his "ask" was added to the bill's final version via a floor amendment.

The divided House then quickly passed the 1981 Farm Bill a few days before Christmas by a paper-thin, 205-203 vote.

"The difference was my vote," Foley related, and his point – "Know what people need to get to 'yes'" – was driven home again.

Any new GOP Speaker got that message from Kat Cammack, a Florida Republican on the House Ag Committee, prior to any vote.

"They're" – whomever is speaker – "going to have a very tough time regardless, trying to find a way to get conservatives and moderates to support a farm bill that is very much needed," Cammack told Politico's Weekly Agriculture in mid-October.

Translation: It's House Republicans that Ag Committee Republicans need to worry about, not House Dems.

The bigger – and maybe even smarter – Farm Bill question House Republicans face isn't if they can scrape together enough votes to extend the 2018 law through Dec. 31. If, in fact, they can find the votes to extend, why not extend the expired law through the end of 2024 to give everyone time to write a better bill?

For now, anyway, House Ag Chairman, G.T. Thompson, Republican from Pennsylvania, favors a short-term extension over adding another year. He told Politico last week "that the 'real drop-dead deadline for the farm bill is December 31,' meaning a new farm bill extension will be necessary before then" without mentioning any effort to push the deadline through next year.

But even that might be a hard ask of the deeply split, deeply suspicious House Republicans. While they rightly brag that they have passed three 2024 appropriation bills, nine more still hang fire. Moreover, any if not all, House spending bills will run smack into serious bipartisan opposition in the Senate.

And that's if the legislative process even gets that far with the mid-November budget deadline now roaring into view and, 45 days after that, the 2024 campaign kicks off.

# Galva solar farm location revealed

GALVA — The City of Galva announced at its meeting Monday that a solar farm will be installed at the former drive-in theater property across from Galva High School.

The city purchased the land from Justin West for \$94,829.40. In September the council announced the solar farm without specifying a location.

In other action, the council unanimously voted to borrow \$273,855 for 10 years at an interest rate of 6.16% to pay for parts for two of the city's wells.

The second ordinance passed was to borrow \$124,000 for 5 years at 6.16% interest to purchase a new John Deere backhoe.

After executive session the council also approved donating \$7,500 to the Galva Senior Citizen Center for repairs.

Jim Huffman, who lives northeast of Galva, gave a presentation on the proposed Wolf Carbon Solu-

tions CO2 pipeline. Huffman said it will come close to Galva, one-half mile from his house and through his farm fields, if approved. Huffman said he is worried about first responders if there was a rupture of the pipeline.

The line is proposed to come from Clinton, Iowa to Decatur. Huffman said the Henry County Board and several townships have passed moratoriums to halt construction for two years. He asked the city to pass a similar resolution.

Linda Grant, who lives north of Galva, asked the city to consider a splash pad in Washington Park. She said the solar project coming to Galva is donating \$50,000 to be used in city parks. She also said the basketball court in Washington Park is not in good condition.

Several concerns were raised about corn dust coming from the Galva Co-Op and from trains next to Washington Park.

Resident Bridgett Owens

told the council they need to look at putting a stop sign or two on SW 3rd Street since a lot of people cut through there to avoid going through town.

City Administrator David Dyer asked the council to re-join the Henry County Tourism Bureau, as the city dropped its membership several years ago. Membership costs \$2,500.

Third ward alderman Jackie Clucas said she would rather give \$2,500 to John Taylor for Levitt AMP concerts. Third ward

alderman Dougie Anderson said he wants more information before voting.

Halloween hours were set for Oct. 31 from 5-7 p.m. at homes with porch lights on.

Police Chief Kraig Townsend reminded residents they can burn leaves only on Tuesday, Thursday and Saturday from dawn to dusk.

And a free yard waste pick-up will be Nov. 20. Yard-waste bags must be out by 6 a.m., but do not need a sticker.



County's 19-14 season-opening win over Rushville-Industry.

"My stomach was hurting and I was really nervous," said Holmstrom, a starting linebacker. "But I got in and felt I did what I needed to do."

Gibler's opener went even better, at least in his eyes.

"I kind of killed that first game at defensive end and I kept playing there over the season and built up endurance and realized I had a lot more game left in me," Gibler said. "I realized I was a lot stronger than what I had anticipated."

The success was a pleasant surprise for Noard, who admitted he wasn't sure what to expect when they informed him they had decided to play.

"Are they coming out just to wear the jersey or are they coming to really contribute?" Noard admitted to wondering. "From day one, they've really tried to contribute."

Like the rest of the team, the newcomers gained

even more confidence after a 21-20 win over perennial power Annawan-Wethersfield in the second game. A key to that contest was a late defensive stand on a two-point conversion and limiting A-W running back Zeb Rashid.

"We just came together as a team and we just knew what we needed to do," Holmstrom said. "We knew we needed to stop (Rashid)."

From there, the Rebels have not looked back, with last week's 28-20 victory over United the closest result out of the final seven victories. Defense has been solid through all those wins, Noard said.

Gibler agrees. "Our line has stepped up our game, definitely," he said, crediting Price as "the one we can't do without."

Defensive backs and linebackers have also had plenty of time to shine. Holmstrom returned an interception for a touchdown during the regular-season win over Princeville – one of four

such scores by the defense this season.

"That kind of sealed the game and put it out of reach," Noard said.

And last week against United, Gibler played some offensive guard in addition to his usual starting role at defensive end.

"They are talented kids that can play the game," Noard said. "When you add them to the kids you already have, it makes you all the better. We're not as good a football team without them."

So it probably goes without saying that the two late-arriving seniors are happy with their choice to play football.

Gibler said he likely would have been helping his father at Gibler Ice in Toulon if he wasn't playing. Holmstrom said he might also be working with his father at Wolf Inc. in Dunlap.

Football is better than work, both players agree.

"I didn't think I was going to have this much fun," Holmstrom said.

"But as soon as I got out here and started tackling

people ... oh, it's so fun.

"And people in the community are super excited about us. They all just love Stark County football."

Added Gibler, "I would say football is 100 percent more worth it. Just because of the memories and the class that I have. I want to make as many memories as possible with this class. You only live once."



## Rebels go 9-0

Stark Co. outlasts United, 28-20; will face Princes in 1A playoffs

**WYOMING** — There was nothing easy about Stark County's final win last Friday over Monmouth United.

But perfect football seasons seldom come easy, and years from now, what will matter for these Rebels is that they joined four other Stark County teams in recording 9-0 regular seasons.

With its 28-20 victory over United at Gary Johnson Field, Stark County also completed an 8-0 championship season in the LincolnLand Conference small division.

And the fifth-ranked team in Class 1A will host a first-round playoff game Friday at 7 p.m. against Princeville. Stark County won the regular-season meeting, 48-28, on Oct. 6.

The Rebels played with more fire against Princeville than they did vs.

United, Rebels Coach Jade Noard indicated.

"We didn't have quite the energy that we've had and I don't know the reason," Noard said. "Finding a way to win when you're not at your best is a positive. And every time they cut it to one or two points we scored."

Nolan Orwig ran for Stark County's first two scores in the second quarter after yet another slow opening quarter for the offense. Orwig's runs were 6 and 5 yards and he finished with 104 on 12 carries.

But every time Stark County scored, United (3-6, 2-6) responded with a TD. And United's 19 first downs were more than Stark County's 17.

Quarterback Luke Reverts had the Rebels' two scores in the second half on runs of 6 and 27 yards. The senior finished with 108 yards on 13 carries and passed for 165, completing

8 of 12 passes.

"Offensively, yardage-wise it was one of our best outputs of the season," Noard said.

The perfect 9-0 regular season record is the fifth for a Stark County High School team. Here's a look at how the previous perfect seasons went.

2003 – Bumped to 2A, Stark County was upset at home in the first round by Watseka, 35-29.

2010 – After a 30-20

first-round win over Lexington, the Rebels turned the ball over nine times in the 1A second round and lost at home to North Shore Country Day, 44-12.

2014 – Lost to eventual 1A state champion Forrester 33-19 at home in the quarterfinals.

2015 – Lost the 1A state title game to Arcola, 35-17, at DeKalb.

"So we've had varying levels of success," Noard


