SOLAR FIELDS KEEP SPREADING

Billtown considering solar array

WILLIAMSFIELD – About 20 acres of village-owned vacant land at the north edge of Williamsfield is being targeted for a solar-energy development.

Nothing is imminent, but at least one solar-development firm has presented the Village Board with a proposal. To lease the property, Florida-based Bow Renewables has offered to pay the village at least \$40,000 annually once the project is completed.

"If the land isn't being used by the municipality, we can repurpose it, and if we can bring some benefits, we're all for that," said Mike Musso, a Bow associate developer.

Musso and Bow Managing Partner Tom Olenick, both based in their

company's Chicago office, addressed the board during its meeting Jan. 2. According to Olenick, Bow approached Village President Robert Johnson regarding the proposal.

Bow is overseeing three solar-farm developments on city-owned land in Galva. The Billtown project, which might cost about \$7 million, has been proposed for an area south of Park Road and west of Illinois Route 180.

Construction is estimated to begin about two years after an agreement is in place, Olenick said.

Bow is to pay the village an initial

option-period lease of \$5,000 a year. If all goes according to plan and once the project begins to generate power, the lease would be 30 years, with two five-year extensions possible. Lease payments would increase from \$40,000 by 2% each year, for a 40-year total of \$2,416,079.33, according to Bow.

"The way technology is advancing, after the first 20 years there may be a revamp," Olenick said about the proposed solar installation.

The project might lower electricity

Princeville board OKs solar project

PRINCEVILLE – Here comes the sun. Or here comes to Princeville a solar-energy project, to be more accurate.

During its meeting Jan. 3, the Village Board authorized Trajectory Energy Partners to transform a 17-acre plot in northwest Princeville into a 2-megawatt solar farm.

Construction is expected to begin late this year and finish in early 2025, according to Kiersten Sheets, a Trajectory project-development manager.

"I personally think it's going to be a big benefit, a big asset to our village," said Jeff Troutman, the Princeville village pres-

ident.

The solar array along West North Street near Princeville Township Cemetery is expected to generate at least \$16,600 in first-year property-tax revenue, an increase of more than \$14,000, according to Highland Park-based Trajectory.

First proposed in 2018 and revived about two months ago, the solar farm received an OK in late December from the Princeville Zoning Board of Appeals. Trajectory contacted neighboring property owners and homeowners by mail and/or in person to address potential concerns.

Toulon awaiting word on sewer project

TOULON – The Toulon City Council heard that almost all of the unfinished business agenda items are in progress during a meeting on Jan. 8.

Giffin Engineering Representative Justin Reese provided an update on the unsewered community planning report grant. The city is waiting for the Illinois Environmental Protection Agency to complete its process for construction and a start date. Reese said the project, impacting northwest res-

idents of Toulon, will likely be done in the spring or early summer.

There was no update about engineering plans for Toulon's water mains.

Two local contractors are expected to bid on a railing at the baseball field once dimensions are finalized by Councilman Michael Schott and city employee Jake Streitmatter.

The city received a quote to purchase caustic chemicals for the water plant. The city needs a permit to purchase the chemical to correct the pH of the water. It will

replace lime, which is hard to obtain.

The council discussed a contract for Streitmatter to become the sewer operator. Mayor Larry Hollis said a city employee can't also be a contractor. Details of this are still being finalized.

The council approved a \$1,250 donation to the Stark County Parents' Club for its auction, up from the last donation of \$1,000.

Tabled was an ordinance to change how the mayor, the council members, the city treasurer and the

 city clerk are paid for attending council meetings. Currently the mayor receives \$125 per meeting, the council members \$75 per meeting and the city clerk and city treasurer receive \$66.67 per meeting.
 Also tabled were employee job de-

scriptions, expectations and goals. Councilman Brandon Simpson wants to establish a legal framework for this and Councilman Ryan Kelly wants documentation of employees entered into their personnel files.
 The council set 2024 meeting dates for the second Monday of every

month at 6 p.m. at the Toulon Fire House/Station. The exception to these dates is Oct. 14, which is Columbus Day. The city will announce an alternate date later.
 Finally, the council passed an ordinance to allow the sale of excess property, such as tools, at an auction.

 bills by 10 to 15% for Ameren customers in Williamsfield who subscribe to it, according to Bow. Massachusetts-based Navisun, a Bow partner, is to own and operate the solar farm once it comes online.
 Bow proposes to donate

\$25,000 to the local park district at the start of construction and \$5,000 a year to the Williamsfield School District for scholarships. That amount would increase by 2% annually.

In other communities, Bow has helped fund parking lots and agricultural-education programs, according to Olenick. Private capital and state grants are to pay for the project and community-solar contributions.

"With this particular program, I think there's a lot of options to help the town itself," Olenick said. "If there's anything they can think of that maybe they just can't quite afford or need a little bit of financial

assistance with, we're able to help the municipality in those ways."

Johnson said the village probably will solicit a proposal from at least one other solar-development firm before any decision.

 sions," said Sheets, whose firm is developing a solar installation in Brimfield.

None of that necessarily meant Village Board ap-

proval was automatic, although Richard Schoenbeck proved to be the only one of the six trustees to vote against it.

One neighbor, Martin Fairchild, expressed concern about six 35-foot poles that abut his residence along Shawn Street.

Those poles facilitate connections between the solar farm and the Ameren Illinois power grid. Sheets said Trajectory will work with Ameren to move the poles farther south and perhaps bury additional lines.

Trajectory estimates the solar installation will provide Princeville subscribers more than \$40,000 in utility-bill savings annually.

Illinois wheat growers break yield records

Illinois wheat growers broke yield records for the third year in a row and Knox County was one of five counties to top 100 bushels per acre for average yield.

The new state average wheat yield estimate for 2023 is 87 bushels per acre, up from 79 in 2022.

Illinois wheat farmers also broke county high-yield records. It is the first time a county averaged more than 100 bushels per acre

Washington County, which has the most wheat acreage in Illinois, had the highest production last year, coming in at more than 6.4 million bushels.

Randolph County came in second in total production, just shy of 3.4 million bushels, and Perry County came in third with almost 3 million bushels.

As for 2024's wheat crop, experts say it's looking good so far. Like last year, milder temperatures helped winter wheat get off to a good start.

Supreme Court denies weapons-ban appeal

SPRINGFIELD – The U.S. Supreme Court has denied one request to review the Illinois assault weapons ban, but many believe the court is more likely to take up another challenge to the law later this year.

The high court turned down a request by Republican State Rep. Dan Caulkins, of Decatur, to hear an appeal of the case he lost before the Illinois Supreme Court in August.

In his appeal, Caulkins argued that he was denied a fair hearing at the state supreme court because two of the state justices had received large campaign contributions from Democratic Gov. JB Pritzker, who signed the assault weapons ban into law.

Caulkins also claimed the law is unconstitutional because it allows some people to keep their assault weapons if they acquired those guns before the ban took effect.

The justices at the U.S. Supreme Court gave no reason for declining to

hear Caulkins' appeal. But many people expect the court to take up a separate challenge to the law from the National Association for Gun Rights, which argues more broadly that the ban violates the Second Amendment of the U.S. Constitution.

The 7th Circuit Court of Appeals ruled against the gun rights group in November. The group is expected to file its appeal with the U.S. Supreme Court within the next several weeks.

NOTICE TO TAXPAYERS OF STARK COUNTY

Renewal forms for the 2024 assessment year are being mailed to all Stark County property owners who had previously signed up for the Senior Citizens Assessment Freeze, Homestead Exemption, Disabled Persons and the Disabled Veterans. The deadline for their return is July 1, 2024.

The following is a list of all exemptions. If you have any questions concerning any of the homestead exemptions, or to obtain applications, contact the Supervisor of Assessments office at 130 West Main St., Toulon, Illinois, or call 286-7172.

Owner Occupied Exemption reduces the final equalized assessed value by the amount the current equalized assessed value exceeds the 1977 equalized assessed value up to a maximum reduction of \$6,000. To qualify a taxpayer must own and occupy a property as his or her principal dwelling on January 1st of the assessment year.

Homestead Exemption is for taxpayers who will be 65 years of age or older anytime during the assessment year and who own and occupy their property. This exemption reduces the equalized assessed value by \$5,000.

Senior Citizen Assessment Freeze

Exemption is for taxpayers who will be 65 years of age or older during the assessment year, have a total household income of less than \$65,000 for the prior year, and occupy their dwelling on January 1 of the taxable year, own the property and be liable for payment of property tax for the taxable year. Applications must be submitted annually to the Supervisor of Assessments.

Home Improvement Exemption reduces the Board of Review assessed value by the amount of increase in assessed value due to improvements being added to an existing residential structure. The exemption is for four years from the date of completion and is for maximum amount of \$75,000 in market value.

Disabled Persons Homestead Exemption provides a \$2,000 reduction in a property's EAV to a qualifying property owned by a disabled person. Applications must be submitted annually to the Supervisor of Assessments office.

Returning Veterans Homestead Exemption provides a one-time \$5,000 reduction in a property's EAV to a qualifying veterans who return from active duty in an armed conflict involving armed forces of the United States. To receive this exemption, the veteran must file an application with the Supervisor of Assessments office upon their return home.

Disabled Veterans Standard Homestead Exemption provided a reduction in a property's EAV to a qualifying property owner owned by a veteran with a service connected disability certified by the U.S. Dept. of Veterans Affairs. A \$2,500 homestead exemption is available with a disability of at least 30% but less than 50% or a \$5,000 homestead exemption with a disability of at least 50% but less than 70%, and a disability of 70% or more, the property is exempt from taxation. The veteran must file an annual application with the Supervisor of Assessments office.

Disabled Veterans Exemption reduces the Board of Review assessed value by up to \$70,000 in assessed value for homes especially built or remodeled to suit a veteran disabled while serving in the Armed Forces. Applications are processed by the Board of Review. Published 1/12, 1/19/24
