## Oberhelfmans give \$1M to wellness center

ELMWOOD – Momentum for a community wellness center and YMCA north of the city received a substantial boost Monday thanks to Doug and Diane Oberhelfman.

The Oberhelfmans, residents of Edwards who own reclaimed strip-mine land south of Elmwood, announced they are donating \$1 million toward a matching grant for the proposed 33,000-square-foot facility to be built north of Graham Medical Group's Elmwood

clinic.

"Rural communities are the backbone of our country," said Doug Oberhelfman, former Caterpillar Inc. CEO.

"Supporting this project for the rural communities where we call home is very meaningful to Diane and me."

The Oberhelfmans met Monday with members of the Elmwood Community Foundation Board of Directors to formally announce their gift, which also serves as the kickoff of a public fundraising effort.

"The success of Graham Medical

Group, in bringing primary and specialty health care to the region, and drawing patients from over 200 distinct ZIP codes is simply remarkable," Diane Oberhelfman said. "The economic impact and the tremendous quality of life enhancements for this region will pay dividends for generations to come. Doug and I are very proud to wholeheartedly support this project."

A total of \$7.2 million of the \$12.5 million estimated construction cost has now been raised, according to ECF

## FACELIFT FOR SCHOOL

### Brimfield to upgrade grade school

BRIMFIELD – The first projects a \$4 million Brimfield School District bond issue will fund are to commence this summer.

Changes to the Brimfield Grade School main office and primary hallway top the list, according to Chad Jones, the district superintendent. New classroom furniture, new lighting and new flooring are to be among the improvements, which include relocating administrative offices to a central area.

An already-authorized window-replacement project at the aging grade-school building provided the opportunity to redo the space, Jones told the Brimfield School Board when it met April 10.

"This really helps us opera-

tionally," Jones said. "When we have to move everything into that hallway this summer because of the window project, it makes sense to do some switching and a different layout for that hallway."

Board members approved a summer capital-project plan estimated to cost \$831,137. Vendors include Illini Supply of Forsyth and Bloomington-based Carpet

Weaver's Flooring & Furniture Gallery. The money is to come from the working-cash bond issue the board authorized earlier this year.

Keach Architectural Design of Morton is to oversee the bidding process for the grade-school central-office construction. According to Jones, three companies

have expressed interest.

"It's just going to look like a whole new building in that wing, and that's the biggest need at Brimfield Grade School," Jones said about the overall work.

"We issued the bonds for capital-project improvements. This will be a huge home run for us ... it'll be really, really nice.

"The thing with these

projects is if you wait, it's going to cost more next year, two years, three years, four years from now. I just think that this is the right time to do it."

The window project, including asbestos abatement, will cost \$1,051,700. It is not to be funded with the bond money.

Also to be done this summer are refinishing of the Brimfield High School

gymnasium floor and re-configuration of the home-side bleachers. The reconfiguration is designed to prevent fans from getting in the way of team benches and the scorer's table, according to Jones.

Future bond-money projects include a bus barn estimated to cost \$1 million.

Administrators decided against pursuing an agreement with OSF Multi-Specialty Group of Peoria to provide athletic trainers. Under the proposal, the Brimfield and Elmwood

districts would have shared costs and personnel.

Jones cited expense. The proposed cost would have ranged between \$25,500 and \$30,855 over the next three academic years.

Jones said the Brimfield district might consider a less-costly alternative.

The board also:

- Approved pay hikes of \$2 per hour for non-certified employees, in keeping with state-mandated minimum-wage increases. The pay rate for most bus drivers is to rise by \$4 daily.

- Authorized field trips May 3 to Six Flags St. Louis (high school seniors) and May 14 to the St. Louis Zoo (eighth-graders).

- Accepted the resignations of grade-school paraprofessional Lisa Dawson and grade-school science/technology teacher Kevin Faulkner.

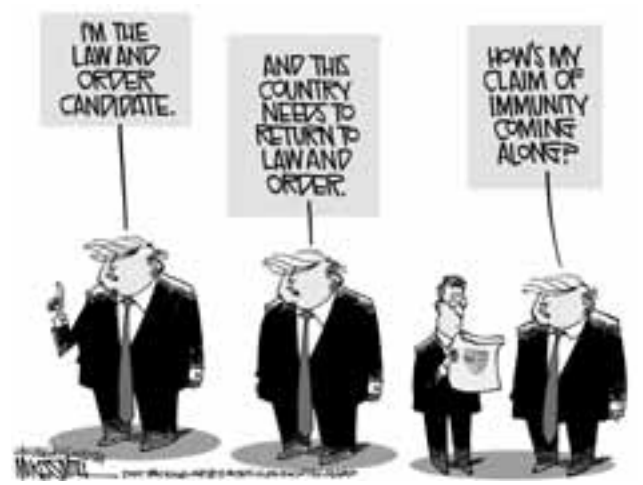

## Simpson chase among iconic memories

Last week O.J. Simpson died of prostate cancer and went to his just reward, whatever that may be. Simpson, Heisman Trophy winner, Football Hall of Famer and former Hertz Rent-A-Car spokesman was acquitted of charges that he murdered his ex-wife, Nicole Simpson, and her friend Ron Goldman.

After the acquittal, Simpson himself pledged to find the real killer or killers. He spent the rest of his life searching golf courses and country clubs for the perpetrators. On word of his demise, a pundit remarked that Simpson can rest easy now because his wife's murderer is dead.

Hearing of Simpson's death, I recalled where I was and what I was doing when the news of the murders and the famous Bronco chase dominated TV and radio in June 1994. My wife, Donna, and I were at the Chicago Botanic Garden in Glencoe to attend a presentation by the English garden author and columnist Christopher Lloyd.

Last week's news of Simpson's death stimulated memories of the Glencoe trip 30 years ago and the intense media coverage of his apprehension and trial. And it got me thinking about other events of the past 70-plus years that have the same

effect. No doubt you've experienced such triggers, too.

I can recall clearly where I was and what I was doing when the Twin Towers of the World Trade Center in New York were attacked on the morning of Sept. 11, 2001. Donna and I had just flown home from a trip overseas. I remember being glued to the television and watching in disbelief, along with Katie Couric and Matt Lauer, as each tower crashed to the ground. It's sobering to think that kids in college today have no memory of 9/11.

That morning, all planes over the United States were ordered to land at the nearest airport. Both private and commercial air traffic were grounded for two days. Had our flights been delayed, we would have been stranded for a couple of days.

Another memory milestone for me is the assassination of President Kennedy on Nov. 22, 1963. A senior in high school, I was in Mr. Vicary's chemistry class when word came that the president had been shot. I remember how quiet and somber the class became as we took in the news in disbelief.

Two days later, Kennedy's assassin, Lee Harvey Oswald, was shot to death on live TV by Jack Ruby. I seldom watched Sunday-morning television, but I happened to witness his murder in real time on TV that day.

Donna and I both have memories triggered whenever we hear the sirens on the first Tuesday of each month. It was a little after 8 a.m. on

Saturday morning, Jan. 13, 2018. We were walking along Kealia Beach on the Hawaiian island of Kauai. A text alert appeared on our phones saying, "Ballistic missile threat inbound to Hawaii. Seek immediate shelter. This is not a drill."

We looked at each other in bewilderment. Others on the beach were looking at their phones. Some were running to their cars.

We decided, after seeing the traffic jam on the road above the beach, to just continue our walk along the water. There was no way to get back to our condo before the missiles arrived. We figured the missiles were more likely to strike the island of Oahu, home to Pearl Harbor and other military installations.

The same alert was broadcast over TV and radio. Many Hawaiians and visitors were in a panic, trying to find shelter and contact relatives. It was 40 long minutes, an eternity for many, before the authorities sent the message, "There is no missile threat or danger to the State of Hawaii. Repeat. False Alarm."

I'm still trying to understand our reaction to the initial alert. Was it disbelief? Helplessness? Acceptance? Surrender? I think my reaction would have been different if Donna hadn't been with me. Think about it. How would you respond to such a situation?

After the fiasco, the governor of Hawaii, David Ige, explained what happened. He said "... an employee pushed the wrong button."

# USDA runs costly manure-making program

If the third time is a charm, Michael Happ might finally make an impression on federal lawmakers and administrators with his fact-filled, 24-page report on the U.S. Department of Agriculture's continued financing of Big Ag's big manure habit.

This is Happ's third detailed look at EQIP, USDA's nearly 30-year old Environmental Quality Incentive Program, in as many years. In each, Happ, a climate and rural communities associate at the Institute for Agriculture and Trade Policy, has focused on where USDA often directs chunks of EQIP's \$1 billion-plus annual budget.

What Happ found in all three was USDA often reverting to its traditional role of backing Big Ag's big-is-better solutions to multi-faceted environmental problems when better, more effective solutions go begging for EQIP's limited funds.

What that often means for on-the-ground EQIP spending is to pour concrete, Big Ag's go-to solution to most problems. And the bigger the problem, the bigger the pour.

In 2023, Happ called these physical rather than biological responses "practices that are often structural rather than plant or natural systems-based."

In turn, some of ag's most pressing environmental threats – like climate change, soil erosion and water quality – are never really challenged, much less solved.

Instead, wagonloads of taxpayer money often underwrite complex and questionable technologies like

today's methane-managing manure digesters.

If 30 years and billions in taxpayer money on these "more concrete" programs actually worked, livestock-heavy, ethanol-soaked states like Iowa would have the safest, cleanest rural water in the nation. They don't. In fact, it's the exact opposite.

These "more infrastructure" fixes carry other consequences, Happ notes.

For example, as "disproportionate shares of program dollars go toward high-cost practices that have little to no climate or conservation benefit," his April 2024 report details, "(w)e find that... nearly two-thirds of farmer applicants (are) being turned away from EQIP" because the handful of Bigs have vacuumed up much of the free cash year after year.

In 2023, Happ writes, "Over \$182 million ... or about 11%" of the annual EQIP funding" was spent on "10 EQIP practices (that) averaged over \$50,000 per contract ... such as waste storage facility, waste storage facility cover, and anaerobic digester (that) have questionable environmental benefits and bolster the polluting concentrated animal feeding operation (CAFO) system of the largest livestock operations."

In fact, building a manure digester – often with vital EQIP seed money – has become one way big CAFO livestock and dairy farms grow even bigger.

Happ explains: A "recent study found that dairy operations that installed digesters grew their herd sizes by ... 24 times the growth rate of dairies without digesters" despite the fact that "less than 10% of the methane emissions from cattle come from manure storage ..."

Still, EQIP continues to throw taxpayer cash at digesters even as mounting evidence confirms that "with increases in herd sizes, the methane reduction benefits of digesters shrink dramatically."

The spending, like the manure, is a waste.

"As the U.S. pursues its methane reduction strategy, we cannot afford to waste billions of dollars on false climate solutions, such as digesters that encourage herd growth," Happ asserts.

And yet, we will. The Biden Administration's Inflation Reduction Act will boost total EQIP spending to \$8.45 billion between fiscal year 2025 and 2031.

Instead, USDA should increase spending on other, cheaper and more effective farm-directed practices that are popular, Happ suggests.

For example, "Of the top 10 most popular practices (underwritten by EQIP), not one averages over \$10,000 per contract. For a small grazer, a \$3,000 prescribed grazing contract can be life changing..."

All of this makes solid financial and environmental sense. USDA should stop spreading EQIP's big spending on Big Ag and recommit to financing more directed, more impactful environmental programs that actually work.

## Yates City board approves raises for village staff

YATES CITY – The Yates City Village Board approved pay increases and water repairs at its April 10 meeting.

The clerk, treasurer and water biller will each receive an increase of \$50 per month. This will take effect in May for the water biller and will take effect following the legal waiting period of six months after the new fiscal year for the clerk and treasurer. The village's public-works employee will get an increase of \$1 per hour in May. There will be no increase for

trustees or the village president.

Work is underway for clarifiers approved at a previous meeting and an additional \$30,000 has been approved for repairs to valves, pumps and slides at the water plant. The board doubts work will be that expensive but wants to have money available so repairs can be finished as quickly as possible.

Elba-Salem Park District President Jim Ralston discussed water usage at Harvest Home Park and thanked the board for allowing the park to use the forgiveness program for its last water bill of \$855. As a result, \$500 of the

bill was forgiven, although the program cannot be used again for another five years.

The meter at the park indicated 4,900 gallons of water was used daily on average, although the park district can't determine where all that water went. Ralston said the area is dry, no valves are open and no valves appear to be leaking. Park toilets were checks for leaks with dye in the tanks and now the main water valve to the concession stand and bathrooms is shut off, too. Ralston said G&M Mechanical of Canton is going to take a look next.

# No home-school extracurriculars at Princeville

PRINCEVILLE — Home-educated children will continue to be prohibited from participating in Princeville School District extracurricular activities, including athletics.

During its meeting April 9, the Princeville School Board tabled possible adoption of a policy that would allow home-school participation. The board began to consider the issue last September, at the request of home-school parents.

More than six months of board discussions didn't appear to yield majority support for a series of proposals administrators offered.

"I don't think it would make sense to force a vote on something we don't seem to have a consensus on," Board Vice President Michael Harmon said.

Some board members might have been influenced by a recent survey of Princeville high school and junior-high teachers.

Of 30 respondents among 33 teachers, 57% favored the status quo.

Another 30% supported a proposal that required home-schooled students to take at least five on-campus high school courses or three junior-high courses; the latter included one core class.

A proposal that reduced the overall junior-high requirement to only one core class received 13% support.

Core classes include English, mathematics, science and social studies.

"I think some expressed their concern pretty deeply," Board Member Grant DeBord said about survey respondents. "I don't want to alienate our staff. That weighs pretty heavy about going through this."

Board Secretary Sue Heffler expressed concern about how home-schooled students might be scheduled if a proposal was approved.

"If a student has to be here at 8 o'clock in the morning and then not until 2 in the afternoon for a class, what are they doing (in between)?" Heffler said. "There are a lot of ifs that I don't know a lot of answers to."

Board President Darwin Stahl suggested revisiting the subject later this year or next, perhaps after more discussion with teachers and staff.

The board did approve an amended salary schedule with the Princeville Unit District 326 Education Association for the 2024-25 school year. The new schedule sets the minimum teacher salary at the state standard — \$41,088 annually.

The union agreement approved in 2021 set the sal-

ary at \$40,710.

"The negotiations with the teachers' union (were) fantastic. Couldn't have went any better," Superintendent Tony Shinall said.

Following closed session, the board:

- Approved three expenses with CDW-Government of Vernon Hills — \$41,060.10 for Chromebooks, \$13,279.42 for staff laptop computers and \$1,800 for Chromebook cases.

- Authorized an agreement with Heart Technologies Inc. of East Peoria to oversee district telephone and door-entry systems. The agreement will cost \$9,700 initially, then \$2,349 monthly.

- OK'd a \$979.02 expense for Mitel software-assurance phone-system renewal.

- Approved Ted Fritzenmeier, Lily Garcia, Neleh Geiger, Jeremy Melick, Libby Snider, Sierra Stahl and Lee Taylor for various

summer-technology positions.

- Authorized hiring Erik Davis as a high school English teacher, Ashley Gammon as eighth-grade class sponsor and Aaron Lorentz as district book-keeper.

Shinall reported the resignations of freshman boys basketball coach Michel Elsasser, fifth-grade teacher Breanna Ely and high school cafeteria worker Veronica Maher.

 Board Member Micki McCarthy.  
 “More people are seeing the progress. The public opinion is shifting from, ‘You really think you can do it?’ to, ‘My goodness, this is really going to happen,’” said McCarthy, who presented recently to attendees at the annual Elmwood Alumni Ban-

quet. “It is our goal for this to be a 2025 construction project.”  
 While that’s one year later than a sign in front of the project location currently says, McCarthy said it is a minor edit for a project of this size.  
 “We realize this is a once-in-a-lifetime opportunity to do something for our rural communities,”

she said. “The ECF Board wants at the end of this year to be able to say ‘2025 Construction, Opening 2026.’”

# Princeville company plans growth

PRINCEVILLE – Construction to accommodate expansion of a Princeville manufacturing company is expected to begin next spring.

On about 15½ acres of land it purchased north of the village, Greenfield Contractors intends to build an office and an area for fabrication and inventory storage, among other uses. The location is west of Santa Fe Avenue and south of Mendell Road.

The village annexed the previously unincorporated property last year, at Greenfield's request.

Dean Bailey, a Greenfield project manager, said the first order of business is to demolish a vacant house on the property. Trees will be felled, as well. That work is expected in the next few weeks, Bailey told the Princeville Village Board property committee Monday.

"We want a clean slate," he said. "We plan to be in the building in 2025."

Ideally, the new facility will be finished by fall of 2025, according to Bailey. Currently, Greenfield occupies a 1,600-square-foot building at 1012 N. Santa Fe Ave. The company constructs fabric-covered and

steel-framed commercial and agricultural buildings. It also has facilities in Iowa and Kansas.

Greenfield employs between 12-24 people in Princeville, including seven recent hires, according to Bailey and company owner Lucas Young. Young said he anticipates growth with the plant expansion.

"We would like to position ourselves to be a desirable employer in the area," Young said. "People would look at us and say, 'It's a good job. They pay well, good benefits. They have a good company culture.'"

Bailey and Young joined three representatives of the Greater Peoria Economic Development Council at

the meeting, during which no action was taken. The EDC is helping Greenfield assess federal and state infrastructure grants and loans, as well as other fiscal incentives.

The timeline for Greenfield construction appears optimal for financial help, according to Sally Hanley, the EDC director of business assistance.

Still to be determined is where on the 15½ acres Greenfield intends to build. Bailey and Young said the plot can accommodate other businesses. Young said the south end of the property would be significantly cheaper as far as connecting to the village sewer system, since the north end is farther from the heart of town.

son Electronics Co. of Peoria will install the fob-entry system for \$6,469 for the community center building and \$6,146 for the city of-fice building.

The council also approved two CEDC recommendations for TIF reimbursement. Colby Evans will receive \$2,500 for window replacement at 222 S. Apple St. and the Farmington Masonic Lodge will receive \$50,522 for upgrades to its building at 134 E. Fort St.

On hand to voice agreement for an intergovernmental agreement

were members of the Farmington Township Board, who will pay the city \$17,000 to maintain Farmington Township Park. The agreement also calls for a \$2,000 contingency fund.

The council also approved paying no more than \$18,500 for a Summer Food and Fun youth activity program at Jacobs Park. Activities will be held from 8 a.m. to noon five days a week and may include free lunches thanks to an ISBE grant, according to City Administrator Bettina Bohanan.

Bohanan said about 130 young-

sters signed up for last year's summer program, with about 60-80 participating each day.

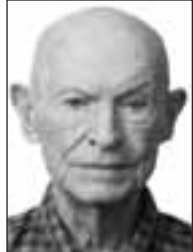

# B-E softball trip to Tennessee rained out

The Brimfield-Elmwood softball team didn't take the last train to Clarksville, but the Indians ended up playing no games there.

Days of rain earlier in the week prompted cancellation of all three games the Indians were to play April 13 at Heritage Park Sports Complex in Clarksville, Tenn. That was the site of a 12-team event split into three round-robin groups of four. B-E (8-2) was in the top group.

"I was certainly bumming," B-E Coach Kurt Juerjens said about the rainouts. "The girls were bumming at first, but they understood. Some things are just out of your control, and that was out of our control."

The Indians played twice before they headed south and won both games. On April 10, they beat North Fulton 5-2 behind 13 strikeouts by pitcher Sawyer Drury. In the fifth inning, a bases-loaded walk to Josie

Wiewel scored CJ Troxell with a run that broke a 2-2 tie. Kendyl Binder then scored on a passed ball.

B-E defeated Bushnell-Prairie City 21-0 the previous day. The Indians scored 15 in the second inning. Troxell had four RBI overall, and Layla Hersemann had three.

Juerjens said the season has gone well so far, but bad weather — here and in Tennessee — has been a problem.

Ridgewood swept a doubleheader April 10 from R-W, 5-0 and 8-2. Avery Rigg was 2-for-3 with an RBI in the second game.

The previous day represented another sweep, this time for R-W as it beat Annawan-Wethersfield 5-0 and 10-6. Izzy Nelson was 3-for-4 with one RBI in the first game. Ella Rigg was 2-for-3 with two RBI. Ava Landon struck out nine A-W batters.
