NATIONAL HISTORIC PLACE

Brimfield church named to national registry

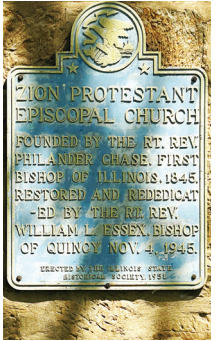
BRIMFIELD – A historic building here has earned a significant designation from the U.S. Department of the Interior and the National Park Service. Zion Episcopal Church, built by Bishop Philander Chase in 1845, was recently added to the

National Register of Historic Places. The sandstone church at 205 E. Van Buren St. is one of seven Illinois locations that was selected in early April during the bi-annual meeting of the National Historic Landmarks Committee and is one of 36 properties so designated in Peoria County.

Partial credit for that goes to Ed Barry, an architect with the Farnsworth Group of Peoria, who filed a detailed nomination for the church and in February presented to the Illinois Historical Sites Advisory Council. Approval by the Illinois group was a key to receiving the national designation, Barry said. “The Academy Award (for historic buildings) is the National Register of Historic Places,” he said.

“The vote was unanimous in favor of granting national register status to Zion.” Barry said most of the credit for that goes to local business owner Rita Kress, who has a keen interest in all things Brimfield. When the Quincy Diocese of The Episcopal Church reached out to potential buyers in 2021, Kress showed immediate interest, though her only

previous visit to the church had been in the 1970s.

“I just felt it was an opportunity to preserve Brimfield’s history,” Kress said. “It’s a good feeling to be part of history.”

Kress bought the church June 14, 2021, for \$49,000 and then started planning for the building, which like many old structures had issues to go with its obvious character.

An immediate change Kress made was to have gray siding removed from an addition built in 1995 to serve as a gathering space for churchgoers. In place of vinyl siding, Kress had the exterior covered with sandstone that closely resembles the stone facade of the original church.

“We tried to find something ‘sympathetic’ to the rest of the building,” Kress explained.

Later, bats had to be excluded from the building. Walls were repainted white. Exterior windows were repaired.

But many original items were intact, including church pews and

More bar time

Williamsfield extends alcohol sale hours

WILLIAMSFIELD – Now there’s no stopping late-Sunday or early-Monday revelry at Williamsfield liquor-selling establishments. Except for themselves, perhaps.

The Williamsfield Village Board has extended by six hours alcohol sales on Sundays. The latest closing time allowed will be 2 a.m. Mondays, the same as the other six days of the week.

Sunday closing time has been 8 p.m. Trustee Julie Van Dran suggested that was too early, particularly on holiday weekends and Super Bowl Sunday. She

recommended the board extend closing time to 11 p.m., but Village President Robert Johnson proposed the 2 a.m. limit.

“That way there’s no guessing,” he said when the board met Monday night.

“It would just be across the board and make it easier for all of us to do and manage.

Farmington now offers large-garbage options

FARMINGTON – Though they weren’t kissing babies or passing out candy, the Farmington City Council did plenty to please residents at Monday’s regular council meeting.

In addition to passing ordinances that will continue two popular TIF grant programs, the council also approved upgrades to two Farmington parks and talked about solutions to trash pickup problems.

First, to the trash. Mayor Kenn Stufflebeam reminded

citizens that the city has a 20-yard dumpster sitting in its police impound lot that can be used by residents who have large garbage items Waste Management will not pick up.

“Come to the (city) office, show your ID and we’ve got a dumpster in the impound lot you can dump stuff into,” Stufflebeam said.

He said the city is also handling recycling of electronics, paint and tires. Staff is on hand to help with the recycling on Wednesdays from 5-7 p.m. and Saturdays

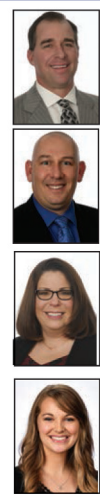

 “The longer places are open, the more tax revenue that comes in.”

The only place in Williamsfield that serves booze by the drink currently is Double Take Bar & Grill, 111 N. Oak St. Ladd’s Food Mart, 214 Illinois Route 180, sells package liquor. A bar-laundromat combination is planned, according to Johnson, although no opening date has been announced.

It wasn’t long ago that Williamsfield authorities

extended non-Sunday closing times from 1 a.m. to the current standard. Van Dran advocated for the extra hour then, a move designed to keep Billtown drinkers close to home instead of venturing to municipalities that had later closing times.

“The whole reason I asked to change it is because I’d watch them at 1 a.m. leave the Double Take and have that extra hour to go to Knoxville and Brimfield,” Van Dran said. “They’re driving their cars out of town and

had some cocktails and then had a few more.”

Police Chief James Robertson told the board his department has not had additional calls for service regarding that closing-time change.

The Sunday-night extension sprang from a proposal to increase the village video-gaming license fee from \$100 per machine to \$250, the maximum the state allows. Both moves were approved in one motion. Double Take and Ladd’s each house four video-gaming terminals.

“If they’re able to stay open later, they’re able to recoup some of that \$250,” Van Dran said. “It’s give and take.”

State law permits video-gaming terminals only in businesses that sell alcohol. Johnson said the total amount wagered locally exceeded \$1 million last year.

In other business, the board approved a change order for work regarding an ongoing water-improvement project. The changes are to save the village about \$275, according to Andy Logsdon of Bruner, Cooper & Zuck, Inc., a Galesburg

engineering firm that’s overseeing the project.

The board authorized spending up to \$1,000 on equipment designed to prevent cyberattacks on village water facilities. Municipal credit cards with limits of \$10,000 for Johnson and \$2,500 for Mark Niebuhr, the village maintenance supervisor, also were approved.

Johnson said he has been using a personal credit card to make some village purchases, including about \$2,700 recently for a new high-pressure water pump. The village has been reimbursing Johnson.

Following closed session, the board authorized opening for bid two vacant lots in the Ralph Norman Subdivision, but only if the purchasers agree to construct houses on them.

Kelly Goodin and Michael Goodin asked the board for permission to purchase lots at 110 and 301 Cottonwood Court, respectively. Michael Goodin’s residence is next door to 301 Cottonwood Court. Bids for that lot are to begin at \$10,000. Bids for 110 Cottonwood Court are to begin at \$8,500.

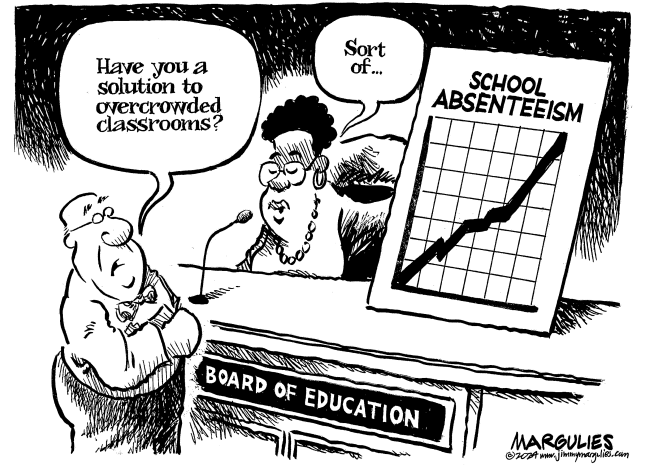

Big Ag not happy with aviation industry

Federal policymakers and their Big Ag friends have a problem: Their hope to make corn and soybeans the feedstock for sustainable aviation fuel hit a wall when the aviation industry ruled that biofuel from either crop did not meet its “sustainable” guidelines. As such, there would be no corn- or soy-based SAF.

That’s not the news the biofuel lobby, farm and ag commodity groups and the Biden Administration wanted. All quickly joined forces to “encourage” the “use of updated scoring by the U.S. Department

of Transportation’s GREET model,” not the aviation industry’s “greener” yardstick, to make sure “the carbon intensity” of “corn-based ethanol SAF” met aviation’s benchmarks

It’s not some minor bureaucratic tiff. Billions of federal SAF tax credits, promised under the 2022 Inflation Reduction Act, are on the table.

Switching to GREET (or Greenhouse Gases, Regulated Emissions, and Energy use in Technologies), all hoped, would deliver a burgeoning new market to ethanol just as electric vehicles are cutting into its government-mandated gasoline market.

Better yet, the U.S. Department of Agriculture could keep an eye on the approval process and, if necessary, put its green thumb on the GREET scale.

At a Washington, D.C., press con-

ference March 21, USDA boss Tom Vilsack pretty much did just that when he noted that farm practices like “no-till, cover crops and energy-efficient fertilizer ... ought to be included” in determining any SAF winner. Then he leaned in even more overtly: “I am confident we’re going to send the right signal,” Vilsack said.

The clear implication was that USDA would be only too happy to apply pressure to any more-art-than-science model ethanol faced to get it into today’s 16-billion-gallons-a-year aviation fuel market.

But just adding green-sounding farm practices like no-till – while stirring in carbon credits from controversial technologies like carbon pipelines and methane-making manure digesters – won’t make ethanol green or SAF sustainable, environmental experts point out.

In fact, when ag-land-use researchers at the universities of Wisconsin, California and Kentucky and Kansas State University measured ethanol’s economic and environmental impact after the Renewable Fuel Standard steeply increased its production in 2007, they found a very mixed, decidedly not-green bag.

Their 2022 joint study revealed that over its first 15 years, the RFS boosted corn prices 30 percent, expanded corn production 6.9 million acres and added 5.2 million acres to total U.S. cropland base.

As much as those new acres and higher prices pleased U.S. farmers and made ethanol a rural industrial giant, all came with a very high environmental cost.

“This increased agriculture,” notes

the report that includes the following parenthetical notations, “has been accompanied by more fertilizer use (3-8% each year), more water quality degradation (3-5% increases in nitrate leaching, phosphorus runoff) and more carbon emissions attributable to land use changes.”

“This one policy” – the RFS – “effectively bumped up pollution from the entire agricultural industry by several percent,” noted one co-author, Wisconsin’s Tyler Lark.

And, adds the University of California analysis of the report, those RFS-added acres “are responsible for 62% of the estimated increased greenhouse gas emissions” due to a “loss of biomass” – carbon captors like pastures and forests – and increased fertilizer use.

Land Grant researchers aren’t the only carbon worriers blowing the whistle on ethanol. Two climate-change experts from the World Resources Institute offered an even darker biofuel/SAF assessment this past December.

If the Biden White House follows the science “rather than bowing to pressure from the biofuels industry,” they wrote, “it will find that instead of being a climate solution, crop-based aviation fuels are even worse than their fossil fuel alternative.”

Which suggests – again – that the “green” in most farm-directed carbon-credit schemes really means more money for its schemers, not a healthier, more sustainable world.

And so on and so on, until the poor dupe came face to face with the perpetrator.

In one case, a woman with an armload of groceries was victimized, spilling oranges, apples, heads of lettuce and jugs of milk all across the parking lot.

T-Bone, ever the good Boy Scout, was gracious:

“Ma’am, you can keep the dollar,” he offered.

But T-Bone was not mean-spirited, so he and his co-conspirators also helped the lady retrieve her spilled groceries.

There was a certain establishment, a rural watering hole no longer in existence, that was frequented by T-Bone and his boys. It was a popular location, due to its out-of-the-way location and lax ID requirements. It was called The Lone Tree, and was fondly known as “The Stump” to loyal patrons.

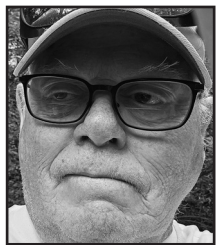
Many a tale could be told of the goings-on at The Stump. But in keeping with an age-old code of honor, what happens at The Stump, stays at The Stump.

Brimfield board OKs maintenance on water tank

BRIMFIELD – The Brimfield Village Board on Monday approved spending up to \$45,000 for a maintenance project on an older ground-storage water tank.

The tank needs its bottom seam repaired, as it has had a leak that has created occasional issues for years and has now become consistent and slow. The village had installed another water tank prior to this project in anticipation of repairs being needed on the older tank.

The repair itself was estimated to cost \$2,400, but Cady Aquastore, the company that makes and maintains the tanks, is concerned about the seam's placement adjacent to the concrete below and anticipates additional expenses.

In addition to the repair, the inte-

rior of the tank will be refilled – basically resealing the interior of the tank – to prevent additional leaks in the future. That's a task Cady Aquastore expected to likely be required during the repair, anyway. The majority of the approved funds go toward this refilling.

The board also passed several resolutions and approvals for its annual meeting schedule, the president's yearly appointments (unchanged from last year) and upcoming village events. The board allotted up to \$1,000 toward a Community Day scheduled for June 23 from 12-2 p.m.

Resolution 2024-A approved the Cruise-In for Diabetes on Aug. 3 from 10 a.m. to 10 p.m. Resolution 2024-B approved Old Settler's Days from Aug. 6 at 8 a.m. to Aug.

11 at 3 p.m., with the closing of East Knoxville Street coming one day earlier this year on a Tuesday to reconfigure equipment setup for the carnival.

Resolution 2024-C approved the Christmas Walk on Dec. 7 from 10 a.m. to 10 p.m.

A budget meeting was set for May 23 at 5 p.m. at Village Hall. The budget hearing was set for July 1 at 7 p.m., also at Village Hall.

Brimfield's Clean Up Day will be Sept. 14 from 9-11 a.m.

New Village Trustee Chuck Christy was sworn in to finish the remainder of former Trustee Nathan Schaub's term, bringing the board to full membership. However, the board is still looking for a Brimfield resident to serve on the planning committee.

Billtown to interview super finalists Monday

WILLIAMSFIELD – The Williamsfield Board of Education is moving forward with the search for a new superintendent of schools and plans to interview two semifinalists on Monday.

The board also plans to interview three candidates today (May 9) to narrow the pool to two semifinalists. The Illinois Association of School Boards is assisting with the search.

School Board President Chad Goff said there were six applicants for the position, which Tim Farquer is vacating as of July 1. Goff said the IASB cut that group to three based on a list of traits compiled based on feedback from stakeholders in the district.

"If any of these three candidates are who we think is going to move us forward, then absolutely we're in a good position now," Goff said.

For Monday's interviews, the board is seeking volunteers to hear responses from the semifinalists and to provide feedback. Those invited include district employees, parents and community members interested in the school. Participants must be able to attend from 4:45-8:45 p.m.

"I think we're pretty excited about the stakeholder part and to hear the feedback from our staff and teachers and community members," Goff said.

To volunteer, email your name, address and any questions to Lacy Stone at lacy.stone@billtown.org by noon Friday, May 10.

Goff said if all goes well, the plan is to have a candidate to approve before the board's regularly scheduled June 10 meeting. Three board members will be unable to attend that meeting, Goff said.

"If we have someone to

make an offer to, we will schedule a special meeting," Goff said. "Obviously we want the entire board there to vote."

At Monday's meeting, Farquer presented an enrollment analysis showing Williamsfield's high school total is 100 students, a 22-year high. Overall preK-12 enrollment is 293 students, up from the average of 290.

Farquer had a chart showing that Williamsfield is the only nearby school with an enrollment increase over the past 22 years, that being 2.81%.

For the same 22-year period, Elmwood is down 0.92%, Brimfield is down 4.82%, Farmington is

down 9.98%, Princeville has declined by 16.36%, Knoxville is down 18.09%, ROWVA is down 24.85%, Stark County is down 28.51% and Galva has dropped by 34.75%.

An amended budget for Fiscal Year 2024 was also approved to be put on display and a hearing is to be held June 10.

Farquer said Oberlander Electric plans to complete electrical work in the bus barn in early June, which is when installation is to start for the school's roof-mounted solar array.

Farquer also provided an update on the new electric buses which he said "continue to exceed expectations." For \$20,000,

Farquer said the district will have \$3.3 million in capital assets, nine new electric buses, 11 charging stations and all the electrical infrastructure needed to integrate the buses with the solar array. But after achieving fuel savings of nearly \$20,000 for the year, the district could actually break even.

In other business, the board accepted the resignation of Pierre Ponce from a full-time position to working only as a bus driver. The board also hired Hanna Shores as a full-time custodian and is planning to post openings for a business teacher and for a dishwashing/fitness center position.

Princeville woman killed in car crash

PEORIA – A Princeville-area woman was killed in a two-vehicle accident at the northwest edge of Peoria.

Nevaeh Mitchell, 18, was pronounced dead at 12:27 a.m. May 5 at the scene, in the 8400 block of N. Orange Prairie Rd., according to Peoria County Coroner Jamie Harwood. An autopsy was to be performed Tuesday.

Shortly after 11:30 p.m. May 4, Mitchell was driving north on Orange Prairie Road when another vehicle struck hers head-on. The other vehicle was headed south in the northbound lanes, Harwood stated. The Peoria Police Department did not identify the other vehicle or driver.

Mitchell resided along Illinois Route 90, according to Harwood.

As of Tuesday morning, a GoFundMe page plea had raised almost \$20,000 to help pay Mitchell's funeral expenses. The goal was \$15,000. The page stated the accident happened as Mitchell was driving home from work. Later this year, she was to attend Loyola University in Chicago.

Peoria police were continuing to investigate the accident.

from 9-12, though items can also be dropped off during regular business hours.

And Stufflebeam said cleanup days will be held the week of May 20, with the city bringing several dumpsters to its parking lot for use by residents.

What's better than garbage? How about grants to help homeowners improve their dwellings? Well, the council unanimously passed a pair of ordinances for Fiscal Year 2025 that continue two popular programs.

The ordinances stipulate that the city will spend up to \$75,000 on rehabbing residences in the Farmington TIF district and up to \$30,000 renovating commercial facades in the TIF district. Those interested in grant money must apply.

Stufflebeam said the council will vote on another grant program for residents outside the TIF district that will likely allocate \$25,000 toward residential repairs.

To keep its younger constituents busy this summer, the council approved buying two new slides. The council voted to spend \$4,509.30 for a GameTime

slide that matches the current playground equipment in Dimmit Park. The slide that was in the park is broken.

The council also voted to spend \$1,978 for a Playworld Glide Slide from Imagine Nation, LLC of Westchester. That new slide will be installed at Reed Park.

In other business, the council:

- Approved selling a lot at 33 N. East St. to the Farmington Odd Fellows Lodge for \$2,400, which is 80% of the appraised value of \$3,000.

- Approved Matt Harris Cleaning to clean four restrooms in the municipal building once a week for \$50.

- Approved purchasing six black, decorative wrought-iron garbage cans for use downtown for \$4,973.10, with funds

coming from late fees paid by residents on their sewer/garbage bills. Cans currently in use downtown will be repurposed in city parks.

- Accepted the resignation of Carolyn Ludwig from the city planning commission. Ludwig was reacting to a letter on social-media conduct she was given by Stufflebeam, writing, "I feel my constitutional right of freedom of speech is more important than a committee that never meets unless something comes up."

- Heard Stufflebeam say that owners of the old Farmington Grade School "wish to do something" with the property and are "putting together a plan."

Finally, the council had some discussion on a new city pool ordinance that is expected to be voted on at its May 20 meeting.

 light fixtures inside the sanctuary. And while the stained-glass windows are not all original, they were also in good shape.

“The structure was good,” Kress said. “It wasn’t like it was falling down or had major zoning problems.”

That was due in part to previous renovations, first in 1945 for the church’s 100th anniversary and re-dedication and then as needed from 1970-1995.

But by the time Kress was approached about buying the building, church services had already been halted. With no congregation to oversee maintenance, the future was uncertain.

“It was going to be turned into an apartment or a store,” Kress said.

She saw a different role for the stone structure. Once the building was stabilized, Kress reached out to the Peoria Historical Society seeking help receiving a historical designation, which is when Barry became involved.

He was impressed with the building and what he calls its Greek Revival characteristics, a dominant style in the U.S. from 1825-1860.

“It’s an absolutely beautiful pavilion-like, simple religious structure, like what you found in 1845 when it was built and when the center of America was being settled and you had religious groups coming in,” Barry said. “To me it’s a wonderful link between Jubilee College and Zion.”

“You can see architectural parallels between the buildings that remain at Jubilee and Zion and even with Kenyon College back in Ohio.”

Similarities are not surprising, since Chase was involved at all three locations and founded Jubilee College.

Barry said the 1945 re-dedication service also attracted prominent citizens from Brimfield and Peoria, including Peoria philan-

thropist Murray Baker.

“The local history is just awesome,” Barry said. “It is just a wonderful testament to her commitment to Brimfield that (Kress) took this upon herself to preserve this. Now it is this beautiful edifice.”

That’s what the church will remain, said Kress, who has created an endowment to fund upkeep and repairs on the building and its quarter acre of grounds.

“I have no real plans except to make sure it’s preserved for the future,” she said. “If something is really going to live for a long time, it has to be endowed. So people can make the right decisions and so it doesn’t have to come down to money.”

In the near future, plans call for an open house and

celebration when the National Register of Historic Places plaque arrives.

Kress said the church may also be open for the Brimfield Christmas walk.

Overall, though, Kress is content to have the building restored and protected.

“You don’t have to have events. It is what it is,” Kress said. “And it’s history. It’s part of the community.”

It’s a unique part of the community, at that, as the only other local entries on the National Register of Historic Places are:

- Lorado Taft’s sculpture “The Pioneers,” located in Elmwood’s Central Park.
- Jubilee College, added to the National Register of Historic Places in 1972 and located northwest of Kickapoo.
- The Washington C. Wear House near Princeville, which is located 1 mile south and 0.4 miles west of the junction of Illinois Routes 90 and 91.
- The Hiram Palmer House at 703 E. Fort St. in Farmington.
- The original Wolf Covered Bridge over the Spoon River was on the register, but was removed after being destroyed by fire in 1994. The bridge has been rebuilt.

Rhubarb gets nod as official pie of spring

It seems every season has its pie. Summer is cherry, fall is apple and winter is pumpkin. Maybe you're thinking the official pie of spring is strawberry, but my vote goes to rhubarb.

Rhubarb is the earliest pie ingredient to appear each spring, followed much later by strawberries. Its cherry-red nubbins poke up through the cold ground most years in early March and soon produce long crisp stalks of tart and tasty deliciousness.

As you've probably gathered, I have a fondness for rhubarb, served up preferably as rhubarb custard pie. However, I'll settle for a tart rhubarb sauce drizzled over vanilla ice cream or a warm baking powder biscuit- or both. My mom made a delicious single-crust, rhubarb-custard pie.

Shewas very meticulous, slicing the stalks into very fine small pieces, just an eighth of an inch or so. The crust, of course, was made with lard. Does anyone use lard anymore?

Rhubarb is most often used in sweet recipes such as pies, tarts, muffins and crisps. But if you do an internet search you'll find interesting recipes for savory items. One salsa recipe calls for fresh-cut rhubarb; onions; green, red and yellow peppers; Roma tomatoes; and a jalapeno, along with lime juice, sugar, salt and some cilantro. Sound good?

How about a barbecue sauce that combines rhubarb, Dr Pepper, onions, vinegar, molasses and a bunch of spices? It's meant to be basted over



grilled chicken, pork chops or hamburgers. Grab your computer and do a search for "7 Savory Rhubarb Recipes."

My daughter Rebecca is an accomplished baker and has developed quite a reputation for her fruit pies. One of her most crowd-pleasing confectionery concoctions is her blueberry pie. It's hard to say whether it's a blueberry pie with rhubarb or a rhubarb pie with blueberries. But it's not hard to ask for a second helping.

She's has a knack for adding blueberries to a number of fruit pies. Her most popular combo is a peach-blueberry pie, with which she won the pie contest at Williamsfield FFA's Ag Day a couple years back. She also makes a blueberry-cranberry pie, an uncommon but tasty mix of two of three fruits native to North America. That's right, there's only three and the third is not apple, cherry or peach. It's the Concord grape. But I digress.

Rhubarb is native to China and as far back as 2700 BC, the Chinese harvested and dried the roots of rhubarb and ground them to a powder for use as a laxative and a medicine for digestive ailments. Somewhere around the 10th century AD, rhubarb made its way to Persia (present-day Iran) where physicians hailed it as a powerful medicine to treat a number of digestive maladies.

Rhubarb traveled to Europe in the 1300s, but it wasn't until the 1600s in England that rhubarb became a popular ingredient in both savory and sweet dishes. It provided a tasty but tart contrast to sweet desserts like pies, jams and tarts. In the American colonies, rhubarb was known as the "pie plant" for obvious reasons.

Rhubarb can have a sentimental aspect, too. When your children or grandchildren settle into a new home, share rhubarb plants with them. Plants passed from one genera-

tion to the next are especially meaningful and pies made from them can stimulate conversations and bring back priceless memories of times gone by. I would love to have a plant or two from my grandparents' gardens.

In other news, Sunday, May 5, was International Dawn Chorus Day, when folks across the globe arise before dawn and go outside to listen to the songs of the birds. My lovely partner and I participated for the first time last year. We used Cornell University's free app to identify birds making the merry melodies. It's called the Merlin Bird ID and it's a cinch to use. Dawn in early spring is the best time to hear songbird melodies, especially those of migrating species.

The bird sounds carry much farther in the early morning when there's less traffic noise.

New law impacts November election

Candidates eying ballot access say they feel cheated after Illinois Democrats in less than two days approved and enacted legislation to end the slating of candidates for the November election if they didn't run in the March primary. Some candidates are eyeing a potential lawsuit.

Gov. J.B. Pritzker signed Senate Bill 2412 Friday morning, less than two days after it was approved by the House and concurred by the Senate.

The measure brings about three non-binding ballot referendums for Illinois voters about in vitro fertilization, poll-worker safety and property taxes. Another provision effectively ends the slating of candidates for the November election by Democrats or Republicans in races where

no candidates for that party ran in the primary.

"It really does make sure that we don't have backroom deals to put people on the ballot and run as a result of some small group of people in a smoke-filled room making the choice," Pritzker said.

Republicans said it changes the rules for the general election midstream. Democrats argued no one was officially slated, so there's no harm.

The Illinois State Board of Elections told The Center Square on Friday they have already accepted some slating filings and despite the new law will continue to accept them under the original deadline of June 3.

After that, there is the objection process. There could also be litigation from those objecting to the law.

Illinois tourism increased in 2023

CHICAGO – The Illinois Department of Commerce and Economic Opportunity, Office of Tourism, said Illinois saw a significant increase in international visitors in 2023.

Illinois welcomed 2.16 million international visitors in 2023, a 39% increase from the previous year, according to data provided by Tourism Economics. Additionally, international visitors injected nearly \$2.7 billion into Illinois' economy in 2023, a 47% increase in spending compared to the previous year.

"This significant achievement highlights the growing global appeal of

our great state and the hard work of our tourism and hospitality industry partners to make Illinois a world-class destination," said Gov. JB Pritzker.

The top five markets for visitation to Illinois in 2023 include Canada, Mexico, India, the U.K. and Germany.

Canada emerged as the leading market for international visitation, with an increase from 425,000 to 627,000 visitors, representing a substantial 48% growth.

Overseas visitors (defined as visitors not from Canada and Mexico) also showed significant growth, surging from 963,000 vis-

itors in 2022 to 1,347,000 in 2023, marking a 40% increase.

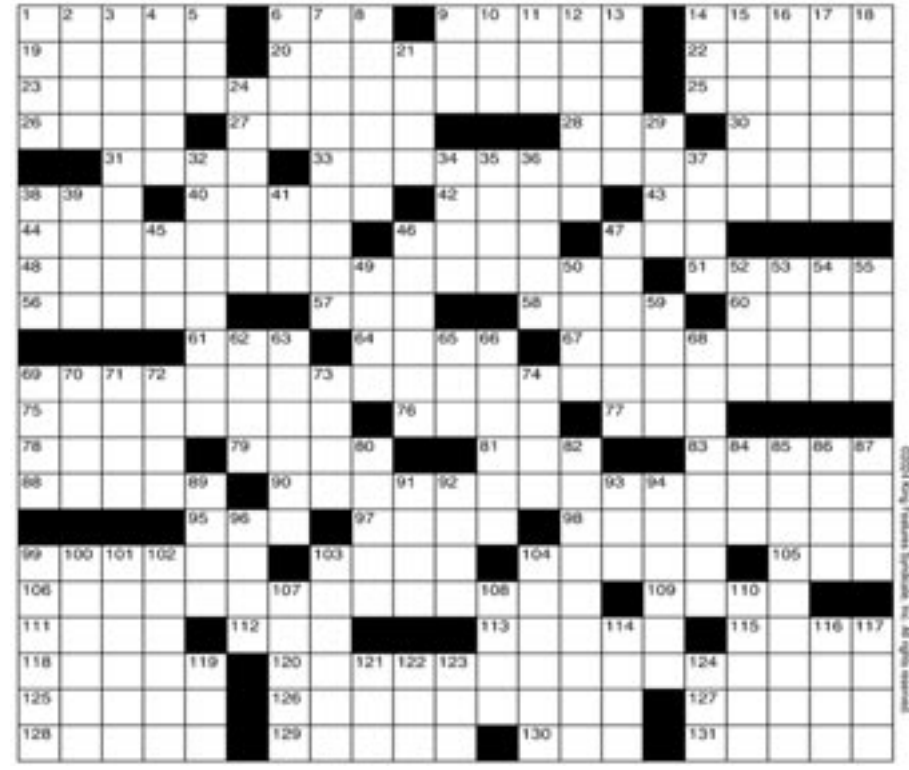
India demonstrated substantial growth in visitors to Illinois, with an increase of 55% from 2019 to 2023.

Mexico contributed to the upward trend, with visitation numbers climbing from 164,000 to 183,000, reflecting a notable 12% rise.

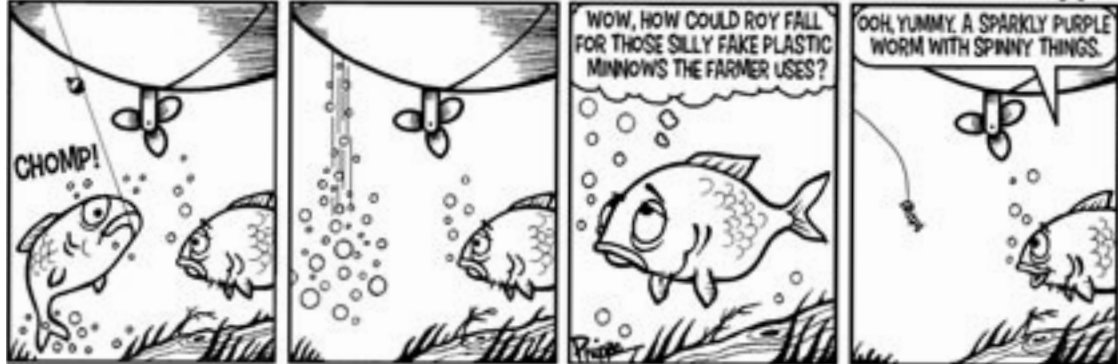
Officials attribute the growth to strategic-marketing initiatives, enhanced partnerships and a wide array of unique attractions and experiences that appeal to international travelers.


