Good news, bad news for Brimfield school renovations

By NICK VLAHOS For The Weekly Post BRIMFIELD – Ongoing renovations at Brimfield Grade School appear to be a good news-bad news situation.

The good news, as Brimfield Superintendent Chad Jones sees it: Flooring, painting and new-window installation in the gymnasium and junior-high section are to be completed before classes begin Aug. 14.

Bad news: The kindergarten-through-fourth-grade section won't receive new windows until after classes begin and probably won't receive new classroom furniture until winter break. The window delay had been long anticipated. It will require window spaces to be sealed with watertight materials until the new pieces are ready for installation. That probably will happen in mid-August. The furniture delay is out of district control, according to Jones.

"Our goal was not to start the school year with boarded-up windows and old furniture, but we will persevere and we will have the best Christmas ever because after winter break, our primary classrooms will be complete," he stated in a report to the Brimfield School Board.

Existing primary-wing furniture is being stored in the gym. Some of it is beyond repair, but there should be enough functional pieces to begin the 2024-25 academic year, Jones told board members July 17. *Continued on Page 2*

Twisters confirmed

July 15 storm spawned 3 local tornadoes

For The Weekly Post Storms that passed through the area July 15 spawned at least three tornadoes in northern Peoria and eastern Knox counties. No injuries were reported.

The longest-lasting tornado touched down about 8:15 p.m. near Monica, where it damaged a couple of roofs and trees, according to the National Weather Service office in Lincoln. Several large trees were damaged as the tornado progressed about 4¹/₄ miles east-southeast before it dissipated about 8:19 p.m. just south of Princeville. Peak windspeed was esti-



Continued from Page 1 "It's a bummer, but all the other (work) will be done," he said. "I'm reminded that even though we didn't get everything we wanted accomplished, there's going to be significant progress."

Removal of asbestos in the grade-school building has been completed. The reconstruction work is not to affect the academic cal-

Among other business,

the board authorized district fees for 2024-25. That includes fee increases for online high school courses and for dual-credit courses through Illinois Central College.

The cost of a threecredit-hour course is to be \$275, up from \$190. Twocredit-hour courses are to rise from \$127 to \$184. The previous collegecredit fees were not enough to cover an ICC-

initiated increase, according to High School Principal Marcy Steele.

Still, she stated the cost is less than what ICC charges its students -\$160 per credit hour.

Online high school course fees are to be \$275. That's a \$35 increase assessed by Edmentum, a Minnesotabased firm that offers Brimfield students worldlanguage courses, among others. Brimfield-district lunch prices also are to rise, by 10 cents.

The board also approved a \$21,605 bid from C.J.L. Landscaping, Inc., of Brimfield for materials and installation of mulch in grade-school playground areas.

Regarding personnel, the board accepted the resignations of Ashley Haines as a grade-school special-education teacher and Erich Weiger as district band and choir teacher. Haines left for a job in another district and Weiger left for a non-academics position, according to school officials.

Weiger's vacancy is a bit problematic because of the timing as well as the specialty nature of the job, Jones and Steele sug-

gested. Retired band teacher David Ericson is to substitute until a permanent hire is made. That might not happen until second semester.

Ericson filled in for Weiger when he missed extended time recently because of illness, according to Steele.

"The kids already know Mr. Ericson," she said. "We've got a pretty good Band-Aid on it."

The board authorized hiring Lisa Dawson as a full-time grade-school paraprofessional and Kristin Wagner as a full-time grade-school librarian and media specialist.

Other hires approved were Hollie Cahill as seventh-grade girls track coach; Griff Inskeep as eighth-grade boys track coach; Devin Jones as a volunteer track coach; Amy McKinty as a Scholastic Bowl head coach; Fran Meyers as seventhgrade boys track coach and as a Scholastic Bowl assistant coach: Erin Self as eighth-grade girls track coach; and Jaden Shoff and Melissa Smith as coyearbook supervisors.





Last week in a story about a new OSF HealthCare medical clinic coming to Brimfield, I wrote that the village was "unwilling" to extend city water to the site of the office.

That's not accurate, according to Village President **Dan Fishel**. He said the village was willing to extend its water lines to the medical clinic but was not willing to have water lines extend east past

the clinic to 150 homes in two subdivisions.

"We're not in a position with our backup well to add 150 users," said Fishel, who in 2022 wrote a letter supporting construction of the new clinic.

Since the village must have two water sources, capacity of the backup pump is a limiting factor. And while that backup can generate enough water for the village in case of an emergency, Fishel said engineers have told the village that's not true if demand increases substantially. Cost for a new backup well is \$1.8-\$2.5 million, according to Fishel. That's money the village does not have. As always, we apologize for my

One of these years, **Shirley Ludolph** is going to win our annual big tomato contest. Maybe this year? As she has



for several years now, Ludolph has been first to bring in an entry. And it was a good one, a 3-pound, 7.9ounce heirloom German tomato that traces its history back to her late father, Frank Ludolph, who died 42 years ago. Shirley has collected seeds every year since her father passed away and usually grows about 80 plants. Most are given to friends, but she plants about 10 per year. Wet weather in July has not helped many gardeners, Shirley said, as she has heard reports of blossom rot and a fungus that is turning leaves brown. So she was pleasantly surprised to pick the big one pictured above. Time will tell if she gets to pocket the \$50 first prize, as our contest runs through Sept. 9 this year. ... As is often the case, one tomato begat another. One day after Shirley braved our messy office garage for a picture, Pam Ciaccio of Elmwood hauled in a tomato weighing 2-8. Despite not taking the lead, Ciaccio was kind enough to donate the sizable vegetable/fruit for my next BLT. ... Those last sentences basically encapsulate why we started this newspaper: to

have yet another garage in which to store stuff and to open a conduit to free tomatoes and pies (rhubarb always welcome). ... Just FYI, if Yellowstone ever erupts, we are in the secondary ash zone, not the kill zone.

Not all news was good this week, though, as **Kip Stevenson** sent in a picture of a young buck that died in standing water in Knox County near Oak Run. Though it's hard to be certain without somebody smarter than me testing the deer, this sure looks like a case of epizootic hemorrhagic disease. EHD, or blue-tongue as some call it, is a viral disease of whitetail deer transmitted by biting midges. It's usually more of a problem in dry years when deer are forced to congregate around scarce water holes. But heat can also lead to outbreaks. Whatever the cause, an outbreak of EHD is the last thing deer hunters want to see after populations have finally ecovered from past outbreaks. ... High winds are hard on all trees, but if you took an inventory of what was damaged last week, you'd surely come up with a high percentage of soft maple, Bradford pear, white spruce or other fast-growing trees that are susceptible to wind damage. What to plant that won't get blown over but will provide shade within your lifetime? Bald cypress, persimmon, basswood, beech, hornbeam and live oaks are good options, according to experts. Unfortunately, there are a lot more maples around than persimmons, which explains all the branches down. ... Parting shot: As Moe once told Curly, "I'll squeeze the cider out of your Adam's apple."

For Blue Sky School sits under a broad expanse of azure skies on the Knox County prairie northwest of Yates City.

School no longer serves its original purpose, yet the structure has been enveloped within the walls of a series of private residences over the

years.

When I became acquainted with Blue Sky School (originally Union School), between the ages of 3-8, it no longer served as a country school. From the inception of public education in the 19th century through the mid-1950s, the young scholars of Elba Township gathered in Blue Sky School to learned basic skills – readin', writin' and 'rithmetic – along with a smattering of science and history.

Some of my earliest childhood memories were formed there. Most revolve around the Saturday-night square dances my parents, siblings and I attended. As a farm family living just one mile away, we gathered with our neighbors in the spirit of community that existed in rural-1950s Illinois.

Of course, there was food to accompany the dancing. The finest fare was prepared by the skillful hands of accomplished farm wives. These women (including my mom, whose contribution to the effort was her outstanding pies) were practiced, furnishing huge meals daily for the men, who required a major intake of calories to fuel the physical nature of farm work in those times.

Older siblings of my Yates City classmates and other acquaintances attended there. From their nearby homes they walked or rode bicycles to school. Teachers at Blue Sky and other

country schools are deserving of a great deal of respect. Though their classes were small, they taught all subjects in first through eighth grade. This required exceptional classroom-management skills.

And according to students of those times, instruction came not only from the teachers. Those in upper grades also helped tutor younger classmates.

As for instructional materials, in

the early years, students were provided a small square slate and chalk for writing.

Many country schools, and no doubt Blue Sky in the beginning, were heated by a wood-burning stove, which the teacher was responsible for maintaining. This required an early arrival before classes began. Eventually, however, a furnace was installed in the basement at Blue Sky.

Originally, of course, there was no indoor plumbing. The alumni I spoke to for this story who attended in the late 1940s through the early 1950s, however, mentioned that more modern conveniences were available during that time.

Blue Sky School is such a poetic name. It conjures a happy place, with children playing, swinging, running, laughing and singing. Or a community gathering for adults and children alike, with square dances, the Hokey Pokey, so much good food and equal amounts of good fellowship.

Blue Sky School lives on within the walls of private homes and within the hearts of Elba Township folk lucky enough to have been there. *Randy Sollenberger is a self-published au*-





Princeville to pay for aquatic center survey

By NICK VLAHOS For The Weekly Post PRINCEVILLE - More municipal money will be spent on the shuttered Princeville Aquatic Center. But not much more, and not with majority support from village trustees.

Village President Jeff Troutman broke a 3-3 tie July 16 to approve paying for a survey of the aquaticcenter property. An attorney for a not-for-profit group that seeks to reopen the swimming-pool complex asked the village to fund the survey, according

The board decision essentially resets a 60-day period in which the savethe-pool group, also called Princeville Aquatic Center, is to determine whether a reopening is feasible financially.



Building permits were issued for a 6-foot wooden privacy fence and a 10-by-10-foot deck and metal pergola, both at 126 N. West St.



Elmwood hires YMCA for after-care

ByJEFF LAMPE For The Weekly Post ELMWOOD – Elmwood CUSD 322 students will have new after-school care providers for the 2024-25 school year.

The Elmwood School Board on Monday approved a three-year aftercare program with the Greater Peoria YMCA.

The YMCA will replace Right at School, which handled after-school programing last year.

"I think it will be a better service for our families," said Joel Schmieg, who was presiding over his first meeting as superintendent.

Schmieg noted that the YMCA is a partner in a proposed Wellness Center in Elmwood, which could offer expanded programming down the road if the facility is built.

Schmieg said the YMCA will charge \$55 per week for one child participating in five days of after-care. That's \$3 more than Right At School charged last year but is \$6 lower than the YMCA typically charges, Schmieg said.

The board also unanimously approved a threeyear lease with Heart Technologies, Inc., of Peoria for phone service. Heart will provide new phones, software upgrades and technical support for a cloud-based system that will cost \$1,200 per month.

The current school phone system was installed in 2015, according to School Board President Mark Davis. In addition to a \$28,000 system upgrade required to run the old phone system, nearly half of the school's 60 or so Mitel phones would have to be replaced at \$375 apiece, according to Kevin Faulkner, the district's director of technology.

As another part of its consent agenda, the board approved Schmieg to develop a tentative budget for Fiscal Year 2025 and to expend funds until the budget

In personnel, the board approved several 2024-25 hirings. Hired at a salary to be set by the collective bargaining agreement were Jennifer Ferguson, Spanish teacher; Rick Hutchison, second-shift custodian; Kimberly Lawrence, bus driver; and the following part-time paraprofessionals: Makayla Vicary, JoAnna Bernal, Constance Roberts, Mallory Miller, Emily Brunnelson and April Jansky.

Also hired was Cara Edwards as a long-term substitute, Branden Bruninga as emergency long-term elementary physical-education substitute, Dianne Burwell as learning loss specialist, Susan Flinn as part-time student facilitator, Cooper Hoffmann as junior high boys cross country coach and Kate Meyers as a volunteer junior high boys and girls cross country coach.

In other business, the board approved naming Schmieg and Treasurer Stephanie Baysingar as Freedom of Information Act officers.

After the meeting, Schmieg and the board toured the building. Renovations to the elementary school are completed and include new floor tile and paint in all hallways and classrooms.

The first day of school for students is Aug. 15, with dismissal at 2:15 p.m.





Continued from Page 1 the chance of getting mildew by keeping the area around the plants open and clear so the air can circulate freely. That won't cure mildew but it can help prevent it from spreading. A fungicide can be effective if applied at the very first sign of mildew.

I think the best solution is to plant mildew-resistant varieties and position them behind other plants in the border. Even resistant varieties can develop mildew in our humid summers but it won't be as unsightly if the plants are behind others in the border. After flowering, the plants can be cut back to 8 or 12 inches above the ground if they're too ugly.

A friend of mine, retired lion tamer Claude Badly, called to say he's worried his trees are dying. The leaves on many of the branch tips are turning brown. Whole clusters are dropping to the ground.

I told him not to worry. That phenomenon is called flagging and is the result of the cicada invasion this summer.

When a female cicada cuts into a

tender young branch to lay her eggs, she disrupts the vascular system, thus depriving the branch of water and nutrients. And so it dies. The branch falls to the ground and the cicada nymph crawls out and burrows into the ground, not to be seen for 17 years. Healthy trees will survive the attack with no help from us.

Avid vegetable grower Herb Gardner asks, "When should I set out broccoli, cabbage and cauliflower plants for fall harvest?"

August is the time to set out these plants, so hopefully you've already started your seeds in a flat or tray.

Such plants may not be found easily at garden centers and box stores this time of year. And you need to be wary. Some of these vegetable plants may be holdovers from a late spring crop. They won't amount to anything because they will be severely root-bound by this time.

Many gardeners tell me they prefer the flavor of the fall-harvested cole crops over those grown in early spring. At our place we've had good luck with fall cabbage and broccoli but not so much with cauliflower. Justin Thyme wants to know when

he can divide and move his peonies. Justin, September is the time for such a project. Peonies hardly ever need to be divided unless you want to propagate them. In that case, each fleshy root division should have at least three to five eyes. Plant each root piece so that the eyes end up an inch or two below the soil line. Peony roots planted too deep will refuse to produce flowers. You'll get only foliage for your efforts. Peonies flower best when located in a sunny spot.

And Justin also asks, "When can I divide hostas and daylilies?"

Although the textbook says to do it in early spring before the leaves unfold or in autumn after the foliage begins to wither, the real answer is whenever. I've dug and divided these things in every spring, summer and fall month.

Truth be known, that's one reason these plants are so popular. They're almost indestructible.

cant tree damage on five properties, the Weather Service reported. One


homestead lost 40 trees.

The tornado, which had peak winds of 105 mph, lifted about 8:23 p.m. in a field near Feucht and Salem School roads west of Dunlap. En route, it toppled a tree onto power lines along Evans Mill Road.

A pair of tornadoes also was reported between 8 and 8:10 p.m. in Kewanee – one on the north side of the city, one on the south side. Extensive tree damage was reported, as was varying damage to building roofs, according to the Weather Service office in the Quad Cities.

Also new this year is a sensory-sensitivity hour, from 2:30-3:30 p.m., designed to be a smaller event with limited lights and sounds. This event will be set up at the north end of Dick's parking lot, separate from the main Emergency Expo event.

Illinois traffic stops increase 12% in 2023

Illinois police departments had a busy year in 2023, with an increase in traffic stops over the year before. In Illinois Department of Transportation data compiled by the American Civil Liberties Union of Illinois, there was a 12% increase in traffic stops last year from 2022.

"Police in Illinois conducted another 200,000 additional stops in 2023 compared with 2022, and to put that in a finer form, it means there are 500 additional stops happening every single day," said Ed Yohnka, ACLU of Illinois director of communications.

Yohnka adds that the data showed black and Latino drivers were stopped at higher rates than white drivers in almost all areas of the state.

The ACLU reports the numbers are based on data that every law enforcement agency in the state is supposed to report annually, although about 20% of police agencies failed to submit the required data for 2023.

PRINCEVILLE - The Princeville Board of Education has decided to delay a decision on hiring a technology assistant for at least another month.

Kelly Jenkins, Princeville's technology coordinator, has requested the addition of this position alongside her own in the technology department in order to properly train someone who would ideally be her replacement upon her retirement.

Jenkins has held her position for 14 years. She says it has changed dramatically and that she believes it requires an assistant in the way it has evolved.

Jenkins was hoping to have someone in the position by the beginning of the school year as she describes the first few weeks as controlled chaos and would like the assistant to be prepared prior to school starting.

During its July 16 meeting, the board expressed concern over the creation of a new position and the specifics of the job description as reasons for tabling the decision until its next meeting.

Superintendent Tony Shinall will reach out to other districts to get a better idea of the makeup of their technology departments.

The board also approved the only bids it received for milk supply and fuel supply.

Prairie Farms will be supplying milk for the school in 2024-25 with a few price increases. A half-pint of 1% white milk increased 4 cents to 39 cents. A half-pint of both 1% chocolate and strawberry milk increased 4 cents to 41 cents.

The price of a gallon of whole milk did not

lactose-free milk at 74 cents A half-pint of whole milk will cost 44 cents.

AG-Land FS submitted the only bid for fuel and was approved by the board, also with some price increases. A gallon of unleaded gasoline with ethanol will increase 5 cents per gallon, to \$2.70 per gallon. Both premium diesel and bio-diesel fuel will reflect a 7-cent increase per gallon, to \$3.06 per gallon.

Gorenz & Associates of Peoria was hired to perform the Fiscal Year 2024 audit at a cost not to exceed \$22,500. Shinall said he suspects the total cost will be less than the approved amount.

Improvements are also being planned for the Princeville school campuses. The board heard that the garage used to house buses has holes in the roof and walls that were described as having a little sway to them.

Shinall reached out to an unnamed local firm for options and reported that repairs to the roof were quoted at \$6,900.

Another option is demolishing the building, at a cost of somewhere between \$3,000 to \$4,500, and erecting a new metal building for less than \$10,000.

No action was taken on the bus building.

Grant money will be used to upgrade radios used by faculty members. Shinall is working with the same vendor the Peoria Police Department uses to determine the best option.

Shinall also said during the meeting that "reunification drills are probably going to be required drills sooner rather than later."

The plan is for the school to have a drill in the fall. According to the Risk Strategy Group website, "School reunification drills are an essential

The school is also looking to hire another parttime van driver to transport special-education students to SEAPCO, which is located in Bartonville.





Sangamon Co. deputy charged with murder

By BETH HUNSDORFER

Capitol News Illinois Sonya Massey's last words were: "I rebuke you in the name of Jesus," followed by "I'm sorry," as Sangamon County Sheriff's Deputy Sean Grayson put his hand on his 9 mm pistol and threatened to shoot her in the face.

Seconds later, he did. Grayson, 30, who is white, was charged last week on counts of firstdegree murder, aggravated battery with a firearm and official misconduct for the fatal shooting of Massey, a 36-year-old black woman.

In a video released by Sangamon County State's Attorney John Milhiser, the July 6 shooting of Massey in her home near Springfield shows the events that unfolded at about 12:50 a.m. on July 6.

Grayson and an unidentified Sangamon County Sheriff's deputy arrived at the home in response to a 911 call made by Massey reporting a prowler.

Massey's killing caught the attention of the White House on Monday. President Joe Biden issued a

statement commending Milhiser for acting quickly to charge Grayson.

"When we call for help, all of us as Americans – regardless of who we are or where we live – should be able to do so without fearing for our lives," Biden said in the statement. "Sonya's death at the hands of a responding officer reminds us that all too often Black Americans face fears for their safety in ways many of the rest of us do not."

Massey's family has hired renowned civilrights attorney Ben Crump, who represented the families of George Floyd, Trayvon Martin and Breonna Taylor.

Grayson had worked for the Sangamon County Sheriff's Department since May 2023, according to the Illinois Law Enforcement Training and Standards Board. He was fired after the criminal charges were issued. He remains detained at an undisclosed location until trial.

The work status of the deputy who was with Grayson at the time of the shooting is unknown.





Weekly Post Sports Five weeks until football

Princes enjoying new weight room; Farmers, E-B have new foes

For The Weekly Post Weightlifting can get to be a drag for football teams as summer wears on. Not this year in Princeville.

Thanks to a \$30,000 offseason investment in a new weight room, the Princes have had big crowds pumping iron all summer.

"We're averaging 42-44 kids in the weight room," Princeville Coach Jon Carruthers said. "This is the best off-season I've had in a long time."

And instead of a dropoff after July 4, Carruthers said numbers have stayed steady. Some credit for that goes to Jack Arnett, a Princeville alumni who has been helping run the lifting program after working last summer as an intern in the University of Cincinnati weight room.

"He's done a good job," Carruthers said of Arnett, a Eureka College graduate. "There's a lot of energy."

Carruthers hopes all that lifting will help what is still a young Princes team in a very solid Lincoln-Land small-school division. Princeville has 55 players out, and just eight of those are seniors.

"We've got some pretty good numbers at the froshsoph level," said Carruthers, whose Princeville teams have usually averaged about 44 players.

The Princes have a fourday football camp next week in Princeville and have 7-on-7 scrimmages with Chillicothe IVC, Tremont and Canton.

In terms of its upcoming schedule (See Page 19), Princeville faces the same order of teams as last fall, when the Princes finished 5-5 with a first-round playoff loss to Stark County. • ROWVA-Williamsfield -

The order of opponents is the same for R-W, but the Cougars will look very different after graduating 14 seniors from a 9-3 Class 1A quarterfinalist.

Coach Grant Gullstrand said he expects 45-48 players out for football when practice officially starts on Aug. 12.

Gullstrand is excited to have five offensive linemen out this year who have starting experience. Three of them started last year for R-W, one is a transfer and one is a senior who missed the last two seasons with health issues but played as a freshman.

"We've talked about not comparing ourselves to last year's team," Gullstrand said.

The Cougars have had 7on-7 sessions with Kewanee, Illini West and Galesburg at home and Continued on Page 19




