

Princeville administrators discuss IHSA classifications

For The Weekly Post PRINCEVILLE – Some Princeville School District administrators and board members don't appear thrilled with how the Illinois High School Association is classifying its non-boundary members.

The current statewide controversy regarding the frequency of private schools winning IHSA championships was a topic of conversation when the Princeville board met Dec. 10. Superintendent Tony Shinall said it was the dominant discourse on a recent conference call with counterparts.

"There are lots of upset folks around the state talking about (it). It's not a secret," Shinall told the board.

Private schools won seven of the eight football state titles decided Thanksgiving weekend. In response to that and recent private-school state-trophy hauls in other sports, the IHSA announced it is abandoning its two-year enrollment-classification cycle in favor of a one-year cycle.

# Farmington lowers city tax levy for 2024

For The Weekly Post FARMINGTON - The Farmington City Council on Monday approved a 2024-25 tax levy that is \$26,000 lower than last year.

"At this point, we feel the city is operating within its constraints and we would like to give as much relief as we can," Mayor



But Princeville board Vice President Michael Harmon appears to believe the classification change alone isn't sufficient. He referred to the private-school issue as a debacle.

"I think the shift everyone wants is for them to be in their own conference," Harmon said.

nts propriate for us to apply," Harmon said. Earlier, the board ap-

> proved the district's new property-tax levy, which is \$5,988,850. It's an increase of 4.99% from the previous year, just under the 5% threshold that obligates the district to conduct a truth-in-taxation public hearing.

Avoiding a hearing might not be possible every year, Shinall suggested. Increased expenses is one reason. Another, according to the superintendent, is the proliferation of tax-increment-financing districts in Princeville. That restricts the school district's share of growth in the assessed value of property. "We're doing our best to

keep it in line," Shinall said about the levy.

The board decided to continue to abate the district's share of Peoria County Facility Sales Tax revenue, about \$111,000. But Board President Darwin Stahl and Secretary Sue Hefler suggested the district review that policy, probably early next year.

Also approved was a \$10,959 deal with Smith & Potter Equipment of Princeville for a Kawasaki Cheetah II lawnmower to be used at the high school.

Following closed session, the board authorized hiring Maggie Dwyer as high school sophomore volleyball coach. She had been freshman coach. Dwyer replaces Tracy Thole, who resigned.

Shinall announced another resignation, that of Kamryn Rahn as a daycare worker. Paraprofessional Yolanda Rodriguez is taking unpaid time off, and daycare worker Melinda Shimmin is taking a Family and Medical Leave of Absence.

#### Presidents exercise power, move on

Pardons. Just say the term and people will give you an opinion. The offender got out of his sentence unjustly. The offender was unjustly convicted and a wrong has been righted.

The offender has redeemed himself and is worthy of grace. The opinions are there and they certainly are not exclusive of each other.

Recently, the country has been somewhat animated about President Biden's pardon of his son,

Hunter Biden, on gun and tax evasion charges. Both Democrats and Republicans have taken to the airwaves to voice their disapproval, especially as President Biden had explicitly told the public that he would not pardon his son. My read on the issue may annoy or anger some and it may amuse others.

The power to pardon is given exlusively to the President by the Con-

ton also incurred public displeasure when he pardoned his half-brother on drug charges.

Presidential pardons tend to be given at the end of the president's term because there may be political difficulties for the president should he be facing election. And that is the key. The only recourse the public has for a pardon the public views as wrong is to impeach the president or to vote him out of office.

The ballot means nothing if the president is not running for office. Impeachment has a similar limitation and Congress is simply not inclined to take up an impeachment over a pardon. Neither course of action will take the pardon away. The individual's pardon is irrevocable.

Biden, Trump and Clinton all made decisions to pardon, as have other presidents. Those decisions are beyond the public's purview. The only person with the authority and power to pardon is the president, and there

Neely, suffering from mental illness and perhaps drug abuse, boarded a New York subway train and was threatening other riders.

Penny is the individual who placed Neely in a choke hold. Neely would die in the incident and Penny was charged with what amounts to manslaughter. This case caught national attention as Neely was black and Penny was white, with the addition of Prosecutor Bragg, who is also prosecuting Trump.

A New York jury acquitted Penny last week. This case begs the question of why was it even charged. Penny remained at the scene until the police arrived. He voluntarily gave an in-depth interview with detectives.

What is most telling is that the police did not detain Penny. They released him after they interviewed him and other passengers on the subway. Police officers are trained to detain any individual they believed they have probable cause to believe com mitted a serious felony. Death is a serious felony. It is clear the officers involved did not believe they had probable cause to detain Penny. It took the prosecutor 10 days to actually file charges against Penny. The taxpayers of New York paid a fortune for an acquittal of a Good Samaritan. The nation needs to get back to a common-sense justice system. ## **REINDEER:** A boost to Christmas-tree operation

*Continued from Page 1* His dream of deer became a reality after Beth retired from Northern Illinois University and Randy wrapped up a 40-year career in the seed business. As they started a second act in life, the couple set aside 18 acres to grow the small Christmas-tree operation they began years earlier on the family farm.

As Randy researched ways to promote Christmas trees, he discovered Hardy's Reindeer Ranch in Rantoul. He visited owner Mark Hardy for some tips and promptly fell in love with reindeer.

"In hindsight, I wish I had listened better to Mark," Randy says. "He told me to take all the money I was going to spend on Christmas trees and buy another reindeer or two. Reindeer have turned into our major focus, and they are actually less work than the Christmas trees."

Before buying any reindeer of their own, the Espes joined the Reindeer Owners and Breeders Association and the Reindeer Farmers Association to learn how to responsibly breed and care for reindeer. By 2018, they felt ready to welcome their first four reindeer from Alaska. Today, their herd numbers more than a dozen.

Far from their native lands in the Arctic and mountainous regions of eastern Europe, Siberia and Scandinavia, reindeer living in Illinois require special care. According to Randy, ticks and heat present the biggest challenges.

Reindeer prefer frigid winter weather. During warmer months, the reindeer typically stay in the barn all day, emerging at dawn and dusk to graze in cooler temperatures.

Those amazing antlers – grown by both males and females – also present a serious safety hazard for reindeer. Sprawling like a tree canopy, the antlers can easily become wedged in a fence or gate.

The Espes have also learned reindeer have a magic all their own. "The reindeer always

## Yates City ups garbage, water rates

YATES CITY - The Yates City Village Board on Dec. 11 passed an ordinance raising the garbage rate 30 cents for the year as well as increasing the water rate by 3%.

As a result of the ordinance, 2025 garbage rates will be \$15.83 in town and \$22.83 out of town.

The in-town water rate will rise from \$52.33 for the first 1,000 gallons to \$53.90, and the out-oftown water rate for the first

1,000 gallons will increase from \$60.66 to \$62.48. In lieu of drafting

another ordinance, the Village Board also created a new policy stating that snow removal at businesses - including the sidewalks and entryways – is the responsibility of the businesses themselves.

The village is willing to serve as backup for snow removal, but the focus for village workers will be on getting the roads done. After the roads are plowed, the village is willing to

The board approved the purchase of a 72-inch skeleton grapple bucket for the skid steer for \$1,639.95 from All SkidSteers Inc, The new attachment will be used to assist in clearing brush and moving heavy objects.

The board also approved two donations: \$300 to the Elba-Salem Fire Department's Santa Breakfast event and \$300 to the Harvest Home Committee to be put toward new stoves. The stoves are 36-inch residential grade with six burner tops and are deeper and wider than the current stoves being used.

Holiday bonuses for city employees were approved in the amount of \$100 each, with the exception of Village Clerk Neely Carr, for whom the board approved a bonus of \$275 for going above and beyond.

## Elmwood will repost principal job

By MOLLY RICHESON For The Weekly Post ELMWOOD – Hopes of hiring a new principal for Elmwood Junior-Senior School were not met Monday night during the monthly School Board meeting.

The board had expected to approve a three-year contract for Brock Zinke but pulled the item from the agenda at the beginning of the meeting.

Superintendent Joel Schmieg issued the following statement: "One item was removed from the agenda due to unforeseen circumstances. Although very early in this process, we were hopeful to recommend a ... principal candidate after conducting a first round of interviews. We do not yet have a candidate at this time. Our interview team did a terrific job of representing our staff and now believe the best decision is to exercise patience and repost the position to give additional candidates time to apply. We will repost before winter break."

The board did recognize five seniors as Illinois State Scholars: Bernie Cantorna, Sawyer Jansen, Caleb Livengood, Riley McElroy and Kaylin Williams. State scholars are chosen based on their ACT or SAT test scores and sixth-semester class rank. They rank in approximately the top 10% of graduates from Illinois high schools.

The Class of 2025 recognized other award winners. Kaylee LaFollett was recipient of the Daughters of the American Revolution award and Williams received the Lincoln Award. Both awards are determined by academic excellence.

Results of an annual audit conducted by Gorenz and Associates, Ltd., of Peoria resulted in the hiring of a treasurer for the board. Sherry Swindler will take on the role. Her hiring will address the audit item concerning internal controls and the segregation of duties for those handling money. Swindler will work closely alongside the bookkeeper.

A \$753,314 deficit was found during the audit and was explained by Board President Mark Davis as stemming from construction of the Industrial Arts Building. Davis said it was a planned deficit.

Auditors said the district ended Fiscal Year 2024 with \$4,415,128 in operating funds, or about six months of reserves.



Once the code is scanned, information from that cellphone is sent to scammers who receive the recipient's personal and financial information. The contents of the package can be kept or thrown away, but recipients never should scan unknown QR codes, according to police.





#### Brimfield girls among 13 with 1,000 wins

**By JEFF LAMPE** For The Weekly Post The Brimfield girls basketball team joined an elite group of Illinois programs earlier this month by posting the school's 1,000th victory.

"It's a testament to all the players and coaches before us," Lady Indians Coach Josh McKown said. "We're the fortunate ones to happen to be coaching and in uniform for win 1,000."

McKown said Brimfield is planning a celebration of the milestone during its Jan. 23 home game against Lewistown. He said the Illinois Basketball Coaches Association will make a presentation and former coaches and players will be welcomed back.

"Anybody that's put on the uniform or who has coached is a part of it,"

McKown said. "It's a pretty storied program, if you think about it."

McKown said only 13 Illinois girls programs have reached 1,000 wins. He is the 10th girls coach at Brimfield, according to Illinois High School Association records. Those same records show just three losing records since the program started in 1974 under Terry Hart.

And this year's team looks determined to keep the winning ways going.

The Lady Indians (7-3) bounced back from a loss earlier in the week by beating Midwest Central-Delavan 54-27 on Dec. 12.





For The Weekly Post PRINCEVILLE – A defensive change early this season has done Princeville boys basketball some good.

The Princes won two of their three games last week and are 5-2 since they switched from man-to-man to zone defense. According to Princeville Coach Tait Sennett, the need for change became apparent in the second game of the season, against Varna Midland at the Peoria Heights Thanksgiving tournament.

"Midland was going to blow us out of the water," Sennett said. "We changed and the roles reversed. Our footspeed from last year to this year just isn't the same. We had some

It's different for Sennett foremostly. He said he coached zone defense early in his career but later switched to man-to-man to put more pressure on opposing ballhandlers.
