Princeville school resource officer removed from job

PRINCEVILLE – The Peoria County Sheriff’s Office deputy who for a decade has been stationed in the Princeville School District has been removed from that job.

An internal investigation resulted in the action taken against Deputy Crystal Strauss, Sheriff Chris Watkins stated Monday. Strauss, who became the Princeville school resource officer in September 2015, has been re-

assigned to patrol duties.

The Strauss investigation regarded alleged policy violations, according to Watkins. He was not more specific. The Princeville SRO job opening has been posted internally. Watkins expects it to be filled next week.

According to Princeville Superintendent Tony Shinall, the sheriff’s office informed the district Jan. 2 that it would be receiving a new SRO. Shinall had no additional comment.

Strauss joined the sheriff’s of-

fice in March 2014, according to Watkins. In 2025, Strauss was among 12 statewide finalists from more than 650 nominees for Illinois School Resource Officers Association Officer of the Year. The winner was Officer Candi Buhl of the Canton Police Department.

The school district and village government split the cost of the Princeville SRO. Separately, the village contracts with the sheriff’s office for overall police protection in Princeville. Local

government is not involved with the current issues regarding Strauss, according to Village President Jeff Troutman.

Word about Strauss’ reassignment spread quickly in the Princeville community, particularly through social media. Most posts supported Strauss.

“I don’t even have any kids in the district, but I know she is amazing and those kids loved her,” Alicia Vonk posted on the Princeville Families Facebook page. “She doesn’t deserve this

at all.”

A community meeting regarding Strauss was expected to take place Wednesday night at High Voltage Taphouse in Princeville. The meeting was to be held after The Weekly Post deadline. The next Princeville School Board meeting is scheduled for Jan. 13.

The Weekly Post has filed Illinois Freedom of Information Act requests with the sheriff’s office and the Peoria County State’s Attorney’s Office for documents related to Strauss’ reassignment.

Interest from Byzantine

BRADFORD – New hope has emerged for the future of Saint John the Baptist Roman Catholic Church in Bradford.

Slated for permanent closure by the Diocese of Peoria after a final service on April 19, the church has attracted interest from the Byzantine Catholic Church. Working with local supporters, a group is exploring using St. John’s to establish a mission church for the Ohio-based Byzantine Catholic Eparchy of Parma.

Residents of Bradford and the sur-

rounding area are invited to a community informational meeting on Jan. 18 at 3 p.m. at the Saint John’s parish hall to learn about a proposal that could keep the historic church building in ac-

tive use. Also invited are nearby Byzantine Catholics, who would be prospective parishioners.

Positive project for Farmington

Focus on vacant or neglected properties has paid off

FARMINGTON – A concentrated effort to deal with vacant and neglected buildings and trailer homes in Farmington appears to be paying off.

At Monday’s meeting of the Farmington City Council, Police Chief Chris Darsham reported he has received responses regarding 21 of 30 vacant or neglected buildings or trailer homes currently in violation of city codes. A few other responses arrived Tuesday morning, the chief said, though he has not processed them yet.

Letters were sent to owners of the properties along with a form now required for vacant structures in the city.

“We just want to know who owns them and what their plans are for them,” Darsham said,

presentation followed by time for questions and discussion. Speakers will include clergy and others involved in the transition who will explain the proposal and what level of community interest and support would be required. A light soup and sandwich lunch will be provided.

Saint John’s is a part of the newly formed Incarnation of Our Lord Catholic Parish, which also includes Saint Joseph in Brimfield, Saint Mary of the Woods in Princeville and Saint

Dominic in Wyoming. The Rev. Corey Kriengel is pastor of Incarnation Parish and said both he and Bishop Louis Tylka of the Peoria Diocese are very supportive of selling Saint John’s to the Byzantine

church. “We’re not in formal negotiations yet,” Kriengel noted. “Right now we don’t know if they’re going to buy it or lease it. We’re still working out those details.”

While all involved say no decision has been made, the plan could involve the Rev. Thomas J. Loya of Annunciation of the Mother of God Byzantine church in Homer Glen, located about 37 miles southwest of Chicago.

Kriengel is hopeful some deal can be worked out, ideally after the final serv-

ice planned for Saint John’s on April 19 at 2 p.m. That service is a celebration of the 150th anniversary of the Bradford church’s founding.

“We were trying to find a solution to keep the church open and this came up,” Kriengel said. “I do see it as a possible answer to prayers.”

The Byzantine Catholic church shares the same faith as the Roman Catholic Church and is in full communion with the Pope but has some differences in worship style and liturgy.

“Byzantine Catholic churches are an equally valid option for (Roman) Catholic believers,” Kriengel said. “It’s a version of Catholicism that’s more common in other parts of the world. It’s comparable to the Maronites in Peoria” who worship at Saint Sharbel Maronite Catholic Church.

Seniors paying a price for COLA

If you are reading this, you have survived another year and are starting a new one. Congratulations.

Now let’s get real. The Social Security Administration sends its Notice of Cost-of-Living Adjustment in early December telling seniors what their Social Security benefits will be for the new year. The news media had been broadcasting that the increase would be 2.8%.

Sure enough, that’s what the notice said in its first line. I honestly did not look at the form beyond that until the next day, when my wife said she looked at her benefit sheet and wasn’t happy. I took a second look at the benefits to see what had caused my wife’s displeasure.

The COLA is supposed to be designed to keep seniors at or near to the same buying power they had when they first retired. There has been much discussion lately that the COLA does not take into account the additional medical costs that seniors incur and the factors of what is the actual cost of living for seniors versus the rest of the population. We will leave those issues aside and just address the form itself.

The form starts with your gross benefit and then deducts what the form refers to as common deduc-

tions. Most people get hit with a deduction for the Medicare Part B and Part C premium. This premium does not include what many pay extra for in either a Medicare Supplement plan or a Medicare Advantage Plan. Then comes the deduction for the Medicare Prescription Drug Plan, which many people have if they don’t have a Medicare Advantage Plan.

After that comes a voluntary federal-tax withholding line if you are using your Social Security benefits to pay income taxes. My wife and I were just looking at the medical deductions and realized we just went in the hole. Ivy’s Social Security check goes down \$27 in January and mine goes down \$1.20 per month. Instead of keeping even with the cost of living, we just lost money year over year.

If you are a senior whose source of income in retirement is Social Security, you are losing money in 2026. I am very grateful that we have pension income in addition to that Social Security check, but many do not have that luxury or retirement savings. You can guess which direction our Medicare supplement plans went. I assure you those costs have not decreased.

My family’s medical-insurance costs are very small on a national scale. But multiply our net loss by the

millions of seniors on Medicare and that number has major significance. President Barack Obama and former House Speaker Nancy Pelosi stressed to the American public that we could all keep our doctors and that insurance premiums would go down.

The American public was sold a pipe dream by Obama and Pelosi. The Republicans may not have sold us the pipe dream, but they have yet to present a plan in Congress that truly addresses the medical needs of the American public in a national public-policy format. The bottom line is the Democrats have billed us to death and the Republicans have stuck their head in the sand. Neither approach works, and yet both parties are blaming the other. Perhaps a little introspection by both sides in Congress is in order.

The American public will pay the premiums for quality service. The problem is Congress has yet to provide that quality plan to the public. The current plans simply have seniors and others going deeper in debt. The current scenario will by its own definitions implode after time. It’s time for a little maturity on both sides in Washington. Happy New Year.

House fire causes \$150,000 in damages

BRIMFIELD – A house fire in Brimfield caused about \$150,000 in damage, according to authorities. The blaze at 230 N. Washington St. began about 6:30 a.m. Jan. 3. Nobody was home at the time, according to a Peoria County Sheriff’s Office report. The resident was on his way to work in Macomb, he told a deputy. A space heater had been operating in a rear bedroom, the resident said. Most of the damage was closest to that room. Most of the roof and outer walls were damaged, and the interior sustained major damage from fire, water and smoke. Brimfield fire officials reported

nothing suspicious. The Office of the Illinois State Fire Marshal was to investigate. Firefighters from the Akron-Princeville, Elmwood and Logan-Trivoli departments assisted. An Elmwood firefighter sustained a minor cut to one of his hands, but BYE Ambulance Service personnel treated it, the report stated.

Project costs piling up for Billtown board

WILLIAMSFIELD – Now that it has some extra cash, the Williamsfield Village Board needs to juggle it a bit. Replacement of a water-well pump is going to cost as much as \$45,000 more than expected, according to Village President Robert Johnson. Because of that, Johnson suggested Monday night the board delay construction of a new village public-works building. But trustees hesitated, given the dilapidated state of the current, century-old public-works building. Instead, they’ll try to ensure the well work is accounted for in the next fiscal year, which begins in May, instead of the current one. “We’ve got that thing holding up with popsicle sticks,” Trustee Kyle Gibbs said about the building. “What do you prioritize? Well, it’s both – safety and water.” Chris Ebert Company of Washington is in line to handle the well project, which is expected to be in the \$60,000-65,000 range. In addition to the pump, the well casing also needs to be replaced. That helped increase the initial estimate of \$20,000, according to Johnson. Ebert’s schedule probably will push the project into the next fiscal year, anyway, Johnson said. The village could tap financial reserves to pay for the well project and the new public-works building sooner or simultaneously, but he deemed that imprudent. “I really want that new building, but the well is the priority,” Johnson

said. The board approved a \$6,000 deal with Bruner, Cooper & Zuck, Inc., a Galesburg engineering firm, to prepare paper-work for the Illinois Environmental Protection Agency regarding the well project. Earlier Monday was the closing on the sale of the former Williamsfield Retirement Center, which the previous owner donated to the village. All About Houses Inc. of Hanna City purchased the building for just less than \$200,000. The new owners are to convert the building into a 55-and-older independent-living facility. According to Johnson, 18 people are on a list to move there once it’s completed. The new owners have talked with various local businesses about providing services. “They’re very hip on the town,” Johnson said. Money from the sale is to combine with a bank loan to finance the new public-works building, which is to cost about \$300,000. Progress there has been slowed because of zoning issues, according to Johnson. The Knox County Zoning Board needs to review the plans. The process prompted Johnson and trustees to discuss creation of a village zoning board. The Knox County board meets too infrequently and inconveniently, they indicated. During public comment, area resident Mark Ebner asked the board to reconsider its continuation of the 1% grocery sales tax the state terminated as of Jan. 1. He suggested taxes on discretionary items, like alcohol, are different than taxes on food. “You can choose not to buy a bottle of liquor, but you can’t choose not to buy food,” Ebner said. “Ethically, is that the right thing to do? Tax people’s food?”

adding forms are kept on file and properties that continue to be neglected will receive fines for ordinance violations.

The prospect of fines has spurred response, Darsham said. He expects half of the eight vacant trailers at 100 W. Pearl St. to be removed soon. He also anticipates sales of several other vacant properties whose owners said they want to avoid fines.

The city has also been active in acquiring some of the worst properties, demolishing vacant structures and then selling the cleared lots.

On Monday, Mayor Kenn Stufflebeam got approval from the council

to pursue the purchase of two such properties, at 181 E. Court St. and 427 W. Fulton St.

“I’ve often said I don’t think the city needs to be buying property, however, there’s a couple nuisance properties coming up,” Stufflebeam said. “These may be the worst of the worst.”

Stufflebeam said the properties will be available if property taxes are not paid by September.

Alderman Alex Gilles said he wants to make sure the city has plans to sell any new properties it acquires. Stufflebeam agreed and noted that a bid opening is scheduled for Jan. 19 for 165 N. Wall St. Stufflebeam said

if that property sells, the city will own only about six lots, one of which is leased by Mid Century Communications.

In other business, the council approved the purchase of a new K-9 dog to replace Koala, the current K-9 dog, who is well past his service time. Also approved was training for K-9 officer Jeremiah Ulm with Cedar Creek Kennels in Monmouth.

Darsham estimated the total cost of a new dog and training will be \$15,000 to \$18,000. Payment will come from the city’s K-9 fund that Darsham said has \$20,000 that has been donated or accumulated at fundraisers.

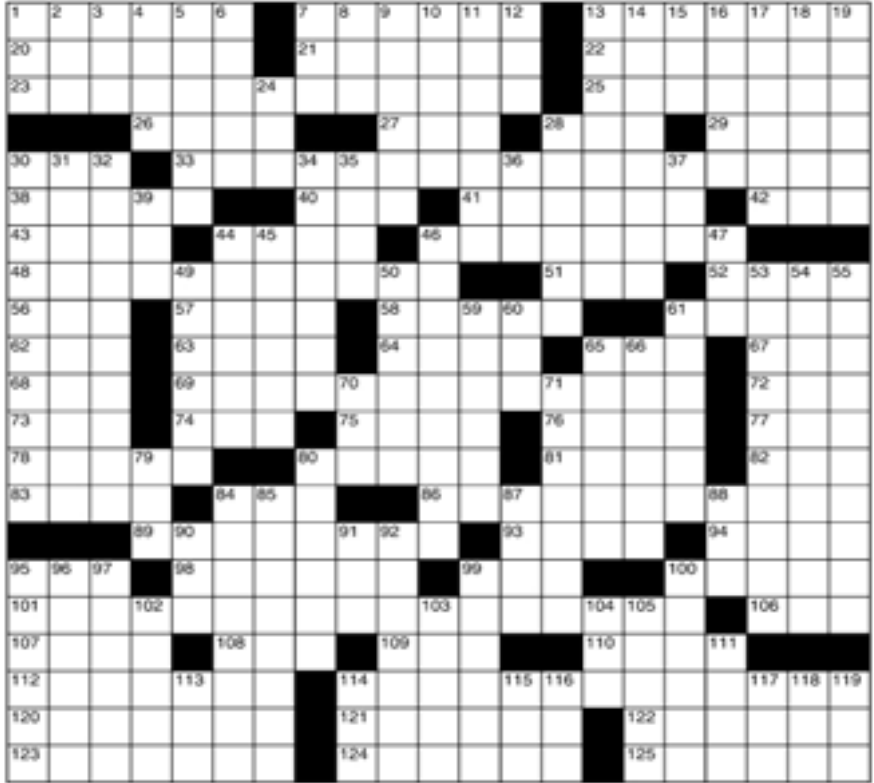

The improved play of junior Lynsey Shriber and freshman Ella Essex has given a boost to Farmington's girls basketball team.
