## Stark Co. shines at FFA event

SPRINGFIELD – The Stark County FFA chapter had a tremendous showing at the 98th Illinois State FFA Convention in Springfield last week. Six agriscience fair projects were selected as state winners and all will advance to the national level for judging.

Students with state-winning projects were Cash Kinsella and Jaxon Carder, Jake Primo, Toby Williams, Taylor Price and Darilis Knobloch, Creighton Stahl and Madison Ensey and Annalynn Terwilliger.

Williams was the 2026 winner for his Agriscience Proficiency Award and was the 2026 State STAR in Agriscience. He will advance with his record book to the national level with further judging this summer, if selected.

Isaac Macke, Will Denton and Stahl were also selected to represent Stark County in the State Convention Band. Macke will audition for the 80-member national FFA band later this summer.

Finally, Stark County FFA was selected as a gold-rated chapter in Illinois, signifying the top 8% of state chapters, and is a finalist candidate for the National Chapter Award. The National Chapter Award is given to the top 3% of chapters nationally and judging will take place this summer.

Macke will represent Stark County in Washington D.C. this month for leadership training with Illinois FFA and the Illinois Farm Bureau.

## Couple was sold on Williamsfield

WILLIAMSFIELD – One existing building in Williamsfield has become the site of 16 new addresses. Scott Perkins and Bobby Brown hope that leads to at least 16 new residents.

The husband-and-wife team are the owners of Country Aire Senior Manor, a new independent-living facility along Illinois Route 180. The new owners purchased the building earlier this year for about \$200,000 from the village, which received it last year by donation.

For Brown and Perkins, it sounds like it was love at first sight.

"We didn't even make it into



the building and I told her, 'We're buying this place,'" Perkins said. "I knew as soon as we pulled in. I said, 'Unless we walk in here and I see something completely different than what the outside tells me, we're buying this place,'

And we did."

Not to say all was perfect. Brown and Perkins have been upgrading an almost-40-year-old building that was a retirement center-turned-group home. Among the upgrades

## DOE grant to fund fall school work

Bus barn, paving work planned for October

WYOMING – In planning for expected funds from a Department of Energy Clean Energy Grant, the Stark County School Board on Monday discussed two construction projects slated for October once monies are released.

One project the board approved was for Potter and Son's Blacktopping Inc. to pave the staff parking lot for \$65,000. Other work on a new concrete apron, a main entrance to the bus barn, an asphalt bus lane and additional gravel for \$107,909 was not approved, as Elliott is seeking an extension beyond 30 days on the bid until funds are released.

The district received two bids for an electric bus barn, one from Greiner Buildings of Kewanee for \$100,300 plus an alternative bid for a garage door at \$31,288.55 and one from T&J Builders for \$72,500 and a \$9,950 quote from Sullivan Door for the garage door. No action was taken, as Elliott is seeking an extension beyond 30 days on the initial bids.

After a public hearing that elicited no comments, the board also approved an e-learning plan for 2026-29 that does not force

# SCHOOL BOARD: New baseball coach hired

the district to use e-learning days but ensures the availability in cases of need.

Again looking to the future, the board established its 2026 meeting schedule, starting with a board retreat at 8 a.m. on July 20 followed by a 1:30 p.m. regular session. Other meeting dates in 2026 are Aug. 17, Sept. 21, Oct. 19, Nov. 16 and Dec. 21. Dates in 2027 will be Jan. 19, Feb. 16, March 15, April 19, May

17 and June 21.

In other business, the board approved replacing 170 Chromebooks for 4th, 7th and 10th grades at a cost of \$69,0004 through the State Bank of Toulon and accepted a bid for milk and for publication of The Rebel Reporter in FY27. The lone bid for milk was from Prairie Farms and included an increase of 4-6 cents per pint. Lampe Publications LLC of Elmwood was the lone bidder for printing The Rebel Reporter.

The board also heeded a recommendation from Superintendent Brett Elliott to retain Miller, Hall and Triggs as board legal counsel for the 2026-27 school year with a 3% increase for the hourly rate. Elliott praised the district's work relationship with the Peoria-based law firm.

In personnel matters the board approved hiring Rich Schertz as head high school baseball coach to take over for Cole Hartley, whose resignation was accepted. Other resignations accepted were from Beth Chapman and Taylor Wilkinson as senior class sponsors.

Donald Trenholm was approved as an elementary school custodian and the board acknowledged the planned retirement of Brandi Helms at the conclusion of the 2029-30

school year, making her eligible for a 6% retirement incentive.

Finally, the board approved closing the Class of 2025 activity account, creating a Class of 2030 activity account and a resolution to transfer Fiscal Year 2027 interest.

Prior to the business portion of the meeting, the board recognized the school's IESA state track meet qualifiers and noted the success of Stark County FFA students at the Illinois State FAA Convention held in Springfield earlier in June.

The board also heard from Elliott that the Education Foundation plans to have its annual golf outing on July 31 at Midland Golf Club.

Village of Bradford Residents,

To make sure every resident is aware of changes, we are writing to inform you of an increase that will affect your water bill in the coming months. For the last several years, the cost of running the water and sewer facilities has continued to increase. The Village Board has investigated and discussed alternative solutions to keep the cost to citizens down. Bradford has attempted to apply for Grant Funding to help our area, the board was told by USDA Rural Development that we cannot apply as we do not meet the criteria. Bradford was told we do not charge enough on water and sewer to maintain upkeep of the repairs. Until we increase our rates, Bradford will not qualify. Unfortunately, this problem has come to a head.

To give residents a glimpse into this decision, we have compiled a few items that we acquire regular increases on. Ameren costs alone have increased by approximately 41 % on average from 2023 to 2026. This overall rise is driven by two main factors: rising "supply" prices (market cost for electricity) and periodic "delivery" rate hikes (regulated fees for grid maintenance). Yearly cost of municipality maintenance has increased as well. Wastewater / Sewer costs for some municipalities have increased 25% in 2026 alone, following the 40% increase in prior years to fund required upgrades set by the EPA.

In early 2025 the village experienced an extremely heavy burden. Membranes for the water treatment facility needed to be replaced immediately. These are basically "filters" inside the vessels that the water flows through. Wyoming just had the same issue in July of 2025. The cost of the membrane is around \$75,000. Then, if not installed and pressurized correctly, the membrane can blow out and will need to be replaced again.

In Bradford's case, we were fortunate enough to have our own City Maintenance Manager who is educated in this matter and saved Bradford substantial funds. Bradford replaced the membranes for \$39,480.34.

The increase in the water and sewer bill was not a decision that was made lightly. Several conversations trying to establish alternative actions have been discussed. The increase affects all residents in Bradford. We do understand the constraint that this can put with individuals in low-income households. Copies of funding assistance can be found in the front lobby of the Village Hall if needed. We encourage residents to call these resources if needed.

It was discussed by the board to raise the cost of water and sewer during the February Committee Meeting. Voting on the increase was determined at the April Board Meeting. The rate for water will increase from \$45.50 to \$50.50 and the rate for sewer will increase from \$35.50 to \$40.50 so the total bill will be \$110.00. This is an increase of \$10.00 per month and this will take effect on the bill issued in July.

**Graduation in D.C. different than home**

It is that time of the year when our kids and grandkids graduate from high school and college. Every school and location tends to do it differently. And if one has to travel to the event there are additional concerns.

This past week my wife and I traveled to Falls Church, Va., for the high school graduation of our grandson. What got my attention, to start with, was the price of gas and a motel room.

For those of us who live in Illinois, we can be proud of our gas taxes. Illinois has some of the highest gas taxes in the nation, though we do rank second fiddle to our friends in California.

We went through Illinois, Indiana, Ohio, Pennsylvania, West Virginia, Virginia and Washington D.C. Every gas price was lower than Illinois. We saw gas for \$3.19 in Indiana and we left home at \$4.74.

Every business in Illinois that uses gasoline is paying more than our competitors next door. Is it any wonder that businesses and residents are leaving Illinois?

The hotels tell a little different story. We drove the first night without a reservation as we didn't know how far we would travel. We ended up in a huge thunderstorm in eastern Ohio at a Sleep Inn. Not your fanciest hotel, but the room was clean and the breakfast was pretty good. The price was \$97, which I thought was great.

Sunday afternoon we arrived at the

Marriot in Falls Church, a suburb of Washington D.C. I had tried to book a reservation online but kept getting told the hotels were sold out of handicap rooms, if not the entire hotel.

I gave up and used an American Express travel agent to find us a room. The travel agent did her job and got us the room, but the price was a shade bit more than that Sleep Inn. It cost us over \$400 per night for that room and, if we had stayed a third night, the price went up to over \$700.

Now it was a beautiful hotel and the food was served on real plates and silverware, but my country roots were hurting. Lesson learned: Get your reservation early as the Washington D.C. market is as volatile as it gets.

We finally get to the graduation on Monday, but it is nothing like a central Illinois graduation. There are multiple high schools in Falls Church. Three of those schools had their graduations on that Monday at the 7,000-seat George Mason University basketball arena. Ceremonies were at 9 a.m., 2 p.m. and 6 p.m.

I am amazed at how efficient the university is in getting the crowd out and the new group in, as each school had over 600 graduates.

The ceremony itself was a typical graduation ceremony, save for the graduates. From my less than scientific observation, at least 25% of the graduates were ethnic Muslim. A significant proportion were of Hispanic background and there was a noticeable Indian/Asian group.

One of the student speakers, who

spoke excellent English, stated he was an 8th grade non-English speaking boy when he came to the United States from Afghanistan. He gave a lot of credit to his teachers for assisting him in his assimilation into American society.

Another girl was from Bolivia and she was acknowledged for her English acclimation. I don't know how many languages I heard out in the foyer of the arena. The kids were all speaking English to each other and then speaking their native tongue to their older family member.

I was intrigued by the diversity of the setting. To that thought, we went out to dinner afterwards and our grandson, who was born in Germany as an American citizen, was speaking English to my wife and me. But he would revert to Armenian when speaking to his mother, who is very fluent in English, and is a U.S. citizen.

The differences in settings between Washington D.C. and central Illinois were acutely obvious, but there was also the sameness of being Americans at a high school graduation.

We asked our grandson what his plans were for after graduation. He was starting work the next week at the Pentagon in the maintenance department as a trainee, after spending his last semester of high school going through all of the security clearances. It is my understanding that he is one of the youngest employees there.

Our nation is evolving and growing and every graduate adds to the future of the country.

This report is intended to provide you with important information about your drinking water and the efforts made by the water system to provide safe drinking water.

#### Source of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production, and mining activities
- Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not

necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline at (800) 426-4791.

- In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

- Some people may be more vulnerable to contaminants in drinking water than the general population.

- Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800) 426-4791.

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The drinking water supplier is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. #### Source of Water: Bradford

Based on information obtained in a Well Site Survey published in 1991 by the Illinois EPA, several potential sources are located within 1,000 feet of the wells.

The Illinois EPA has determined that the Bradford Community Water Supply's source water is not susceptible to contamination. This determination is based on a number of criteria including: monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and available hydrogeologic data on the wells. Furthermore, in anticipation of the U.S. EPA's proposed Ground Water Rule, the Illinois EPA has determined that the Bradford Community Water Supply is not vulnerable to viral contamination. This determination is based upon the evaluation of the following criteria during the Vulnerability Waiver Process: the community's wells are properly constructed with sound integrity and proper siting conditions; a hydraulic barrier exists which should prevent pathogen movement; all potential routes and sanitary defects have been mitigated such that the source water is adequately protected; monitoring data did not indicate a history of disease outbreak; and the sanitary survey of the water supply did not indicate a viral contamination threat. Because the community's wells are constructed in a confined aquifer, which should prevent the movement of pathogens into the wells, well hydraulics were not considered to be a significant factor in the susceptibility determination. Hence, well hydraulics were not evaluated for this system ground water supply.

was the addition of 16 new mailboxes, one for each room. Each mailbox required an address.

The new owners suggested that process was laborious. Perhaps that's why, while Brown and Perkins were providing a recent tour, they appeared to take particular pride in the gleaming mailboxes protruding from a vestibule wall.

"We had to go get addresses, but it's worth it," said Brown, a Canton-based mortgage banker.

Brown and Perkins believe the entire endeavor is worth it.

The two have been in the rental-and-rehab business for years. That work includes Country Aire apartments in Hanna City, which like the new Billtown facility is for tenants 55 and older. Brown and Perkins were looking to expand that concept at a more-affordable price.

Country Aire in Williamsfield offers three types of rooms – small, medium and large – for monthly rents of \$895, \$995 and \$1,095, respectively. The cost includes utilities but does not include internet or cable television. Common areas include those amenities

and a full kitchen. Individual units have kitchenettes.

"I'm able to provide a really good service at a really good price because I got the building at a good price," said Perkins, a retired Caterpillar Inc. mechanical engineer.

"From a business standpoint, seniors really are phenomenal. What you've got to figure out is what they care about. They care about keeping it cheap. They care about survival. They're just worried about where they're going to live, essentially until the end of their lives."

The first Country Aire tenant moved in last month, Perkins said. The building is not staffed 24 hours a day and does not provide medical services,

although Graham Health System of Canton operates a clinic in the village.

A local restaurant, Billtown Diner, has agreed to deliver up to three meals a day for residents, at \$8.50 per meal. Ladd's Food Mart in Williamsfield has offered to deliver groceries. Those businesses and services helped convince the new owners to take a chance on the community, Perkins said.

"To me, the town speaks for itself," he said. "The base is solid in this town. They have everything (my residents) need. I own houses in other places that I drive into town and I'm like, 'This town is dying. I need to get out of it.' When I drove into this town, it's not."

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

If no such petition is filed within said thirty (30) day period, then the City shall thereafter be authorized to issue the Revenue Bonds for the purposes hereinabove provided.

Notice is hereby further given that if a petition signed by 101 or more electors of the City (being equal to the greater of (i) 7.5% of the registered voters in the City or (ii) 200 of those registered voters or 15% of those registered voters, whichever is less) asking that the issuance of the Alternate Bonds be submitted to referendum is filed with the City Clerk within thirty (30) days after the date of publication of this notice, an election on the proposition to issue the Alternate Bonds shall be held on the 3rd day of November, 2026. The Circuit Court may declare that an emergency referendum should be held prior to said election date pursuant to the provisions of Section 2A-1.4 of the Election Code. If no such petition is filed within said thirty (30) day period, then the City shall thereafter be authorized to issue the Alternate Bonds for the purposes hereinabove provided.

An Ordinance authorizing the issuance of Waterworks and Sewerage Revenue Bonds of the City of Toulon, Stark County, Illinois, in an aggregate principal amount not to exceed \$1,000,000 or, in lieu thereof, General Obligation Bonds (Alternate Revenue Source) in an aggregate principal amount not to exceed \$1,000,000 for the purpose of paying the costs of improving the waterworks and sewerage system of the City.

Whereas, the City of Toulon, Stark County, Illinois (the "City"), is a duly organized and existing municipality incorporated and existing under the provisions of the laws of the State of Illinois, and is now operating under the provisions of the Illinois Municipal Code, as amended (the "Code"), and for many years has owned and operated a municipally-owned combined waterworks and sewerage system (the "System") as set forth in Division 139 of Article 11 of the Code; and  
Whereas, the City Council of the City (the "City Council") has deter-

mined that it is advisable, necessary and in the best interests of the City to pay the costs of improving the System, including construction of a new water storage tower (the "Project"); and  
Whereas, the estimated costs of the Project, including legal, financial, bond discount, printing and publication costs, and other expenses, is not less than \$1,000,000, and there are insufficient funds on hand and lawfully available to pay such costs; and  
Whereas, in addition to the System revenues (the "System Revenues"), there exists a source of funds, the same being Illinois State income tax as shared with municipalities by deposit to and payment from the Local Government Distributive Fund in the State Treasury, as such tax is supplemented and amended from time to time, and any tax which may be substituted for such tax in the future (the "Shared State Income Taxes"), received by the City and available for any of its corporate purposes, including for the payment of costs of the Project; and  
Whereas, the City Council has further determined that it is advisable, necessary and in the best interests of the City to construct the Project and, in order to finance the costs thereof, to issue up to \$1,000,000 of revenue bonds payable solely from System Revenues as authorized to be issued at this time pursuant to Division 139 of Article 11 of the Code (the "Revenue Bonds") or, in lieu thereof, up to \$1,000,000 alternate bonds (the "Alternate Bonds"), being general obligation bonds payable from (i) System Revenues and (ii) Shared State Income Taxes (collectively, the "Pledged Revenues"), as authorized to be issued at this time pursuant to the Local Government Debt Reform Act of the State of Illinois, as amended (the "Act"); and  
Whereas, if the Pledged Revenues are insufficient to pay the Alternate Bonds, ad valorem property taxes upon all taxable property in the City without limitation as to rate or amount are authorized to be extended to pay the principal of and interest on the Alternate Bonds:  
Now, Therefore, Be It Ordained by the City Council of the City of Toulon, Stark County, Illinois, as follows:

Section 1. Incorporation of Preambles. The City Council hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and does incorporate them into this Ordinance by this reference.

Section 2. Declaration of Intent. The City Council hereby declares its intention to avail of the provisions of the Code and the Act and to issue the Revenue Bonds or, in lieu thereof, the Alternate Bonds in an aggregate principal amount not to exceed \$1,000,000 for the purpose of paying the costs of the Project.

Section 3. Determination to Issue Bonds. It is advisable, necessary and in the best interests of the City to construct the Project for the public health, safety and welfare, in accordance with the estimate of costs as hereinabove described, and that for such purpose, there are hereby authorized to be issued and sold the Revenue Bonds in an aggregate principal amount not to exceed \$1,000,000 or, in lieu thereof, the Alternate Bonds in an aggregate principal amount not to exceed \$1,000,000.

Section 4. Publication. This Ordinance, together with a notice in the statutory form (the "Notice"), shall be published after passage hereof by the City Council in The Prairie News, the same being a newspaper of general circulation in the City, and if no petition, signed by 67 electors of the City (being equal to ten percent (10%) of the number of registered voters in the City) asking that the question of the Project, as provided in this Ordinance, and the issuance of the Revenue Bonds therefor be submitted to the electors of the City is filed with the City Clerk within thirty (30) days after the date of the publication of this Ordinance and the Notice, then the Revenue Bonds shall be authorized to be issued.

If no petition, signed by 101 electors of the City (being equal to the greater of (i) 7.5% of the registered voters in the City or (ii) 200 of those registered voters or 15% of those registered voters, whichever is less) asking that the issuance of the Alternate Bonds be submitted to referendum is filed with the City Clerk within thirty (30) days after the date of the publication of this Ordinance and the Notice, then the Alternate Bonds shall be authorized to be issued.

It is expressly provided that in the event that there shall be filed with the City Clerk in a timely manner a petition, asking that the issuance of the Revenue Bonds be submitted to referendum, the Alternate Bonds shall not be authorized to be issued until such time as the issuance of

the Revenue Bonds shall have been submitted to the electors of the City and a majority of the votes cast on such question shall have been in favor thereof.

Section 5. Additional Ordinances. If no petition with respect to the issue of the Revenue Bonds or, in lieu thereof, the Alternate Bonds and meeting the requirements of applicable law is filed during the petition periods hereinabove referred to, then the City Council may adopt additional ordinances or proceedings supplementing or amending this Ordinance providing for the issuance and sale of the Revenue Bonds or, in lieu thereof, the Alternate Bonds and prescribing all the details of the Revenue Bonds or, in lieu thereof, the Alternate Bonds, so long as the maximum aggregate principal amount of the Revenue Bonds or, in lieu thereof, the Alternate Bonds as set forth in this Ordinance is not exceeded and there is no material change in the Project. Such additional ordinances or proceedings shall in all instances become effective in accordance with applicable law. This Ordinance, together with such additional ordinances or proceedings, shall constitute complete authority for the issuance of the Revenue Bonds or, in lieu thereof, the Alternate Bonds, under applicable law.

Section 6. Reimbursement. None of the proceeds of the Revenue Bonds or the Alternate Bonds issued in lieu thereof will be used to pay, directly or indirectly, in whole or in part, for an expenditure that has been paid by the City prior to the date hereof except architectural or engineering costs incurred prior to commencement of the Project or expenditures for which an intent to reimburse it as properly declared under Treasury Regulations Section 1.150-2. This Ordinance is in itself a declaration of official intent under Treasury Regulations Section 1.150-2 as to all costs of the Project paid within 60 days prior to the date hereof or on any date after the date hereof and prior to issuance of the Revenue Bonds or, in lieu thereof, the Alternate Bonds.

Section 7. Severability. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

Section 8. Repealer. All ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict hereby repealed.

Section 9. Effective Date. This Ordinance shall be in full force and effect from and after its passage and approval, as provided by law. Passed this 8th day of June, 2026, pursuant to a roll call vote as follows:
